Meeting Record

Roll call was taken. Irwin Zonis made a motion to approve the May minutes with edits. John Elston seconded the motion. The May minutes were approved with edits by a unanimous vote.

Administrative Report

Presented by Bill O'Sullivan, Director, Division of Air Quality:

- The U.S. Supreme Court (SC) ruled that USEPA can and should regulate CO2/green house gases.
- The SC upheld USEPA's current requirement to base applicability of New Source Review (NSR) on annual emissions increases.

- The D.C. District Court clarified that the Ozone State Implementation Plan (SIP) rule is partially vacated. This does not adversely impact New Jersey.
- Commissioner Jackson is now Chair of the Ozone Transport Commission (OTC).
- A Mid-Atlantic/Northeast Visibility Union (MANE-VU) meeting was held last week on improving visibility at four Class I areas in New Hampshire, Vermont, Maine and New Jersey.
- The final Ozone SIP proposal package was sent to USEPA on June 15, 2007. Uncertainty exists about attaining by the 2009 deadline. Additional measures go beyond the 2009 deadline.
- This month, USEPA proposed a new ozone standard of 70 to 75 ppb. Their Clean Air Act Science Advisory Committee had recommended 60 to 70 ppb.
- The Reasonably Available Control Technology (RACT) SIP is expected to be finalized this month. This plan commits to propose rules for major sources of NO_x and volatile organic compounds (VOC) where technology has advanced and lower emissions are reasonable.
- The RACT rules and consumer products rule proposals are expected in August and July respectively.
- The New Jersey Clean Air Interstate Rule (CAIR) has been adopted and will be published in July. This rule allocates NO_x allowances based on energy output to promote energy efficiency.
- The Diesel Retrofit Rule is under final review.
- The Diesel Idling Rule was adopted and will be in the July 2 New Jersey Register.
- Diesel Smoke Cutpoint proposal is expected in August to lower allowable smoke from diesel vehicles.
- Work will begin within the next year on rules requiring inspection of medium-duty diesels.
- Air quality modeling evaluations are being done for a railroad yard and truck stop.
- Idle Air Truck Stop press event is scheduled in Bordentown on June 26.
- The Diesel Retrofit Program and the New Jersey Department of Treasury issued a request for proposal (RFPs) for retrofit vendors. The deadline for bids is June 19.
- The Diesel Risk Reduction Program has launched a public awareness and advertising campaign to educate the general public about the idling law. The theme of the campaign is "Idling Stinks...and It's Against The Law." Advertising will appear on billboards around the state, at minor league baseball stadiums, on New Jersey Transit buses, at PATCO rail stations and in newspaper inserts. Funding for this month-long effort was provided by USEPA.
- New Jersey recorded four exceedances in May and seven exceedances in June (as of June 27) of the 8-hour ozone health standard of 0.08 ppm. So far this year, New Jersey recorded one day that exceeded the 1-hour standard.
- In accordance with USEPA regulations, the New Jersey Air Monitoring Network Description was posted for public comment. The website address is <http://www.state.nj.us/dep/airmon/>
- Last week, the New Jersey Department of Treasury issued an RFP to solicit bids for a new contractor to operate the motor vehicle inspection program. The new contract will phase out the dynamometer.
