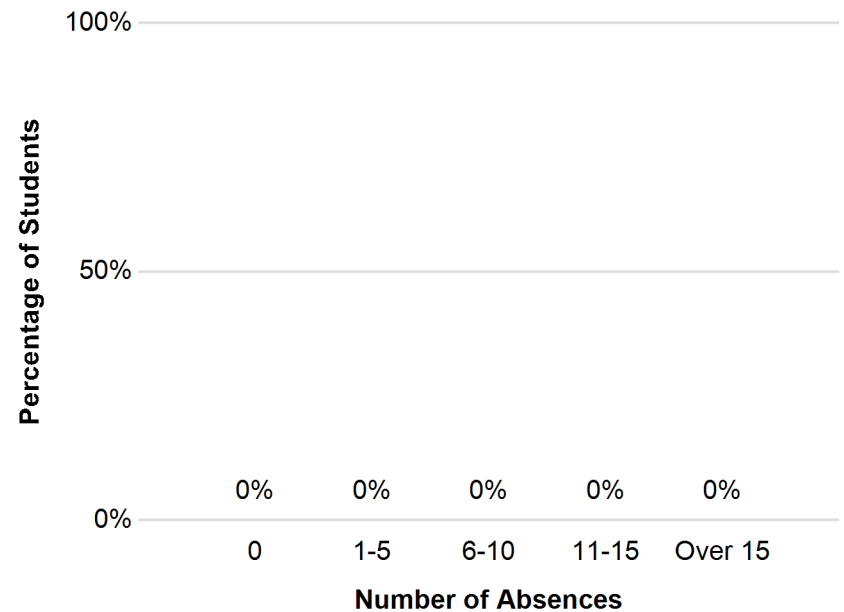

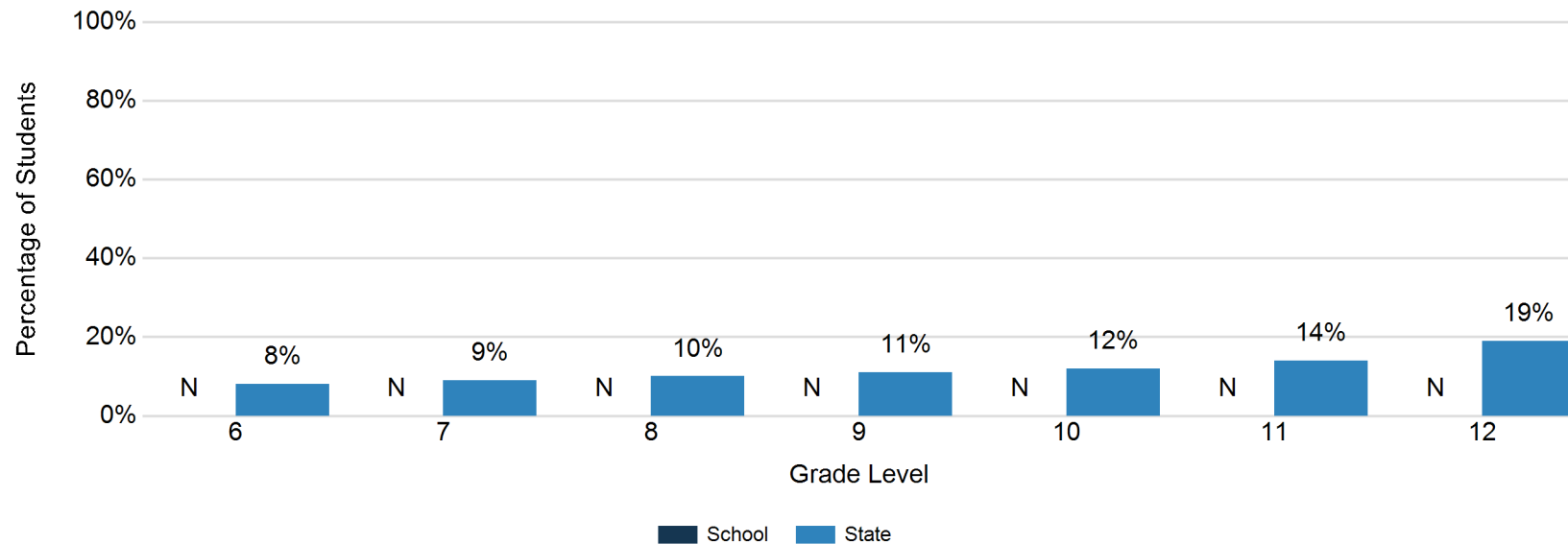

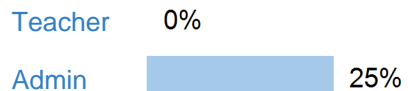
Bachelor's Degree

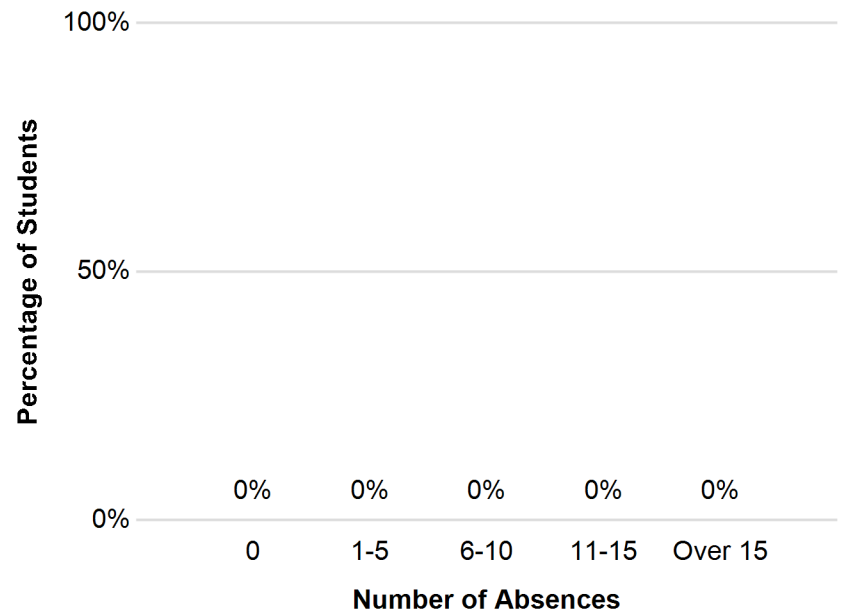

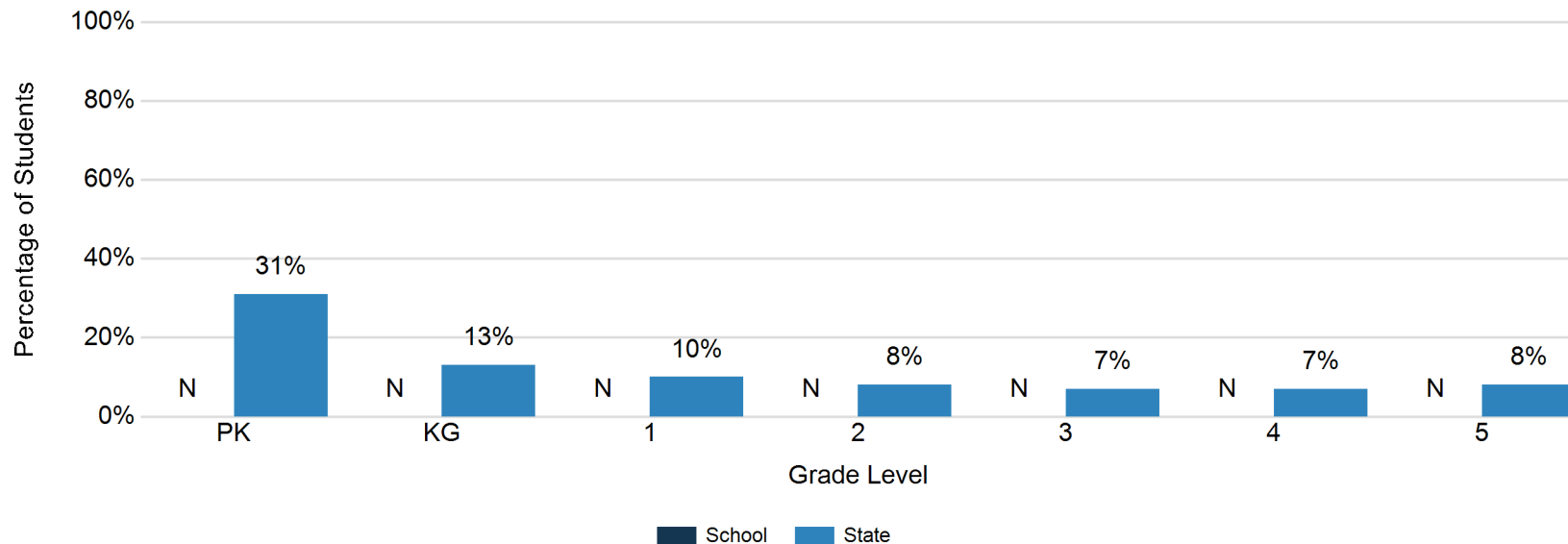

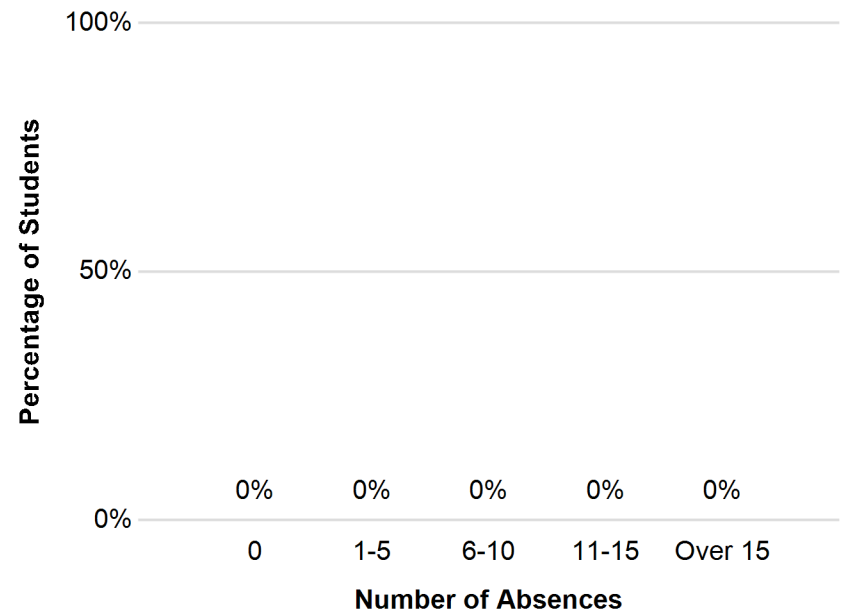

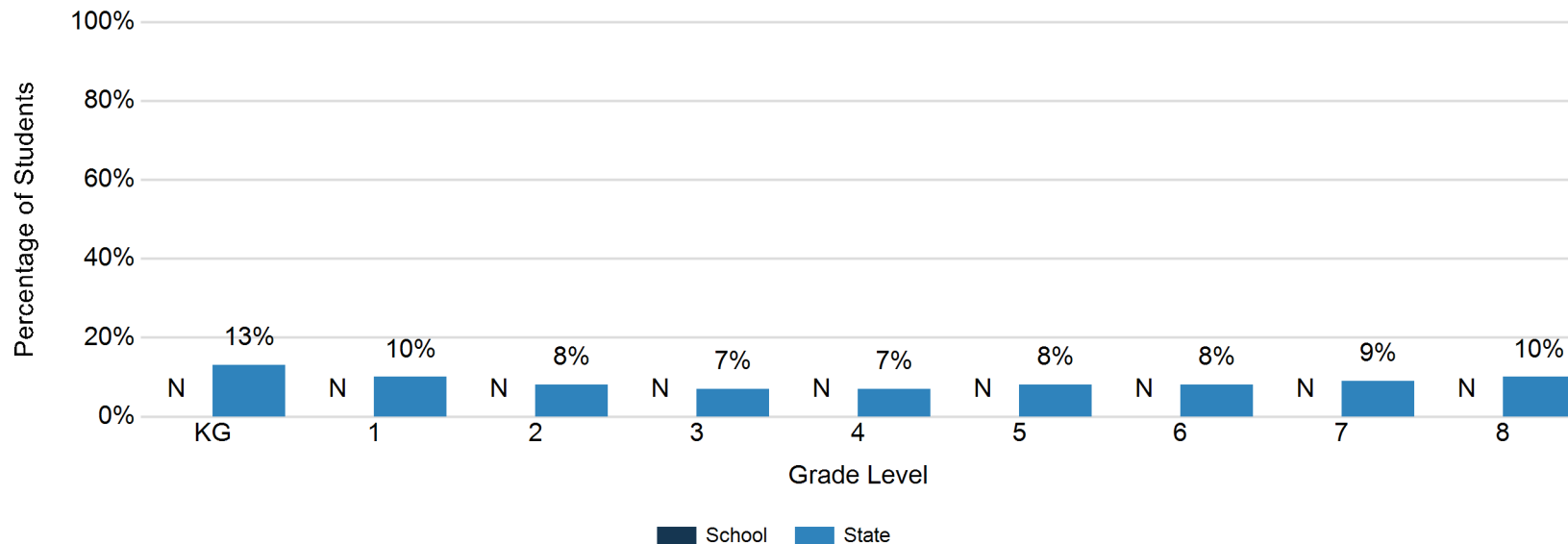
