Chapter Historical Note

Chapter 29, No Passing, was originally adopted as N.J.A.C. 16:28-15 by R.1978 d.268, effective August 1, 1978. See: 10 N.J.R. 297(a), 10 N.J.R. 406(e). N.J.A.C. 16:28-15 was administratively recodified as N.J.A.C. 16:29-1, effective June 14, 1979.

Pursuant to Executive Order No. 66(1978), Chapter 29 expired on August 1, 1983, and subsequently was adopted as new rules by R.1983 d.495, effective November 7, 1983.
