BY HIS EXCELLENCY  
THE GOVERNOR.

Head-Quarters, Trenton, April 22, 1782.

**A**T a Court-Martial whereof Major Richard A Dey was president, held at the bridge in the county of Bergen, by order of his Excellency the Governor, and continued by several adjournments: Capt. Elias Romine was tried upon the following charges.

1st. For taking bribes to remit the fines of persons disaffected to the present government.

2d. For robbing the inhabitants of their property.

3d. For threatening and abusing several of the inhabitants of the county of Bergen, for applying to the Colonel of the said county, to have him arrested and tried for the aforesaid crimes, and declaring that the whigs should suffer for the said complaint, and that he would make them sweat for it.

The court having maturely considered the evidence offered on the several charges against Capt. Romine, do find him guilty of the first and second charges, and not guilty of the third, and adjudged him to be cashiered, and dismissed from the service as an officer of the militia.

The Governor having duly considered the evidence produced to the said Court-Martial, and the sentence and acquittal of the same, approves of and confirms the adjudication of the said court against the said Captain Romine, and orders the same to take place accordingly.

WIL. LIVINGSTON.

L O N D O N, January 24.

Yesterday at one o'clock and not before, Earl Cornwallis arrived in the Metropolis, accompanied by General Arnold and his family. His Lordship brings information, that he left New-York with a fleet of transports, &c. to the amount of 119 sail, on the 12th of December. On the 18th a violent storm arose, and so completely dispersed them, that no four of them ever got together again during the whole course of their passage. The Janus of 44 guns had never been heard of since the dispersion. His Lordship further relates, that in the course of the passage, the Robuste, in which he was originally on board when he left New-York, sprung a leak, and he was removed on board the Greyhound transport. When he came within sight of Scilly, this vessel was captured by a French brig, the Captain of which took out several of the English sailors into his own ship, and put eight Frenchmen and a prize master into the Greyhound, with directions to steer for the first French port. Before they came near the coast of France, a violent storm arose, and the Frenchmen being bad navigators, and the vessel in danger of being lost, Lord Cornwallis proposed to the master to restore the ship to the command and steering of the Englishmen, and he pledged his honour that it should be returned untouched. The necessity of the case left no alternative, and the man complied; the vessel was brought into Torbay, where his Lordship was received by Capt. M'Bride, and the Greyhound was resigned to the Frenchmen.

Yesterday Earl Cornwallis waited on his Majesty at the Queen's house, and had a long conference.

Lord Cornwallis, in his way to town, was complimented by the Mayor and Corporation of Exeter, with the freedom of that city; and so pleased were the people with his arrival there, that he was carried from the London Inn to the Guild Hall on men's shoulders, accompanied by an incredible number of spectators.

When the brave Lord Cornwallis returned to New-York, the Commander in Chief offered him many compliments, but his Lordship declined them all, and dismissed an orderly Serjeant, who was sent to attend him, with this pointed sarcasm, that it was then too late for military assistants.

Several plans for the prosecution of the American war have been lately presented to his Majesty, at his own request, by some general officers, but none of them are as yet fixed on.

Sir John Irwin is confidently talked of to succeed Sir Henry Clinton. Sir John is lately arrived at his house in Picadilly, from Ireland, being sent for previous to the above appointment.—*Gazetteer*.

Extract of a letter from the Hague, Jan. 18.

"It is reported here, but is not however much credited, that a treaty, offensive and defensive, between France and this republic is actually signed; the principal articles of which are, that that power guarantees to these provinces all their possessions in all parts of the world, with protection to their trade and navigation; and that when a peace is concluded, a treaty of commerce shall be entered into very much to the advantage of the Dutch navigation, and which will firmly unite the two powers; that

the States General shall on their side engage to advance the sum of Eighty-five Millions of livres to France, for the service of 1782, and a similar sum, if necessary, for 1783."

The secret service list for the year 1781, is charged with the following sums in the departments they are placed against; treasury, 72,000l. American department, 83,000l. Admiralty, 40,750l. Army, 10,500l. Sec'y's. of state, 58,635l. Total, 264,885l.

Lord Cornwallis, like every man that has lost an army or a ship (the object, whatever it is, committed to his care) can no more appear in the King's presence than General Burgoyne; he must when his captivity is over, be tried by a court-martial. His Lordship has not seen many persons; but those to whom he has opened himself say, that his opinion and complaints are loud against the employment of foreign troops: those in his army had been wrought upon by the Germans, among the enemy, who gave most flattering accounts of the settlements made by the Germans that were taken under General Burgoyne, to whom ample tracts of land were granted in perpetuity, so that most of them were now substantial farmers, settled far out of the reach of the war. Worked upon by these instigations, they called loudly for a surrender, and declared they would throw down their arms, if any more attempts were made. Thus was his Lordship tied down to a conduct, which he would otherwise have abhorred.

The measure which injured the King's affairs the most in Virginia, was the news arriving there, that Lord Dunmore was to be their Governor again—this circumstance operated like a charm—it arrested the activity of every man inclined to loyalty, and quickened with exasperated force, the enmity of the rebels. Whoever advised such an impolitic measure, as re-appointing the old Governors, so detested by the people, when the war broke out, should be marked for ever as an enemy to his Majesty and his councils!

The history of navigation does not produce a more perilous or tedious voyage than that of the Jamaica fleet. During one month of the twelve weeks which the ships were out, several of the crews lived entirely on salt pork and rum, not having either bread, biscuit or water, except a very small quantity of the latter, under which scarcity many died. Other ships were plentifully supplied, and sought every opportunity to relieve their distressed friends, but in vain; the wind was so very high, and the seas so extremely rough, that their good wishes could not be accomplished. The Lord Howe, a very fine storeship, in the service of government, together with four others of the convoy, foundered, and it was with the utmost difficulty the people were saved. It is, however, a pleasing reflection, that not a single ship of so large a fleet fell into the hands of the enemy, who had no less than 12 men of war upon the watch for them.

H A R T F O R D, April 16.

Our last advices from Europe mention, that the Emperor of Germany has lately issued orders for dismantling the Austrian barrier, as it has been long called, the fortified towns of Brabant, in Flanders, by which the Dutch troops, who, according to treaty, have garrisoned those towns, are at liberty to act elsewhere. All this looks like a perfectly good understanding between the Emperor and the Court of Versailles, since those towns were meant as a barrier against the power of France.

C H A T H A M, April 7.

Extract of a letter from Minisink, dated April 7.

"This moment we received the disagreeable intelligence that the savages killed a family of the Smiths yesterday, about 12 o'clock, on the Pennsylvania side of the river, about twelve miles below this place—It is said the whole family, both parents, children and workmen were all scalped together."

R I C H M O N D, April 13.

A report has prevailed within these few days, that the enemy have evacuated Charlestown: the death of the King of England is also mentioned; and it has been asserted, that an action had happened between the French and British fleets, in which the former were victorious, and immediately afterwards landed a considerable body of troops upon Antigua. We do not, however, pretend to mention these matters as facts, but as reports, which have not yet been contradicted by any later intelligence.

It is confidently said, that six ships only of M. de Guichen's convoy were taken, and the late papers confirm it.

Five new 74's have been lately launched at Rochfort and Brest, and twenty-four men of war are on the stocks in France and Spain, besides several frigates, on a new construction, to carry eighteen pounders.

P H I L A D E L P H I A, April 16.

Yesterday morning the brigantine Friendship, Captain Hall, arrived here after a passage of fourteen days from Port au prince. This vessel brings us advice of the arrival of 17 Spanish ships of the line, with 12000 troops, at Cape Francois from Cadiz. These are no doubt destined to act in conjunction with those of his Most Christian Majesty in the attack on Jamaica, which, in all probability, must be subdued by so powerful an armament.

A P R I L 24.

Extract of a letter from Baltimore, dated April 16, 1782.

"Captain Jones, in the schooner Somerset, arrived here this morning, after a passage of ten days from St. Kitts. He brings no news but a confirmation of Guichen's fleet being arrived at Martinico, consisting of ten ships of the line and about 130 transports; the whole force of the French at that place 40 sail of the line, and the British at St. Lucia 39. This is rather too near an equality.

On Sunday the 31st ult. died at Bethlehem, in Northampton county, Mr. HENRY MILLER, late an eminent printer of this city, in the 80th year of his age.

By accounts from the Westward we hear that the Indians have lately appeared near Fort-Pitt, but that the inhabitants had turned out against them, and have gained signal success. Upwards of ninety of the Indians have been killed and scalped at one time, 80 horses taken with a large quantity of fur and skins. Upwards of 300 men have set out from the neighbourhood of Fort-Pitt, properly equipped on horseback, for Sandusky, on an expedition against the hostile nations.

T R E N T O N, M A Y 1.

From RIVINGTON'S GAZETTE, April 25.

Last Sunday evening arrived the brigantine Pearl, Captain Carson, in eight weeks from Lisbon; on her passage she fell in with the private ship of war Virginia, belonging to this port, to whom the European papers were delivered, which prevented us from receiving the intelligence contained in them.—By this vessel we are informed, that the garrison of Minorca capitulated on the 17th of February, and that a considerable fleet of men of war and transports with troops, had sailed from Cadiz for the West-Indies, previous to Captain Carson's departure from Lisbon.

The account of the taking of Minorca was brought by an express to the Spanish Ambassador at Lisbon; it is said there were no more than 1100 men fit for service, and those so exhausted, by incessant exertions, that there was no alternative but in submission to the vast force of the besiegers.

**FIFTEEN HALF JOHANNESSES  
REWARD.**
