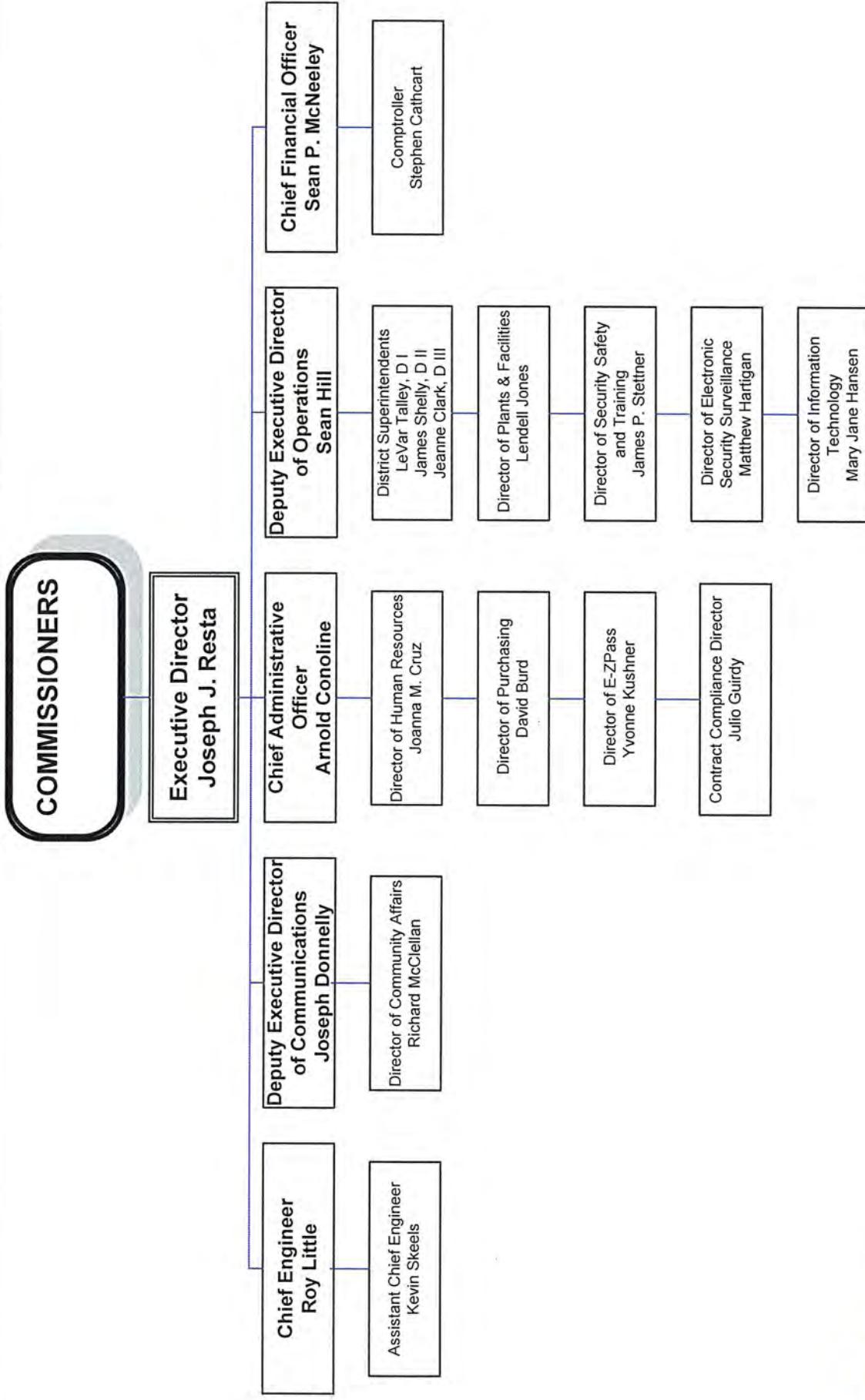

ROLL CALL

Joseph Resta, Executive Director, in his capacity as Secretary for this Meeting called the roll, and at the conclusion thereof, reported that there was a quorum present-there being three members present from the Commonwealth of Pennsylvania and three members present from the State of New Jersey.

WELCOMING REMARKS OF CHAIRMAN

Chairman DeGerolamo welcomed those persons whose identities are set forth hereinabove under "Appearances".

INTRODUCE ANY COMMENTS FROM THE PUBLIC

Chairman DeGerolamo addressed the meeting and invited any comments from the public on items pertaining to today's Agenda.

EXECUTIVE DIRECTOR'S REPORT

Joseph Resta, Executive Director, addressed the meeting and said;

"Good morning. With one month of spring weather now behind us, the Commission's focus has shifted from winter storm response to construction projects at a handful of our bridge facilities.

Work on the Lower Trenton Toll-Supported Bridge Approach Roadway Improvements kicked off in late March and has stepped up in recent weeks. This roughly four-month-long project will address worn pavements, safety deficiencies and other issues at the approach roadways, intersections, and walkways that provide vehicular and pedestrian access to the Lower Trenton Bridge linking Trenton and Morrisville. Work is being staged in a manner that will minimize potential impacts for weekday job commuters who use the Lower Trenton Bridge. The Commission is committed to maintaining single lanes of travel in both directions across the bridge at all times. However, a series of limited side-street road closures and detours are being used elsewhere to complete other elements of the project. Weather permitting, this project should reach completion by late July.

DELAWARE RIVER JOINT TOLL BRIDGE COMMISSION

Earlier this month, mobilization activities kicked off for the Portland-Columbia Toll Bridge Approach Roadway Improvements Project. This project will include concrete pavement rehabilitation, full-depth pavement replacement, cleaning and sealing of roadway concrete joints, milling and resurfacing paved shoulders, pavement-marking replacement, drainage improvements, superstructure repairs, and various other improvements. The project progressed into actual construction this week with shot blasting and sealing of the main river bridge deck. This work is taking place with alternating single lane travel patterns controlled by flaggers. A project-specific webpage had been created to explain the project and inform motorists of travel restrictions. The entire project is expected to be completed prior to Thanksgiving.

Moving down river, surveying and data-collection activities continue in the field for the Scudder Falls Bridge Replacement Project. Subcontractors and engineers for the final design firm – Michael Baker Jr. Inc. – are currently staking out subsurface boring sites, conducting land surveys, and making field visits to assess soil boring and noise-wall locations. Behind the scenes, we continue to move forward with other project preparation efforts. The project's website is being redesigned. A comprehensive project schedule is nearing completion. And an RFP for public involvement services was issued last week.

Last but not least, we are moving ahead with our planned rededication ceremony to mark the completion of the Easton-Phillipsburg Toll Bridge Rehabilitation Project. As a reminder, the event is scheduled for 11:30 a.m. Wednesday on the grounds of our administration building in Phillipsburg. The scope of work for this project was substantial, taking nearly two years to complete. Tasks included: - A thorough rehabilitation of the main-river bridge, including deck rehabilitation, cleaning and painting of structural steel, improvement of the bridge drainage system, structural steel and substructure repairs, and painting of pedestrian railings; Repairs and/or resurfacing of access ramps, approach roadways and approach bridges, including the Bank Street and Third Street overpasses in Easton; Upgrading the access ramp to the pedestrian tunnel at Bushkill Street to make it ADA compliant; Removal and replacement of the former overpass that carried Route 22 across PA Route 611 in Easton; Extensive steel repairs and other rehabilitation measures at the Broad Street Viaduct approach structure in Phillipsburg; Repairs and painting at the bridge's toll plaza in Phillipsburg; Sign structure improvements; Replacement of roadway and bridge lighting throughout the project area; And electrical upgrades at the toll plaza and nearby administration building. As I've noted before, one significant outcome of the project is that the Commission no longer has any structurally deficient bridges in its system. The last two structurally deficient spans – the Broad Street Viaduct and the Route 611 overpass – have now been upgraded to good condition due to work performed during the course of this project.

In closing today, I want to call attention to the recent test installation of lane-divider markers on the open-steel grate floor of the Washington Crossing Toll-Supported Bridge, our narrowest vehicular structure. The reflective markers that were attached to the bridge are commonly seen on paved roadways. The mechanical device for attaching markers to our steel bridge decks was designed in-house by our Chief Engineer Roy Little to help motorists who previously expressed frustration over the faint painted dividing line separating the opposing traffic lanes on the bridge deck. The devices were fabricated and installed by our District 1 maintenance crews about two weeks ago. So far, the devices have stood up under normal traffic conditions and feedback from the travelling public has been good. We will continue to monitor their performance and durability in the weeks and months to come. If the devices continue to perform well, we will definitely want to consider installing them at other aging non-toll bridges with open-steel-grate floors.

Mr. Chairman, that concludes my remarks for today's meeting. I look forward to seeing you and other Commissioners at our rededication ceremony in Phillipsburg on Wednesday."

TOLL TRAFFIC AND REVENUE STATISTICS (March, 2015)

Summary: The Commission experienced an increase in total toll revenue for March 2015 in comparison to the March 2014 traffic and revenue statistics. In addition, total toll traffic also reflected an increase for the month of March.

Analysis of March 2015 / March 2014 toll revenue data comparison:

- An overall toll revenue increase of 3.07 percent was recorded at the Commission's seven toll bridges for the month.
- Commercial-vehicle toll revenue reflected a 4.43 percent increase.
- Passenger-vehicle toll revenue generated a 0.78 percent decrease.

Analysis of March 2015 / March 2014 traffic data comparison:

- Total toll traffic increased by 29,510 vehicles, or 0.99 percent for the month.
- Commercial-vehicle traffic increased by 23,787 vehicles, or 5.70 percent.
- Passenger-vehicle toll traffic increased by 5,723 vehicles, or 0.22 percent.
- Total recorded westbound traffic at the 11 vehicular toll supported bridges for March 2015 decreased by 17,163 vehicles, or 0.68 percent as compared to March 2014. Average daily westbound traffic at the 11 toll supported bridges for March 2015 was 81,276 vehicles as compared for 81,830 vehicles in March 2014.

Traffic analysis for 2015 YTD:

- Average daily toll traffic for the Commission's seven toll bridges for March 2015 was 96,779 vehicles as compared to 95,827 total vehicles in March 2014. Total YTD toll traffic at these bridges is reflecting a 3.14% increase for the first three months of 2015 as compared to the same three month period in 2014.
- Recorded westbound traffic on the 11 toll supported bridges is reflecting a 3.00% increase for the first three months of 2015 as compared to 2014.

DISTRICT REVIEW:

District 1

Total toll traffic at Trenton-Morrisville (TM) reflected a 2.17 percent increase for March 2015 when compared to March 2014 as the result of the increases of 13,057 cars and 1,202 trucks. At New Hope-Lambertville (NHL), the decrease of 3,883 cars and the increase of 169 trucks combined to generate a decrease in total toll traffic of 2.48 percent for March 2015 as compared to March 2014.

District II

The I-78 Toll Bridge recorded an increase of 0.35 percent in total toll traffic for the month of March 2015 compared to March 2014 as the result of the decrease of 8,647 cars and the increase of 11,681 trucks. At the Easton-Phillipsburg (EP) Toll Bridge, combined increases of 11,899 passenger vehicles and 1,063 trucks generated a 3.19 percent increase in total toll traffic for March 2015.

District III

Portland-Columbia (PC) experienced a 1.41 percent increase in total toll traffic during March 2015 as a result of increases of 546 automobiles and 743 trucks compared to March 2014. At the Delaware Water Gap (DWG) Toll Bridge, a decrease of 7,237 passenger vehicles combined with an increase of 8,509 trucks to generate an overall increase of 0.18 percent in total toll traffic for March 2015 as compared to March 2014. At Milford-Montague (MM), the decrease of 12 passenger vehicles combined with the increase of 420 trucks produced a 0.46 percent increase in total toll traffic for the month of March 2015.

E-ZPass Penetration Rates

STATISTICAL SUMMARY OF EXPENDITURES

This includes reports entitled “**Budget vs Actual**” covering the month of March 2015 and the three month year-to-date operations of fiscal year 2015 relative to Toll Bridges, Toll Supported Bridges and Administration departments.

Total expense plus encumbrance totaled \$5,027,142 for the month of March. For the 2015 fiscal year-to-date period, total expense plus encumbrances amounted to \$13,794,042 or 99.1% of the year-to-date operating budget.

Most of the expense line categories are within their normal line item budget except for Overtime Wages which exceed budget by \$119,272 or 102%; Operation Maintenance \$88,884 or 17%; and Regularly Employee Healthcare expense which is \$712,370 or 31%. This over budget situation for Overtime and Operation Maintenance is due to the high level of adverse weather activity for the first three months of 2015. It is anticipated that cost will come in line with the budget during the operating year. The Expense for Healthcare is due to a heavier than usual activity during the first three months of 2015.

There were no unusual items charged to expense in the month of March.

This report itemizes all orders for purchases made for the month of March 2015, showing the divisions chargeable for the expense and the source of authority for issuance of the purchase order. This authority is broken into three categories:

- (1) By authority of the Commission
- (2) By authority of the Executive Director or his designate
- (3) By authority of the Superintendent

The purchasing activities for the month culminated in the preparation and placement of 80 purchase orders in the total amount of \$455,236.04. To secure competitive prices on items being purchased, 54 price inquiries were sent out for 18 of the requisitions leading to purchase orders, an average of 3.00 per order ($54/18 = 3.00$).

Procurements of over \$5,000.00 during the period of March 2015 are shown below:

- 15 Purchase Orders were let, in the total amount of \$223,250.00 for guide rail & attenuator services at various Commission locations. Some of these costs were accrued and were paid using 2014 dollars.
- A Purchase Order was issued, in the total amount of \$64,984.00, for the outfitting of the Ford F-750 Chassis purchased for our Easton-Phillipsburg Facility.
- A Purchase Order was issued, in the total amount of \$31,682.90 for the purchase of a 2015 Ford Explorer XLT for our Trenton-Morrisville Facility.
- A Purchase Order was issued, in the total amount of \$16,371.27, for Commission laptop upgrades.
- A Purchase Order was issued, in the total amount of \$13,509.24, for desktop computer upgrades.

In addition to the practices employed incidental to purchase of materials, etc., from vendors on a direct basis, the Commission also purchases via direct utilization of the purchasing processes of the State of New Jersey, the Commonwealth of Pennsylvania and other joint purchasing arrangements.

Activities for the In-Lane Toll System

1. Xerox continues to perform preventative maintenance for the electronic toll collection system and violation enforcement system.
2. Commission staff is preparing a purchase order requisition that will be issued to Xerox for the 2015 Spare Parts/Consumables..
3. RK&K submitted the final request for proposals (RFP) for advertisement. The RFP was posted on the Commission's website and advertisements were posted Toll Road News and IBTTA's website. Additionally, an email with the advertisement was released to several vendors.

Activities for the E-ZPass Customer Service Center/Violation Processing Center

1. Xerox continues to provide services for the E-ZPass New Jersey Regional Customer Service Center/Violation Processing Center (CSC/VPC).
2. Commission Staff attended a bi-monthly NJ Regional CSC operations meeting at the New Jersey Turnpike Authority (NJTA). During a briefing by the NJTA regarding the on-going procurement for the new CSC, Commission Staff expressed concern regarding the RFP being silent on AET facilities. The NJTA explained that the RFP includes functionality for processing image based transactions and issuing statements. During a subsequent conference call with the NJTA, they agreed to issue a clarification to their response to inquiries that was part of Addendum No. 2. The clarification will note that some agencies will have AET facilities.

General Electronic Toll Collection Program Activities

1. Mr. Stracciolini participated in the IAG E-ZPass Executive Management Committee and Policy Committee meetings.
2. Mr. Stracciolini served on the Non-toll Opportunities subgroup for the IAG. B2GNOW: CONTRACT COMPLIANCE DEPARTMENT DATABASE SYSTEM

The Contract Compliance staff has participated in weekly conference calls with staff of B2GNOW in order to complete the program set up in their system. On several conference calls, the CCD staff has been joined by other commission staff including, Mr. Arnold Conoline, Mr. Sean Hill, Mr. Roy Little, Mr. David Burd, and Ms. Mary Jane Hansen. These conference calls have been crucial for participants to give their input to the CCD and B2GNOW as the team identifies the best way to implement the most effective program possible for the Commission. It is estimated that the program will be set up and running by the middle of May, 2015 where Tyler-MUNIS system will be able to electronically export the identified necessary data to B2GNOW so that it can be imported into its system and uploaded to the Contract Compliance program module. The Value of the import is highly dependent on the quality of the data in the source system. It is also vital that the fields chosen to populate will serve to extract valuable and correct output to track the records of the contracts and activities between the primes and the IBEs.

CONSULTANT:

The QWIC, Inc. invoice was amended and sent to Rich Rash, PM consultant from AECOM to comments and/or send for payment. The QWIC, Inc. consultant was directed to stay on stand-by until further assignment may be issue to her as the CCD continues to make progress with the implementation of the B2GNOW program.

CONTRACT AWARDS:

No new engineering contract that requires IBE participation has been awarded since the last CCD report. The Contract Compliance Department will manage the Primes and IBEs participation for the commission for the existing projects.

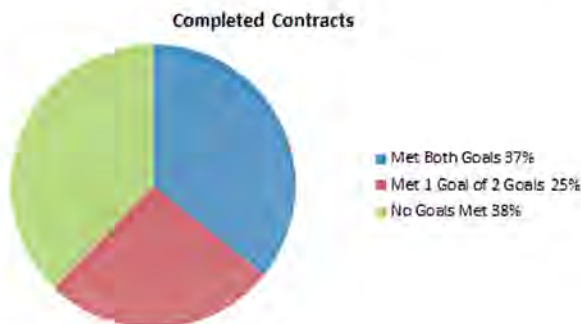

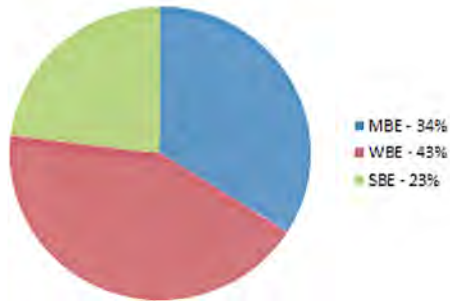
Contract Goals

It subsequently was decided that the current FTP-type website was so outdated as to be unredeemable. The determination was discussed with the Executive Director, Chief Engineer, and project team. ACT Engineers recommended use of a new CMS system – Drupal 7 – to ensure easier updating and a better viewing/access experience for the public. A meeting has been scheduled for early April to discuss implementation.

Scudder Falls Bridge Replacement Project Aerial Mapping – Working with Chief Engineer, project team and Michael Baker engineering firm representatives, drafted and distributed a press release announcing how aerial photography work was kicking off the final design process for the Scudder Falls Replacement Project. The news release generated multiple web and local weekly newspaper items, reaffirming the fact that the Commission is actively moving forward with the project. Outlets picking up the story included: Bucks County Herald, Hopewell Valley News/Princeton Packet/Lambertville Beacon, and CentralJersey.com. The release and articles also garnered some traffic on Twitter and Facebook.

SPACE PROGRAM AND CONCEPT STUDY

Task Order Assignment No. C-598B-3

This Task Order Assignment is for a Space Program and Concept Study for the Trenton Morrisville Toll Bridge Administration Building. The purpose of this assignment is to provide the Commission with guidance in enhancing operational efficiency and facility space utilization. The Space Program will include a detailed analysis of the current versus required space to support the Commission's current as well as the projected operational, administrative and maintenance needs at the T-M facility. Three (3) proposed alternatives will be identified by the Consultant for review and consideration by the Commission

A kick-off meeting was held with Gannet Fleming on February 25, 2014. The Consultant collected as-built drawings, and reviewed building systems deficiencies and improvement recommendations as presented under various recently completed concept studies. An executive staff work session was held on March 14, 2014. A Draft Space Program report was received on April 4, 2014 and a meeting was held with the Consultant on May 1 to share the Commission's comments.

A revised Space Utilization Program report was received on June 30, 2014 and a meeting was held with the Consultant on July 8, 2014. Subsequent to this meeting, the Commission asked Gannet Fleming to explore an additional fourth option to this Project for enhanced maintenance capabilities at the Trenton-Morrisville site that could serve District I wide Maintenance and Operations' needs. A Preliminary Draft Submission was received from the Consultant on November 13th and a submission review meeting was held with the Commission executive staff on November 17, 2014. Commission comments were shared with the Consultant to incorporate and advance this fourth option into a Draft Submission.

Draft Concept Study Report was received on March 20th and an Executive Staff work session meeting was held with the Consultant on March 30, 2015. Consultants Draft Report was presented to the Commission and comments were shared with the Consultant to incorporate into the Final Report.

Cherry, Weber and Associates, P.C. (CWA) was issued Notice of Award and Limited Notice to Proceed effective February 25, 2014. This contract is for the Scope Development, Preliminary and Final Design and Post-Design Services for work at both the Trenton-Morrisville Toll Bridge Approach Roadways and the Lower Trenton Toll-Supported Bridge Approach Roadways. The Capital Program Management Consultant (CPMC) services are being continued under this Task Order Assignment, which began in March 2015. AECOM is providing one (1) full-time Project Manager and one (1) part-time Program Area Manager to oversee and manage various design and construction projects that are being advanced in the Capital Improvement Program. Additional efforts under this TOA include establishing the PennDOT Inter-Governmental Agreement and NJDOT Memorandum of Agreement (MOA) for project interface and interaction with the respective DOT's during the Final Design and Construction Phases of the project; the MOA with NJDEP-Green Acres/NJDOT/Delaware & Raritan Canal Commission/NJ Water Supply Authority for the NJ Pedestrian/Bicycle Facility; and, coordination and support of Commission staff in advancing the project into final design and construction via the RFP design procurement process. DMC Services will now be continued under Task Order Assignment No. C-502A-2G, which was authorized January 16, 2015 and will cover DMC Services through final design and award of the Scudder Falls Bridge construction contracts. Upon receipt and processing of the final invoice this Task Order Assignment will be closed out.

DMC SERVICES FOR MANAGEMENT AND OVERSIGHT OF FINAL DESIGN

Task Order Assignment No. C-502A-2G

AECOM's Design Management Consultant (DMC) Services are being continued from Task Order Assignment C-502A-2F DMC Services 2013-2014, under this Task Order Assignment that was authorized on January 16, 2015. The DMC services being provided under this Task Order Assignment include management and oversight of final design for the project through award of the Scudder Falls Bridge construction contracts. The DMC Services also include support to the Commission with the following: agency coordination, ROW acquisition plan development and coordination, environmental permitting, public involvement support, and coordination of necessary agreements with outside agencies. This DMC Task Order Assignment will cover DMC services through final design and award of the main Scudder Falls Bridge Project construction contract.

Environmental permitting agency coordination continues as well as preparation of the USACE and PADEP permit application packages, including all back-up documentation. Coordination was also ongoing with NJDEP – Green Acres regarding the “No-Net Loss” tree survey and assessment and the back-up documentation required for the final application package. The Jurisdictional Determination (JD) Plans were completed and submitted to the USACE on February 23, 2015 for review and preliminary approval. Also in February, the Commission received the ACT 167 approval letter from Lower Makefield Township for the PA stormwater design. A meeting was also held with Evergreen Environmental on February 24th to review the requirements for receiving wetlands credits from the Nishisakawick Creek Wetlands Bank in NJ, and to discuss options available for the Riparian Zone Mitigation. As a result of these discussions, Draft agreements were submitted for the wetlands mitigation bank and for the riparian zone mitigation services they can provide to the Commission, which are currently being reviewed by staff. Commission approval to move forward with these draft agreements is anticipated at the April Commission Meeting.

The ROW acquisition process continued during the month of March, including coordination between Commission staff and Commission's NJ and PA Legal Counsel. A letter was sent to Mr. James Morris in February notifying him of the Commission's desire to purchase his property for the project; and that an appraisal of his property will be prepared by the Commission. PA Legal Counsel has initiated the necessary appraisals for the various property acquisitions in Pennsylvania. The NJ Legal Counsel has requested proposals from appraisal firms for the NJ property acquisition. The appraisal process in NJ will be initiated once the Commission has received and reviewed the recommended appraisal firms. At the March 2015 Commission Meeting the Commissioners provided authorization, in the form of a Resolution, for the Right-of-Way Acquisition process.

DMC and Commission Staff also reviewed and provided comments on the Draft Geotechnical Boring Contract plans and specifications prepared by Baker under the C-660A contract. Review meetings were held with Baker on March 9, 2015 and again on March 23, 2015 to coordinate and facilitate comments for the boring contract for an early April letting.

SCUDDER FALLS BRIDGE INTERIM DECK REPAIRS

Task Order Assignment No. C-628A-2

Under this Task Order Assignment the Consultant, Dewberry Engineers Inc., is preparing plans for a contract to do deck repairs on the Scudder Falls Bridge. The existing deck is deteriorating and needs to be repaired to provide a satisfactory riding surface until the Scudder Falls Replacement bridge is constructed. The purpose of this task order is to prepare plans for a deck patching contract; and, then have the Contractor retained on an on-call basis for the following two (2) years to repair new potholes as they develop. The Commission will also have an additional one (1) year option with the Contractor for the deck repairs. Dewberry Engineers was issued a Notice to Proceed effective September 2, 2014. Dewberry submitted the pre-final plans on February 18, 2015. Final plans and specification were submitted on March 26, 2015. Due to the Peregrine Falcon nesting on the existing Scudder Falls bridge, the Pennsylvania Game Commission was notified of the intent of the contract, and has issued a letter allowing the project, but restricting work during the nesting season (January 15 to July 31). As a result, the construction start will be delayed until August 1, 2015.

I-78 TOLL BRIDGE MAINTENANCE GARAGE

SPACE PROGRAM AND CONCEPT STUDY

Task Order Assignment No. C-627A-2

This Task Order Assignment is for a Space Program and Concept Study for the I-78 Toll Bridge Maintenance Garage. The purpose of this assignment is to provide the Commission with guidance in enhancing operational efficiency and facility space utilization. The Space Program will include a detailed analysis of the current versus required space to support the Commission's current as well as the projected operational, and maintenance needs at the facility.

At the conclusion of the Space Program, a Concept Study Report will be prepared to include three (3) proposed alternatives for review and consideration by the Commission in selecting the preferred alternative to be advanced to Final Design under a separate procurement process. As part of each alternative, the mechanical, electrical, plumbing, and life and safety improvements will be presented. Also, Building Management Systems will be part of each design concept which will reduce building systems' energy use and benefit the Commission in a long-term energy cost saving.

Bid Documents for the re-routing of approximately 1,150 linear feet of conduit for the electrical system powering the lighting on both spans of the Delaware River bridge were publically advertised on March 31, 2015.

EASTON-PHILLIPSBURG TOLL BRIDGE REHABILITATION, PRELIMINARY, FINAL & POST DESIGN SERVICES

DESIGN Contract No. C-437B

This project was awarded to Parsons Brinckerhoff (PB) at the February 28, 2012 Commission meeting. PB provided the Commission their final design submission on February 22, 2013. Construction bids were received on April 11, 2013. PB continues to provide post-design services and attending project progress meetings as necessary.

The below-listed items represent meetings, communications, tasks, and projects involving the Electronic Security and Surveillance Department:

Radio System

- During the month of March 2015, ESS personnel continued working with Motorola to partially upgrade the Commission's radio system to 700 MHz/P25. The first shipment of new P25 radios is being installed in District III vehicles. Work at the Easton tower site is scheduled to begin this month as long as the weather is suitable.
- ESS personnel arranged for various radio installations and repairs during the month of March 2015.
- ESS personnel alone, and in conjunction with the New Jersey State Police investigated various other DRJTBC radio issues both during and after normal working hours.
- ESS personnel continue to work with the Districts and IT to update the Cartegraph radio inventory database.

Access Control System

- On March 3, 2015, the ESS Department conducted a training session on the Commission's access control system.
- During the month of March 2015, ESS personnel continued to work with Schneider Electric on various access control issues. New card reader installations have been completed for the HR door and the former Print Shop area at Trenton-Morrisville.
- During the month of March 2015, ESS personnel worked with General Supply (Commission's lock smith) to address various lock issues. New, more durable locks are being tested at the New Hope-Lambertville and Lower Trenton Toll Supported Bridges. Additionally, ESS is exploring a new electric lock that can be utilized to secure various rooms and facilities on a temporary or permanent basis.

- In March 2015, ESS personnel created ID badges for new employees and consultants. Additionally, ESS continued making “Essential Employee” ID badges for current employees.
- During the month of March 2015, ESS personnel also issued various Toll System Swipe Cards to Toll Collectors to enable them to collect tolls.
- During the month of March 2015, the ACS database was audited and the system was purged of invalid employee and contractor cards. Various other employee ACS rights were updated and/or changed at the request of supervisors.
- Various door alarms and ACS issues were addressed both during and after normal working hours.

ESS

- On March 19, 2015, ESS personnel attended the Scudder Falls staff introductory meeting to talk about ESS equipment for the new bridge and protocols during construction.
- On March 27, 2015, ESS personnel met with representatives from Schneider Electric to review the maintenance project and various other repairs/construction projects being scheduled.
- During the month of March 2015, ESS personnel worked with Schneider Electric to identify viable analytics for the Commission’s current cameras and future cameras.
- During the month of March 2015, ESS personnel worked with AECOM on the Commission’s bandwidth study.
- During the month of March 2015, ESS personnel continued the weekly conference call with Verizon in an attempt clear up various billing issues the Commission is experiencing with the ESS network.
- ESS personnel reviewed and purged the ESS video storage database that contains copies of videos requested by DRJTBC personnel and outside agencies.
- ESS personnel worked during, and after normal working hours on numerous ESS issues and problems raised by Commission members.
