












Days Absent

Other Information:

Our School District is in its second year of implementing a 1:1 Chromebook program. The students in grades 3-6 take their Chromebooks to and from school each day. The students in K through 2 leave their Chromebooks at school. The program is going well and the staff provide the students with the guidance of appropriate use of technology. The staff has recently written new science curriculum to meet the needs of the NGSS and are implementing them in the 2017-2018 school year. The staff implements Daily 5, CAFE and Guided Reading into each of their reading lessons. We use the GO Math program and Think Central to deliver valuable Math instruction. We also use the Lucy Calkins writing program in each grade level. Our Reading and Math specialists co-teach in each classroom to help meet the needs of the students and to work in small groups to target specific learning needs. Our school district will be implementing a pilot MAP and Classwork program in the 2017-2018 school year. Each student receives instruction in Music, Art, Spanish, Physical Education, and Technology. We are very proud of these programs and they all help to ensure a well-rounded education for all students. Each year, the parents are provided with a student and parental handbook that outlines many of the policies and procedures of the school to ensure safety for all staff and students. Communication between home and school is important to us and we have upgraded our school website to meet those needs. Each classroom teacher hosts individual e-boards to assist with classroom communication. The atmosphere and environment at Atlantic Avenue School in one in which learning is a challenging, fun, and rewarding experience for our students. Further, the environment of concern and commitment generated by the entire school community makes Atlantic Avenue School a premier place to learn and grow academically and socially.















Days Absent

























(completed only one course in an approved CTE program)
















Days Absent












Days Absent



Other Information:

Our School District is in its second year of implementing a 1:1 Chromebook program. The students in grades 3-6 take their Chromebooks to and from school each day. The students in K through 2 leave their Chromebooks at school. The program is going well and the staff provide the students with the guidance of appropriate use of technology. The staff has recently written new science curriculum to meet the needs of the NGSS and are implementing them in the 2017-2018 school year. The staff implements Daily 5, CAFÉ, and Guided Reading into each of their reading lessons. We use the GO Math program and Think Central to deliver valuable Math instruction. We also use the Lucy Calkins writing program in each grade level. Our Reading and Math specialists co-teach in each classroom to help meet the needs of the students and to work in small groups to target specific learning needs. Our school district will be implementing a pilot MAP and Classwork program in the 2017-2018 school year. Each student receives instruction in Music, Art, Spanish, Physical Education, and Technology. We are very proud of these programs and they all help to ensure a well-rounded education for all students. Each year, the parents are provided with a student and parental handbook that outlines many of the policies and procedures of the school to ensure safety for all staff and students. Communication between home and school is important to us and we have upgraded our school website to meet those needs. Each classroom teacher hosts individual e-boards to assist with classroom communication. The atmosphere and environment at Seventh Avenue School is one in which learning is a challenging, fun, and rewarding experience for our students. Further, the environment of concern and commitment generated by the entire school community makes Seventh Avenue School a premier place to learn and grow academically and socially.
