Statement from Governor Murphy on Senate Confirmations of New Jersey Supreme Court Associate Justices Rachel Wainer Apter and Douglas Fasciale

"I am incredibly pleased that the state Senate has confirmed both Rachel Wainer Apter and Douglas Fasciale with bipartisan support to serve as Associate Justices of the New Jersey Supreme Court. I congratulate them both and have complete confidence that they will serve our state and the cause of justice with distinction.
