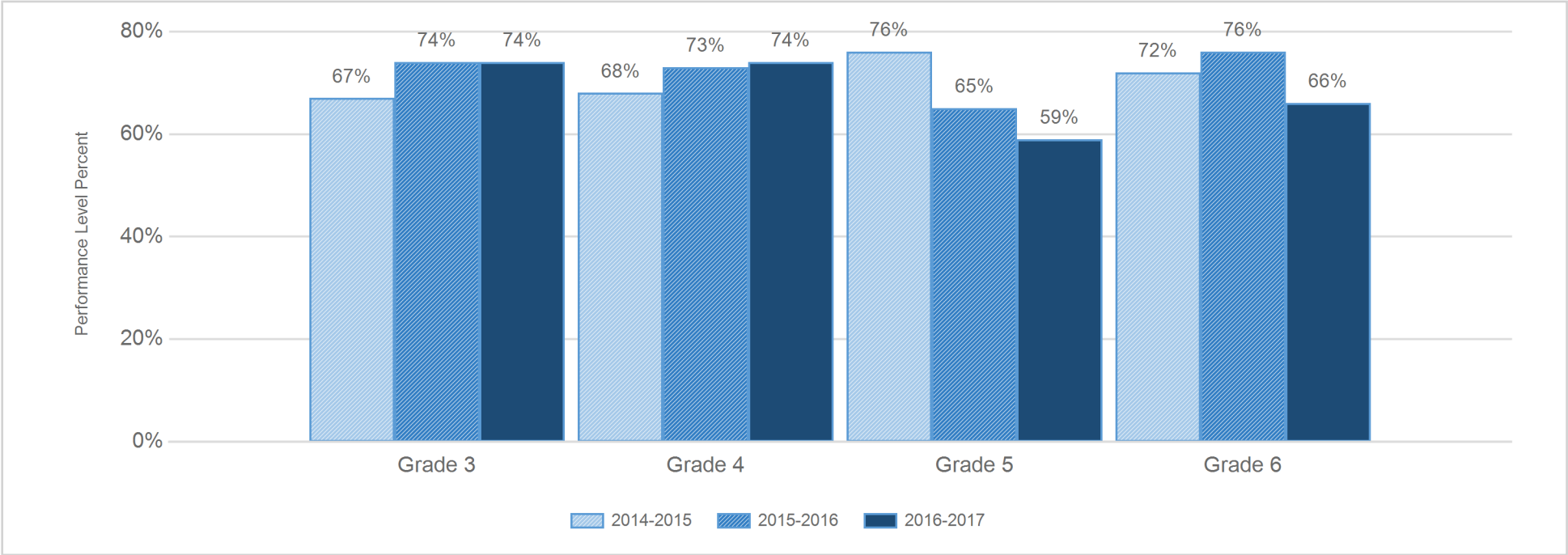

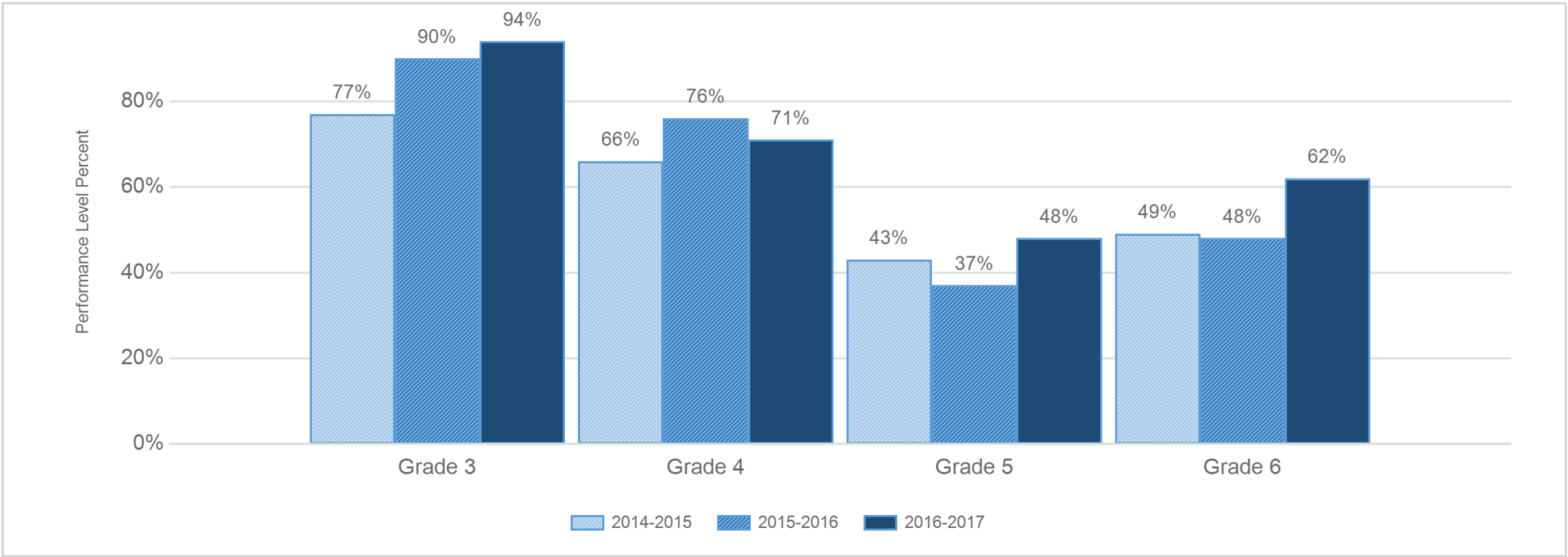

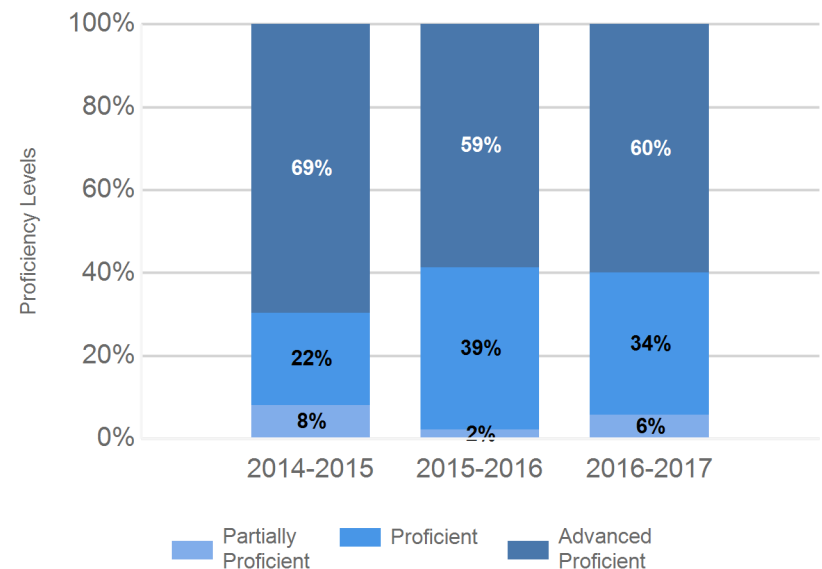

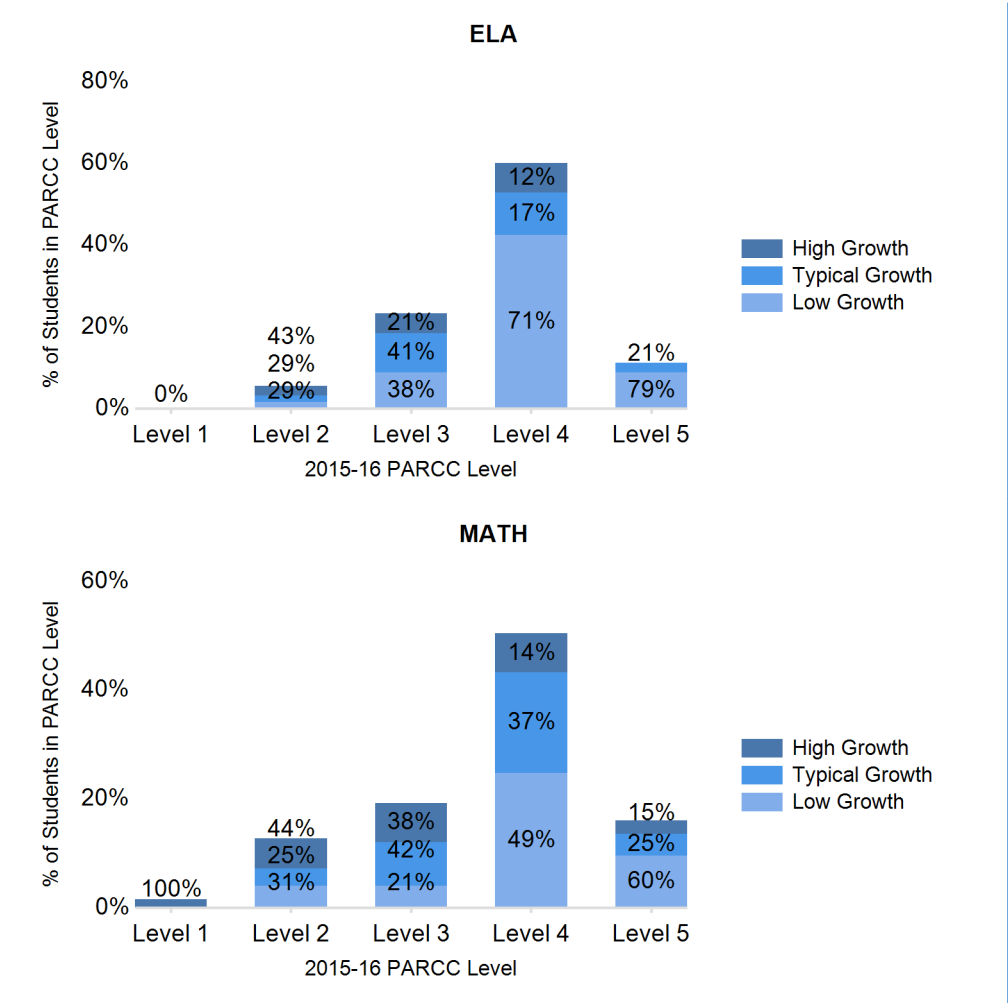

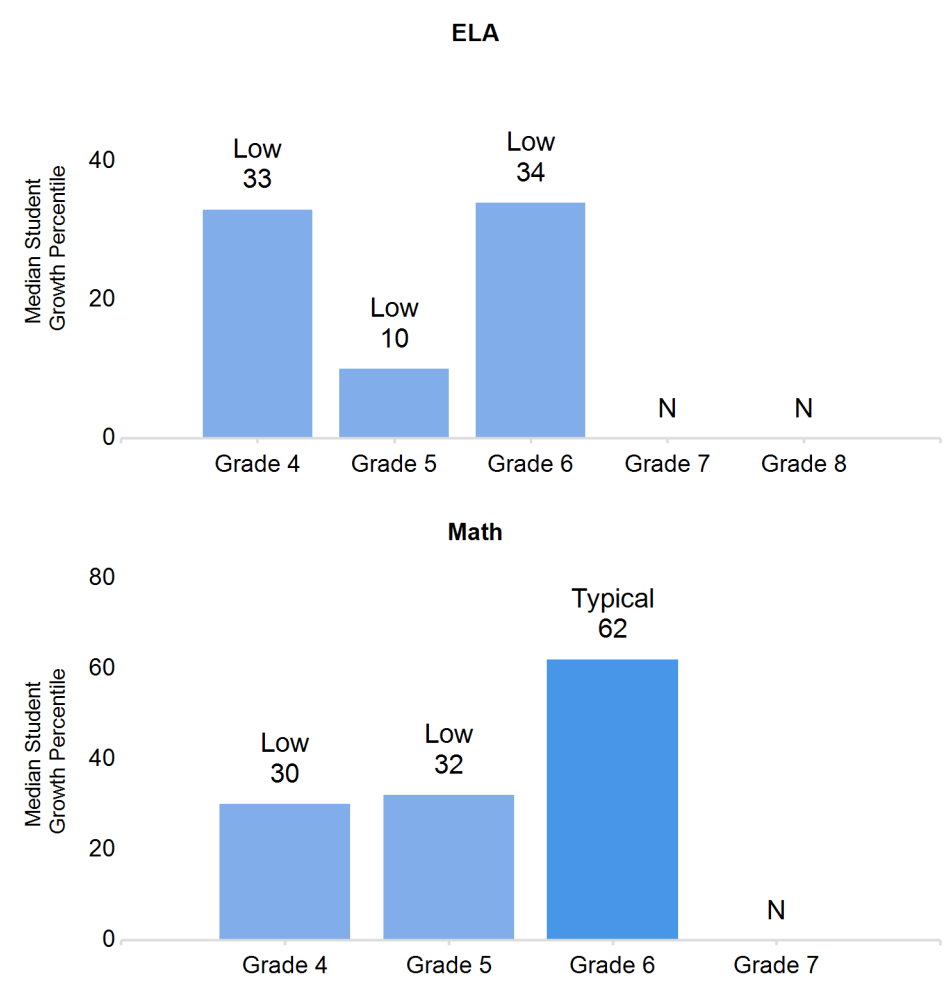
Student Growth by Performance Level

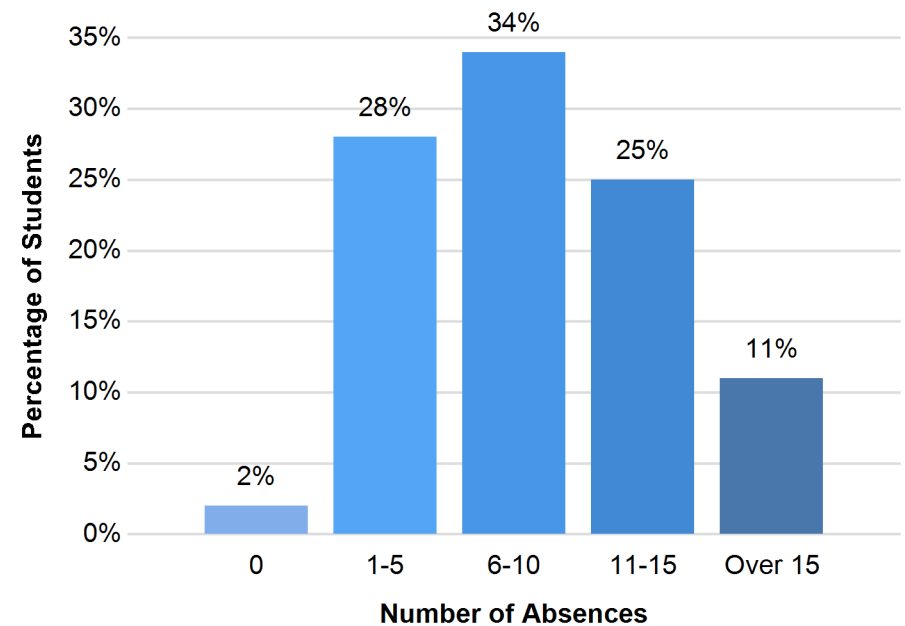

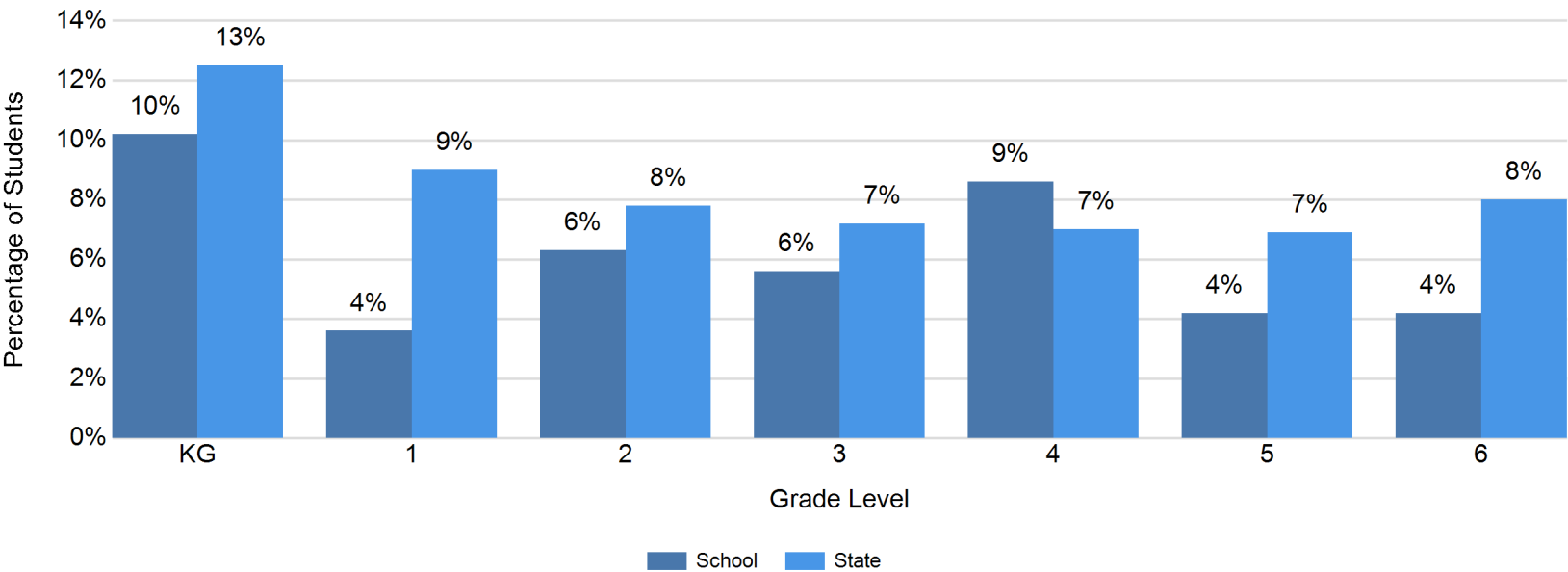
Days Absent
