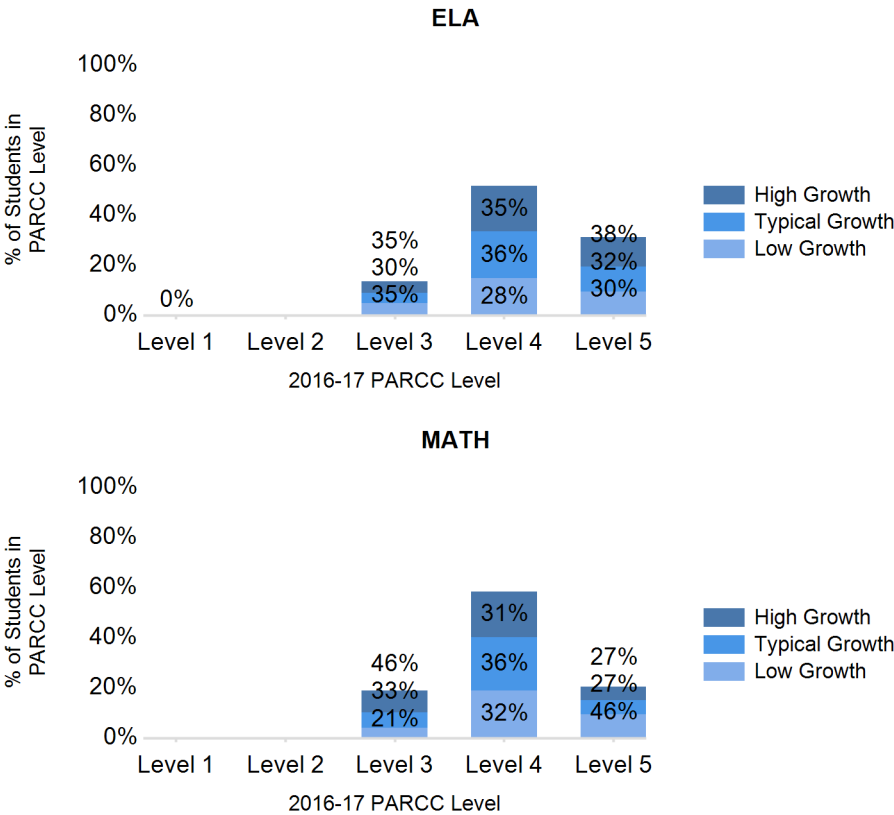

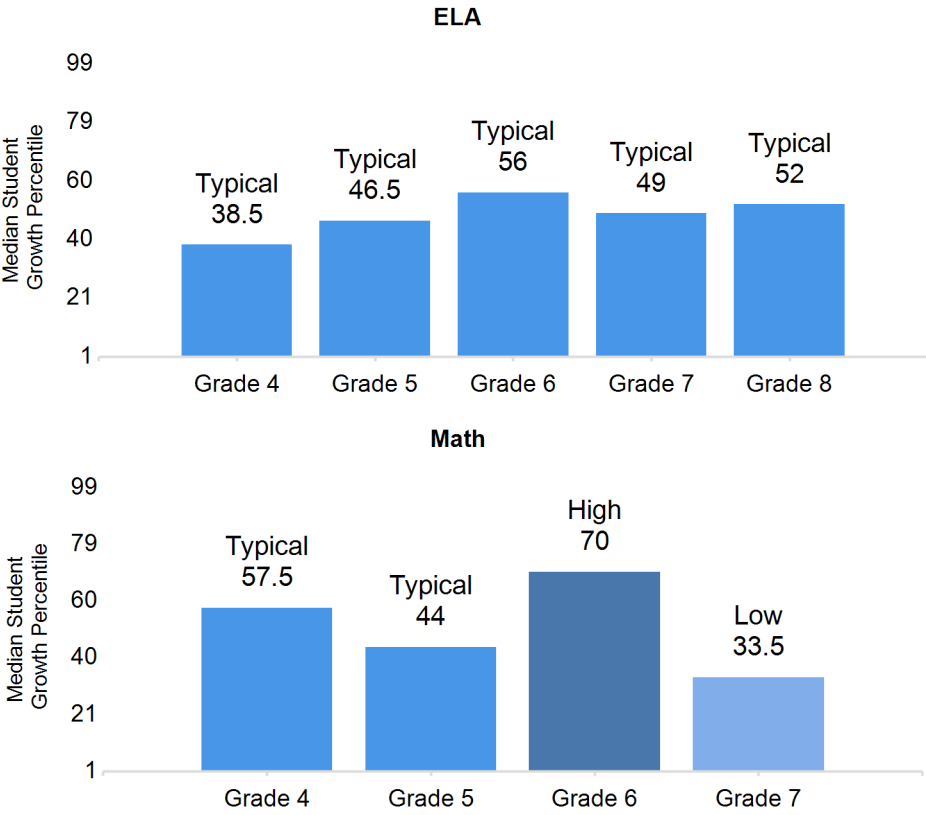
Student Growth by Performance Level

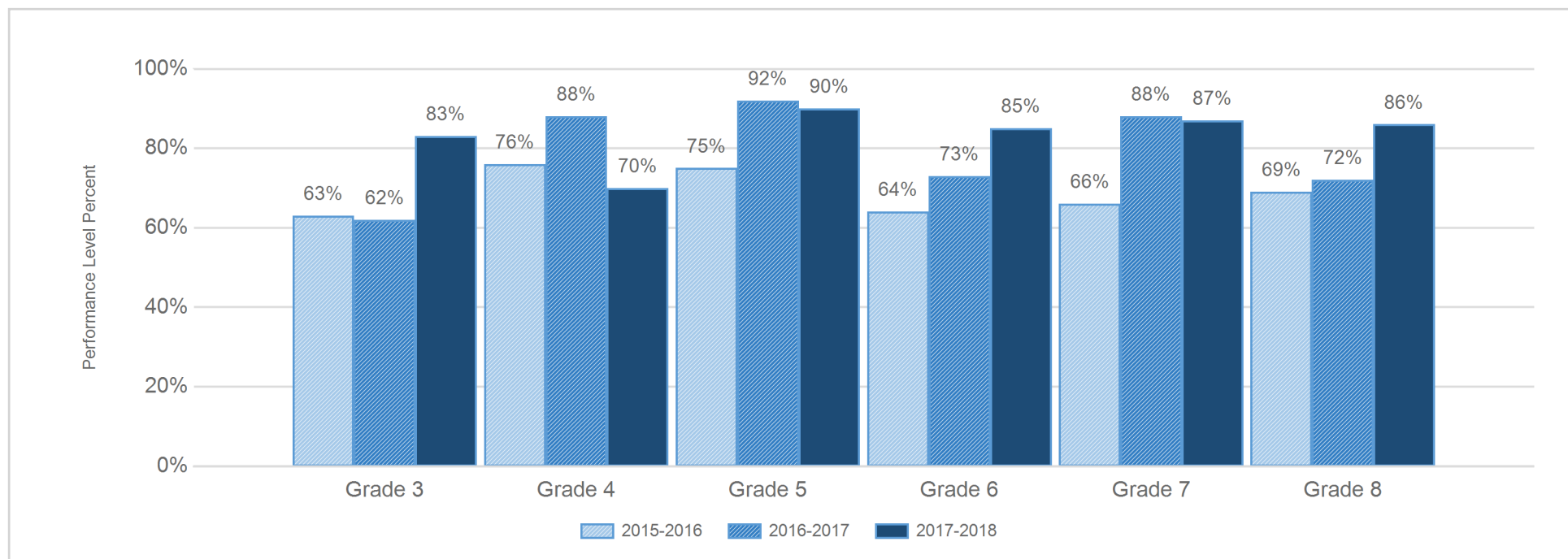

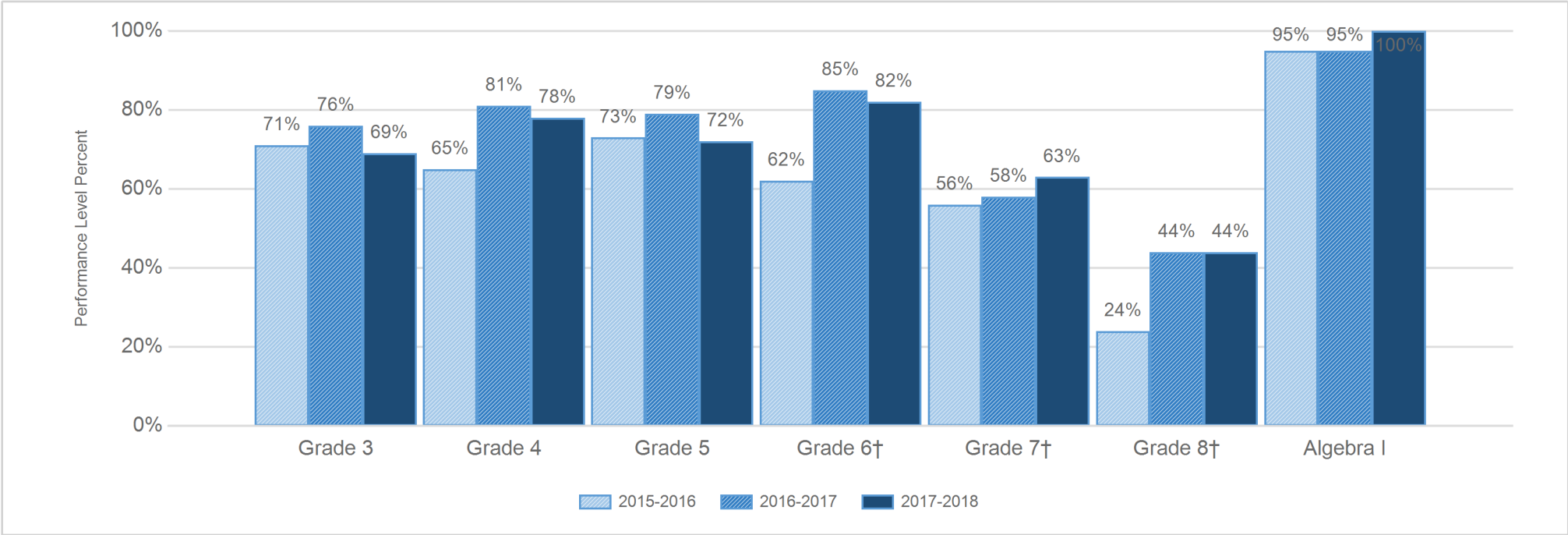

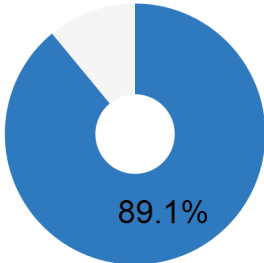

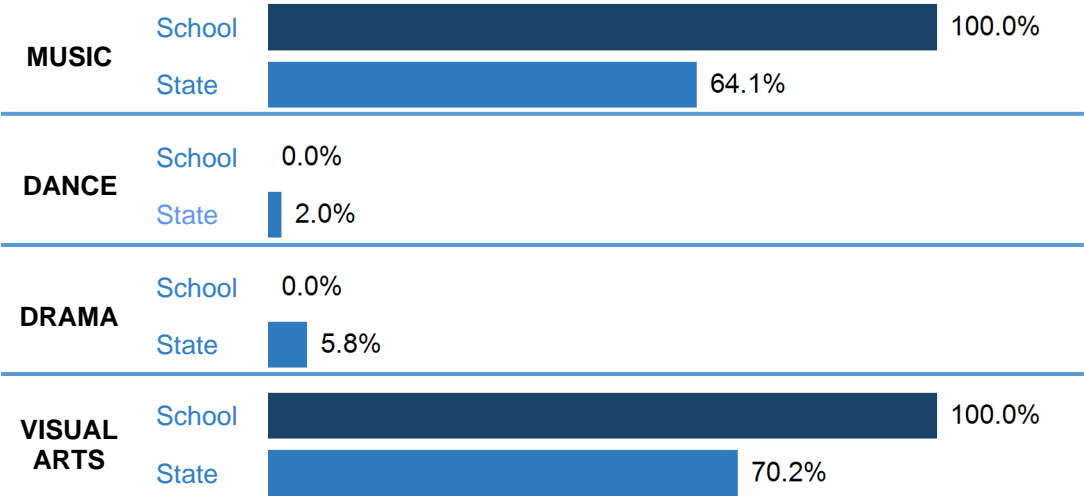

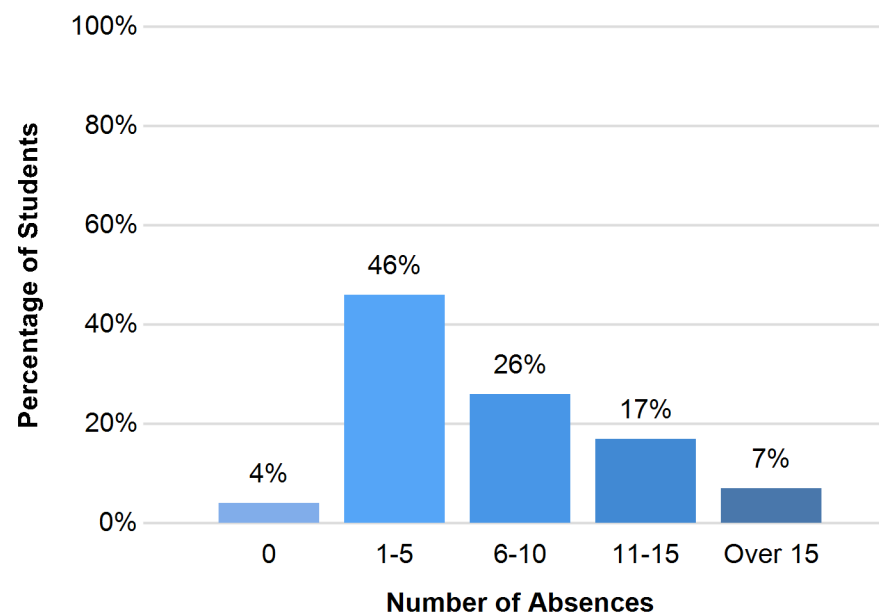

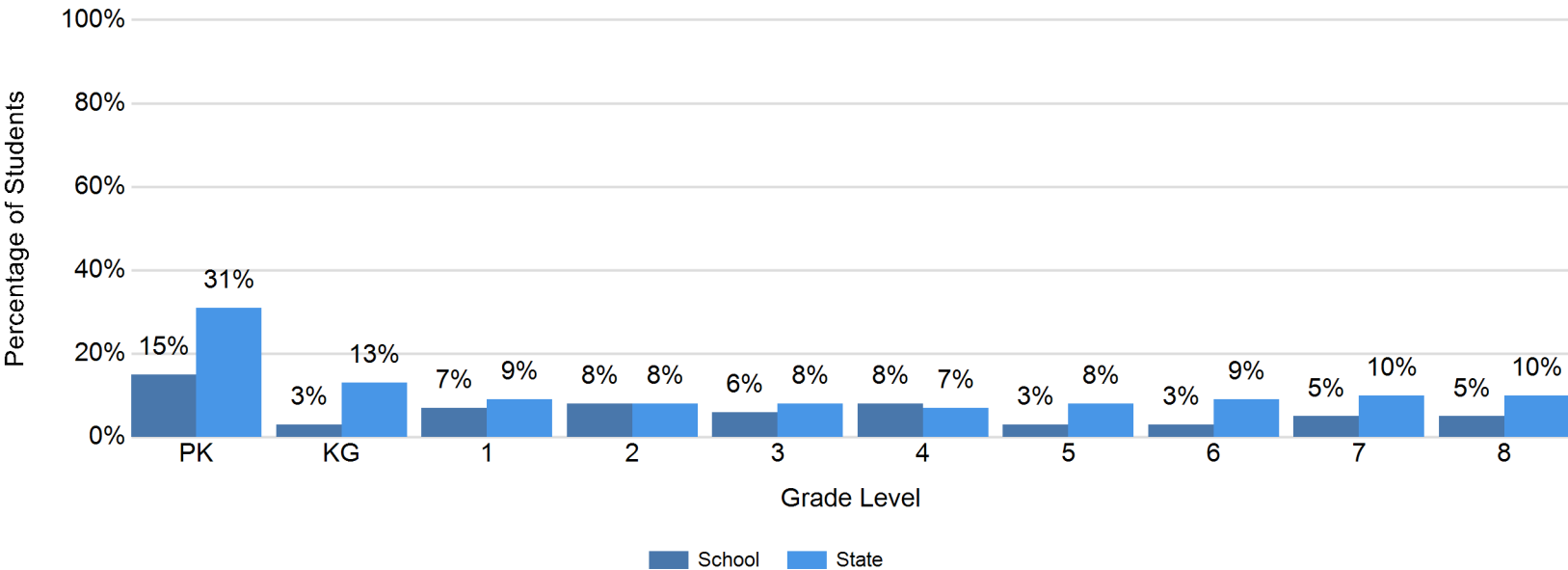

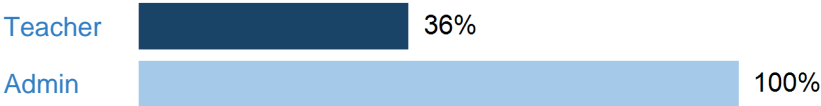

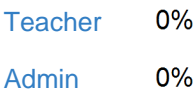

To address special needs, we provide an integrated pre-school and a life skills class for older students. We have several para-professionals on staff to provide in-class support and pull-out with special education teachers. English Language Learners are assessed using the WIDA assessment. Based on the assessment results ELL students receive instruction based on their needs. The Intervention and Referral Services committee, in conjunction with the students' parents, recommend necessary accommodations that will help the student be successful in school.
