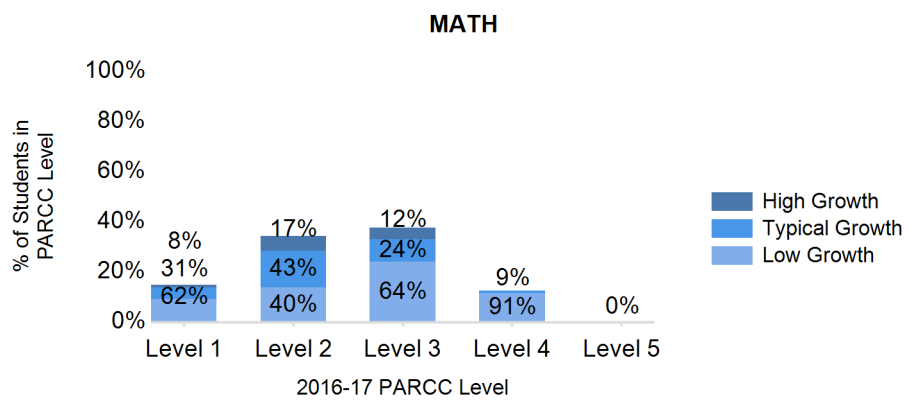
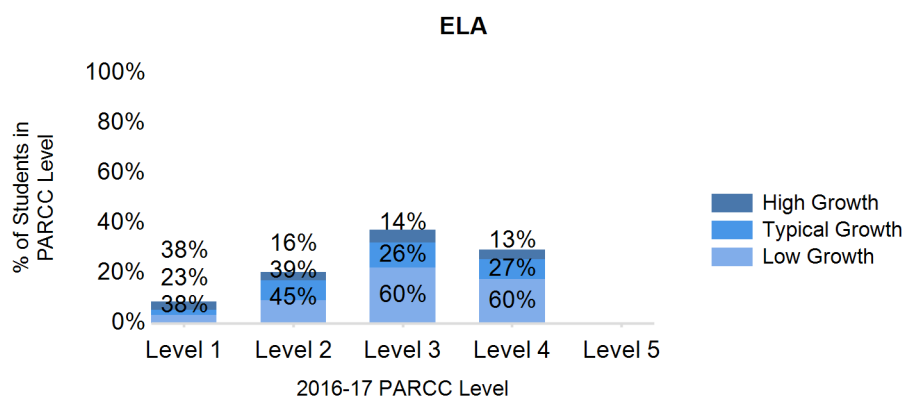

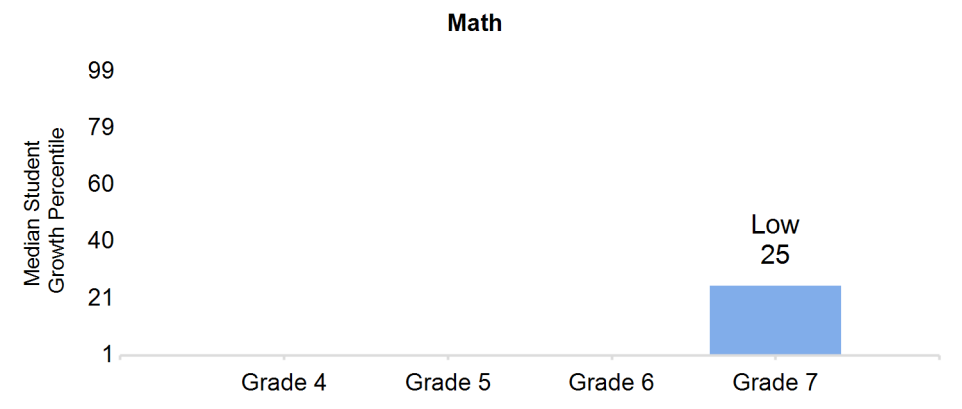
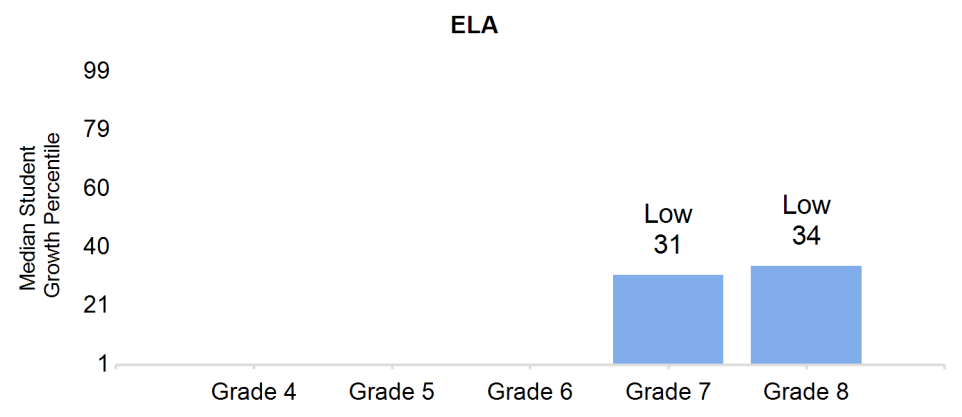
Student Growth by Performance Level

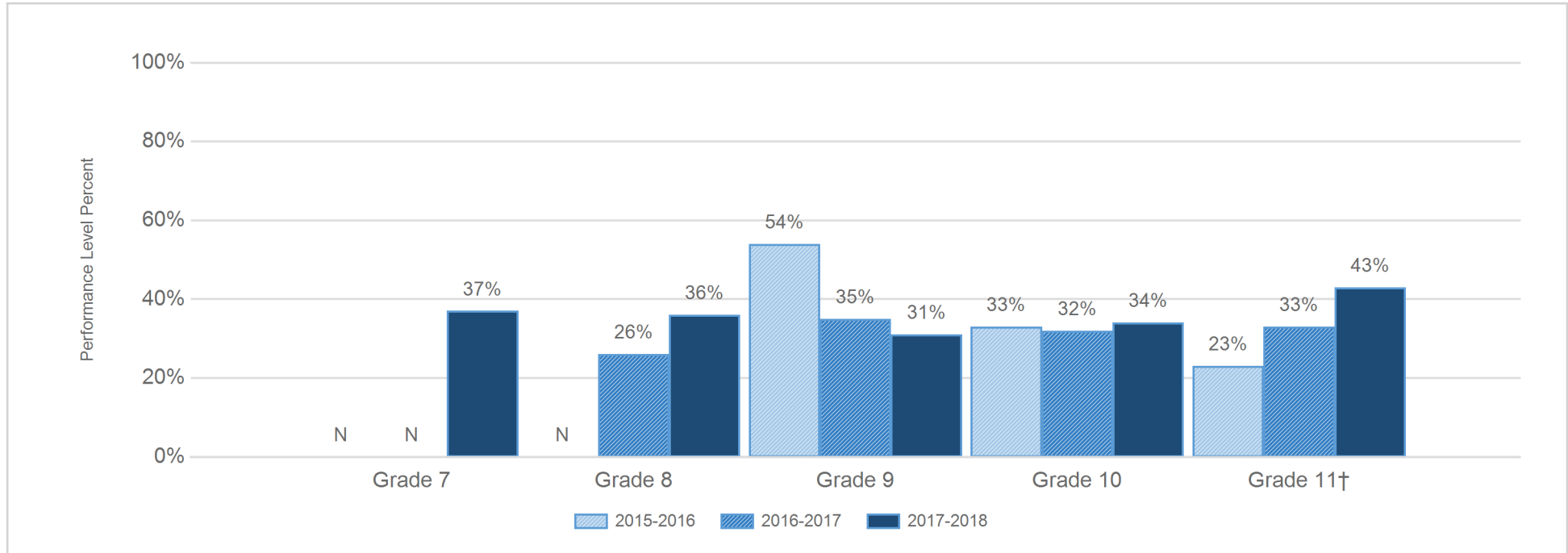

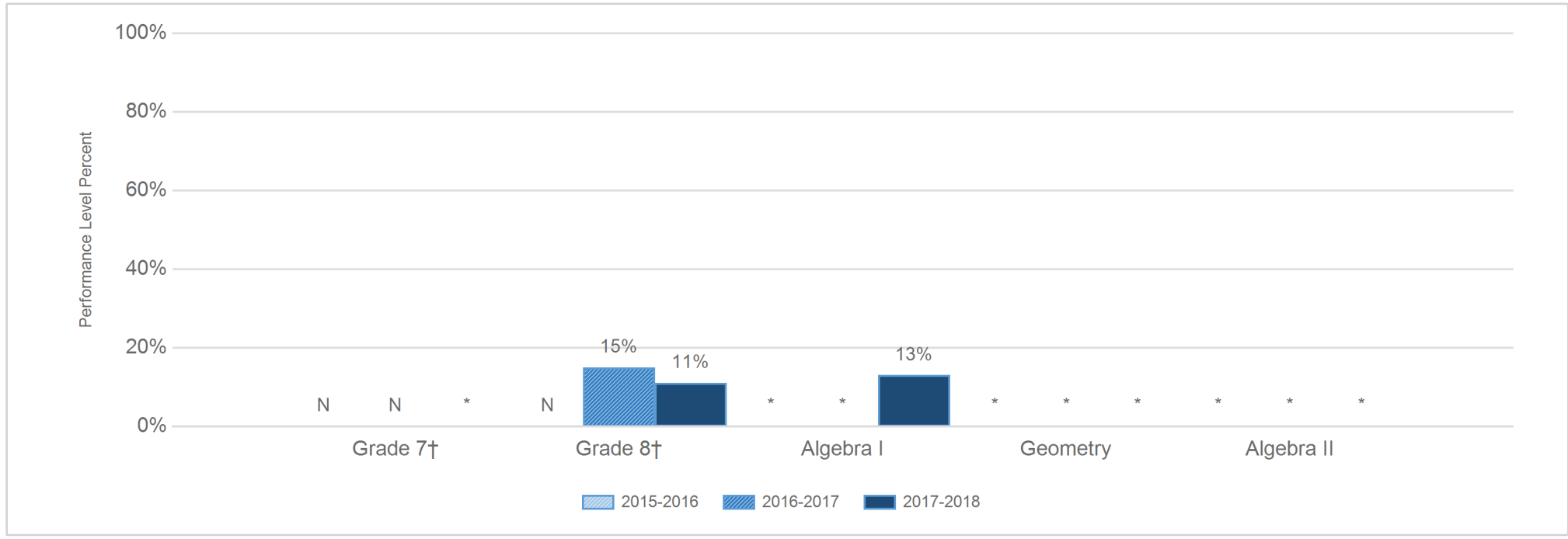

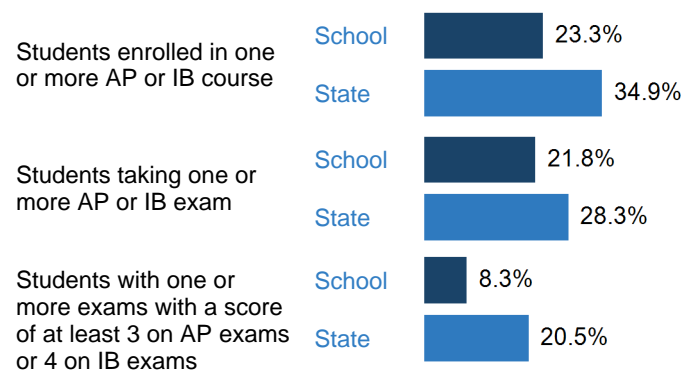

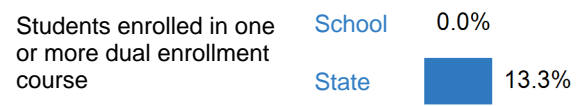

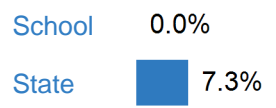

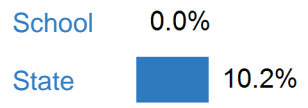
CTE Participants

CTE Concentrators

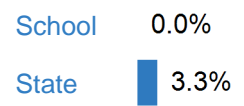

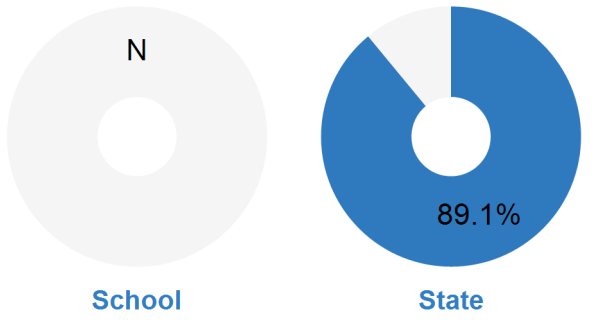

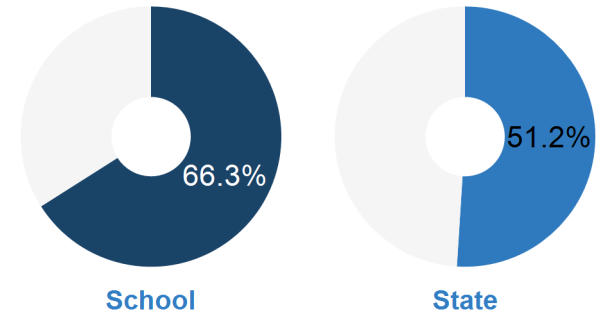

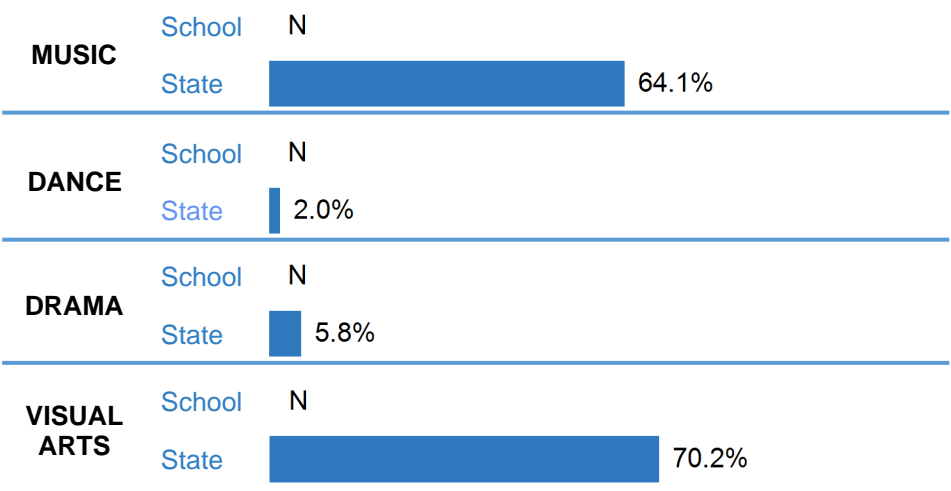

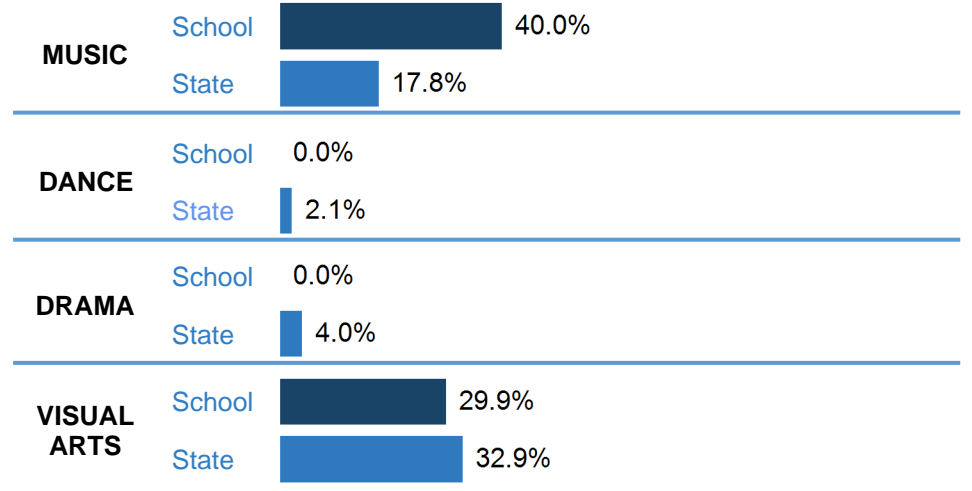

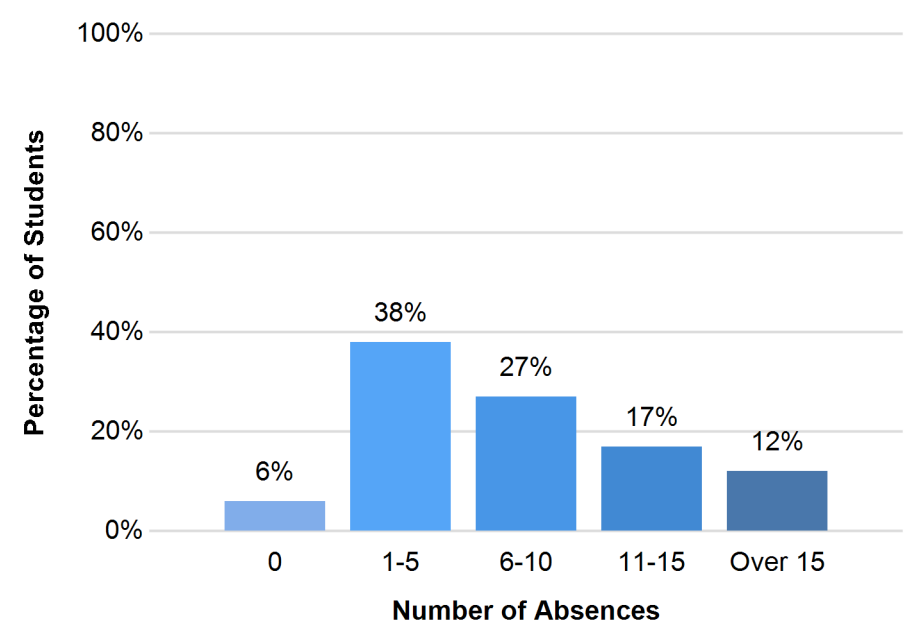

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





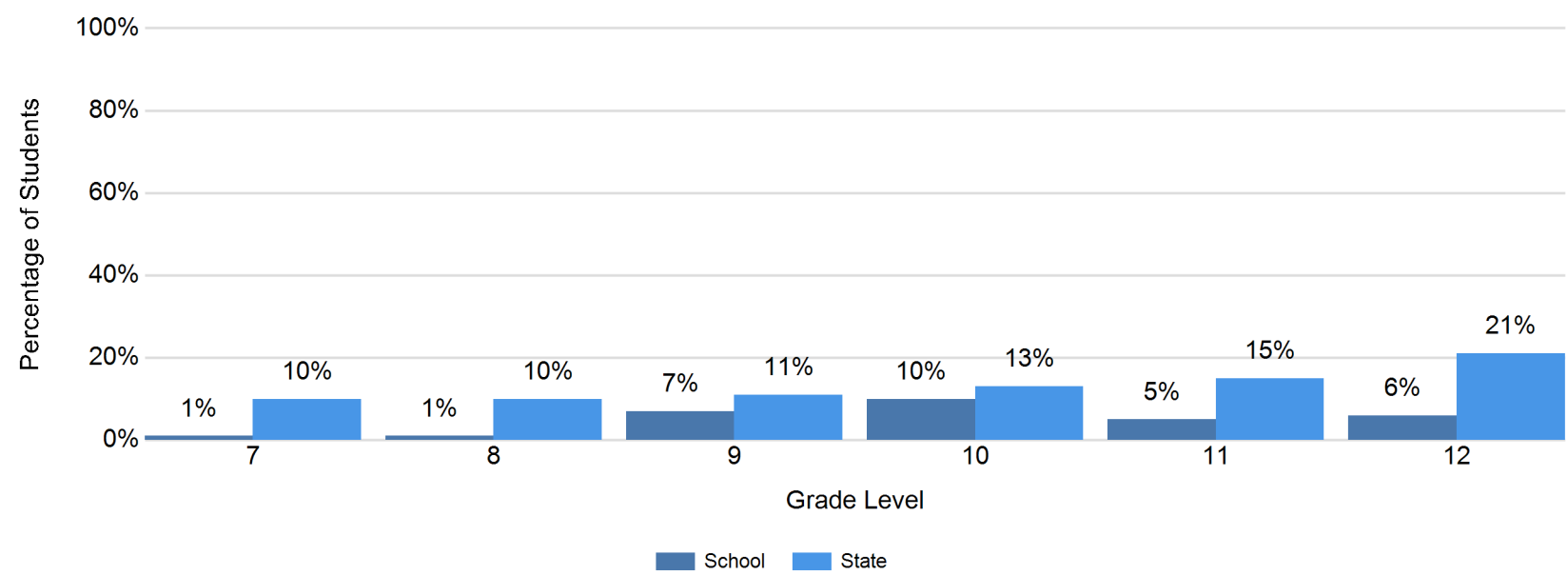

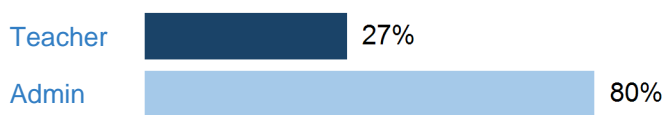

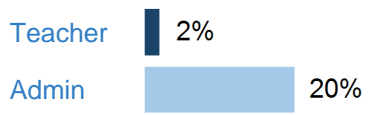
