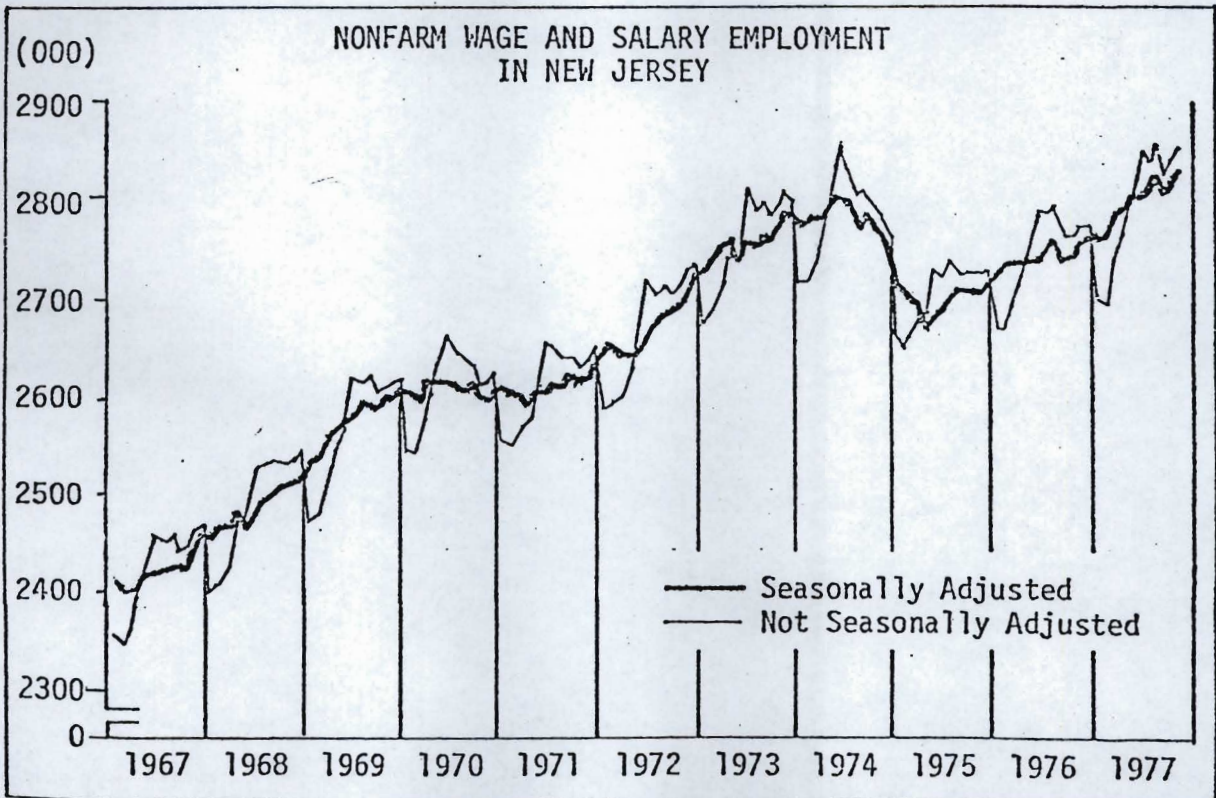

During November, seasonally adjusted nonfarm wage and salary employment rose by 8,400 to 2,829,700, the highest level on record and 155,800 over the low point of the recession reached in May 1975. Private wage and salary employment rose by 10,400 to 2,355,300, the highest since July 1975.

The November total on an unadjusted basis increased by 10,000 from October to 2,851,200, spurred by seasonal increases in wholesale and retail trade.

Nonmanufacturing employment, before seasonal adjustment, accounted for all of the 10,000 over-the-month increase. All major sectors, except services, registered increases with the most notable being an increase of 6,800 by wholesalers and retailers preparing for preholiday shopping. A smaller than seasonal increase of 4,400 in the government sector occurred because of a strike of about 850 teachers and 450 welfare workers. Transportation and public utilities had a modest increase of 2,100 while construction had a small contraseasonal increase of 200 spurred by strength in the residential building sector.

MANUFACTURING EMPLOYMENT UNCHANGED BEFORE SEASONAL ADJUSTMENT

Manufacturing held steady over the month as an increase of 1,100 in the durable goods sector was offset by a decline of 1,100 in the nondurable goods sector. The largest changes in the durable goods sector was an increase of 1,000 in the nonelectrical machinery industry and a seasonal drop of 700 in the miscellaneous manufacturing industries. Major changes in nondurables were in chemicals and allied products, which dropped by 800, and the textile mill products industry, down 500 over the month.

Compared with November 1976, unadjusted nonfarm wage and salary employment rose by 77,100 or 2.8%. Private sector wage and salary jobs increased by 70,800 over the year, which represented about 92% of the November 1976 to November 1977 growth.

Manufacturing climbed 12,700 since November 1976 with seven of the ten major durable goods industries registering gains. The largest increase was the rise of 2,800 in electrical machinery and the largest decrease was 2,400 in the miscellaneous manufacturing industries. Seven out of ten nondurable goods industries also registered over-the-year increases with chemicals and allied products, up by 2,400, reporting the largest increase and apparel products showing the largest drop of 1,400.

Among the nonmanufacturing industries, the largest over-the-year gains were in the wholesale and retail trade sector, up by 21,600, services and miscellaneous up by 20,700, and contract construction up by 8,500.

EMPLOYMENT RISES ON A SEASONALLY ADJUSTED BASIS

On a seasonally adjusted basis, total nonfarm payroll employment rose by 8,400 over the month, which represented increases of 2,600 in manufacturing and 5,800 in nonmanufacturing. After seasonal adjustment, the durable goods sector increased by 1,500 and nondurable goods rose by 1,100. Stone, clay, and glass experienced a seasonally adjusted increase of 700 caused partially by a return of over 200 workers from a strike. Nonelectrical machinery increased by 800, apparel and other finished textile products increased by 900, and paper and allied products rose by 500. Textile mill products dropped by 500.

All nonmanufacturing sectors except government registered increases after seasonal adjustment. Employment declined by 2,000 in government in part because of strikes, while contract construction jumped 2,100, wholesale and retail trade increased 2,000, and transportation and public utilities gained 1,900 on a seasonally adjusted basis.

EMPLOYMENT RISES IN ALL BUT TWO SHORE AREAS

Nonfarm employment, before seasonal adjustment, increased in November in eight of the ten major labor areas; only the Atlantic City area and the Long Branch-Asbury Park area registered declines. The decline in the Atlantic City area reflected primarily seasonal layoffs in services, trade, and construction while in the Long Branch-Asbury Park area a seasonal drop in services more than offset substantial gains in trade.

The Newark area had the largest rise in employment, up by an estimated 5,500 workers, due largely to increases in all nonmanufacturing sectors except federal government. The overall employment level was depressed, however, because of the continued strike of 2,600 longshoremen.

The Camden area employment level increased by 2,600 workers reflecting seasonal developments in the trade and service sectors. The Vineland-Millville-Bridgeton area had a rise in total nonfarm employment resulting primarily from a contraseasonal jump in food processing.

Employment surpassed last year's level in all areas except Jersey City. The Newark labor market led with an increase of 20,300 workers. Manufacturing employment exceeded last year's in all labor areas except Atlantic City and Vineland-Millville-Bridgeton; nonmanufacturing increased over the year in all areas except Jersey City.

EARNINGS RISE AS THE WORKWEEK LENGTHENS

The weekly earnings of manufacturing production workers averaged \$247.76 in November, up \$2.68 from a month ago and \$22.26 from a year ago. The average hourly earnings of \$5.97 were up 5 cents from a month ago and 47 cents from a year ago. During the November survey week, production workers averaged 41.5 hours compared with 41.4 hours a month earlier.

After seasonal adjustment, the average weekly hours registered an increase to 41.2 hours from 41.0 hours in October and 40.9 hours in September. The seasonally adjusted workweek was still about one-half hour shorter than last summer, however, when it averaged a very long 41.7 hours during the months of June, July, and August.

On an unadjusted basis, twelve of the primary industry groups had increases in weekly earnings over the month and seven had decreases. The largest rise in average weekly earnings was \$24.49 in the transportation equipment industry as a result of substantial overtime by both auto and boat producers. The sharpest decrease was \$5.20 in furniture and fixtures due to a shorter workweek.

The highest hourly earnings were in the transportation equipment industry with an average of \$8.37 amounting to weekly earnings of \$365.77 on the basis of a 43.7-hour workweek. The highest weekly earnings in November were in the petroleum industry with \$376.85 for a workweek of 51.1 hours. The lowest average weekly earnings were in the leather products industry with \$149.33 for a workweek of 39.4 hours.

TECHNICAL NOTES

Nonfarm Wage and Salary Employment

Employment data refer to persons on establishment payrolls who received pay for any part of the pay period which includes the 12th of the month. The data exclude proprietors, the self-employed, unpaid family workers, farm workers, and domestic workers in households. Salaried officers of corporations are included. Government employment covers only civilian employees; federal military personnel are excluded.

Persons on an establishment payroll who are on paid sick leave (when pay is received directly from the firm), on paid holiday or paid vacation, or who work during any part of the pay period but are unemployed or on strike during the rest of the period, are counted as employed. Not counted as employed are persons who, during the pay period which includes the 12th, are laid off, on leave without pay or on strike for the entire period, or who are hired but do not work during the period.

Average Hours and Earnings

Hours and earnings data are derived from reports of payroll and man-hours for production and related workers in manufacturing. When the reported pay period exceeds one week, the payroll and man-hour figures are reduced to a weekly basis.

Average hourly earnings for manufacturing are on a "gross" basis, reflecting not only changes in basic hourly rates, but also such variable factors as premium pay for overtime and shift work, and changes in output of workers paid on an incentive plan. Excluded from average earnings are irregular bonuses, retroactive items, payments of various welfare benefits, and payroll taxes paid by employers.
