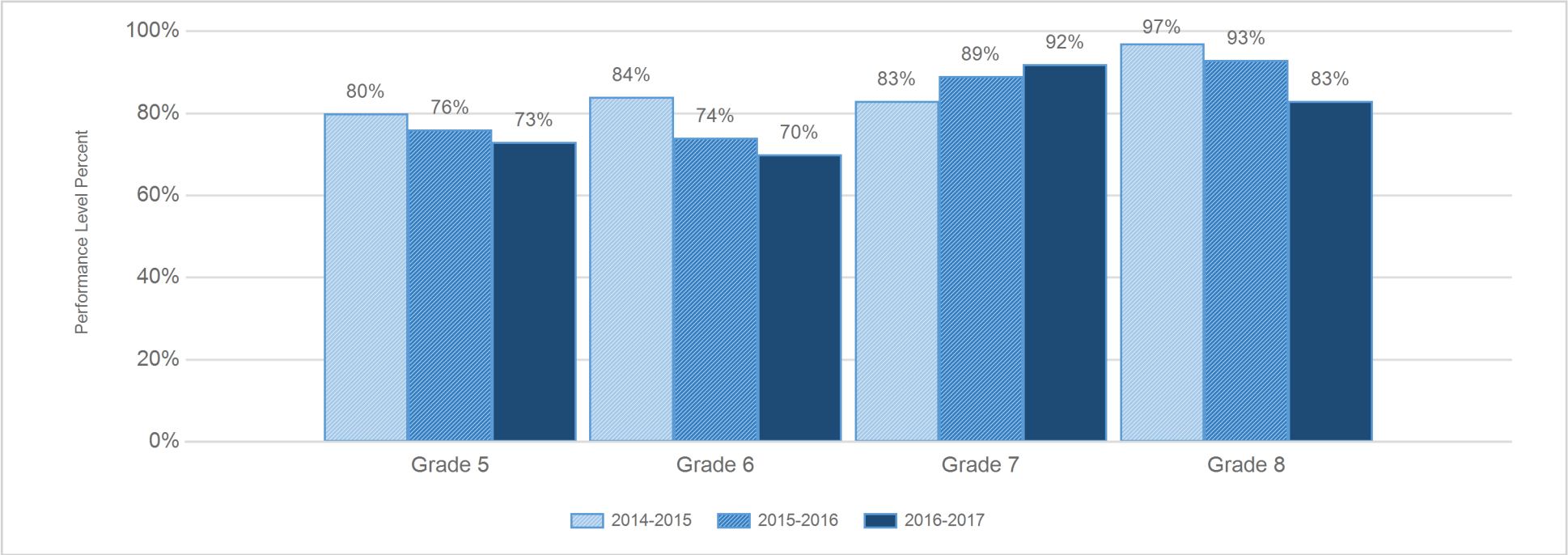

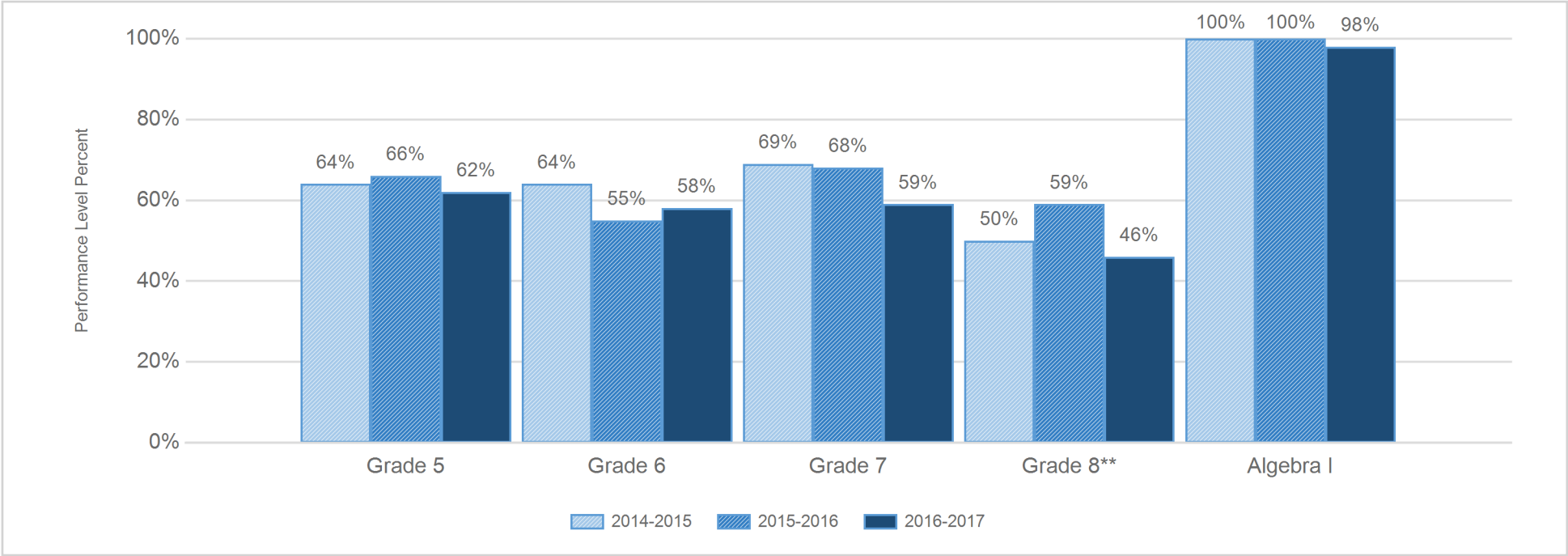

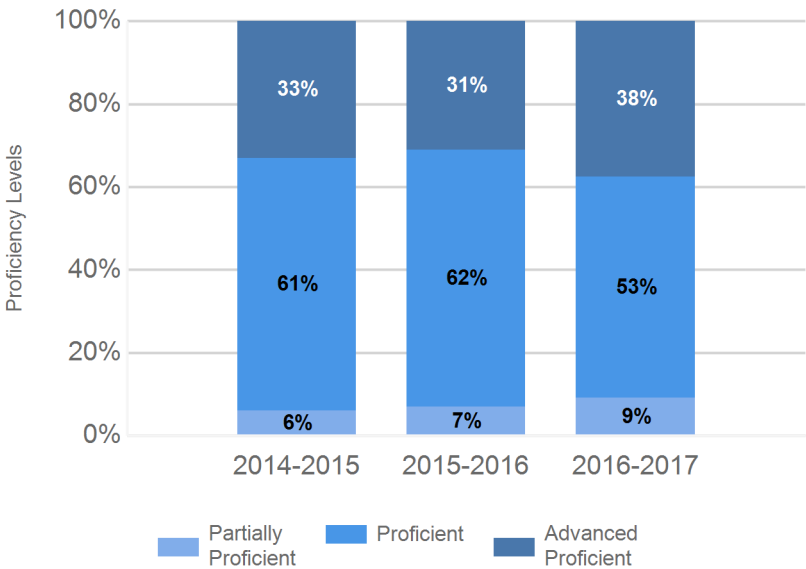

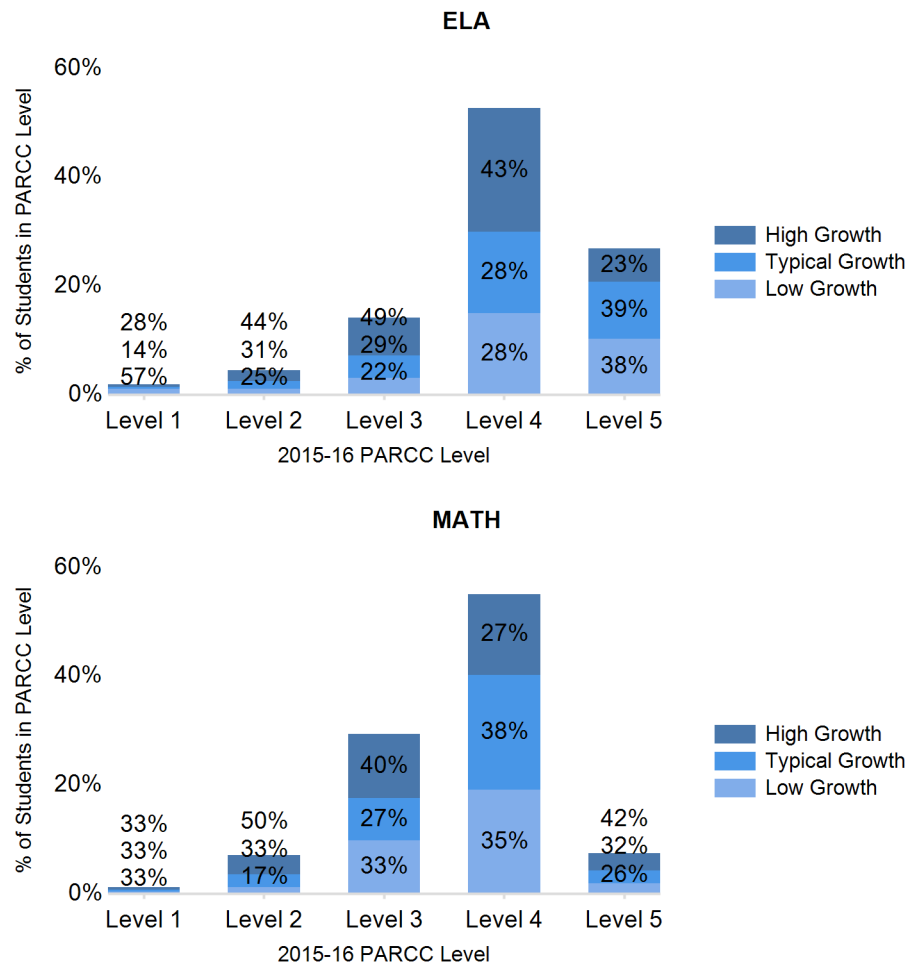

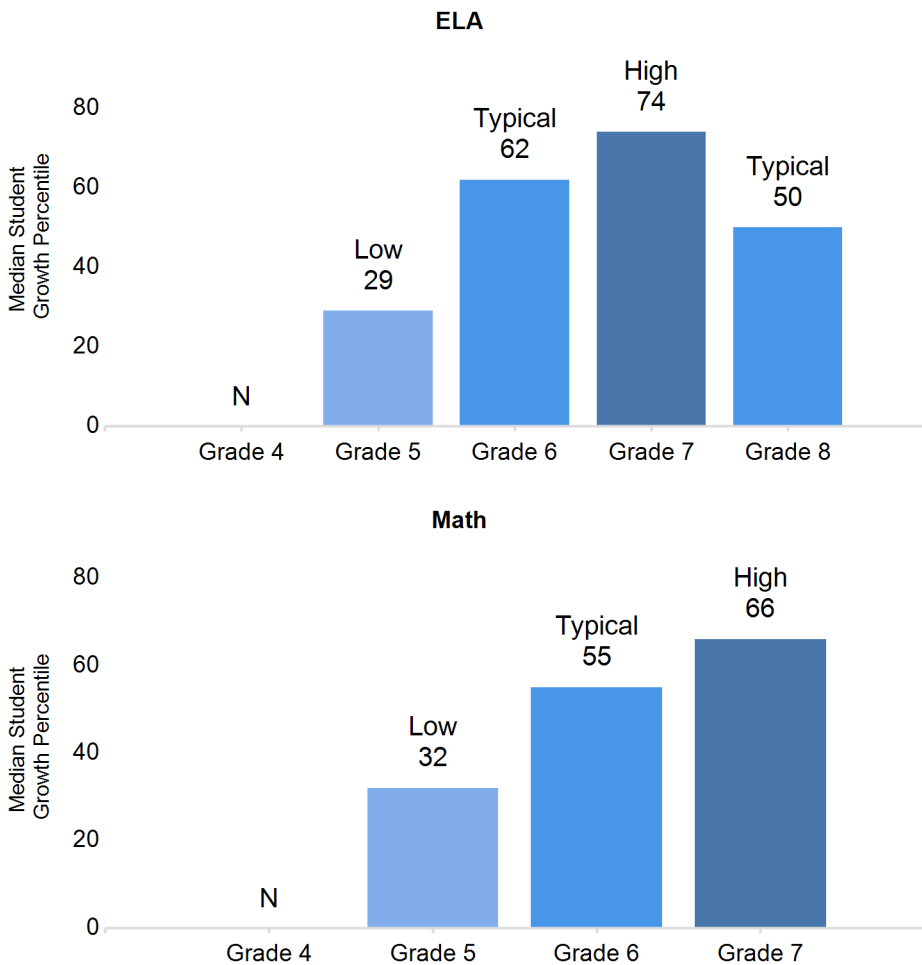

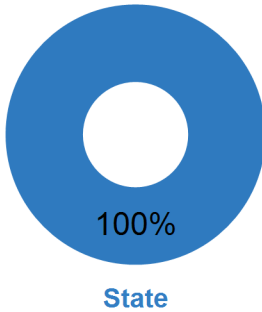

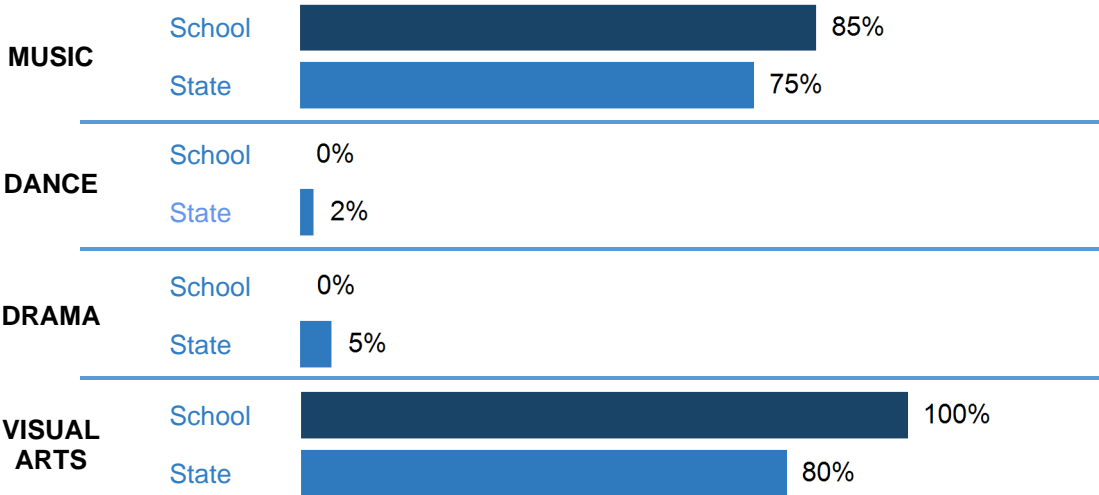

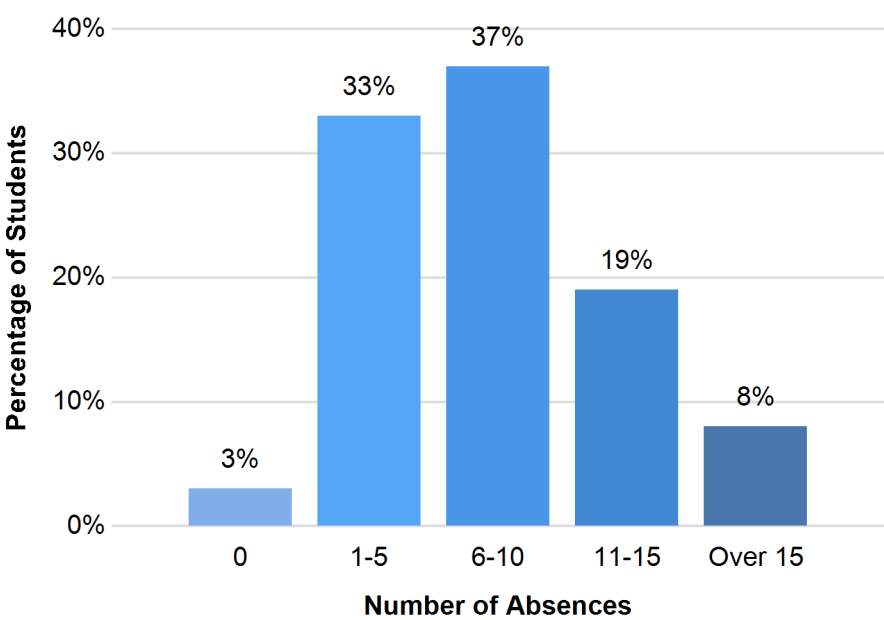

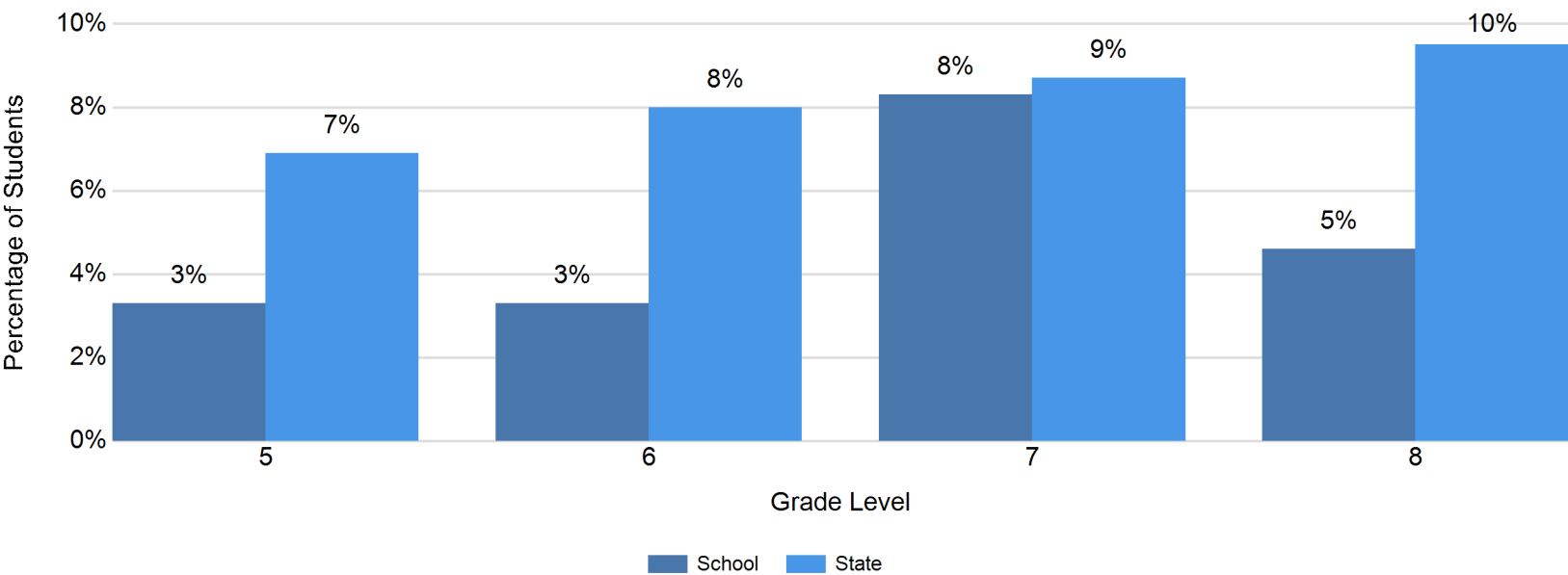

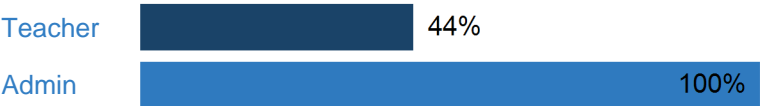

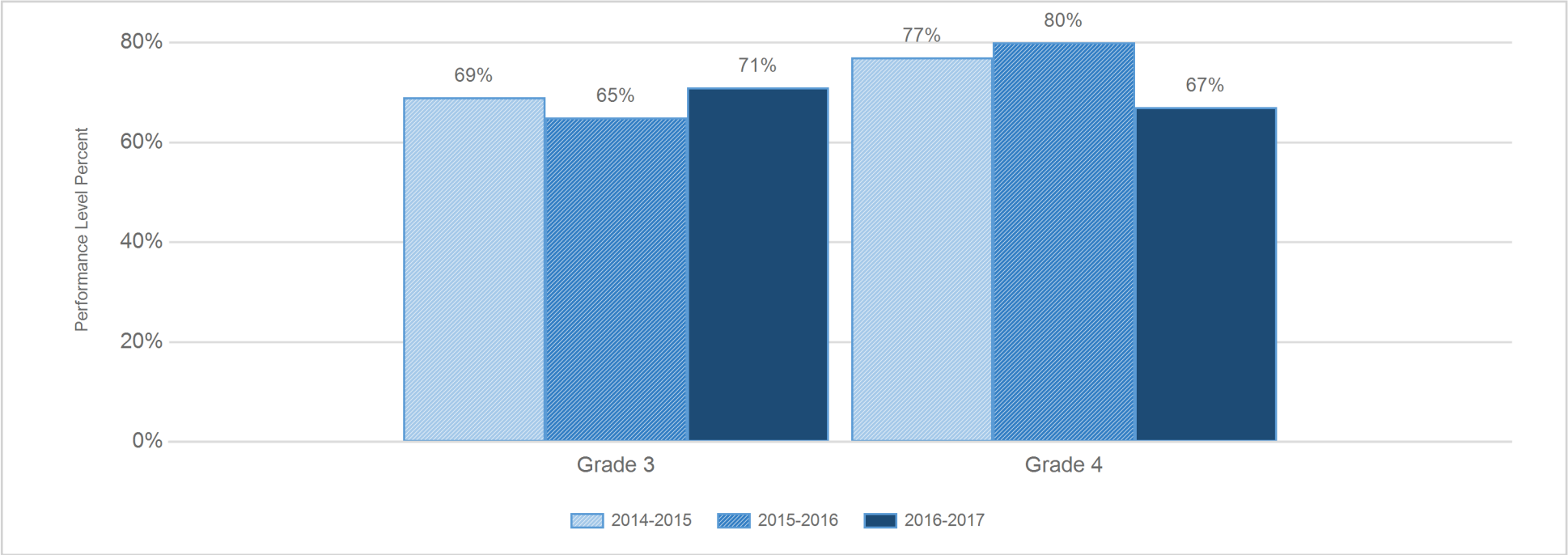

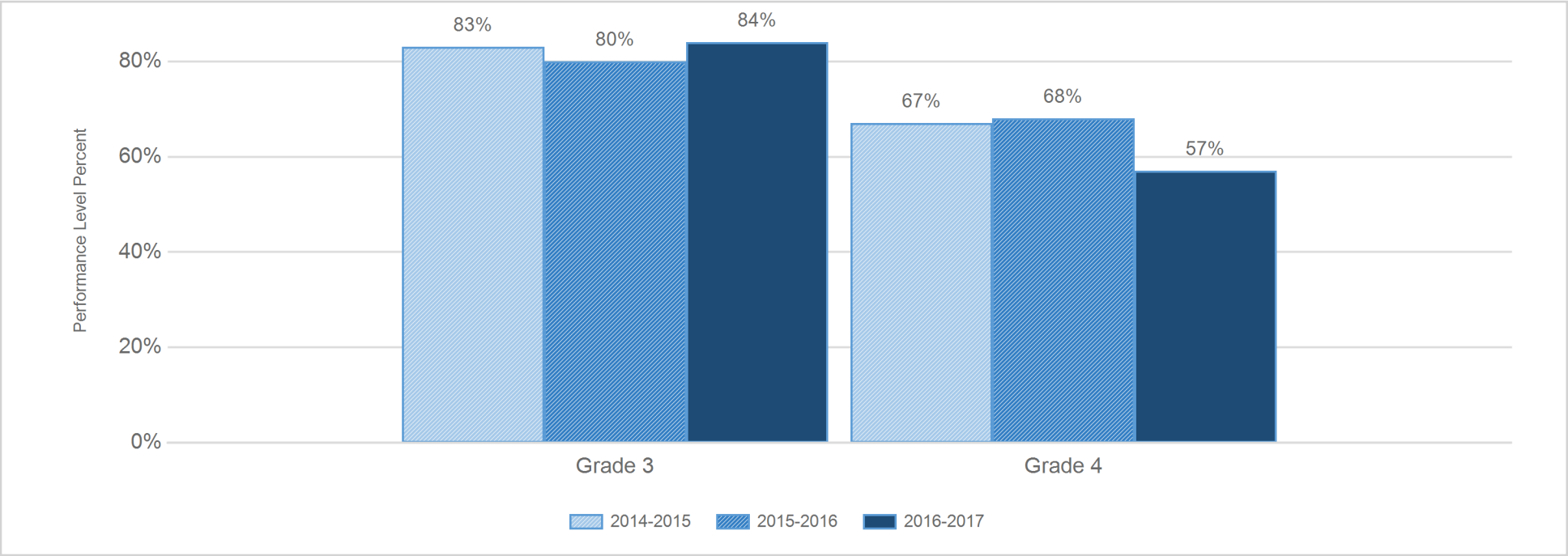

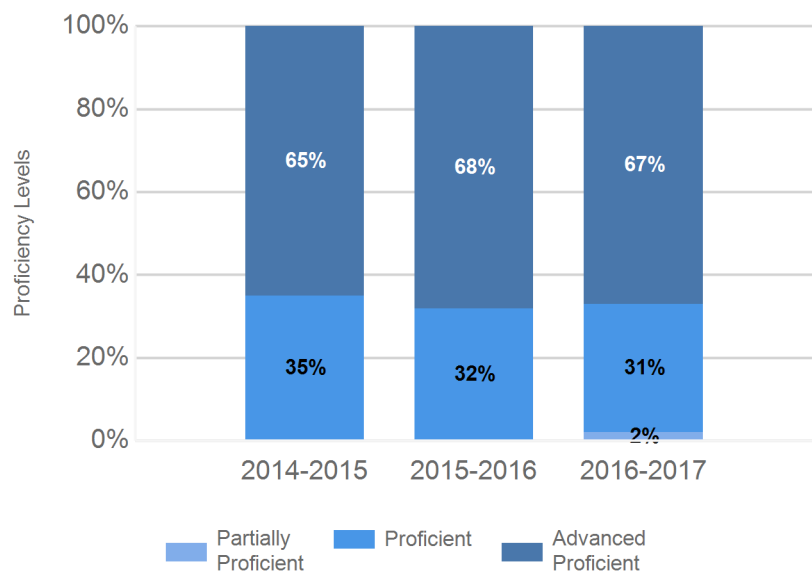

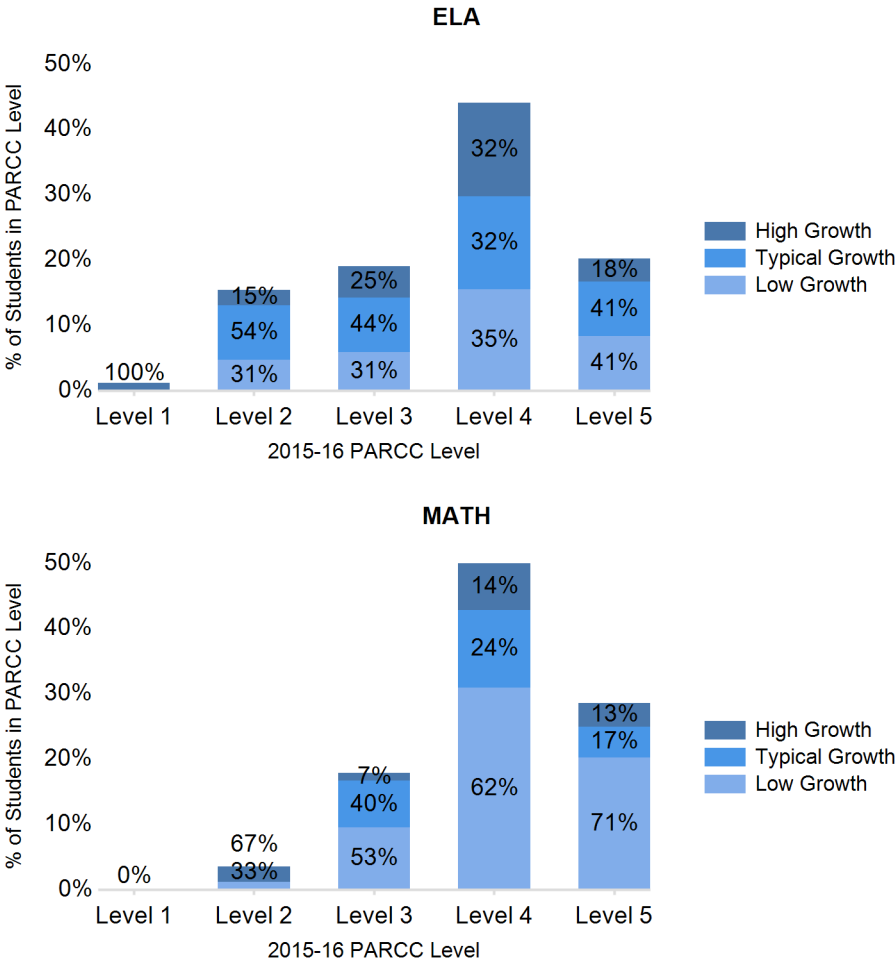

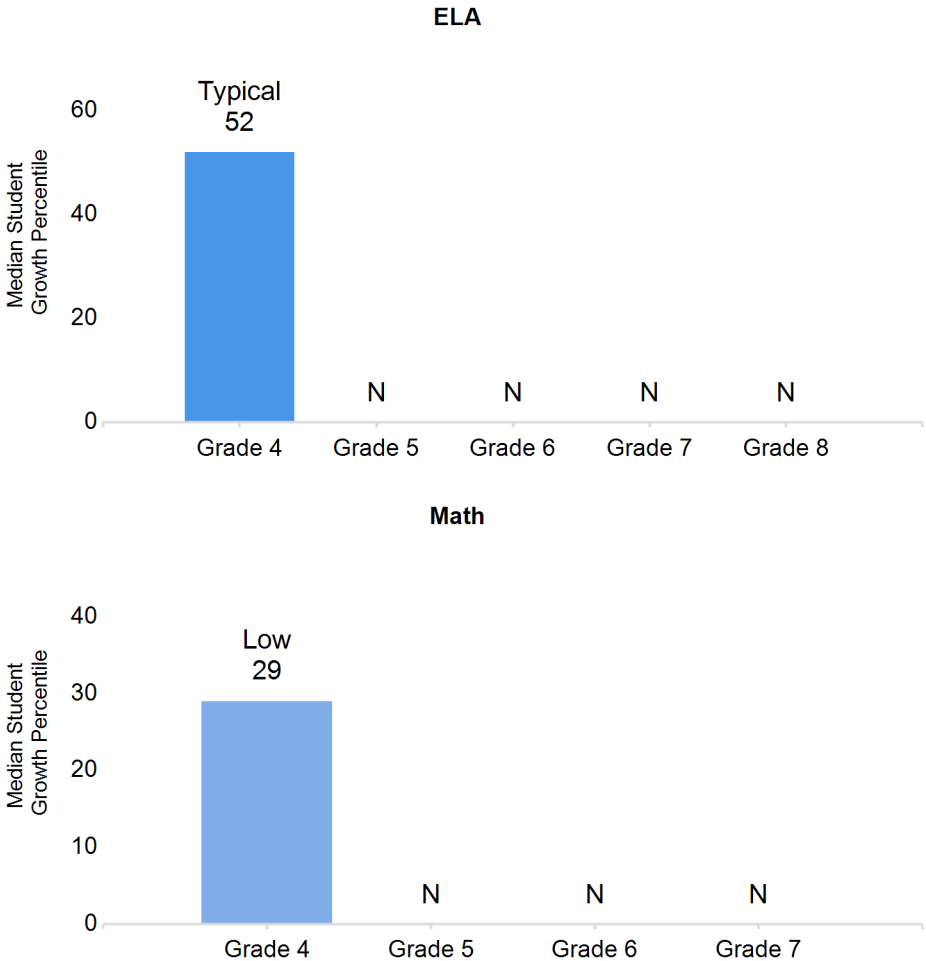

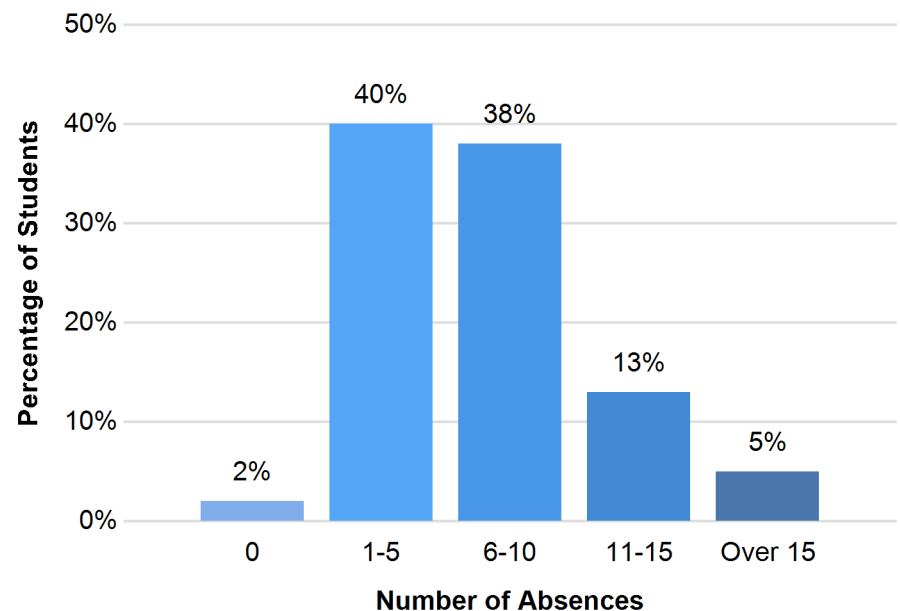

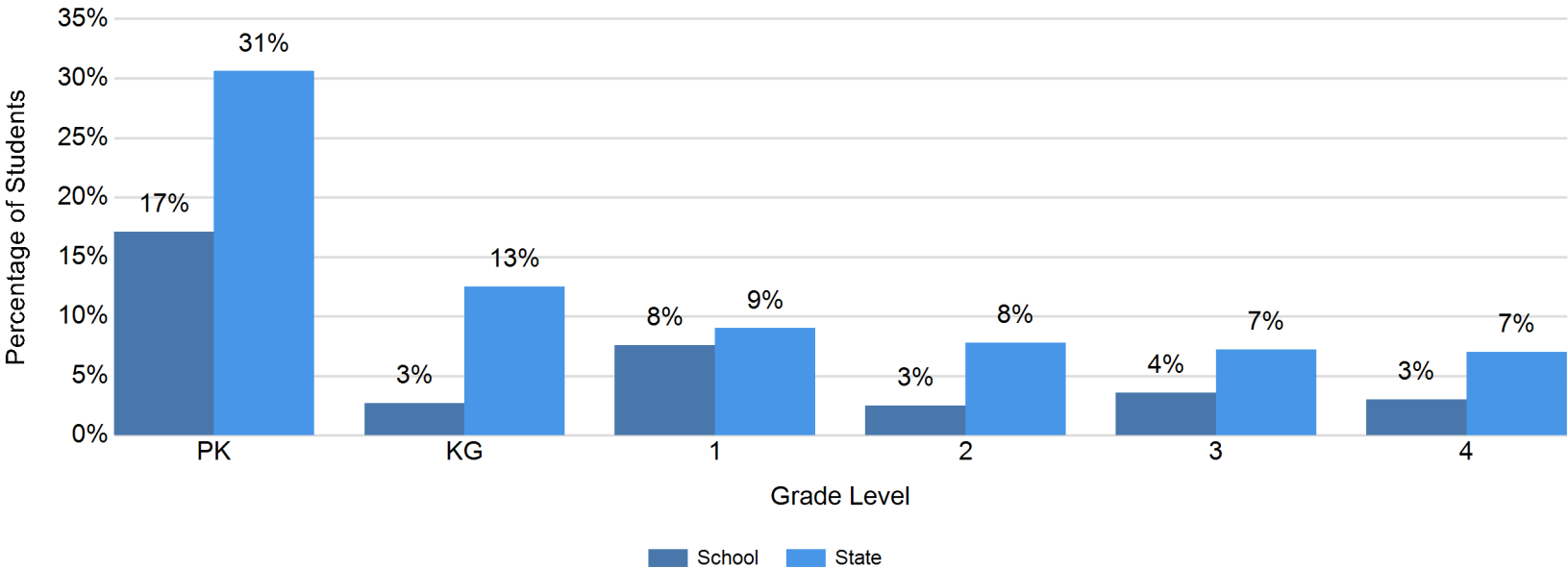
Days Absent
