# *Annual Report*

## Board of Trustees:

An election of the Board of Trustees was held on June 11, 1970. Mr. Charles E. Wagner of the Department of Treasury was reelected for a three year term commencing July 1, 1970, representing state employees. Mr. Wagner has been a member of the Board of Trustees since July 1, 1964.

An election was also held on June 12, 1970 for a municipal employee representative to the Board of Trustees. Mr. Anthony M. Orecchio of Fairview Borough was elected for his first term to the Board of Trustees for a three year period commencing July 1, 1970.

## LEGISLATION

**Chapter 57, P.L. 1970** — The enactment of Assembly Bill 966 into law on May 18, 1970 was duly noted by the Board. The statutes governing the Public Employees' Retirement System were amended to read as follows:

Section 43:15A-6(f) "Regular interest" shall mean interest as determined annually by the State Treasurer after consultation with the Directors of the Division of Investment and Pensions and the actuary of the fund. It shall bear a reasonable relationship to the percentage rate of earnings on investments but shall not exceed 105% of such percentage rate.

Section 43:15A-18 The board shall elect annually from its membership a chairman and may also elect a vice chairman, who shall have all the power and authority of the chairman in the event of the death, absence or disability of the chairman. The actuary of the fund shall be designated by the State Treasurer after consultation with the Director of the Division of Pensions, subject to veto by the board for valid reason.

Section 43:15A-32 The board of trustees shall be and are hereby constituted trustees of the various funds and accounts established by this act; provided, however, that all functions, powers, and duties relating to the investment or reinvestment of moneys of, and purchase, sale, or exchange of any investments or securities, of or for any fund or account established under this act, shall be exercised and performed by the Director of the Division of Investment in accordance with the provisions of chapter 270, P.L. 1950, as amended and supplemented. The secretary of the board of trustees shall determine from time to time the cash requirements of the various funds and accounts established by this act and the amount available for investment, all of which shall be certified to the Director of the Division of Investment.

The members of the finance committee of the board of trustees shall be appointed at or after July 1 of each calendar year by the chairman of the board of trustees to serve through June 30 of the ensuing calendar year and until their successors are appointed. The finance committee of the board of trustees shall consist of five members of the board of trustees, one of whom shall be the State Treasurer, and one of whom shall be the member designated to serve on the State Investment Council. At least three members of the finance committee shall be members of the board of trustees who have been elected by members of the system. A quorum of the finance committee shall consist of three members thereof.

A member of the board of trustees to be designated by a

majority vote thereof shall serve on the State Investment Council as a representative of said board of trustees, for a term of 1 year and until his successor is elected and qualified.

Section 43:15A-36 Except as otherwise herein provided, no trustee and no employee of the board of trustees shall have any direct interest in the gains or profits of any investments of the retirement system; nor shall any trustee or employee of the board directly or indirectly, for himself or as an agent, in any manner use the moneys of the retirement system, except to make such current and necessary payments as are authorized by the board of trustees; nor shall any trustee or employee of the boards of trustees become an endorser or surety, or in any manner an obligor for moneys loaned to or borrowed from the retirement system.

**REPORT ON THE FIFTEENTH VALUATION  
OF THE  
PUBLIC EMPLOYEES' RETIREMENT SYSTEM  
OF NEW JERSEY**

The Public Employees' Retirement System of New Jersey, which began operation January 2, 1955, was established under Chapter 84 of the Laws of 1954. It supersedes the State Employees' Retirement System of New Jersey which began operation as of January 1, 1922. This report, prepared as of March 31, 1969, presents the results of the fifteenth actuarial valuation of the system.

There was no legislation during the year which affected the valuation of the liabilities of the system. However, Chapter 181, P.L. 1968, effective October 1, 1968, permits the Board of Higher Education to adopt an alternate benefit program for full time faculty members of the county colleges and allows such employees who are members of the employees' system to elect to continue their membership or to transfer to the new plan. The act establishes a procedure for the transfer of reserves for those members who elect to transfer similar to that set forth by Chapter 192, P.L. 1967, which became effective August 15, 1967 and applies to certain members of the faculty of Rutgers University. New employees of the county colleges who are members of the Teachers' Pension and Annuity Fund may elect to transfer to the employees' system in lieu of participation in the alternate benefit program. A similar option is extended to new employees of Rutgers University, the Newark College of Engineering and the State colleges under the provisions of Chapters 75, 76 and 77, P.L. 1968, effective June 21, 1968, respectively. The effects of Chapter 181 will be reflected for the first time in the valuation to be prepared as of March 31, 1970.

**MEMBERSHIP**

The data needed for the valuation were furnished to the actuary by the Division of Pensions. The following table shows the total number of active members included in the valuation, together with their annual salaries as of March 31, 1969.

The assets and liabilities of each fund may be considered separately.

**(1) Annuity Savings Fund**

The valuation balance sheet shows the assets of the Annuity Savings Fund, the fund in which the deductions from the compensation of members to provide for their annuities are accumulated, to be \$156,097,935 on March 31, 1969, after interest accrued from June 30, 1968 has been added. The liabilities of the fund are also shown as \$156,097,935. The benefits to be provided from the past and future contributions of members who will retire have been taken into account in determining the liabilities of the Contingent Reserve Fund.

**(2) Special Reserve Fund**

The Special Reserve Fund is the fund to which all profits on the sale of securities and any excess earnings are transferred and against which any losses from the sale of securities are charged. The maximum limit on the accumulations in this fund is set at one per cent of the book value of the investments of the retirement system; any amounts in excess of this limit are creditable to the Contingent Reserve Fund. This fund has reached the maximum limit and has assets amounting to \$4,767,400 as of the valuation date. This figure is also shown as the liability of the fund.

**(3) Retirement Reserve Fund**

The Retirement Reserve Fund has present assets including accrued interest of \$208,933,700, while its liabilities have a present value of \$207,739,461. There is therefore a surplus of \$1,194,239 in this fund as of the valuation date compared to a surplus last year of \$1,336,994. A test of the experience among beneficiaries indicated that the reserves released by death were less than expected on the basis of the mortality tables adopted by the Board. The surplus in the Retirement Reserve Fund was taken into account in determining the normal rates of contribution payable by the State and local employers.

**(4) Contingent Reserve Fund**

The liabilities of the Contingent Reserve Fund are \$895,551,559, of which \$887,631,947 is on account of present active members and \$7,919,612 is on account of death benefits payable to beneficiaries of present retired members. The present assets of the fund including accrued interest and excess interest earnings creditable amount to \$143,818,810. The balance, decreased by the amount of the surplus in the Retirement Reserve Fund, or \$750,538,510, is to be met by the future

contributions of the State and local employers. Of this amount \$114,911,266, which includes \$13,282,635 on account of the liability incurred by the passage of Chapter 229, P.L. 1964, and \$53,868,071 on account of the liability incurred by the passage of Chapter 67, P.L. 1966, will be met by future accrued liability contributions, leaving \$635,627,244 to be met by the future normal contributions.

### **CONTRIBUTIONS PAYABLE BY THE STATE AND LOCAL EMPLOYERS**

The State was originally required to make two contributions to the retirement system, one to cover the liability assumed by the system on account of service rendered by members during the current year, and the other to cover the liability on account of the credit granted for service rendered prior to the establishment of the retirement system. The State completed its payment for prior service credit in 1946. However, under the Public Employees' Retirement System the State is required to pay over a period of 30 years commencing with July 1, 1956 an accrued liability contribution to meet the additional cost for allowances payable on account of service rendered by veteran members prior to January 2, 1955. This accrued liability contribution is adjusted annually on account of additional service credits allowed veteran members during the valuation year in accordance with the provisions of Chapter 229, P.L. 1964.

Each local employer is required to make a contribution for its employees, which consists of a normal contribution and, until the accrued liability on account of its employees has been liquidated, an accrued liability contribution. The accrued liability contribution of each employer for service credit granted to its non-veteran employees prior to July 1, 1966 is based on a special valuation of the liabilities of the employer made at the end of the first year of participation. Each local employer who has veteran members with creditable service rendered prior to January 2, 1955 must also pay an accrued liability contribution in the same manner as provided in the case of the State for its veteran members. This contribution is subject to adjustment annually in accordance with the provisions of Chapter 229, P.L. 1964.

In addition, the State and each local employer are required to make contributions over a period of 30 years beginning July 1, 1967 to liquidate the liability created by the passage of Chapter 67, P.L. 1966, not covered by additional normal contributions. The liability incurred by the passage of Chapter 171, P.L. 1962, was recomputed and included with this liability in determining the annual payments.

In accordance with the law, the normal rate is determined each year on the basis of the annual valuation as the percentage rate of contribution required with the funds in hand and prospective accrued liability contributions, if any, to meet the benefit payments for which the employers are responsible. Separate rates are determined for the State and for the local employers taken as a group, and for non-veteran and veteran members. The calculations are also made separately for 4 per cent and 3 per cent members since their accumulated deductions are credited with 4 per cent and 3 per cent interest, respectively. However, the liabilities for both these groups were determined on the basis of a 4 per cent interest assumption, and we therefore certify one normal rate for both groups.

The normal rates recommended for the year beginning July 1, 1969 are as follows:

On the basis of the normal rates applicable to State employees and the payroll as of March 31, 1969, the contributions for the fiscal year beginning July 1, 1969 payable by the State and the agencies which pay the same normal rate as the State are shown in Table IV. The amount required to pay the premium for the non-contributory life insurance coverage for the policy year 1970-1971 has been deducted from the recommended normal contribution to the retirement system and is shown as payable to the Group Life Insurance Premium Fund in accordance with the provisions of Chapter 79, P.L. 1960. The certifications of the appropriations required of the local employers are submitted separately.
