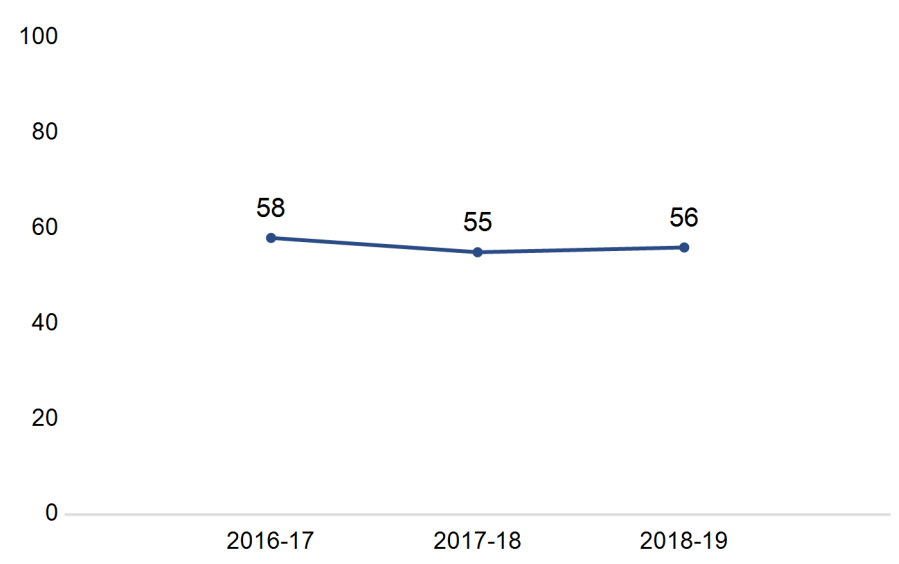

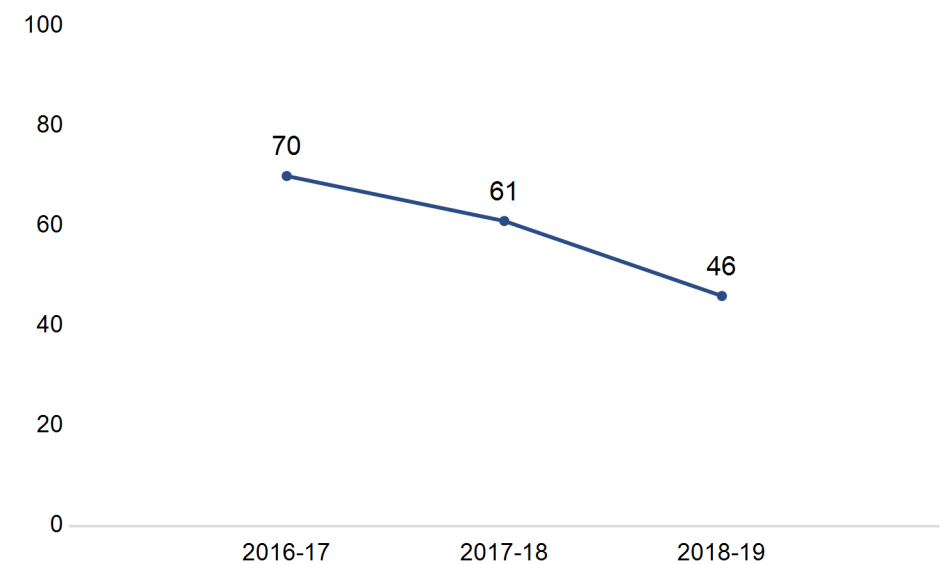

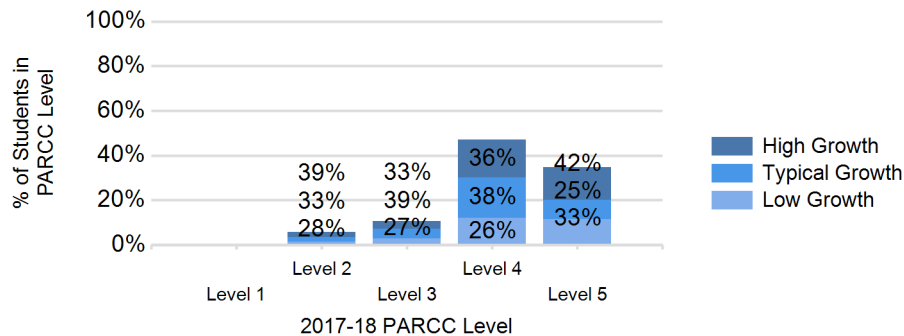

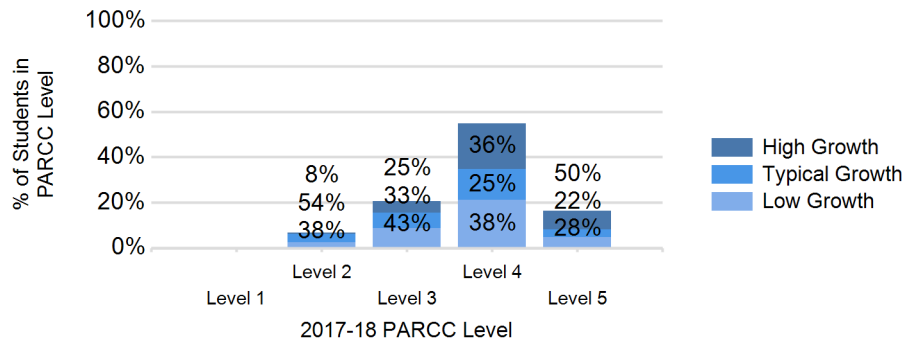
Student Growth by Performance Level

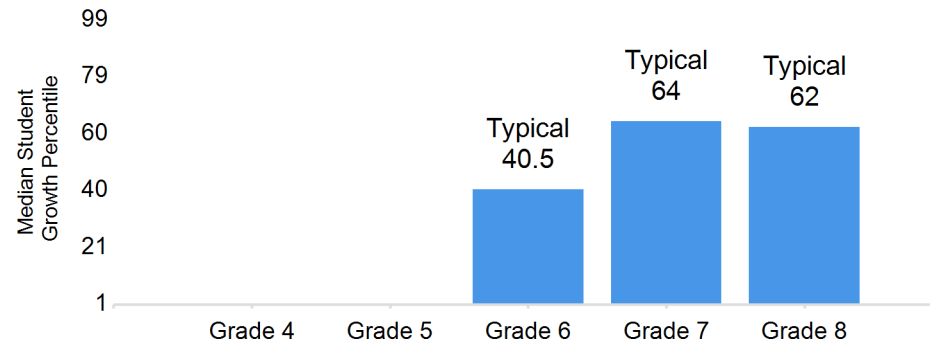

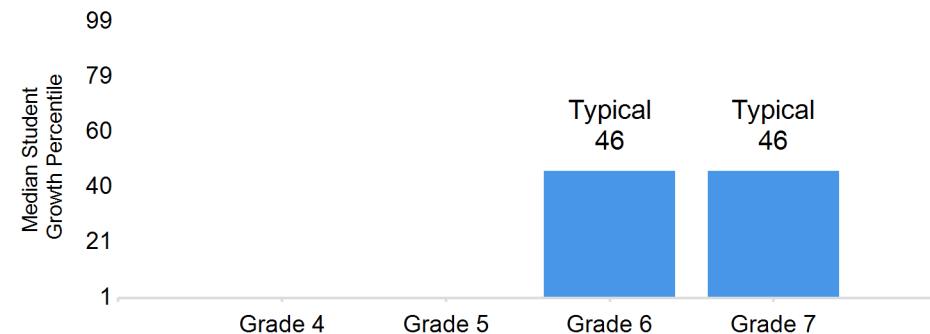
Student Growth by Grade

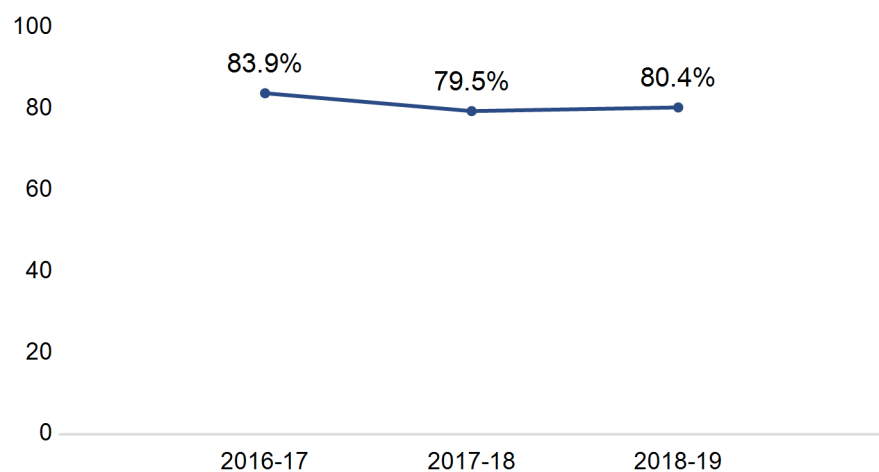

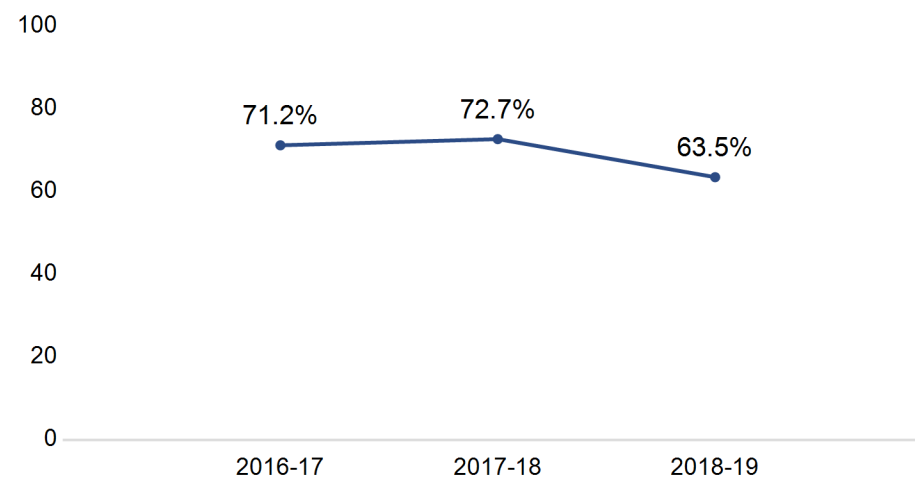
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the statewide assessment (NJSLA for 2018-19 and PARCC for 2016-17 and 2017-18) and the DLM alternate assessment. The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. 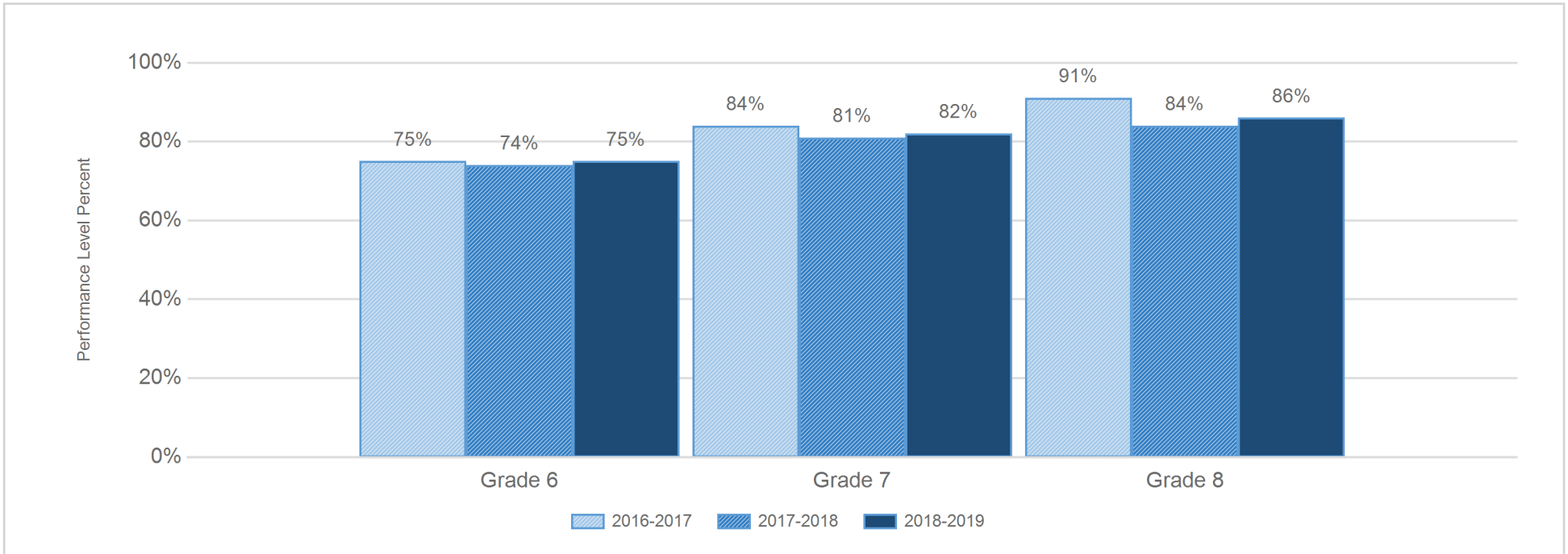

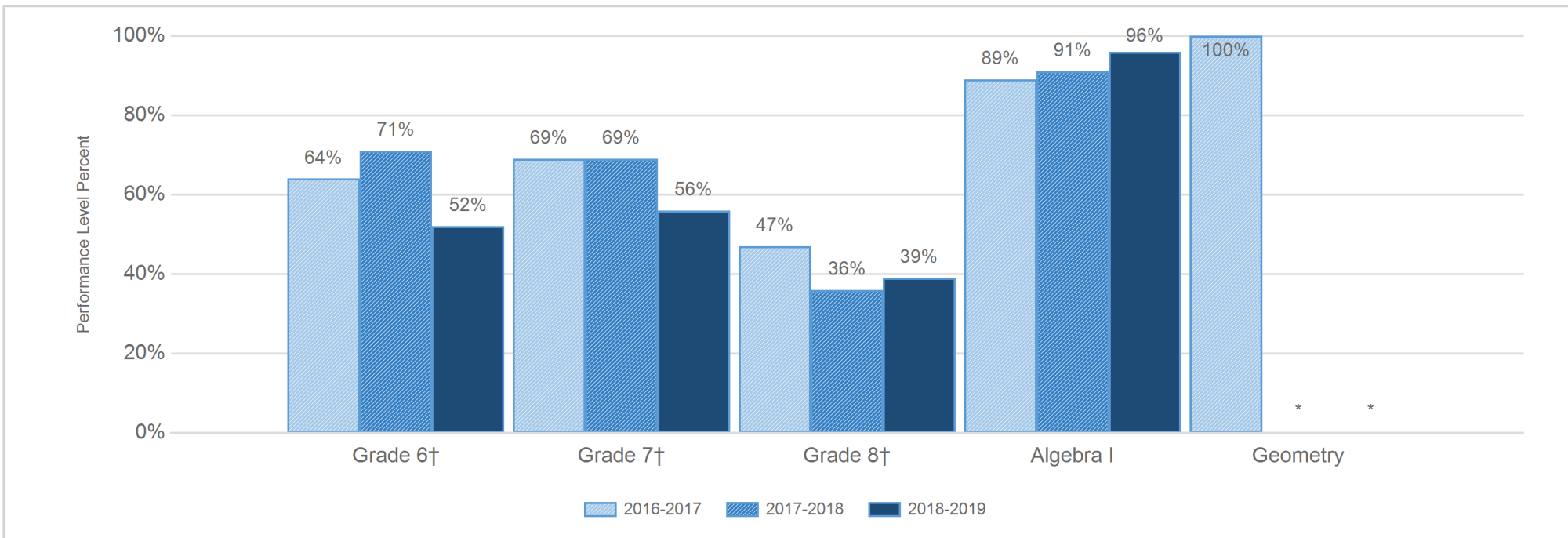

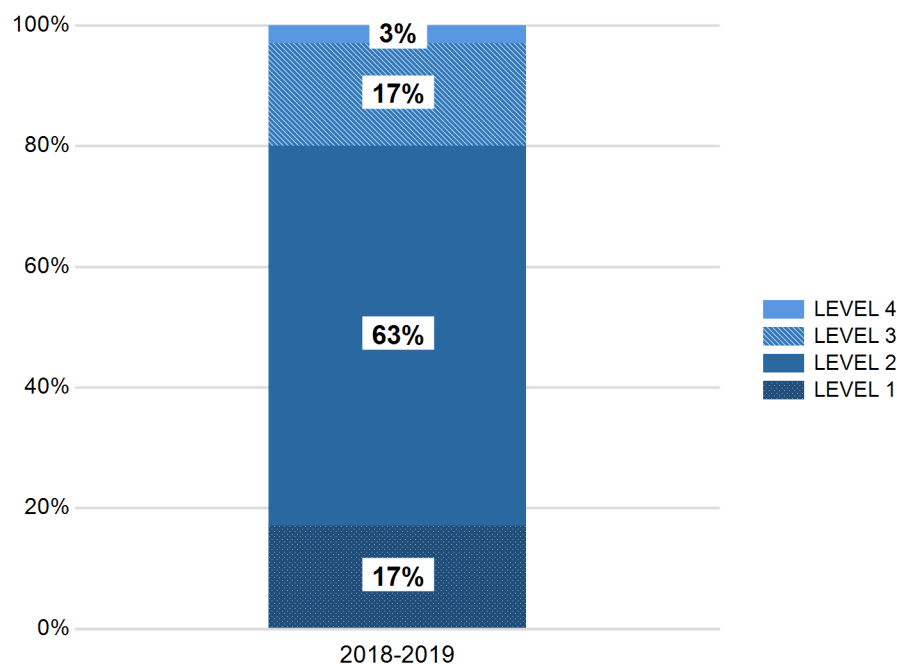

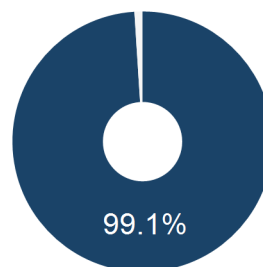

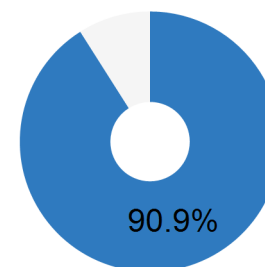

Students enrolled in one or more **visual and performing arts** classes

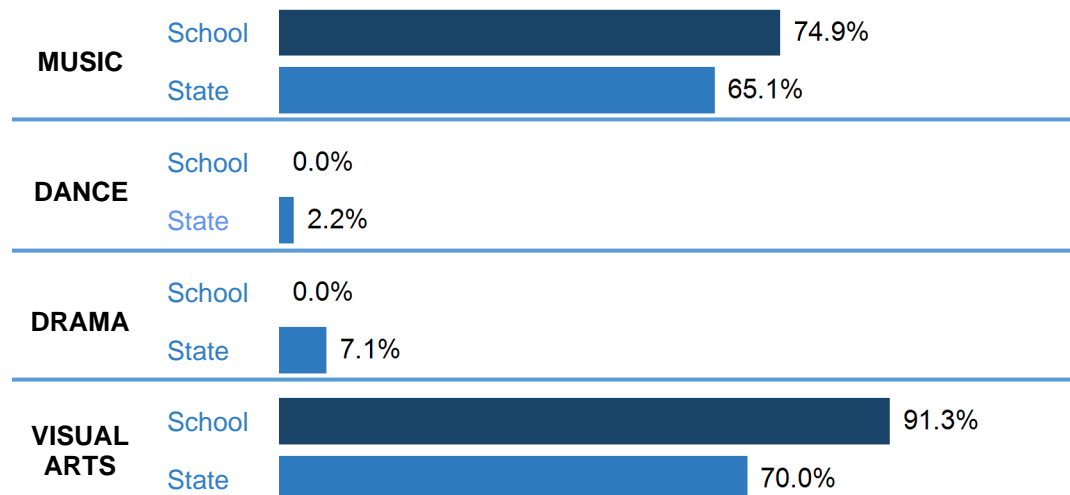

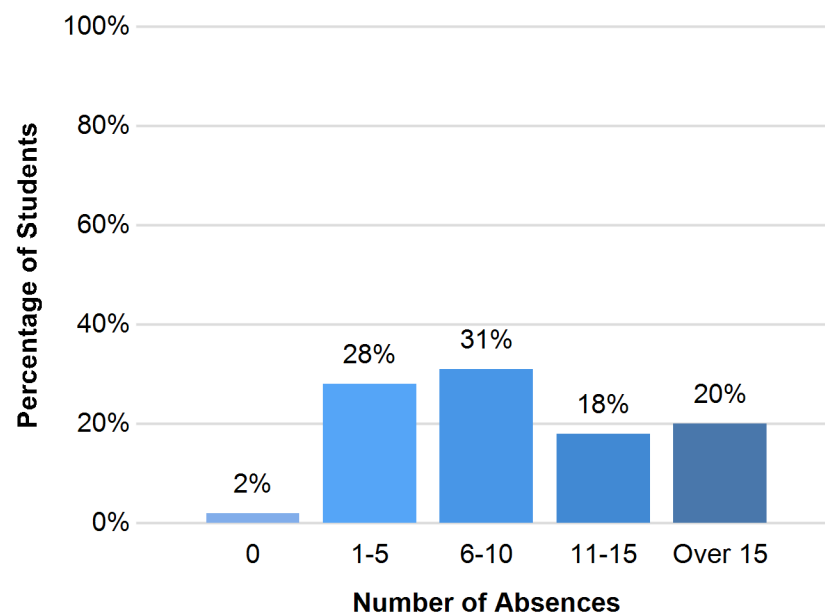

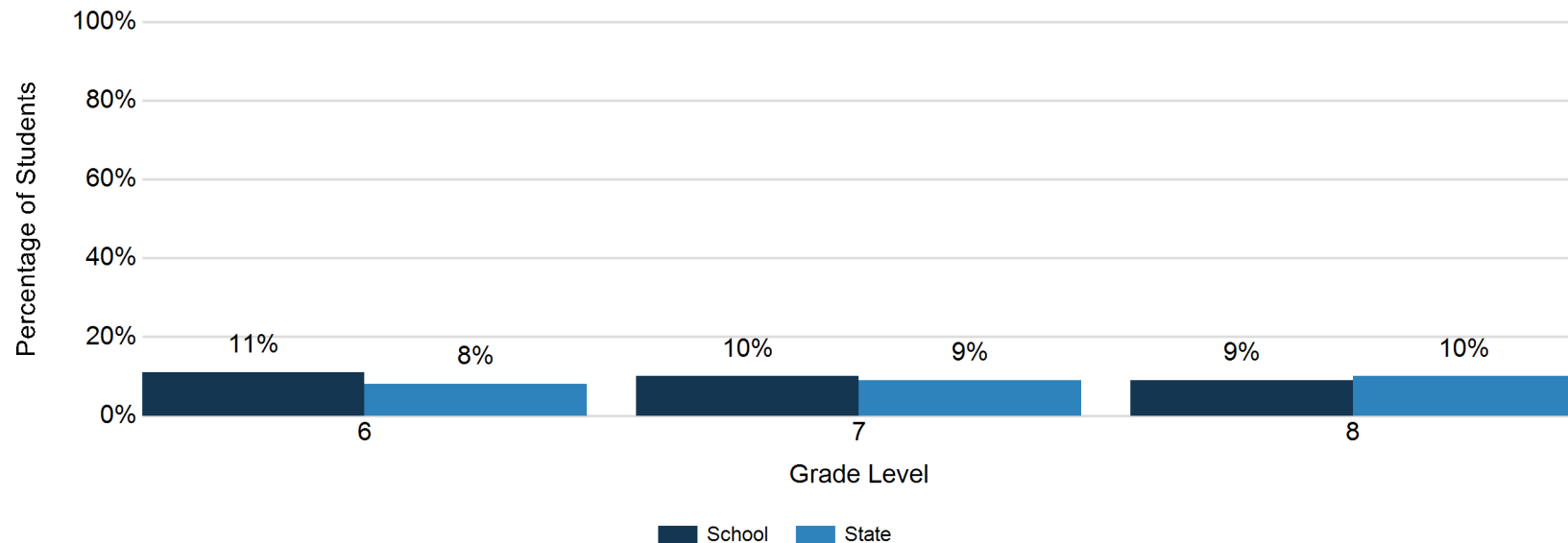

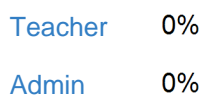

Other Information

Our language arts literacy curriculum has been designed to reflect the Teacher's College Reader's and Writer's Workshop approach and is aligned to the Common Core Standards. Our math program consists of both regular and advanced courses which foster a sense of self-confidence and excitement about mathematics through promoting the ability to reason, construct mathematical ideas, and apply problem-solving strategies. In science, hands-on laboratory investigations are offered, as well as inquiry-based learning experiences so that students are motivated to seek knowledge, information, and meaning through questioning and discovery. Each student participates in at least one marking period of Project Lead the Way® to help foster important engineering principles aligned with the Next Generation Science Standards; sixth grade students take Design and Modeling, seventh grade students engage in Robotics, and our eighth grade students challenge themselves in the Medical Detectives course. The social studies curriculum includes U.S. I, U.S. II and World History topics and incorporates non-fiction reading and writing strategies in an effort to enhance students' ability to analyze and interpret informational text. Spanish and Italian are taught through an interpersonal approach and offered to all students on an alternate day schedule. Our related arts program includes art, music, chorus, explorations of 21st century technology skills, instrumental music, physical education, health, and communications arts. In addition, Cedar Drive offers opportunities to support the social, academic, and emotional development of every student through our advisory program. The main goal of our advisories is to build a strong sense of connectedness among all members of the school community. The program works to empower students to believe in themselves as individuals and to realize the impact that their words and actions have on others.

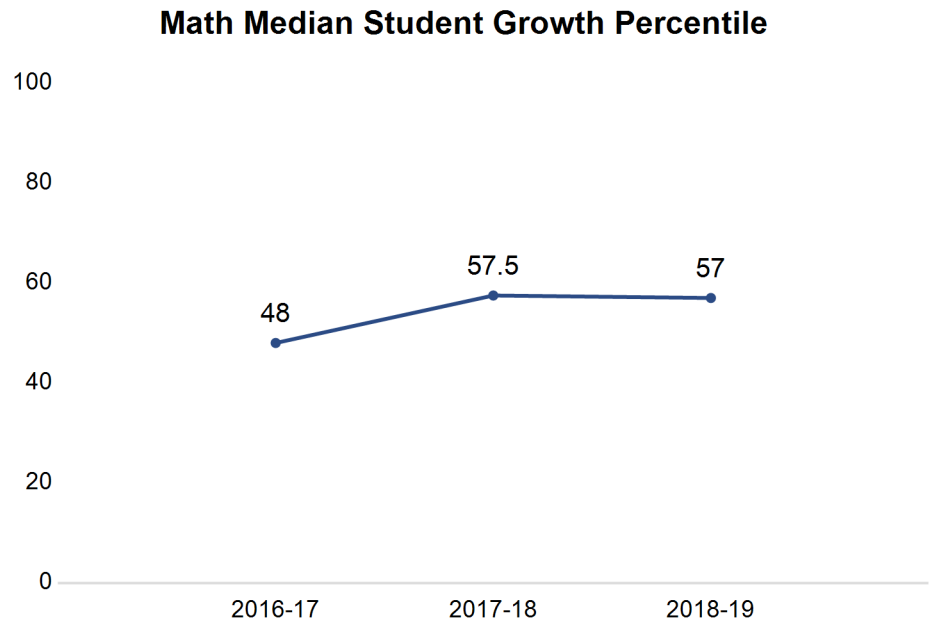

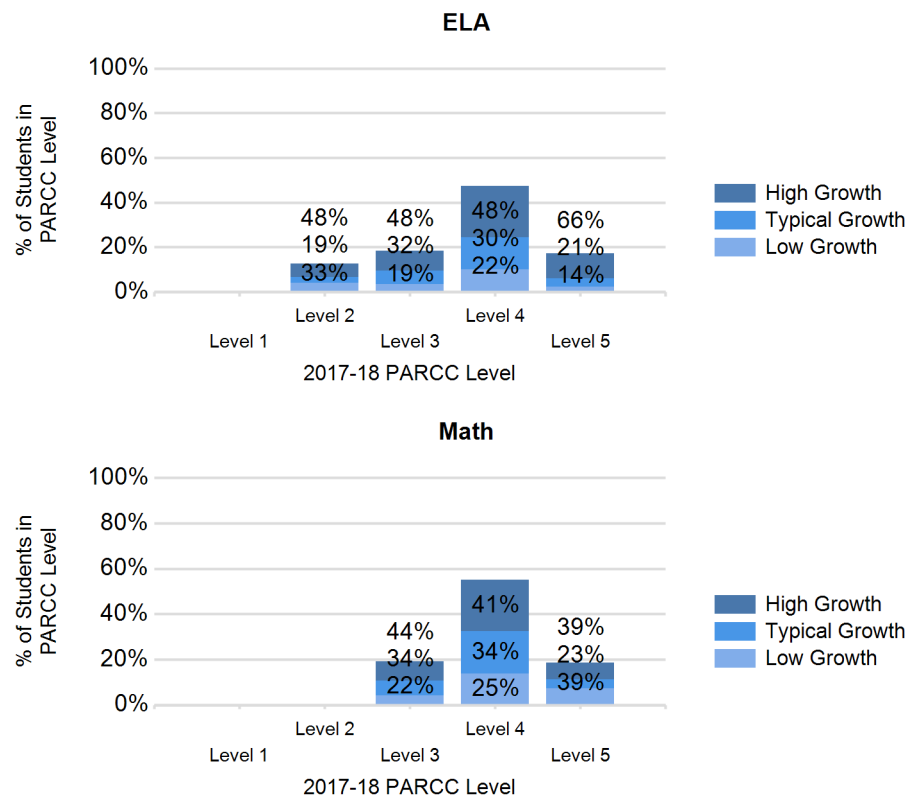

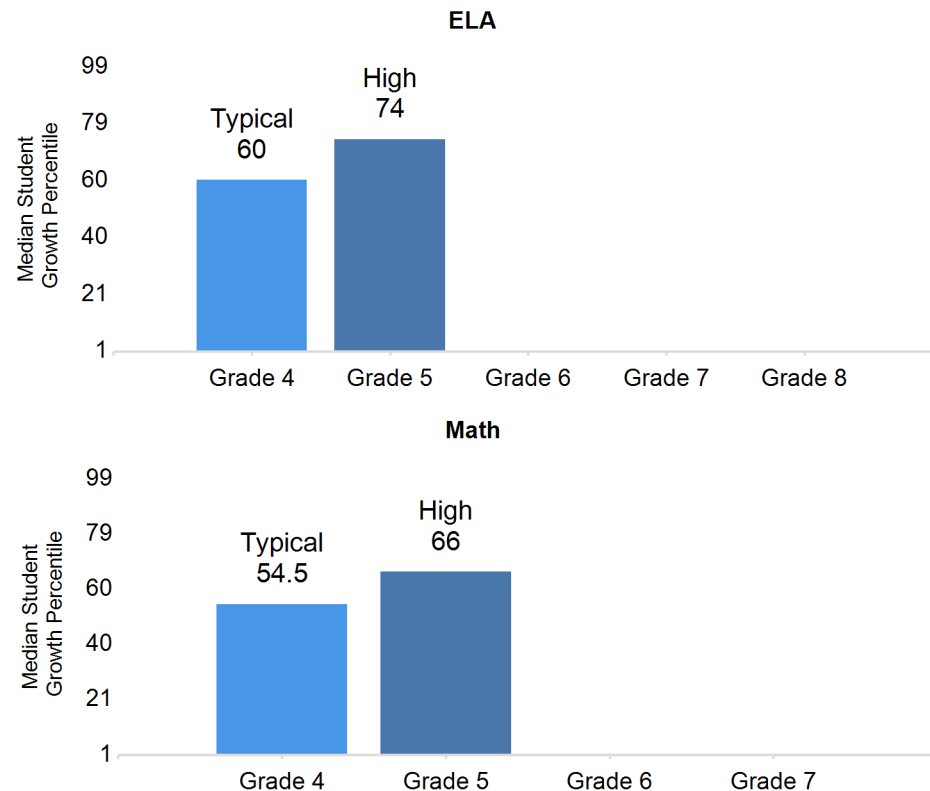
Student Growth by Performance Level

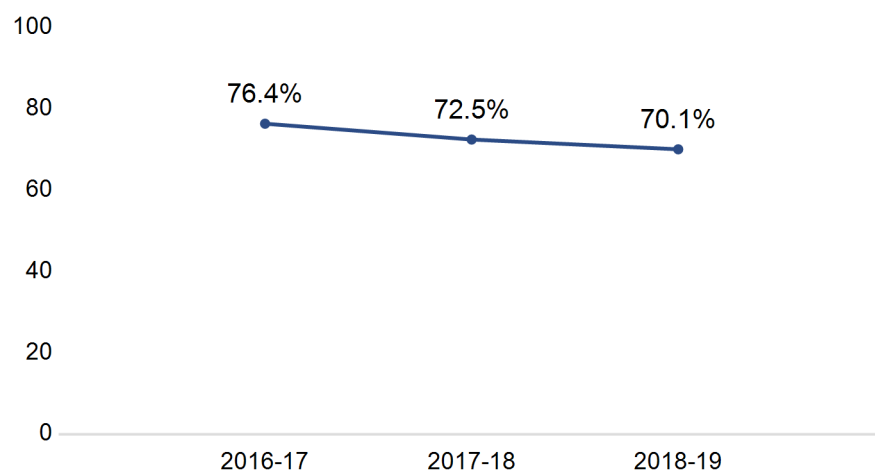

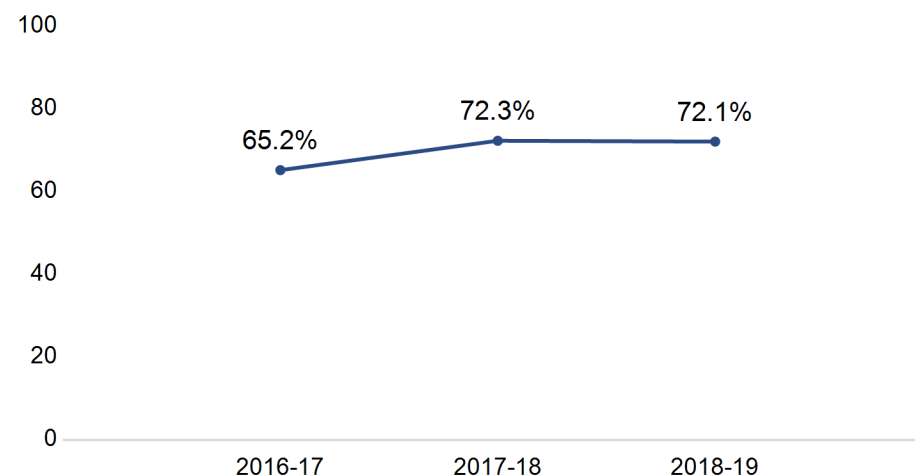

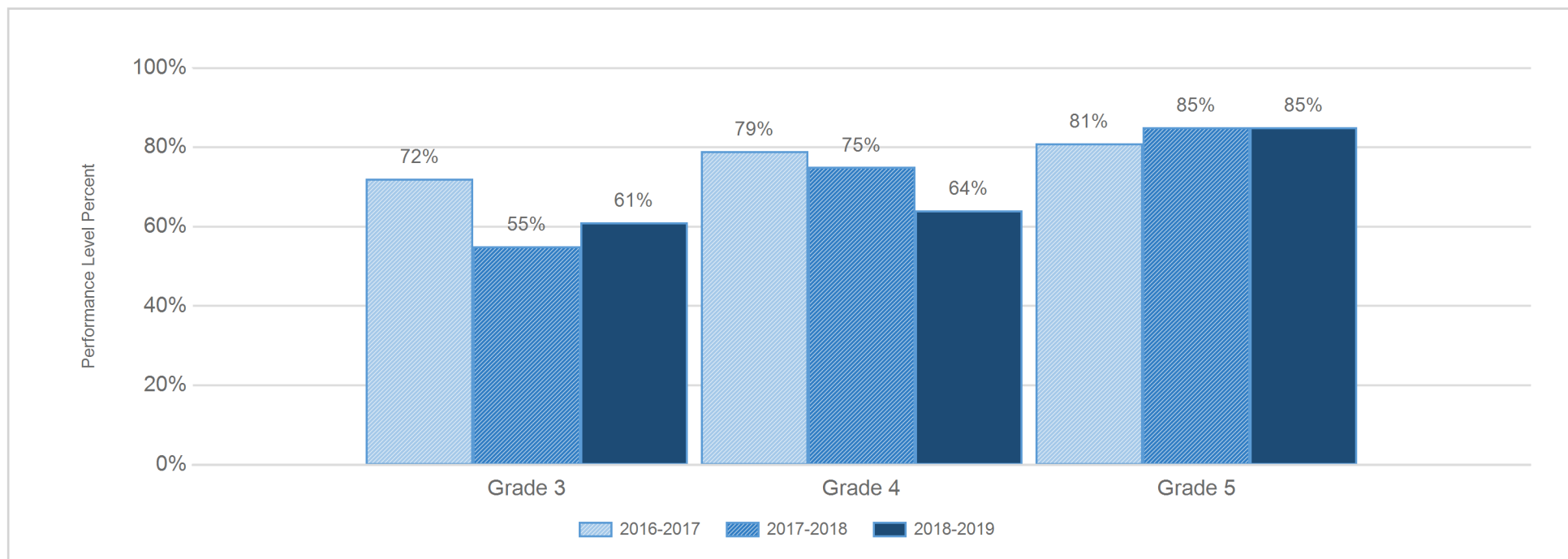

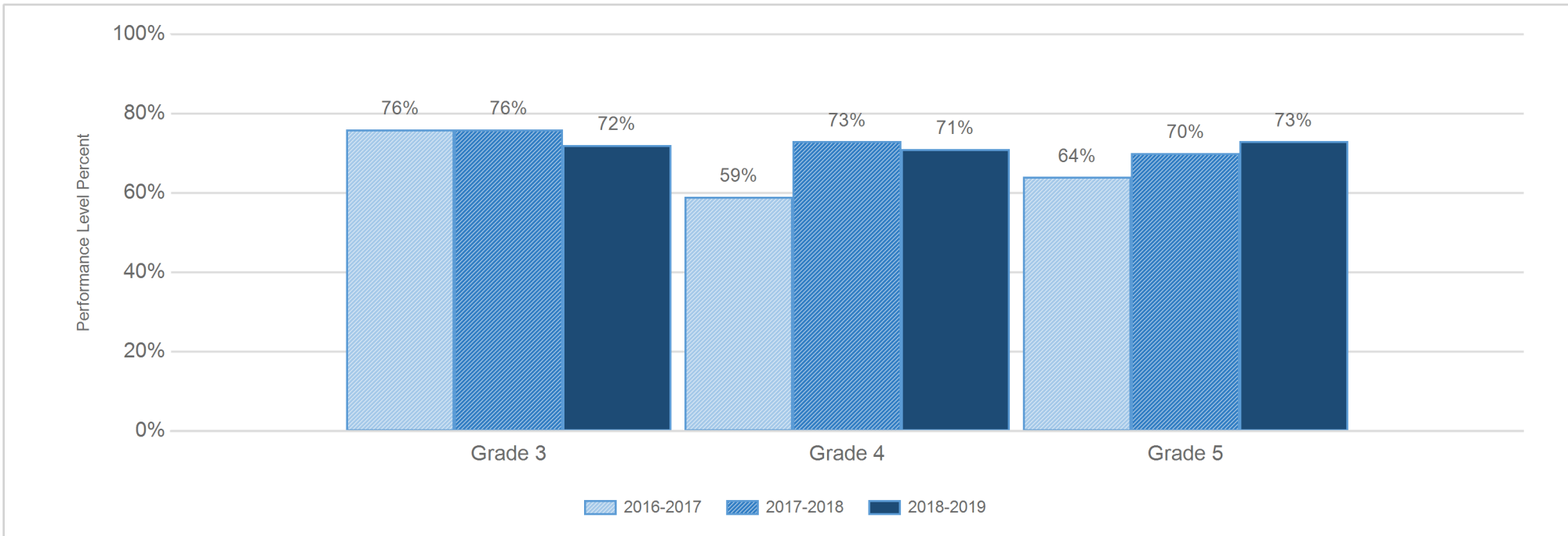

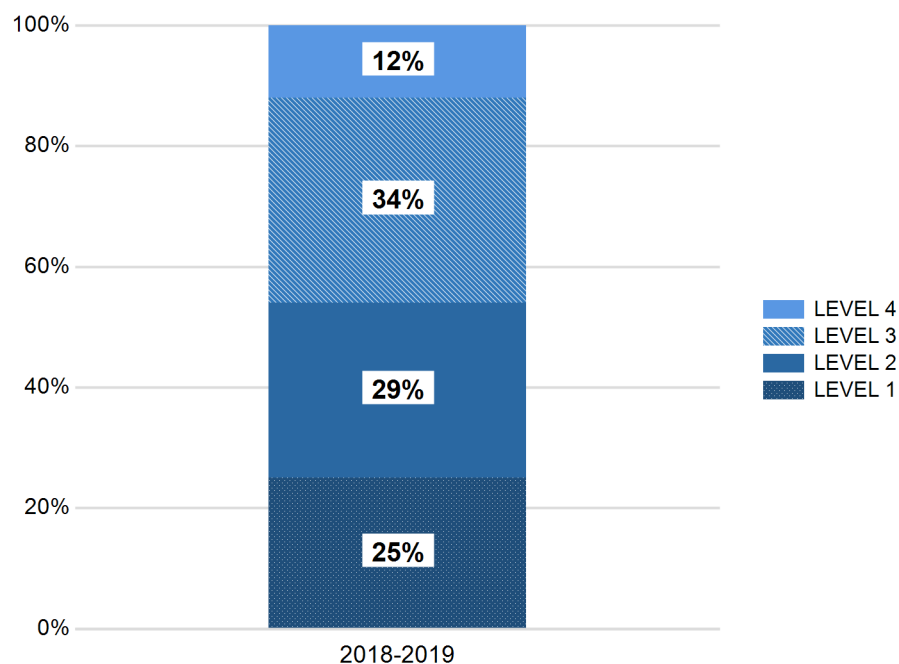

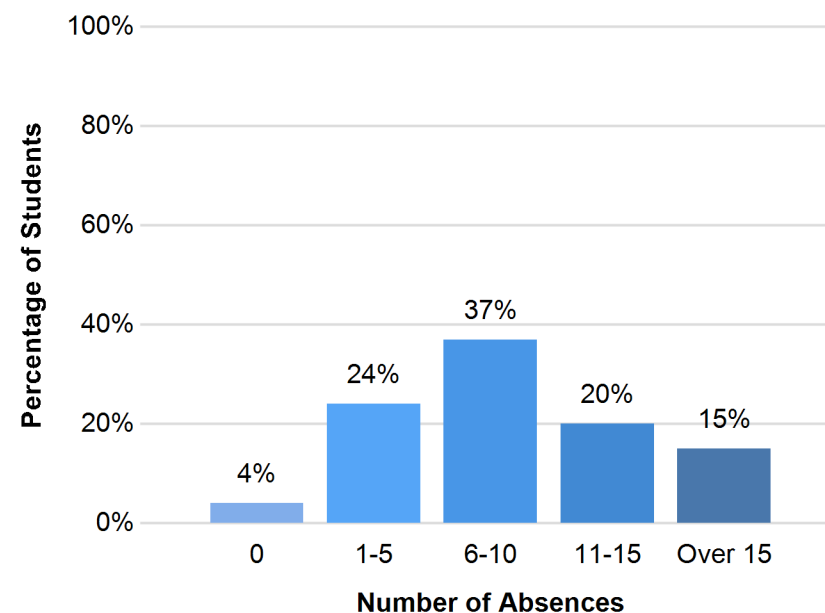

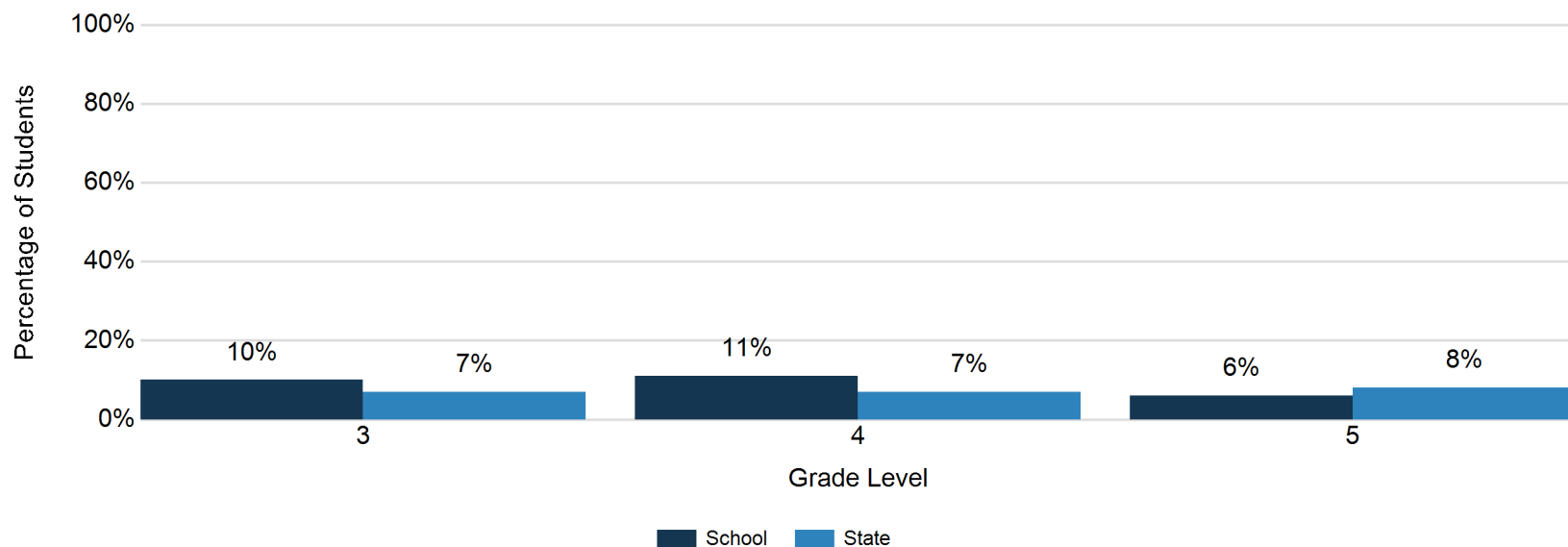

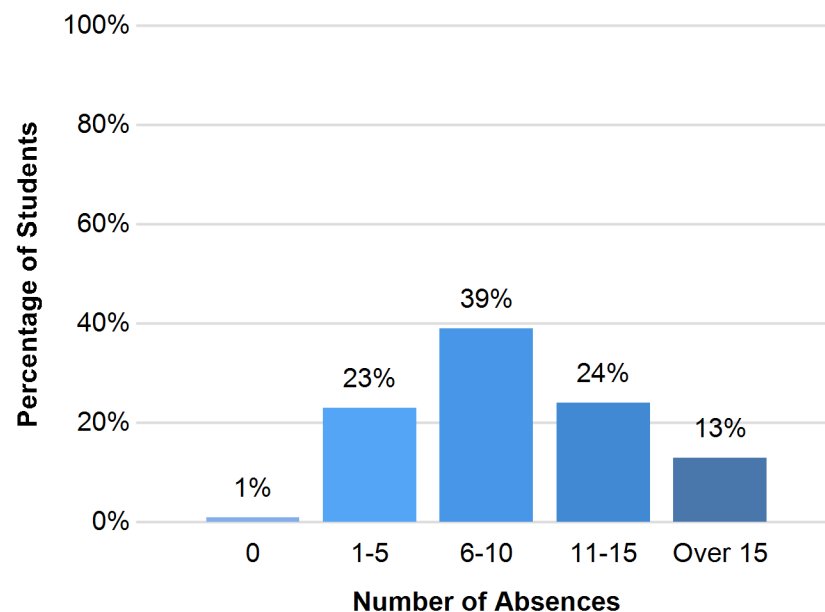

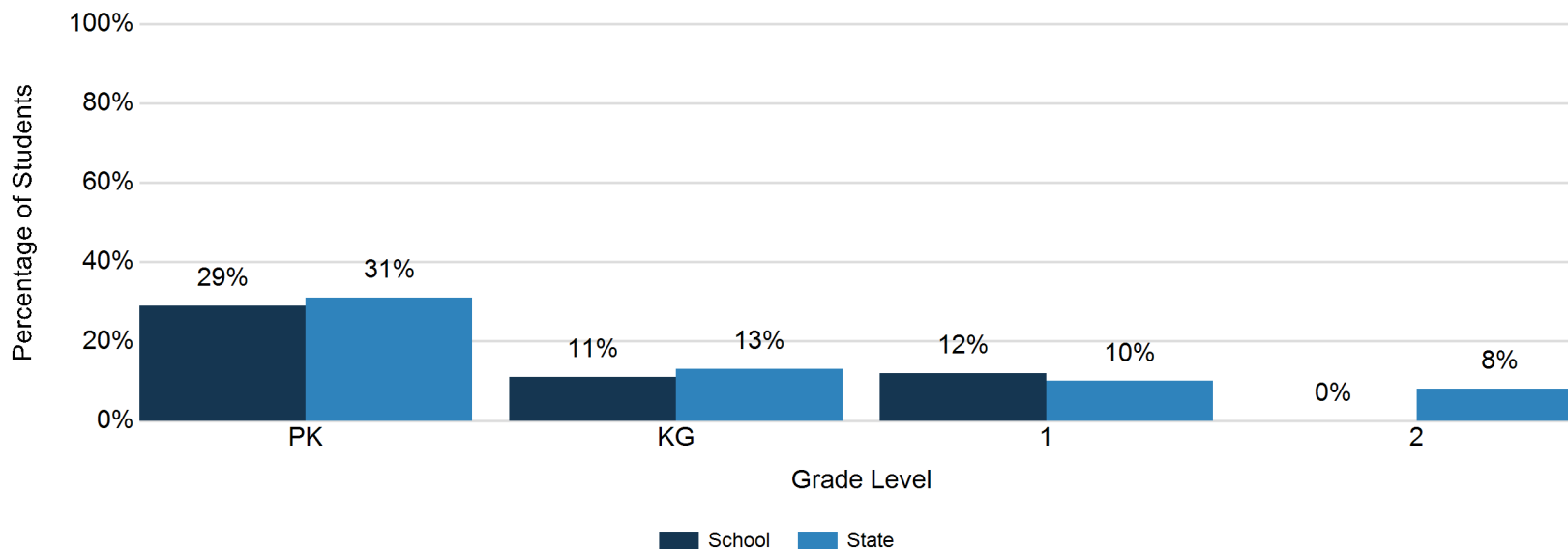
