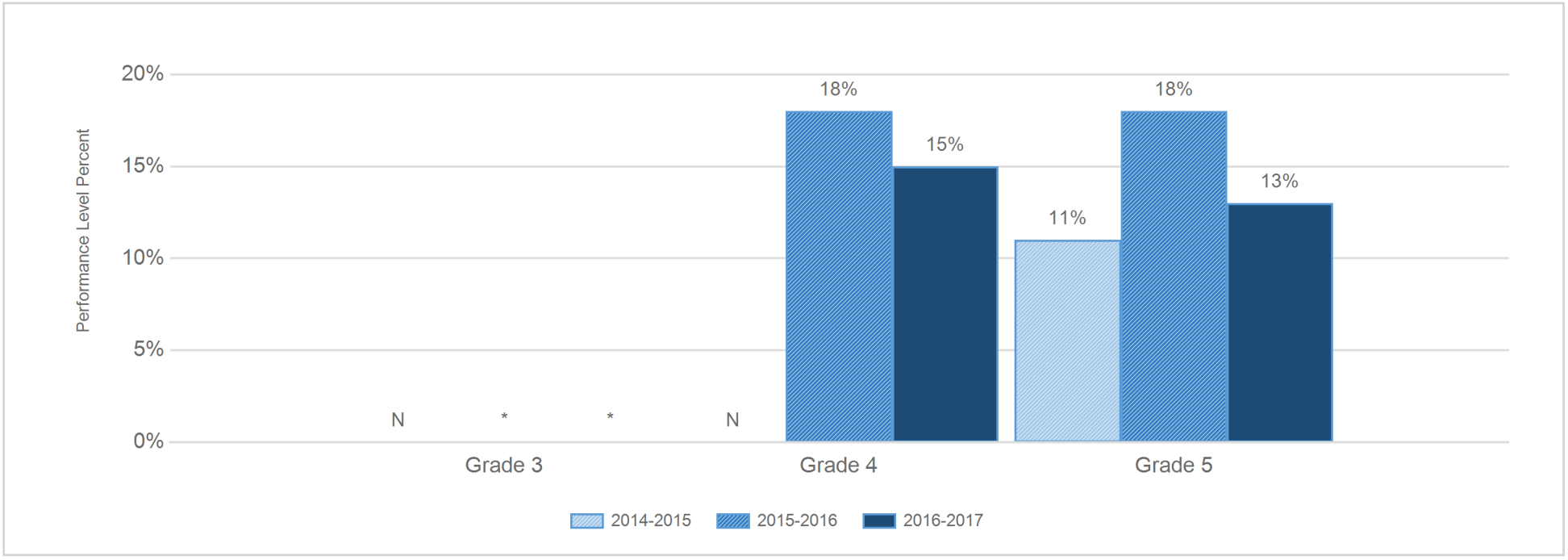

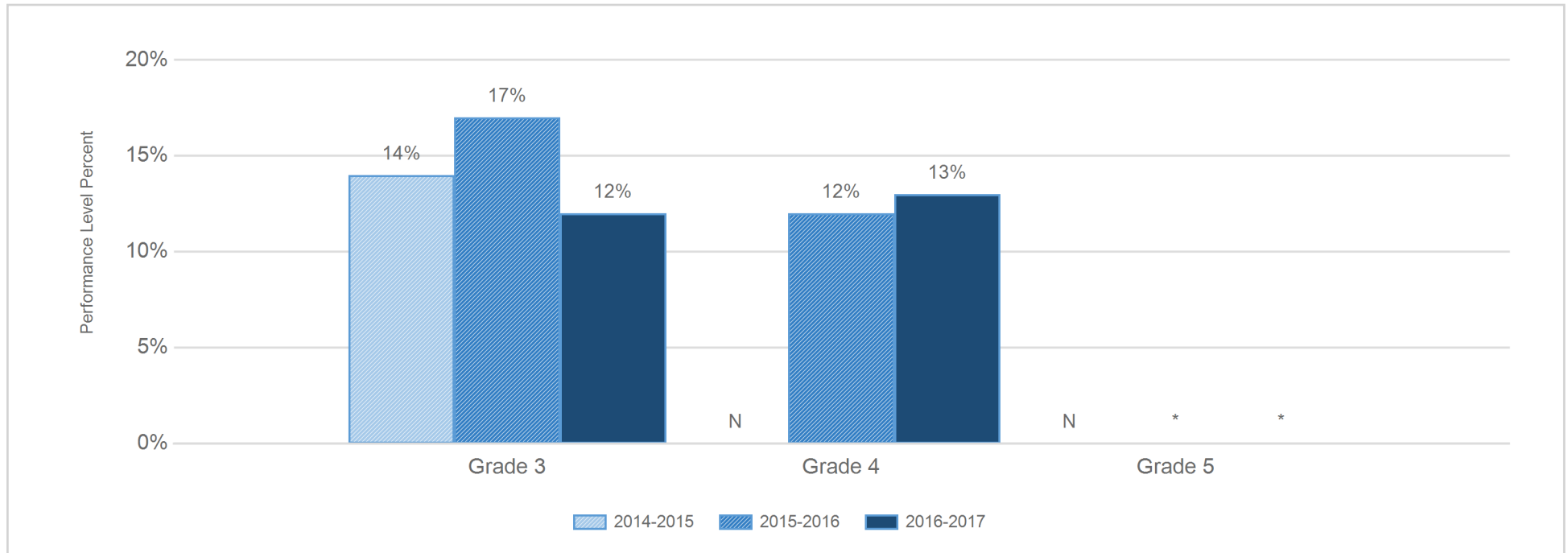

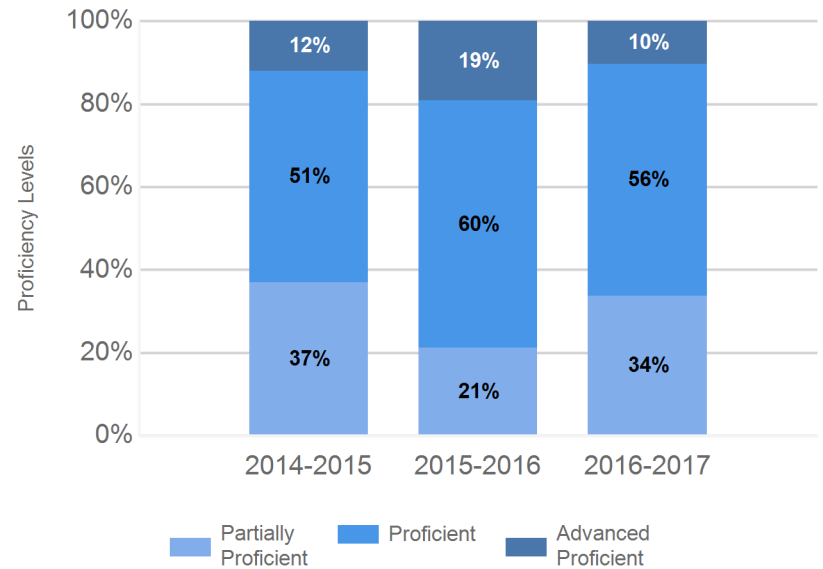

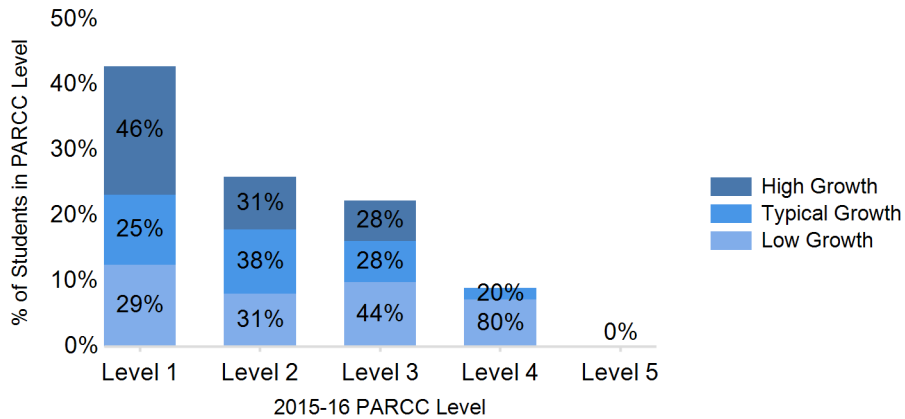

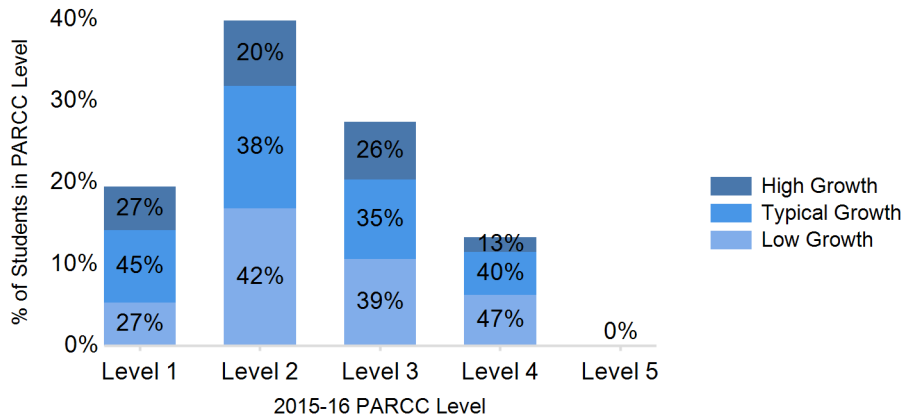

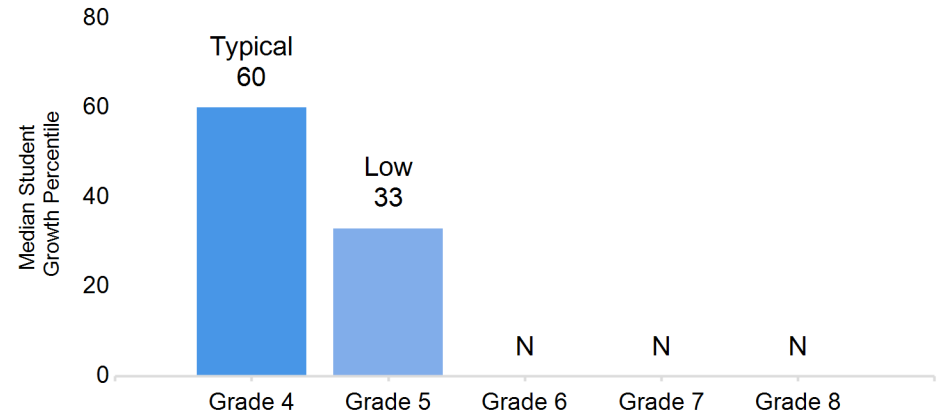

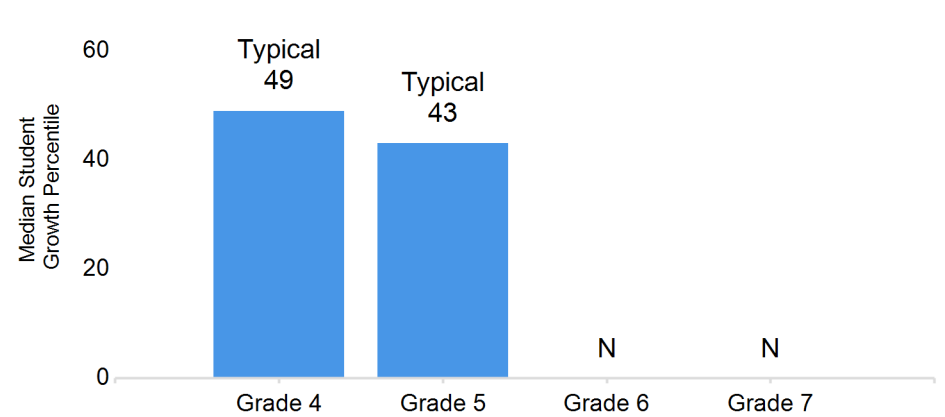
Student Growth by Grade

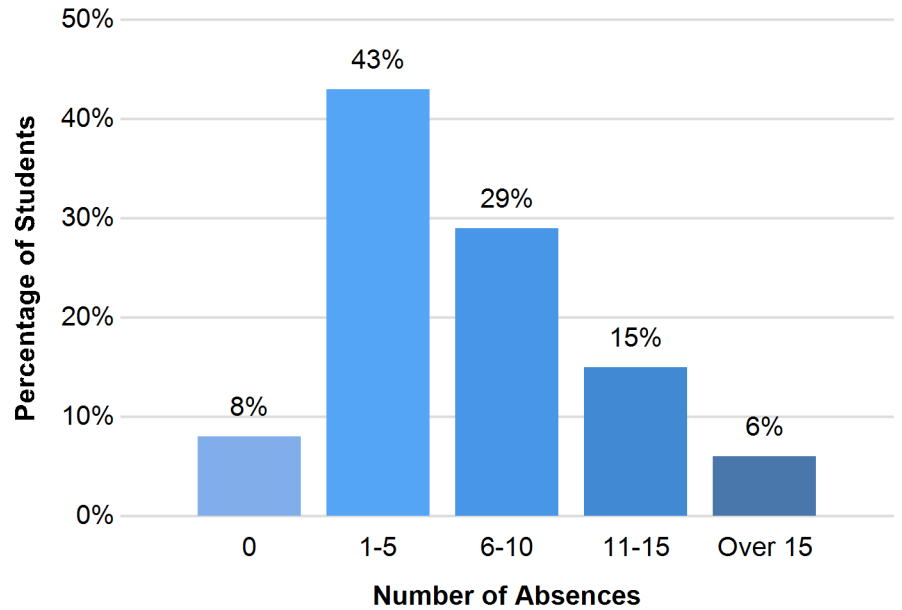

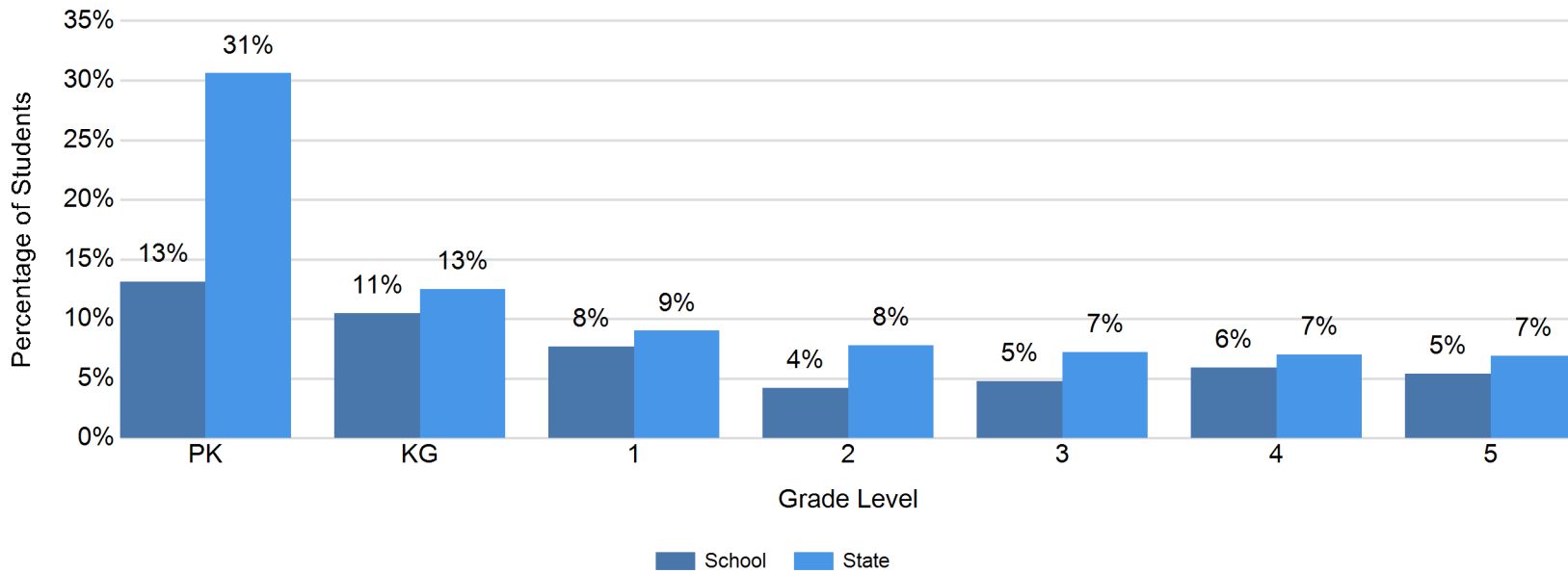

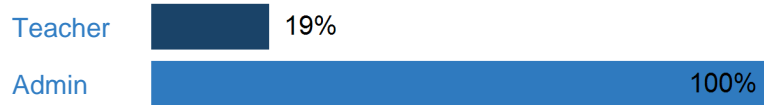

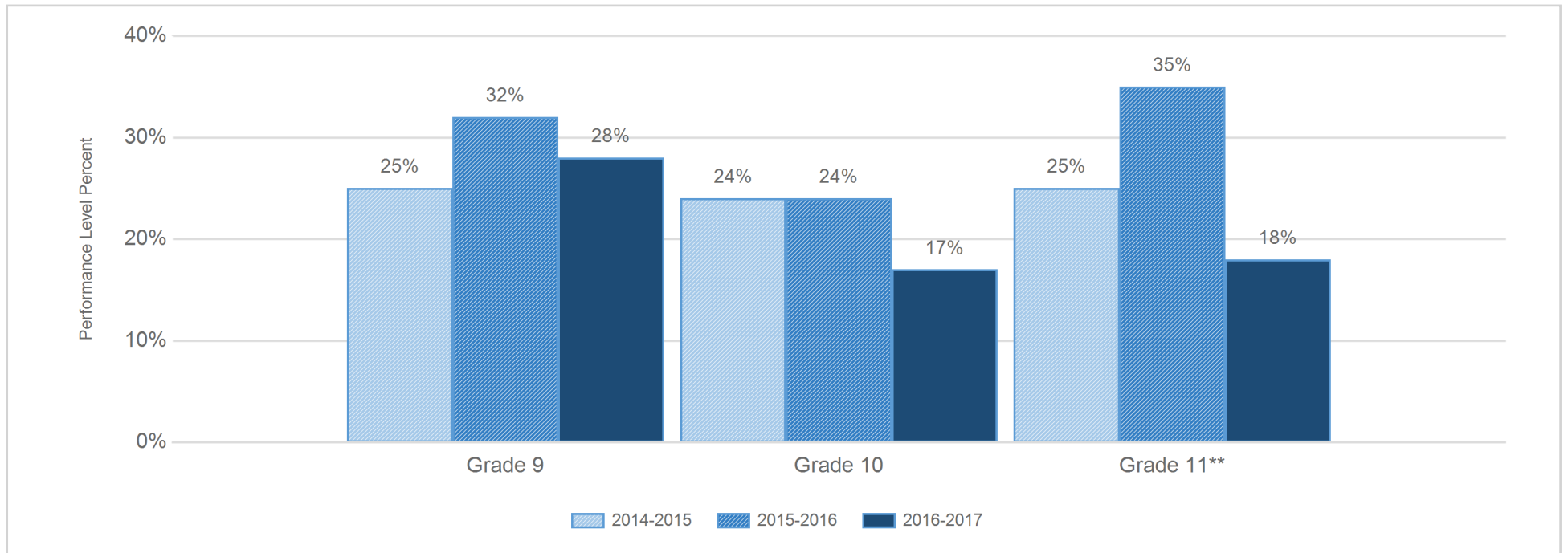

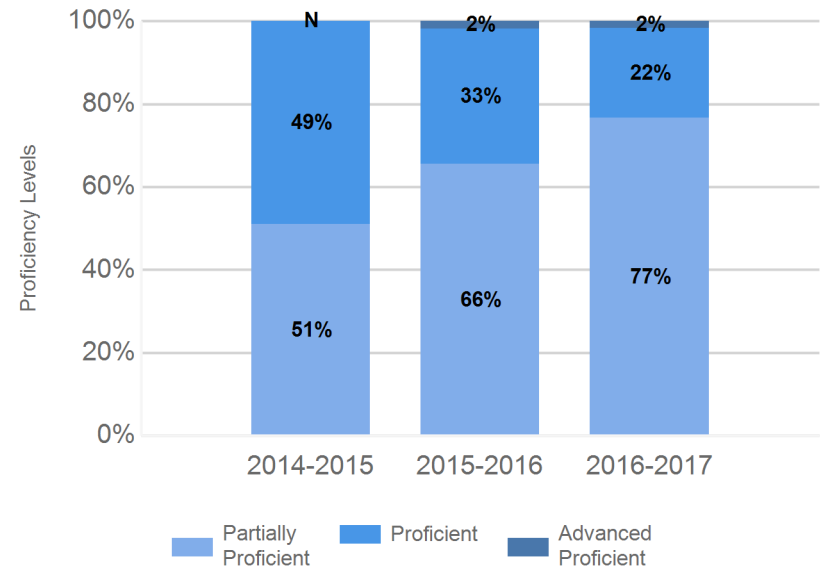

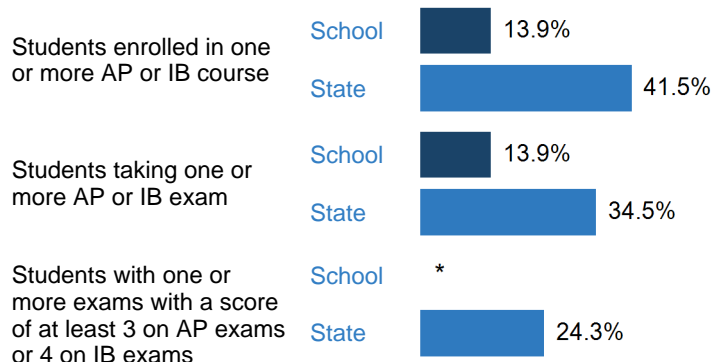

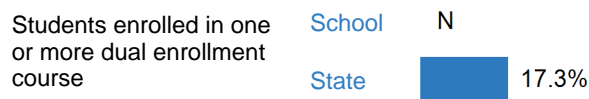

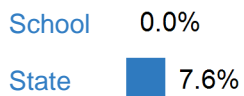

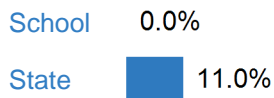

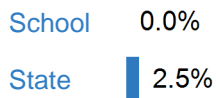

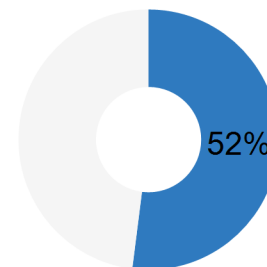

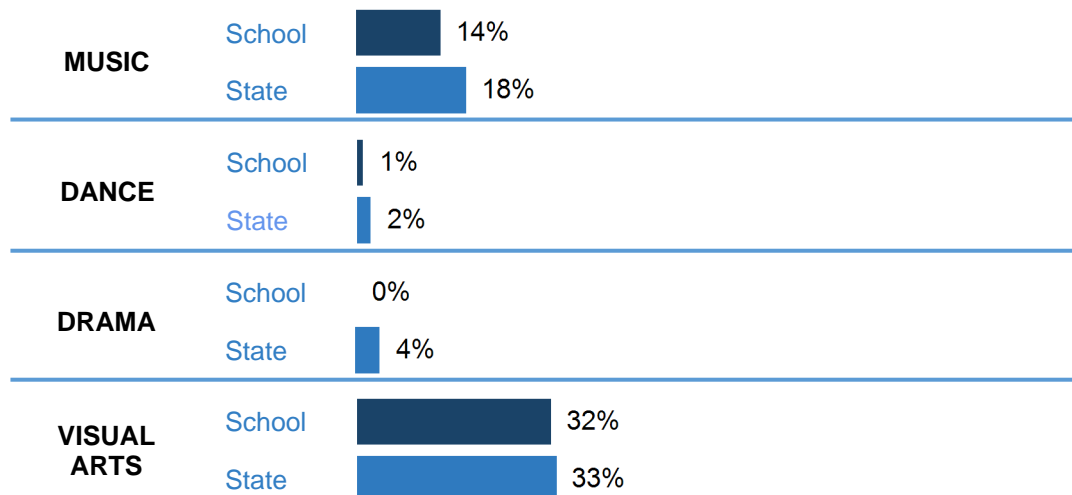

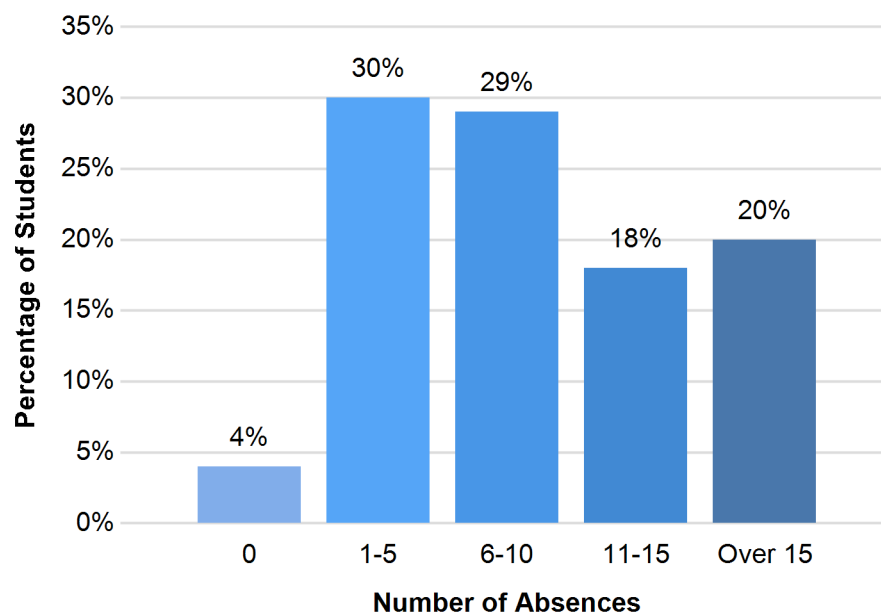

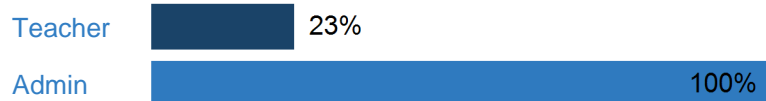

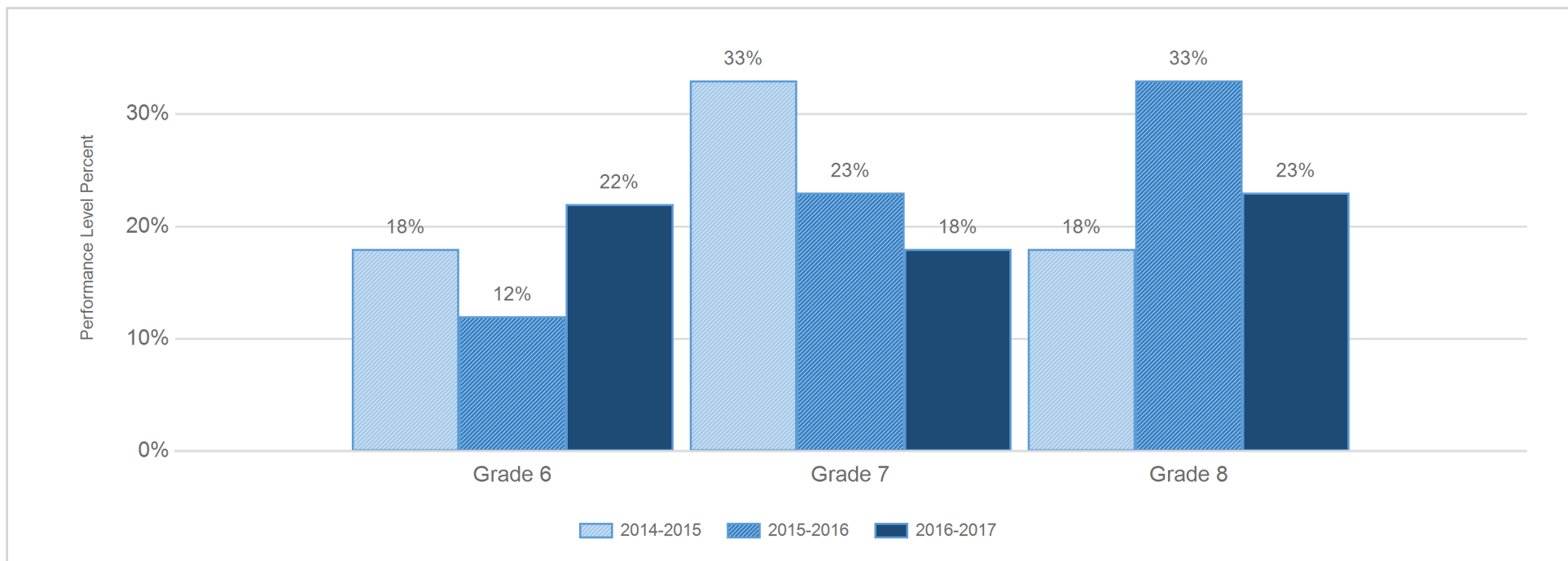

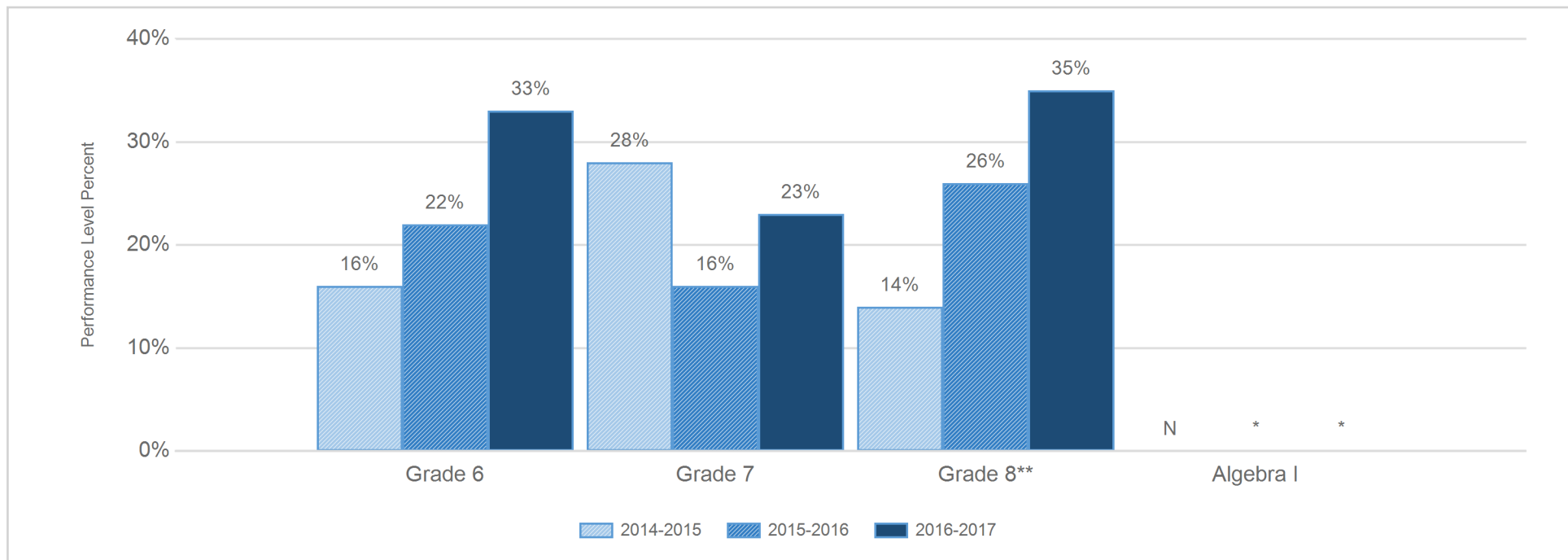

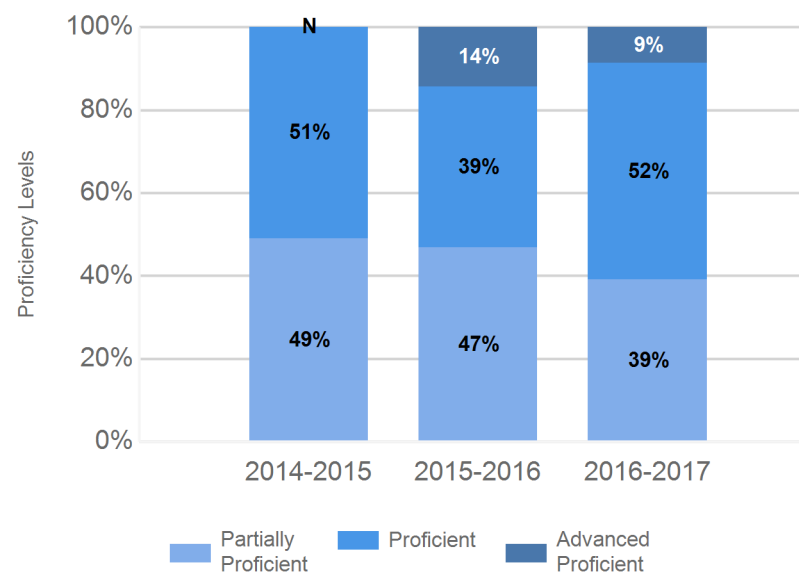

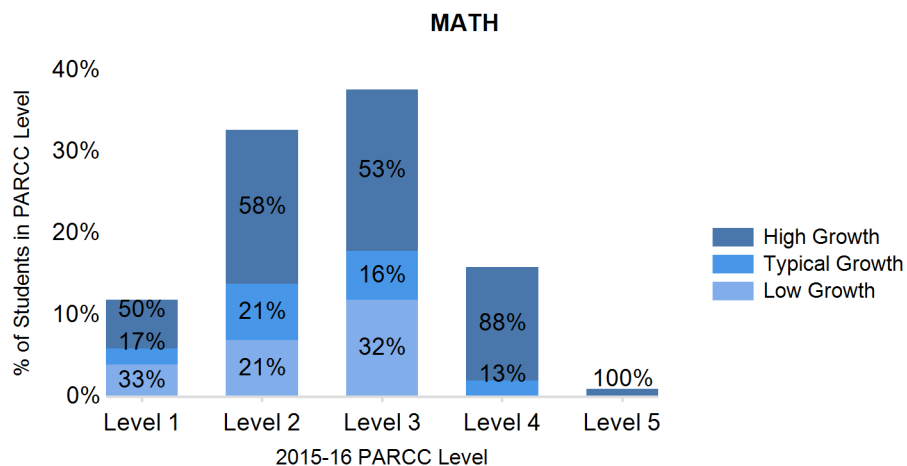

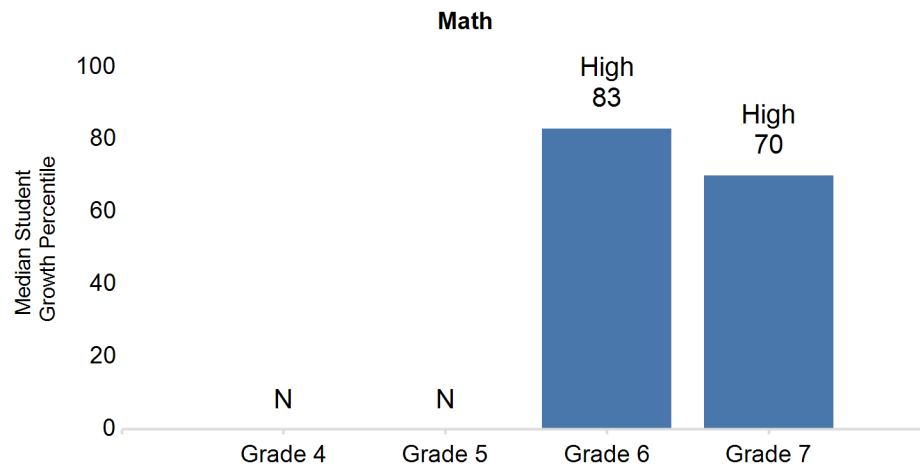
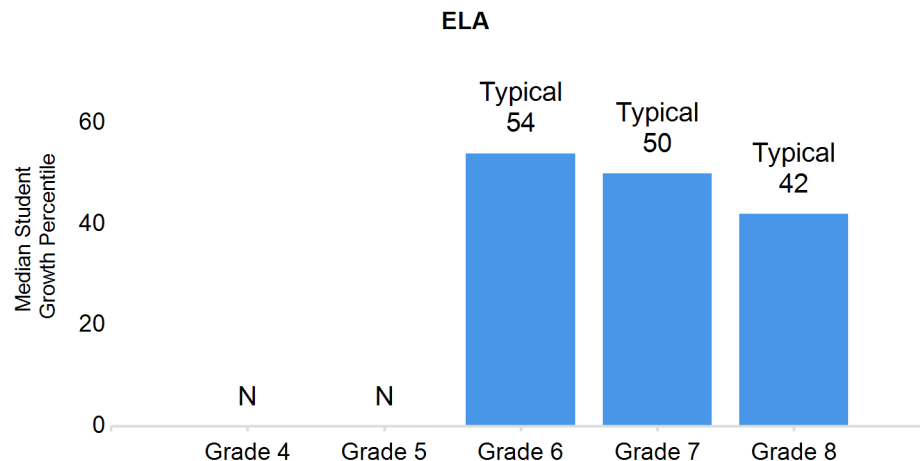

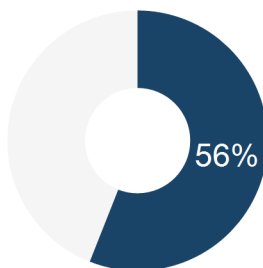

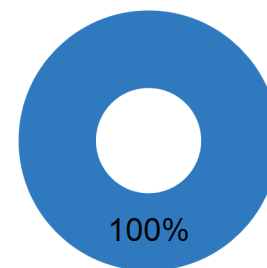

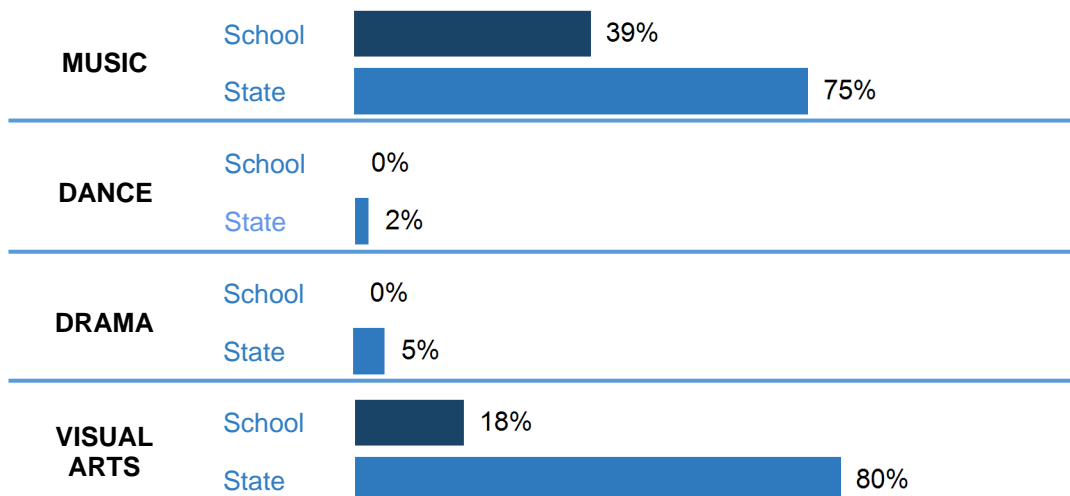

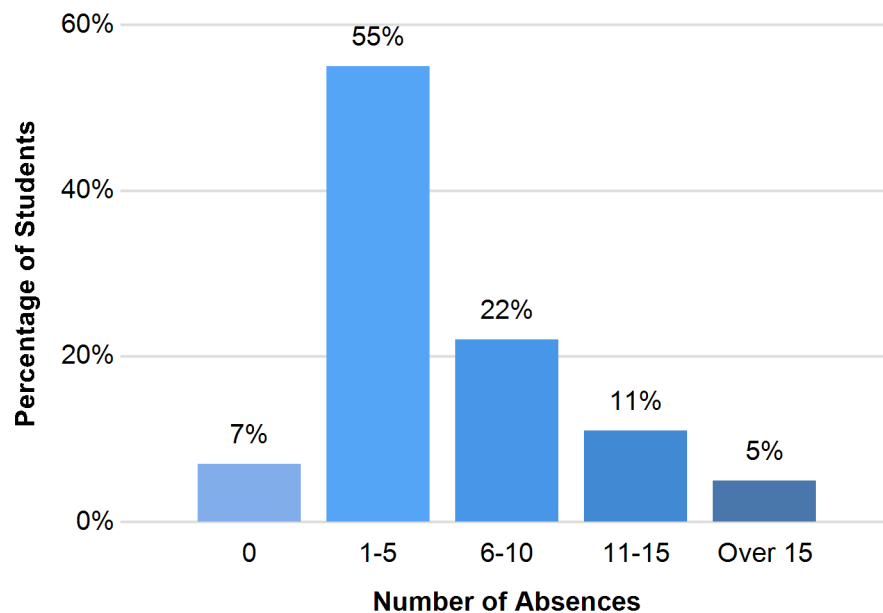

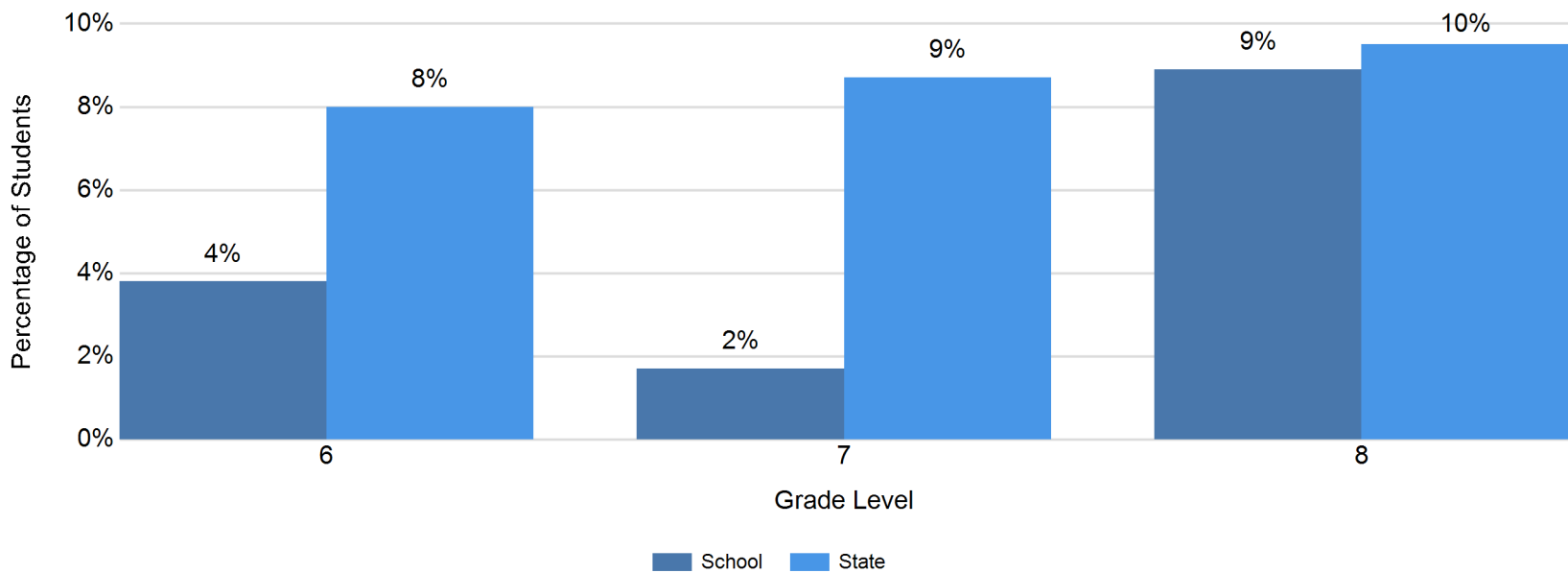
