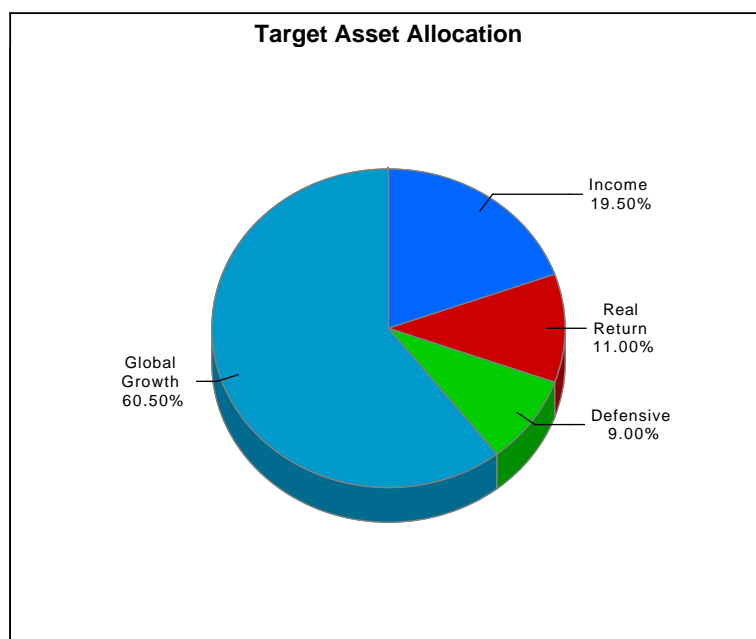
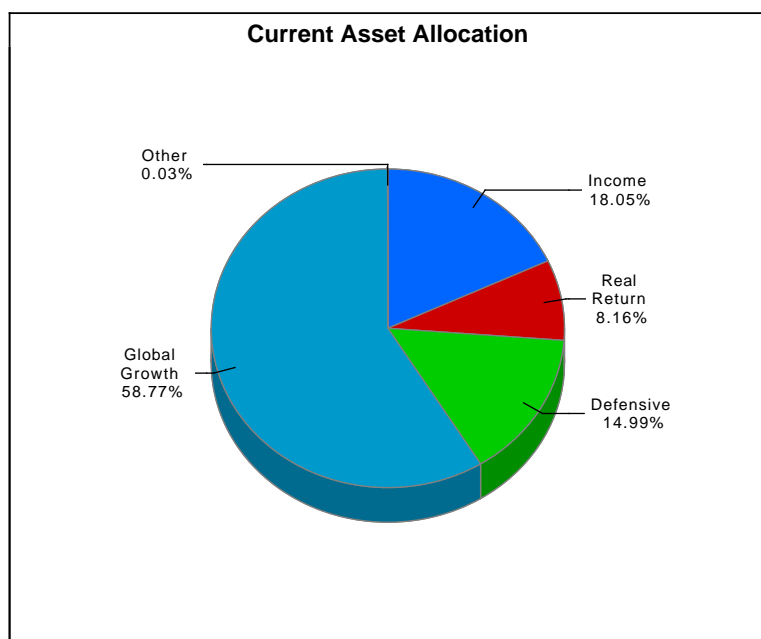

As of November 30, 2025**

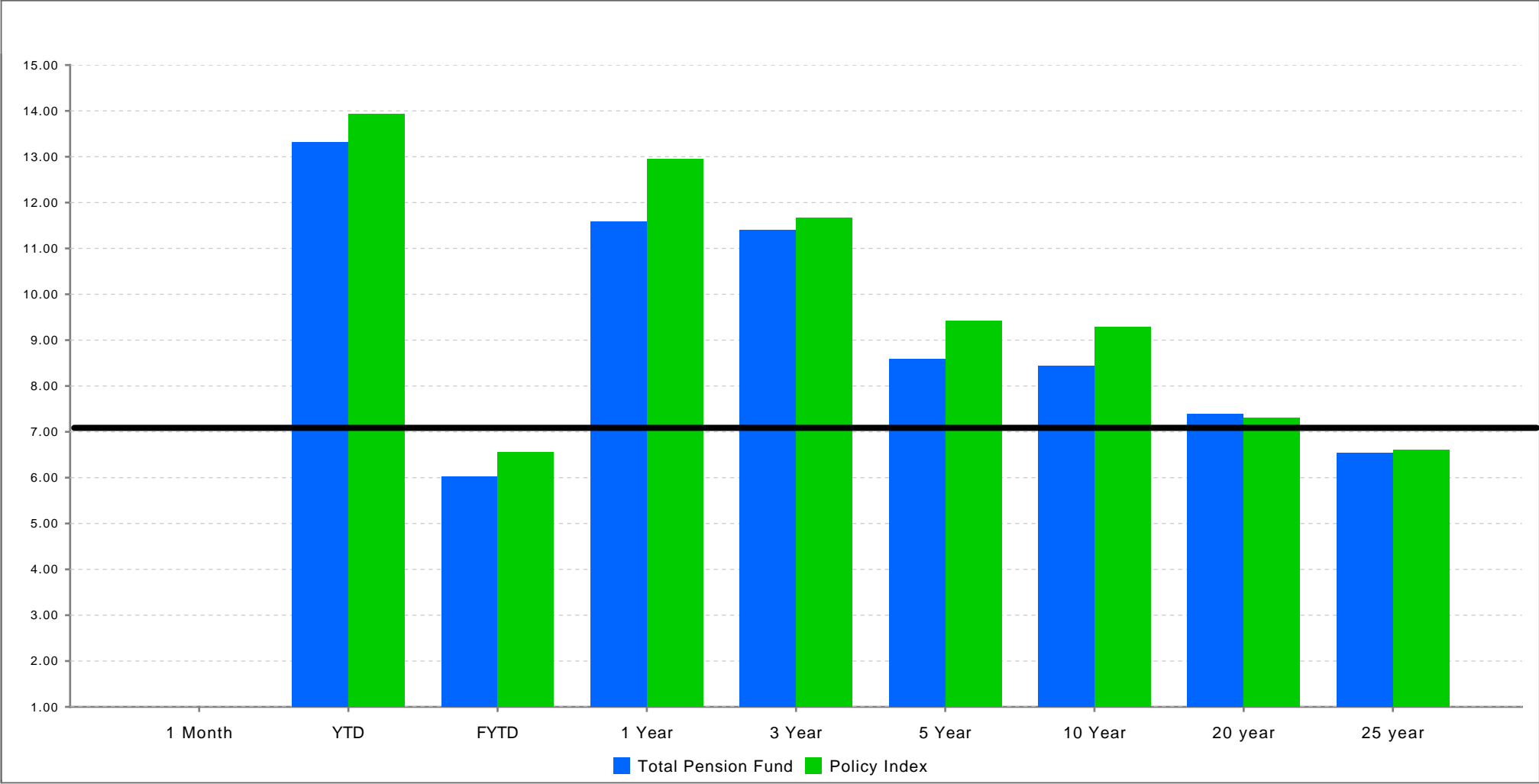

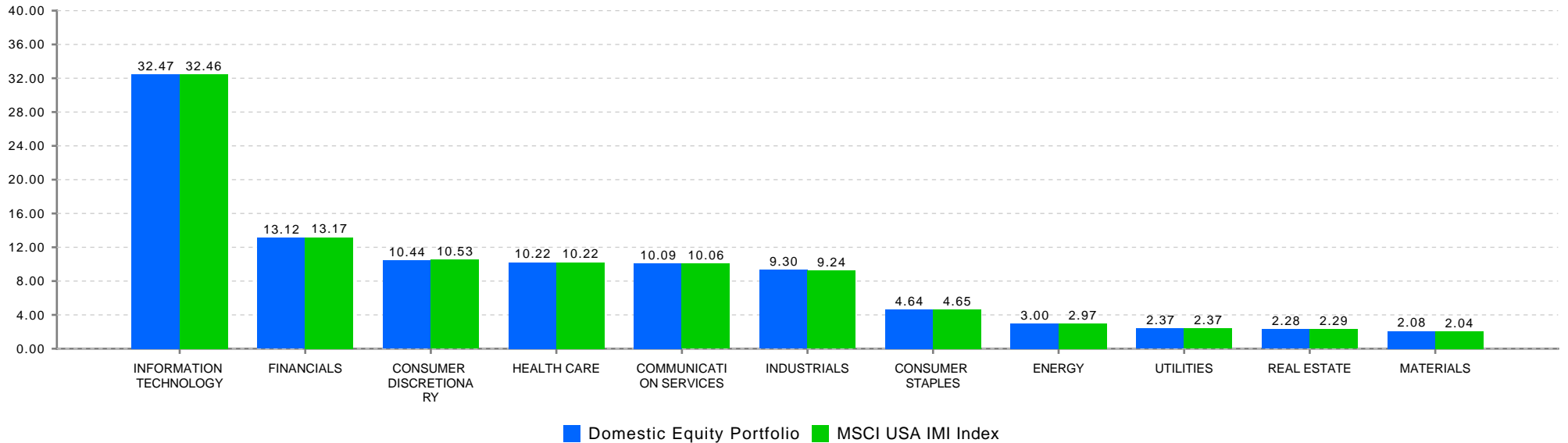

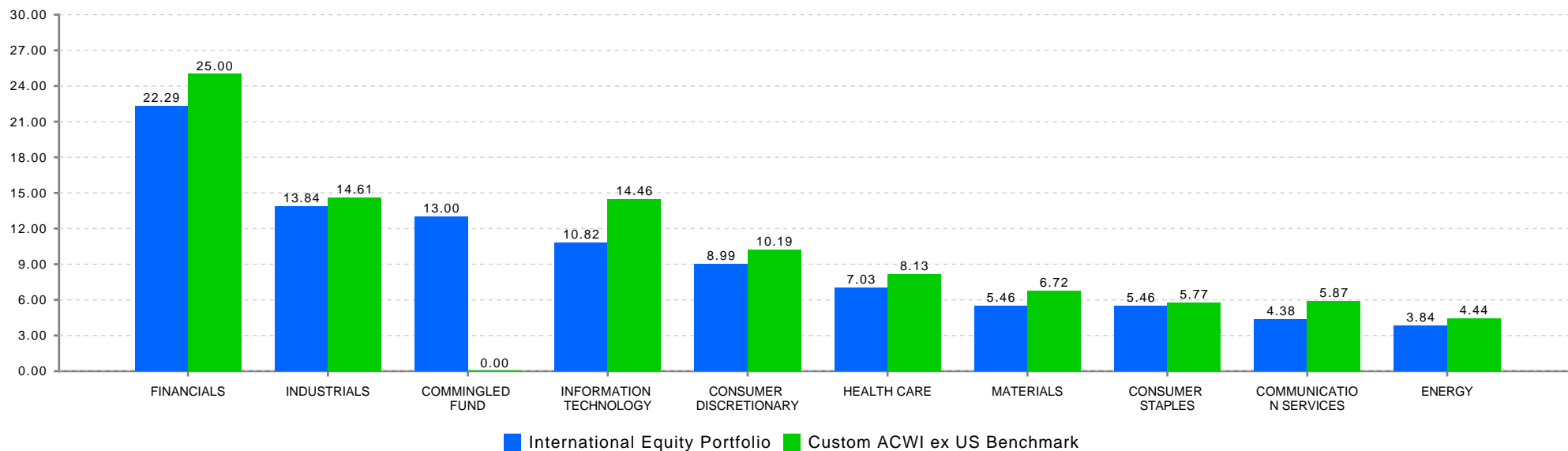

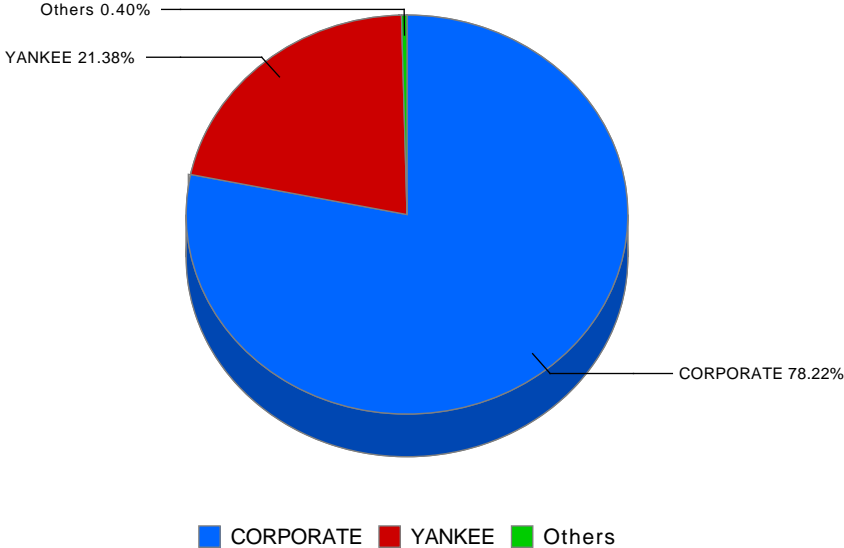
