overtaken vehicle may be passed when it is being driven at such a slow speed as to impede the normal and reasonable movement of traffic.

(c) The northbound shoulder (right-hand lane or curb lane) of Route 35 may be used by buses and is reserved therefor on Saturdays, Sundays and holidays from 3:00 P.M. to 11:30 P.M. from Faber Lane (milepost 7.9) in the Township of Brick, north to Herbert Street (milepost 10.0) in the Borough of Mantoloking, County of Ocean.

(I) Beginning at a point 1,535 feet north of the centerline of the most northerly intersection of Old Mill Road to a point 740 feet northerly therefrom (approximate mileposts 19.66 to 19.75).

(J) Beginning at a point 260 feet north of the centerline of Eighteenth Avenue to a point 360 feet northerly therefrom (approximate mileposts 19.83 to 19.91).

(2) Lane for left turn only:

(A) For both directions of traffic: Beginning at a point 190 feet south of the southerly curb line of Church Street to a point 210 feet north of the northerly curb line of Church Street.

(B) For both directions of traffic: Beginning at a point 105 feet south of the southerly curb line of Meeting House Road to a point 85 feet north of the northerly curb line of Meeting House Road.

(1) No stopping or standing:

(A) No person shall stop or stand a vehicle except in designated areas and between the painted lines.

(2) Handicapped parking:

(A) Locations as indicated on the site plans incorporated herein by reference as an appendix to this section shall be for handicapped parking. All stalls shall be 12 feet wide and signed with R-8 and R-8(p) (Reserved Parking and Penalty Plate).

(3) One-way streets:

(A) The one-way patterns and the hours of operation for these one-way patterns, for all roadways located on the Metropark Train Station are as indicated on the site plan incorporated herein by reference as an appendix to this section.

(4) One-way ramps:

(A) The one-way patterns for all ramps on all levels located in the parking garages and known as the east garage and west garage are as indicated on the site plan incorporated herein by reference as an appendix to this section.

(5) Bus stops:

(A) The area along the northerly curb line of the roadway, fronting the railroad terminal, beginning 25 feet from the westerly curb line of the pedestrian crosswalk and extending 360 feet westerly therefrom shall be for busses only.

(6) Taxis and livery stand:

(A) The area along the northerly curb line of the roadway fronting the railroad terminal, beginning 140 feet east of the easterly curb line of the pedestrian crosswalk and extending 100 feet easterly therefrom shall be for taxis and livery only.

(7) Mid-block crosswalk:

(A) The following described location shall be hereby designated as a mid-block crosswalk—beginning at a point 270 feet west of the westerly curb line of the north driveway and extending 10 feet westerly therefrom.

(8) Lane use reservations:

(A) The lane use reservations for the intersections of the east driveway at Middlesex-Essex Turnpike and the west driveway at Middlesex-Essex Turnpike are as indicated on the site plan incorporated herein by reference as an appendix to this section.

(9) Speed limits:

(A) The speed limit for the east driveway, west driveway and the roadway fronting the railroad terminal shall be 15 miles per hour.

(B) The speed limit for all levels of the east and west garage shall be five miles per hour.

(10) Through street:

(A) The east driveway-west driveway-roadway fronting railroad terminal shall be designated as a through street between the easterly and westerly intersection with Middlesex-Essex Turnpike. Stop signs shall be installed on all roadway and drive-ways that intersect the through street.

16:30-5.2 DOT headquarters

(a) Except as hereinafter provided, the operator of a vehicle shall not park the vehicle in any parking area constructed, owned and maintained at the Headquarters of the N.J.D.O.T. unless such vehicle is registered with a parking permit issued by the Division of Support Services.

(b) Applications for registration and parking permits shall be denied unless the names of those submitted are N.J.D.O.T. employees or are connected with the N.J.D.O.T. in some capacity at the Main Headquarters.

(c) Parking permits shall be serially numbered and shall indicate Parking Area. The permit will be designed for pasting and shall be pasted upon the inside of the rear window.

(d) No person shall counterfeit a parking permit or make a substitute or temporary permit, or use such a permit.

(e) To be valid, the parking permit must be on the car at all times while parked in designated parking areas.

(f) Records of all permits issued will be kept on file at the issuing agent's office.

(g) Vehicles parked in restricted areas may be towed away at owner's expense.

(h) Reserved parking spaces and handicapped spaces may be established within the various parking areas including areas for customer/visitor parking and will be properly marked by signs or markings and the operator of any vehicle using such areas will obey all reserved signs or markings.

(i) On special or emergency occasions any parking area may be designated as a closed area to permit holders. On such occasions proper notice will be given to permit holders as soon as possible and such notice will designate, providing there is space, another area available to them during such time.

(j) The operator of a vehicle shall not stop or stand the vehicle in the driveways or roadways marked with signs or any of the parking areas so as to interfere with the free and orderly movement of vehicles entering or leaving the areas.

(k) The operator of a vehicle will park said vehicle in a proper manner in the spaces marked and they shall not park the vehicle in any other space not so marked.

(l) The operator of a vehicle upon entering, remaining in or leaving the various parking areas will obey all traffic control devices and all Department designated officers that may be on duty at the time.

(m) The Department designated officer on duty in any of the parking areas may control the traffic and parking. All drivers of vehicles shall obey his orders and directions, notwithstanding anything contained in these rules.

(n) Parking permits may be revoked by the issuing agent at any time.

(o) Department employees in violation of these rules may be subject to Departmental disciplinary action as provided for in Departmental Policies and Procedures.

(p) As prescribed by Title 39:4-209 of the Revised Statutes, "Any person who shall violate any of the said regulations may be subject to a fine of not less than \$1.00 nor more than \$15.00."

(a) The following certain parts of State property along State highway Route 52 described in this section shall be designated and established as a Department of Transportation parking lot and restricted to the use of Department of Transportation personnel in the performance of their duty.

Along the northbound side, Beach Thorofare Bridge, Ocean City, Cape May County, beginning at the Thorofare Bridge northerly bulk head extending to a point 100 feet northerly therefrom and at a point eight feet east of the easterly lateral line of Route 52 and extending easterly to the adjacent right-of-way line.

16:30-5.4 Department of Transportation's Region 1 Facility

(a) The operator of a vehicle shall not park the vehicle in any portion of parking lot "A" constructed, owned and maintained at the Region 1 Facility of the New Jersey Department of Transportation unless such vehicle is registered with a parking permit issued by the Division of Support Services.

1. Applications for registration and parking permits shall be denied unless the names of those submitted are New Jersey Department of Transportation employees or are connected with the New Jersey Department of Transportation, in some capacity at the Region 1 Facility.

2. Parking permits shall be serially numbered and shall indicate parking area. The permit will be designed for pasting and shall be pasted upon the inside of the rear window.

3. No person shall counterfeit a parking permit or make a substitute or temporary permit, or use such a permit.

4. To be valid, the parking permit must be on the car at all times while parking in designated parking areas.

5. Records of all permits issued shall be kept on file at the Office of the Division of Support Services.

6. On special or emergency occasions, any parking area may be designated as a closed area to permit holders. On such occasions, proper notice will be given to permit holders as soon as possible and such notice will designate, providing there is space, another area available to them during such time.

7. Parking permits shall be revoked by the Office of the Division of Support Services at any time when the employee fails to comply with this rule.

8. Department employees, in violation of these rules, may be subject to Department disciplinary action as provided for in the Department Policies and Procedures.

9. Department employees, not assigned to the Region 1 Facility of the New Jersey Department of Transportation, shall sign in and this "signing in process" shall serve as a temporary one-day registration.

10. In accordance with N.J.S.A. 39:4-209, any person in violation of this section will be subject to a fine of not less than \$1.00 nor more than \$15.00; provided, however, that any person who shall violate any of said regulations concerning the altering, counterfeiting or misuse of park-

ing permits shall be subject to a fine of not more than \$50.00.

(b) The operator of a vehicle shall conform to the following various traffic regulations in parking area "A" constructed, owned and maintained at the Region 1 Facility of the New Jersey Department of Transportation:

1. The operator of a vehicle shall park said vehicle between the painted lines in the spaces marked, and they shall not park the vehicle in any other space not so marked.

2. Reserved parking spaces and handicapped spaces may be established within parking area "A," including areas for customer/visitor parking and shall be properly marked by signs or markings. The operator of any vehicle using such areas shall obey all reserved signs or markings.

3. The operator of a vehicle shall not stop or stand the vehicle in the driveways or roadways marked with signs or any portion of parking area "A" so as to interfere with the free and orderly movement of vehicles entering or leaving parking area "A."

4. The operator of a vehicle upon entering, remaining in or leaving parking area "A" shall obey all traffic control devices and all Department designated officers that may be on duty at the time.

5. The Department designated officer on duty in parking area "A" may control the traffic and parking. All drivers of vehicles shall obey his or her orders and directions, notwithstanding anything contained in this section.

6. Vehicles parked in restricted areas without proper identification or in violation of any portion of this regulation shall be towed, at the owner's expense, when the enforcing authority deems it necessary in the interest of traffic safety.

(c) The operator of a vehicle shall conform to the following various traffic regulations in parking area "B" constructed, owned and maintained at the Region 1 Facility of the New Jersey Department of Transportation designated as a "Park and Ride."

1. The operator of a vehicle shall park said vehicle between the painted lines in the spaces marked, and they shall not park the vehicles in any other space not so marked.

2. Reserved parking spaces and handicapped parking spaces may be established within parking area "B," including areas for customer/visitor parking and shall be properly marked by signs or markings, and the operator of any vehicle using such areas shall obey all signs or markings.

3. The operator of a vehicle shall not stop or stand the vehicle in the driveways or roadways marked with

signs in parking area "B" so as to interfere with the free and orderly movement of a vehicle entering or leave parking area "B."

4. The operator of a vehicle upon entering, remaining or leaving parking area "B" shall obey all traffic control devices and all Department designated officers that may be on duty at the time.

5. The Department-designated officer on duty in parking area "B" may control the traffic and parking. All drivers of vehicles shall obey his or her orders and directions, notwithstanding anything contained in these rules.

6. Vehicles parked in restricted areas without proper identification or in violation of any portion of this regulation shall be towed at the owner's expense when the enforcing authority deems it necessary in the interest of traffic safety.

(B) The bus loop driveway intersecting the "U" turn ramp-driveway of the Route U.S. 46 Park and Ride Facility shall be designated as a one-way in the direction of Route U.S. 46 eastbound to Route U.S. 46 westbound.

(C) Loop road shall be designated as a one-way street in a counterclockwise direction beginning at its easterly intersection with the "U" turn ramp driveway and ending at its easterly intersection with the "U" turn ramp driveway.

(4) Busses only:

(A) The loop driveway intersecting the "U" turn ramp-driveway shall be used for busses only.

(5) The intersection of loop road and the "U" turn ramp driveway is a stop intersection with the stop sign(s) on loop road.

(6) Mid-block crosswalk:

(A) The following described locations are hereby designated as mid-block crosswalks.

(I) Beginning at a point 88 feet east of the loop driveway—"U" turn ramp-driveway and extending 10 feet easterly therefrom.

(II) Beginning at a point 140 feet east of the loop driveway—"U" turn ramp-driveway and extending 10 feet easterly therefrom.

(4) One way streets: The following streets and lanes are hereby described as one way streets and lanes in the direction indicated.

(A) Lane No. 1—northbound—entire length.

(B) Lane No. 2—southbound—entire length.

(C) Lane No. 3—northbound—entire length.

(D) Lane No. 4—southbound—entire length.

(E) Ring Road—counterclockwise—between the southerly end of Lane No. 2 and Main Entrance Road.

(5) Through streets: The following streets are hereby designated as through streets. Stop signs shall be installed on the near right side of every street intersecting the through street except where yield signs are provided for:

(A) Ring Road: Between the northerly curb line of Main Entrance Road to the southerly curb line of Main Entrance Road.

(6) Stop intersections: The following intersections are hereby designated as stop intersections. Stop signs shall be installed as provided herein:

(A) The intersection of Lane No. 1 and Main Entrance Road is a stop intersection with a stop sign(s) on Lane No. 1.

(B) The intersection of Lane No. 2 and Main Entrance Road is a stop intersection with a stop sign(s) on Lane No. 2.

(C) The intersection of Ring Road and Main Entrance Road is a stop intersection with a stop sign(s) on Ring Road (for both approaches).

(7) Speed limit(s): The speed limit for vehicles shall be 15 miles per hour within the entire complex known as Avandale Park-n-Ride.

(C) Drive "B" in an easterly direction from the center of the curve radius of Main Access Road/Drive "B" to its terminus (merge) with southbound Route U.S. 9.

(D) Parking Lane No. 1 in a north/easterly direction from Drive "B" to Main Access Road.

(E) Parking Lane No. 2 in a north/easterly direction from Drive "B" to Main Access Road.

(F) Parking Lane No. 3 in a north/easterly direction from Drive "B" to Main Access Road.

(4) The speed limit will be 15 miles per hour throughout the entire complex.

(5) Bus stops: Along Main Access Road (west-bound) on the northerly side at Parking Lane No. 1 (far side) beginning at the easterly curb line of Parking Lane No. 1 and extending 100 feet westerly therefrom.

16:30-7.4 Interstate highways

(a) It has been found and determined that the health, safety and welfare of the public require that the use of all Interstate highways in the State of New Jersey be limited to certain classes of traffic.

(b) The following definitions are furnished to clarify the provisions of this rule:

"Commissioner" means the Commissioner of the Department of Transportation.

"Interstate highway" means, for purposes of this regulation, those highways constructed or being constructed within this State and approved by the Secretary of Transportation of the United States as an official portion of the National System of Interstate and Defense Highways pursuant to the provisions of Title 23, "Highways" of the United States

Code, as amended. The traveled way and all land on both sides of the travelled way extending to an abutting owner's property lines is considered part of the Interstate highway.

"Pedestrian" means, for purposes of this regulation, persons walking, running, standing, sitting, or any form of loitering. (Individuals involved in Department approved Adopt-A-Highway Programs, Inmate Litter Pick-up Programs, or any other Department approved program are not considered pedestrians, for purposes of this rule.)

(c) The use of the aforesaid Interstate highways by the following classes of traffic is prohibited unless permission therefor has been obtained in advance from the Commissioner for the classes of traffic identified in (c)3 or (c)6 below:

1. Pedestrians;

2. Animals led, ridden or driven;

3. Bicycles;

4. Non-motorized vehicles (including, but not limited to, skateboards and rollerblades);

5. Motorized bicycles including, but not limited to, snowmobiles and all terrain vehicles;

6. Tractors, rollers and agricultural or construction machinery, self-propelled or towed.

(d) The following traffic is exempt from the provisions of this regulation:

1. NJDOT equipment;

2. Equipment of contractors engaged by the NJDOT for construction or maintenance operations;

3. Equipment of a public utility company as defined in N.J.S.A. 48:2-13;

4. Equipment involved in emergency operations.

(e) Any person guilty of violating a provision of this chapter shall be liable to a fine of \$100.00 for each day of such violation and the cost of prosecution to be recovered by a civil action in the name of the State before any court of competent jurisdiction, by the Commissioner of Transportation.

(1) All ramps and roadways within the Route I-295 Rest Area are hereby designated as One-Way Streets, in the direction indicated on Site Plan 295 (MP 2.1 to 4.0), which is part of these regulations.

iv. Handicapped Parking:

(1) Locations as indicated on Site Plan 295 (MP 2.1 to 4.0) which is part of these regulations, shall be for Handicapped Parking. All vehicles shall be properly identified.

2. In Springfield Township, Burlington County:

i. No stopping or standing:

(1) No person shall stop or stand a vehicle at any time upon the roadways of the Route I-295 Rest Areas, except in designated areas between the painted lines.

ii. One-Way Streets:

(1) All ramps and roadways within the Route I-295 Rest Areas are hereby designated as One-Way Streets, in the direction indicated on Site Plan 295 (MP 49.5 to 50), which is part of these regulations.

iii. Handicapped Parking:

(1) Location as indicated on Site Plan 295 (MP 49.5 to 50) attached to and made a part of this regulation, shall be for Handicapped Parking. All vehicles shall be properly identified.

(A) The use of the Route I-295 Scenic Overlook is hereby prohibited to all vehicles over five tons G.V.W. (10,000 pounds), except that the following vehicles are exempt from the provisions of this restriction:

(I) Emergency vehicles; and

(II) Maintenance or service vehicles actually engaged in the inspection, maintenance or reconstruction of the Route I-295 Scenic Overlook.

(4) Closing of the Route I-295 Scenic Overlook:

(A) No person shall enter upon the area known as the Route I-295 Scenic Overlook between the hours of dusk and dawn.

SUBCHAPTER 12. TRUCK WEIGH STATIONS ON THE INTERSTATE HIGHWAY SYSTEM

16:30-12.1 Truck Weigh Stations established

(a) The Commissioner is authorized, pursuant to the provisions of N.J.S.A. 27:1A-5 and 27:1A-7, to establish Truck Weigh Stations on the Interstate Highway System of this State at such locations as he or she deems appropriate and does hereby establish the following Truck Weigh Stations:

1. Interstate 78, Section 6(c), located in Greenwich Township, Warren County, at or about milepost 4.1 eastbound;
2. Interstate 80, Section 1AJ, located in Knowlton Township, Warren County, at or about milepost 2.3 eastbound;
3. Interstate 287, Section 2K, located in Piscataway Township, Middlesex County, at or about milepost 4.7, northbound;
4. Interstate 295, Section 1AM, located in Carneys Point Township, Salem County, at or about milepost 3.6, northbound.

i. The following traffic regulations shall be made a part of the traffic regulations to be enforced at the Truck Weigh Station located on Interstate 295, Section 1AM, in Carneys Point Township, Salem County, at or about milepost 3.6, northbound:

- (1) All vehicles shall park in designated areas and between the lines provided.
- (2) No person shall stop or stand a vehicle at any time along both sides of any roadway located in the confines of the Truck Weigh Station.
- (3) All stalls, for handicapped parking, shall be 12 feet wide and signed with R7-8 and R7-8p (Reserved Parking and Penalty Plate), in the designated parking areas for persons who have been issued the handicapped parking permit by the Division of Motor Vehicles.

(4) Pursuant to N.J.S.A. 39:4-140, the streets or parts of streets, as indicated on the site plan incorporated herein by reference as an Appendix to this section, are hereby designated as through streets. Stop signs shall be installed on the near right side of each street intersecting the through street except where yield signs are provided for the designation.

(A) Road "A" shall be designated as a through street for its entire length.

(5) Pursuant to N.J.S.A. 39:4-140, the following described intersections, as indicated on the site plan in the section Appendix, are hereby designated as stop intersections:

(A) The intersection of Road "C" and Scale Road; stop sign(s) shall be installed on Road "C."

(6) Pursuant to N.J.S.A. 39:4-140, the following described intersections, as indicated on the site plan in the section Appendix, are hereby designated as yield intersections:

(A) The intersection of Road "B" and Lot "A"; yield sign(s) shall be installed on Lot "A."

(B) The intersection of Road "B" and Road "A"; yield sign(s) shall be installed on Road "A."

(C) The intersection of Road "B" and Lot "B"; yield sign(s) shall be installed on Lot "B."

(7) The following described streets and parking lots, as indicated on the site plan in the section Appendix, are hereby designated as one-way streets.

(A) Entrance Drive "A" shall be designated as a one-way in a westerly direction for its entire length.

(B) Entrance Drive "B" shall be designated as a one-way in a westerly direction for its entire length.

(C) Scale Road shall be designated as a one-way in a westerly direction for its entire length.

(D) Road "A" shall be designated as a one-way in a clockwise movement for its entire length.

(E) Road "B" shall be designated as a one-way in an easterly direction for its entire length.

(F) Lots "A" and "B" shall be designated as a one-way in an easterly direction for their entire length.

(G) Road "C" shall be designated as a one-way in a westerly direction for its entire length.

(8) The speed limits for all parking lots, as indicated on the site plan in the section Appendix, shall be 15 miles per hour.

(9) Any vehicle parked or standing as to obstruct or impede a normal flow of traffic, block any entrance or exit ways, loading zones, oil fills, any grassy area, pedestrian walkway, or present in any way a safety hazard may be removed by towing the vehicle at the owner's or operator's expense.

16:30-12.2 Operation

The Truck Weigh Stations established by the Commissioner pursuant to the regulations in this subchapter shall be operated by and under the authority of the Superintendent of the Division of State Police, Department of Law and Public Safety, for the purpose of effectuating enforcement of all State laws pertaining to vehicle size and weight and to comply with Federal law (23 U.S.C. 127).

16:30-12.3 Signs

(a) The Commissioner, pursuant to N.J.S.A. 39:4-183.27, shall cause to be created alongside of the roadway in advance of the Truck Weigh Stations established by the regulations in this subchapter such signs as are in conformance with the current Manual on Uniform Traffic Control Devices for Truck Weigh Stations. There shall be at least one sign which bears the legend:

"ALL TRUCKS, COMMERCIAL VEHICLES NEXT RIGHT", which shall be in conformance with the current Manual on Uniform Traffic Control Devices for Truck Weigh Station regulatory signs and any such sign is declared to be an "official traffic control device."

(b) In addition to the "official traffic control device" as declared in (a) above, the Commissioner shall also cause to be placed, consistent with the current Manual on Uniform Traffic Control Devices, an informational sign which shall indicate if the Truck Weigh Station is "open" or "closed" for operations, and such other signs as are in conformance with the current Manual on Uniform Traffic Control Devices.

(c) When the Truck Weigh Station is "open" all trucks and commercial vehicles are required, pursuant to these regulations and the provisions of N.J.S.A. 39:4-81 and 39:3-84(3)a, to comply and enter the Truck Weigh Station to be measured and/or weighed. Failure to comply will subject the operator of the vehicle to statutory penalties as provided in Title 39 of the Revised Statutes.

In accordance with N.J.S.A. 39:4-198, permission is granted to erect the appropriate older and walking impaired persons crosswalk signs.

1. In Monmouth County:

i. In Howell Township:

(1) Along Route U.S. 9 (northbound) at Wyckoff Mills Road and Strickland Road (approximate milepost 110.27).
