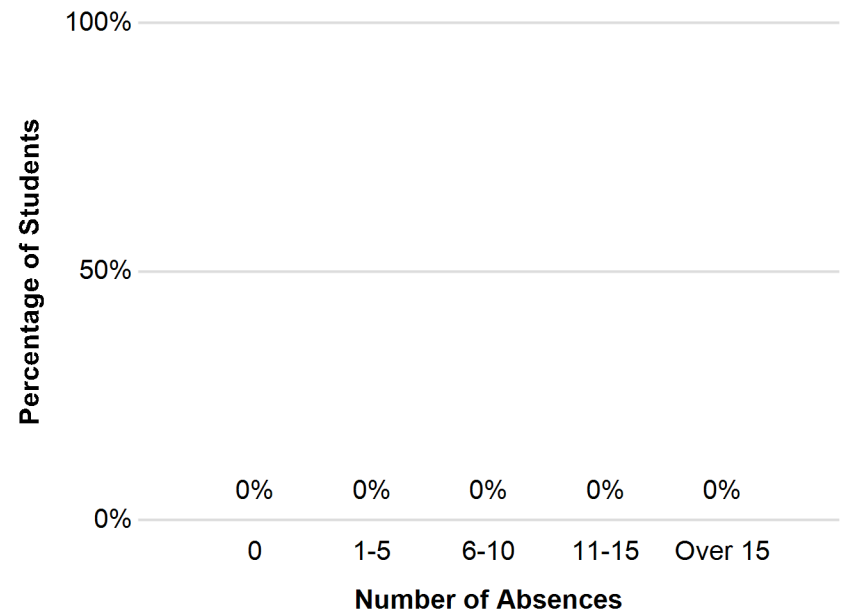

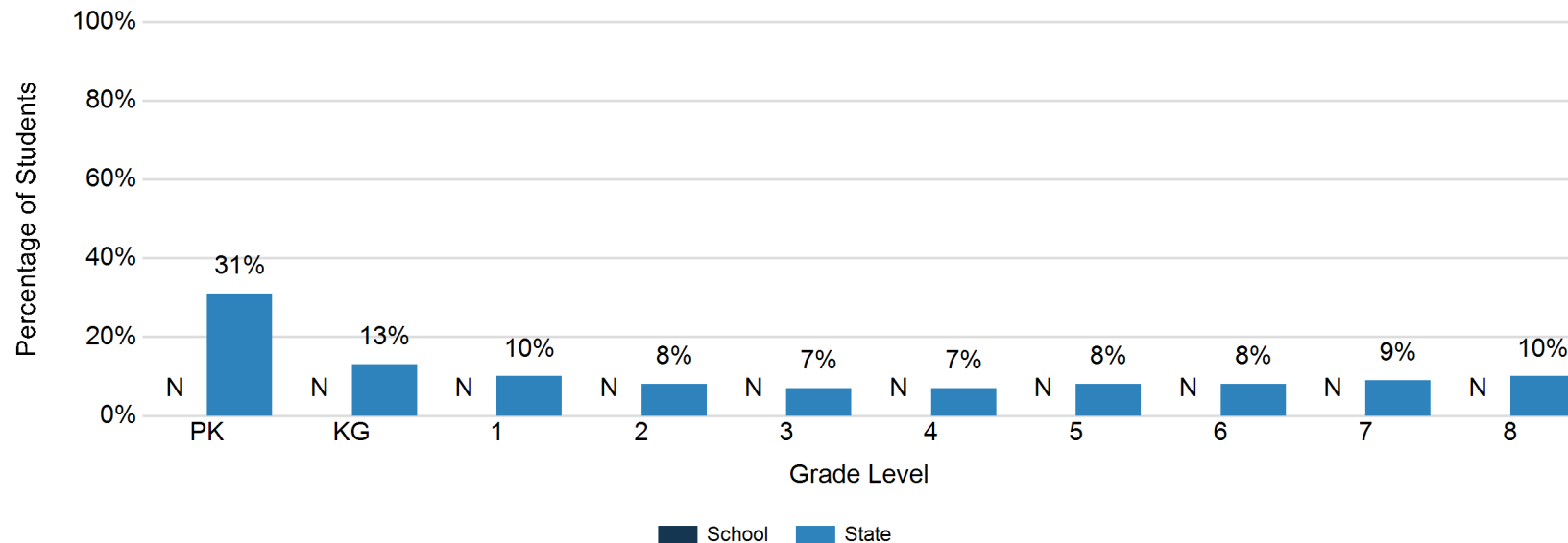

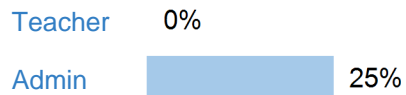

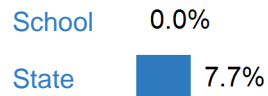

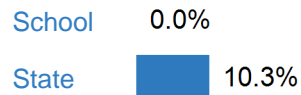
CTE Participants

CTE Concentrators

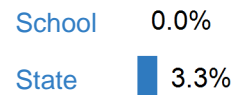

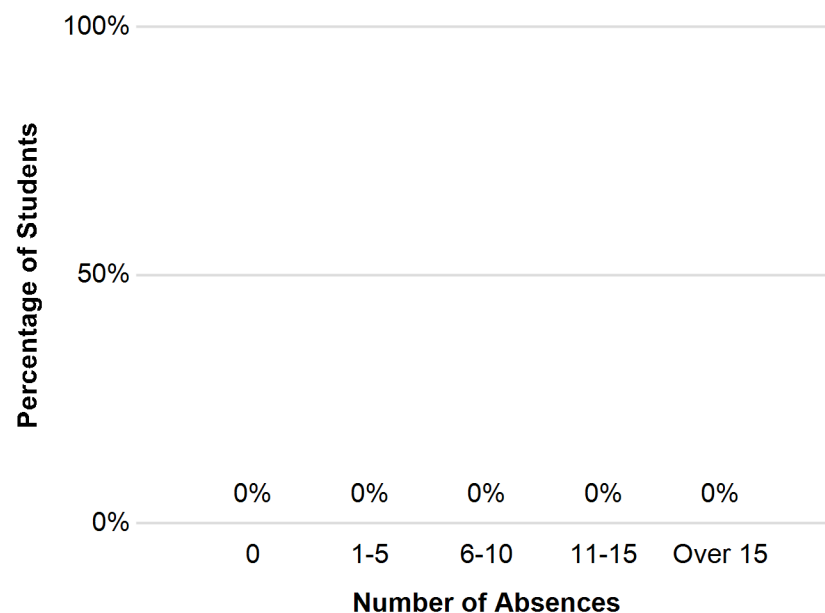

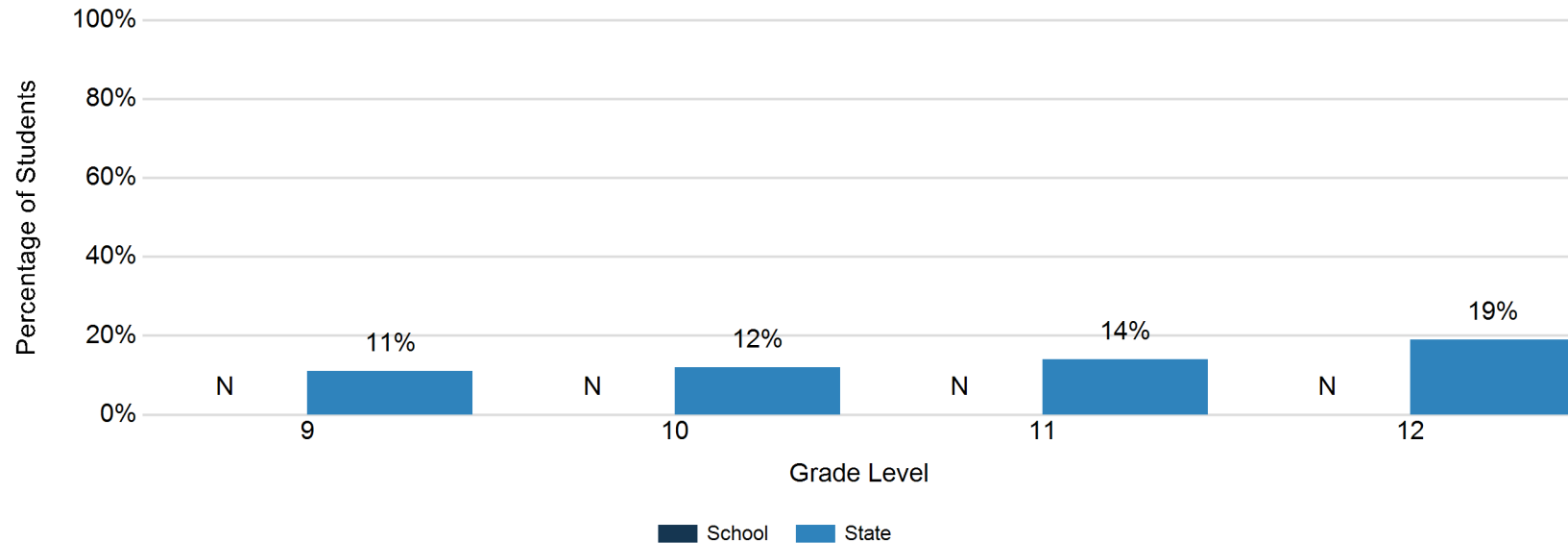
