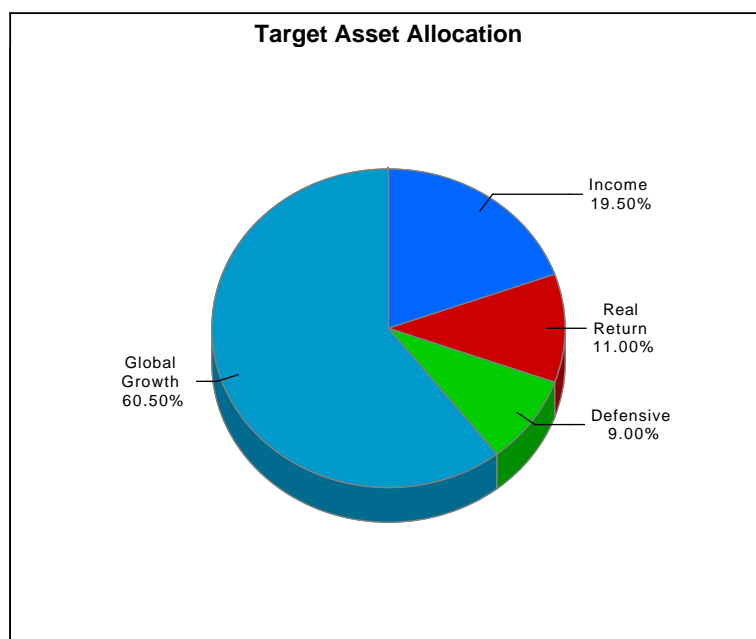
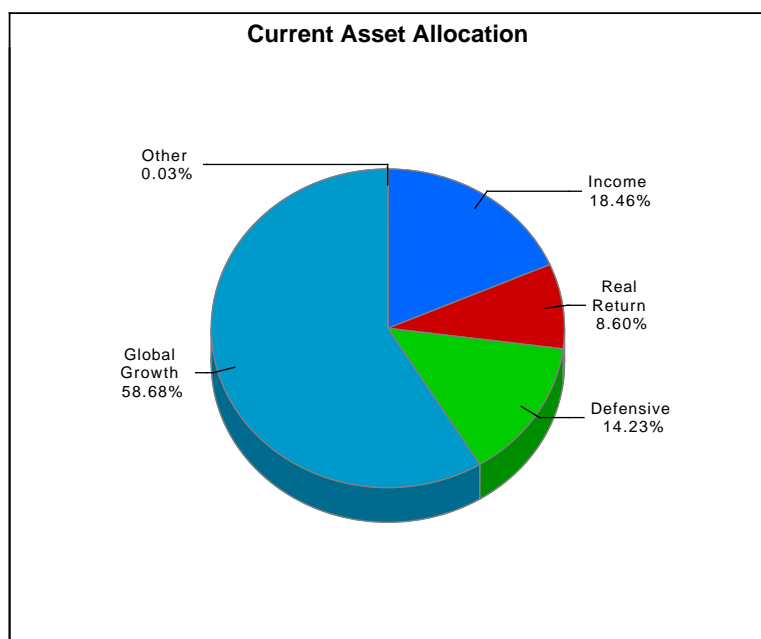

As of December 31, 2025**

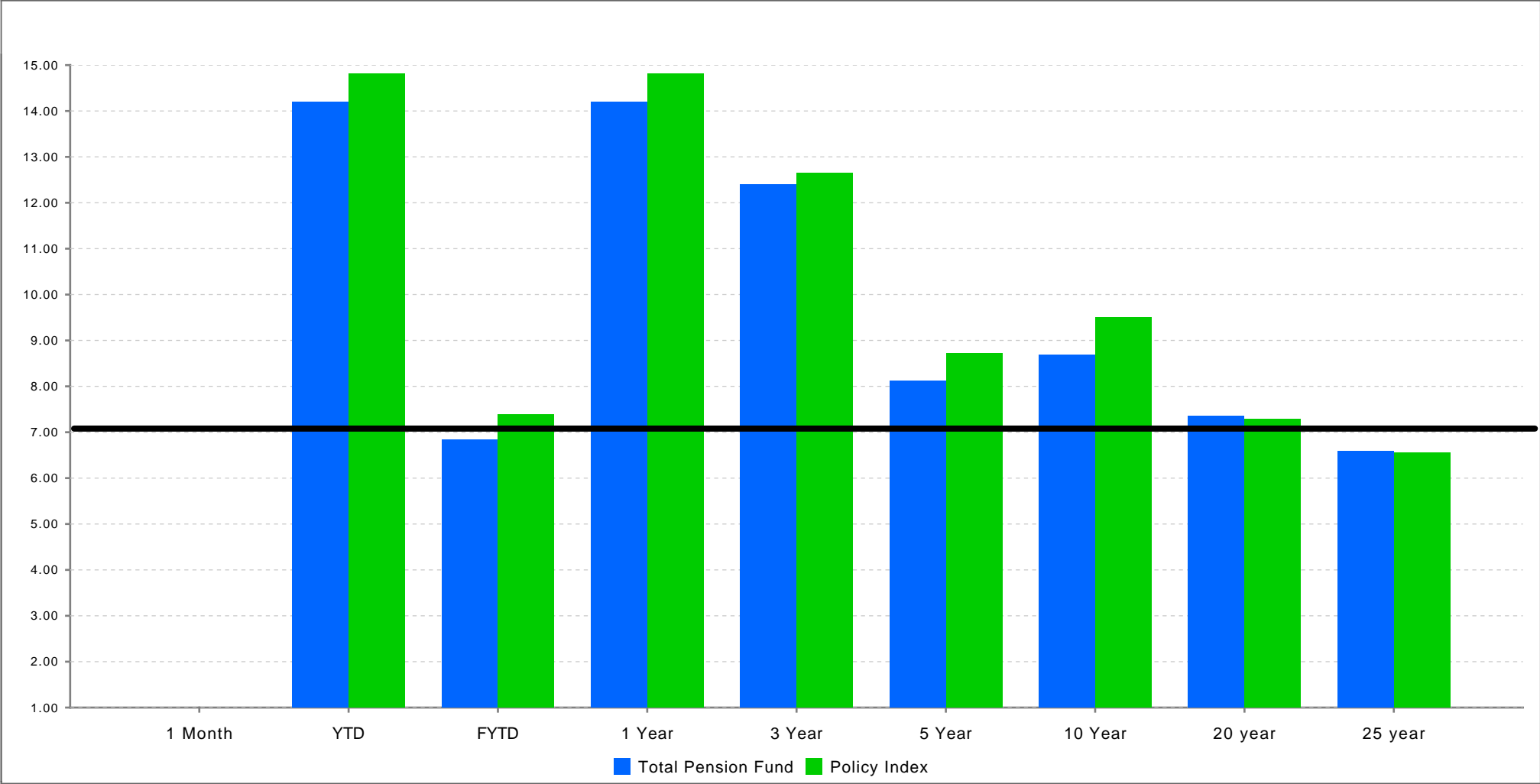

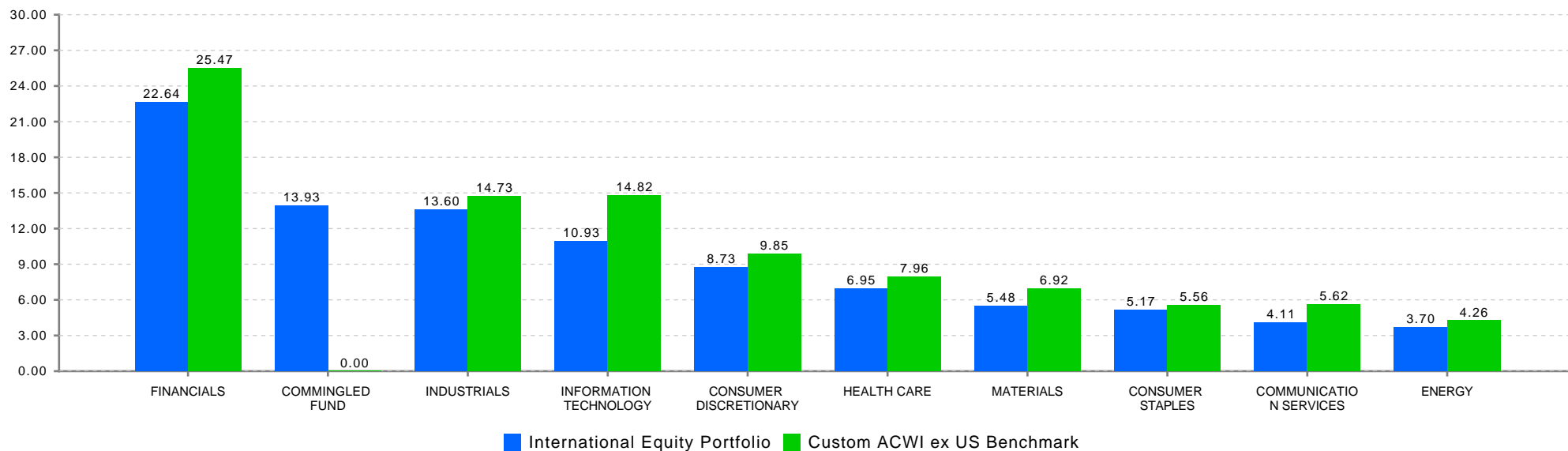

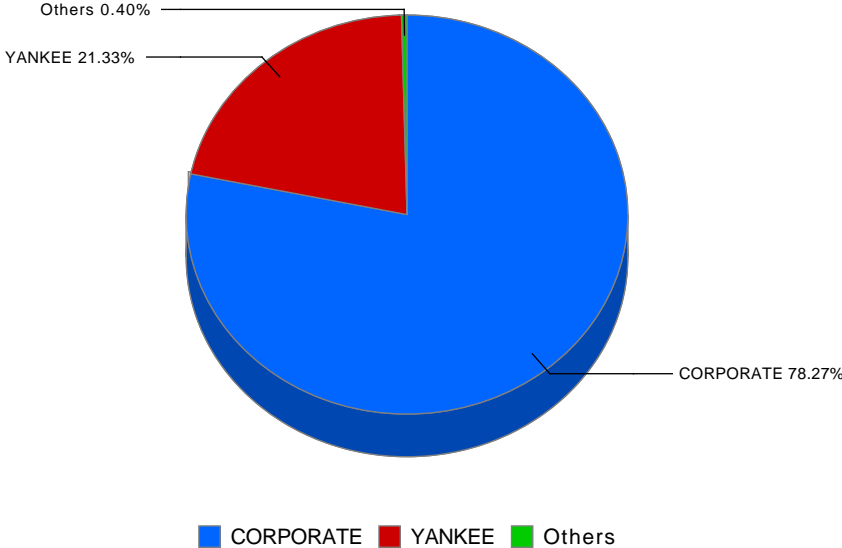
