NOTICE

TO ALL MUNICIPAL ISSUING AUTHORITIES:

Since assuming the duties of Director, I have had requests from many municipal clerks and secretaries of alcoholic beverage boards to find some way of eliminating the long form of application for renewals of licenses, where there have been no changes from the facts submitted in the last preceding long form application.

Knowing full well the many duties imposed upon municipal clerks and secretaries of alcoholic beverage boards, other than the issuance of alcoholic beverage licenses, I am convinced that there is a great deal of merit in the request.


In view of this, I have devised a short form renewal application which may be used by licensees applying for renewal of licenses in instances where there have been no changes of fact, since filing the last preceding application. Of course, the 4-page application form will continue to be used when new licenses are applied for or when there is a transfer, person-to-person or place-to-place.

In addition to the above, I have been asked by issuing authorities if we could not make some other arrangement than that of having issuing authorities wait for proof of submission of application and fee of \$25.00, to this Division, before they may issue licenses. Because of the approximately 13,000 applications and separate fees forwarded to this office within a very short space of time and the laxness of many retail licensees in forwarding the application and fee promptly, issuing authorities have been delayed in issuing licenses. To avoid delays, which are burdensome to many clerks because of their manifold duties, I have determined that applicants submit 3 application forms to the clerk, with the State's fee of \$25.00, (in addition to the municipal fee), for which the clerk will acknowledge receipt thereof on the application form. This will enable the municipal issuing authorities to take whatever action they determine on the application without waiting for evidence of submission of a copy of the application and the \$25.00 fee to this Division. The municipal clerk will immediately upon receipt forward one copy of the application and the \$25.00 fee accompanying such application to this office and the applicant will retain one copy of the application form, which will be kept available for inspection at his licensed premises.

You will note the first page of the long form application has been amended to allow for the above noted changes. The two changes were first discussed with many clerks and appeared to meet with their approval. It was suggested, however, that the changes be further discussed with the executive committee of the Municipal Clerk's Association who in turn, would carry the message back to their members. This was done on Saturday, January 23rd by my representative, who advised me that both suggestions met with the unanimous approval of the executive committee.

I am aware that many municipalities have a supply of A-13 and A-14 application forms on hand. It is not my intention to have municipalities incur additional expense. Accordingly, I have ruled that municipalities who wish to use their old application forms before purchasing the revised A-13 and A-14 forms, or the new short form applications may do so. Under no circumstances are you required to discard your old forms and use only the newly revised forms.

The new forms, (samples attached) herein promulgated are effective for the fiscal year commencing July 1, 1971 and thereafter.
