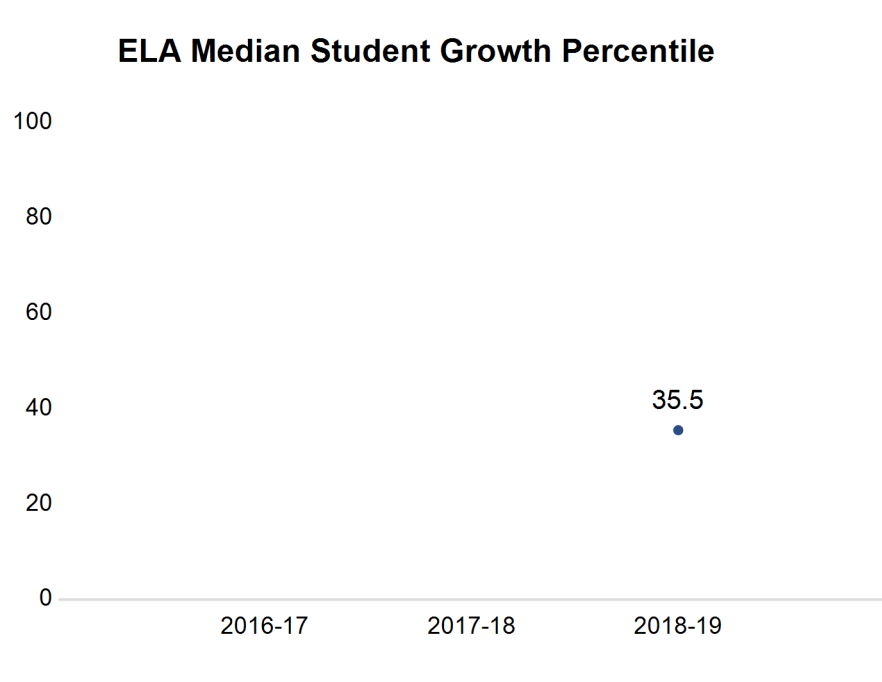

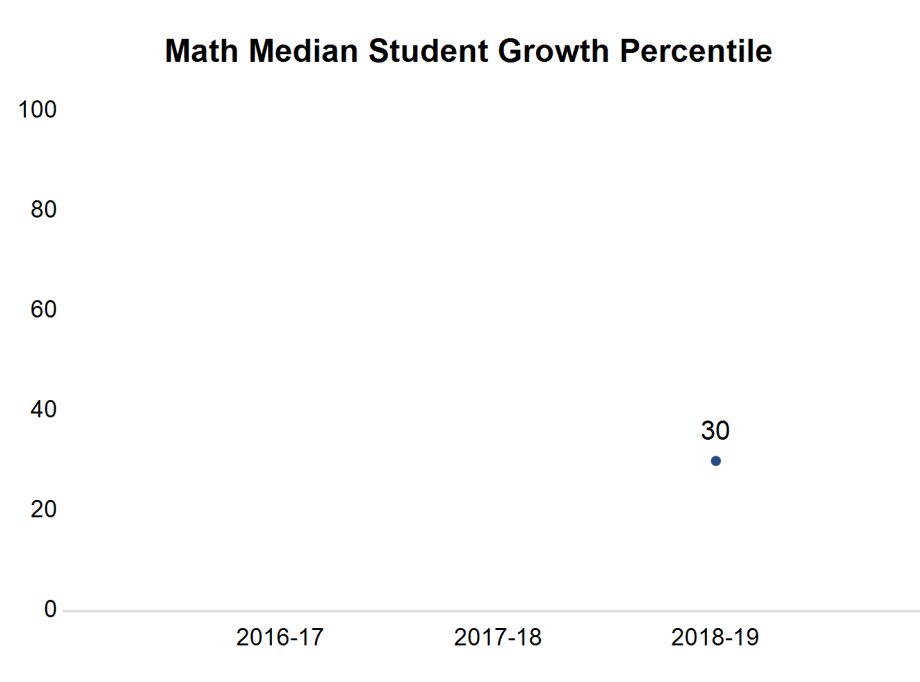

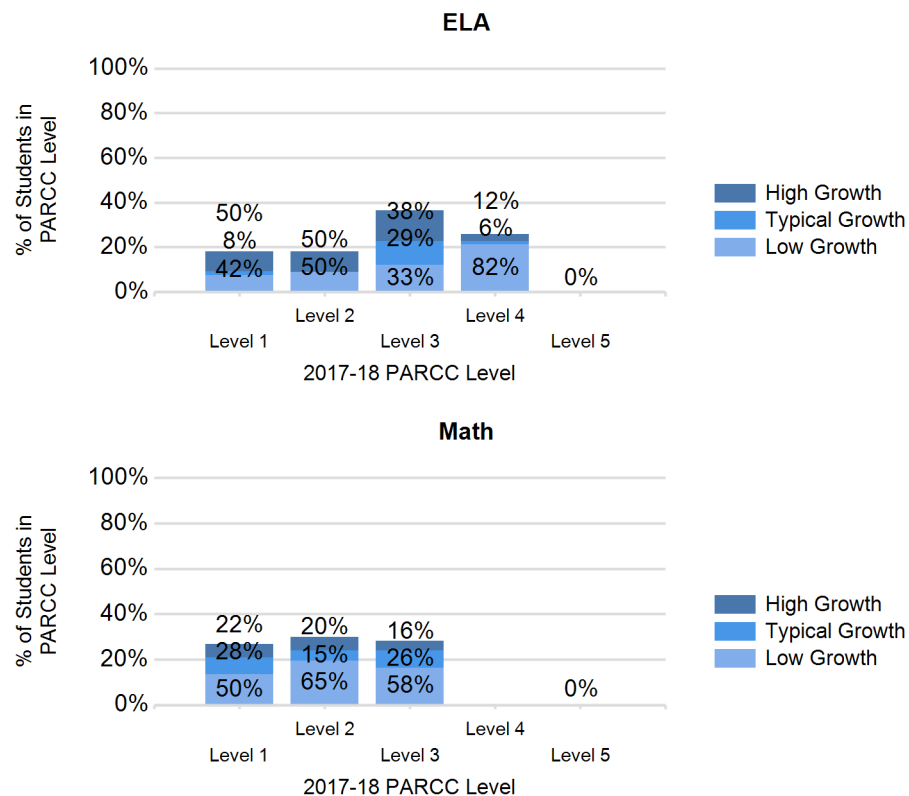

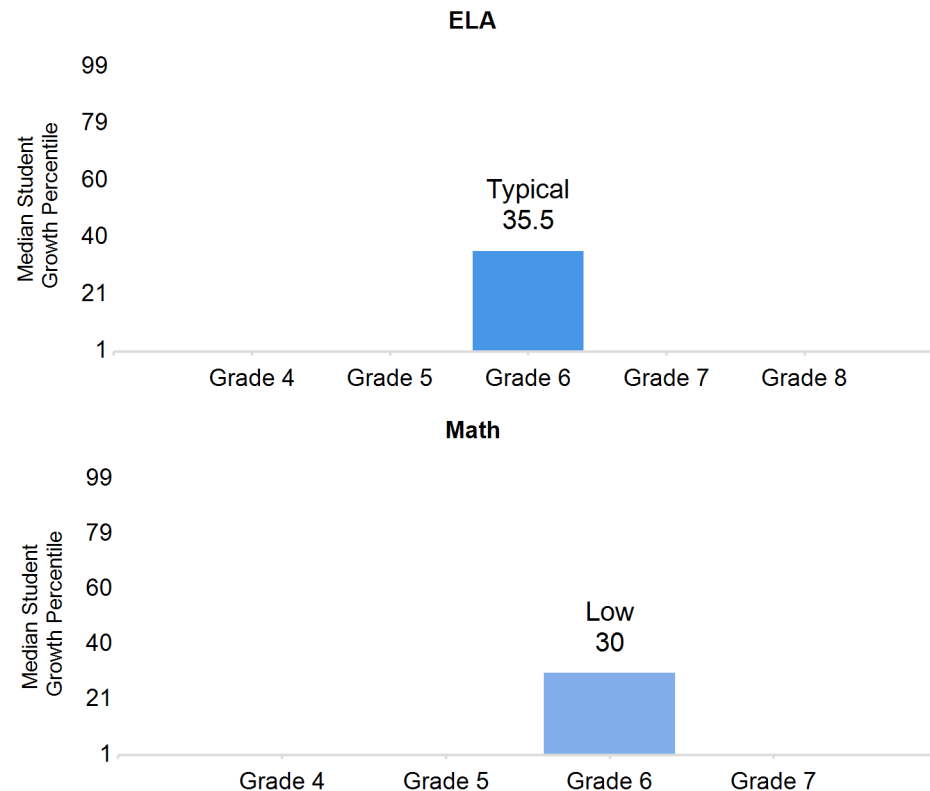
Student Growth by Performance Level

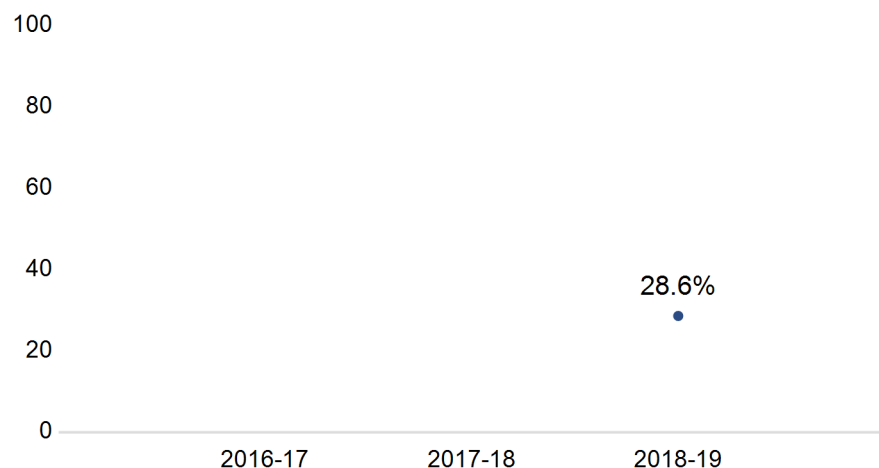

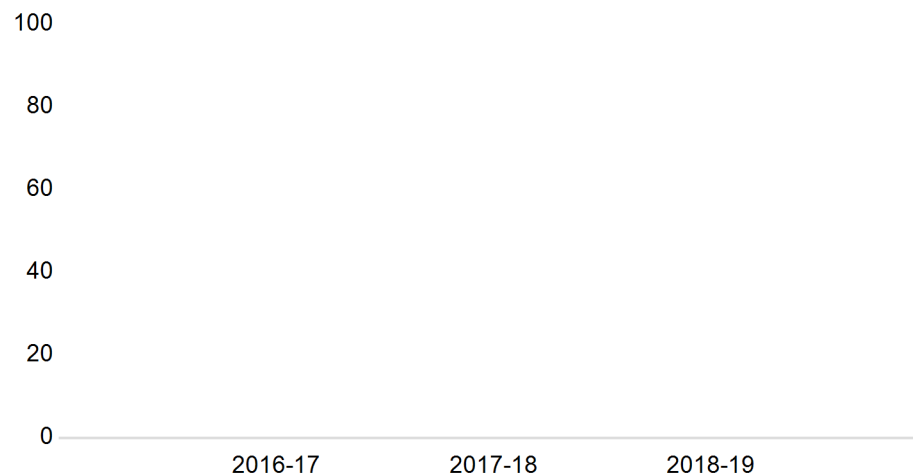
English Language Arts and Mathematics Performance Trends

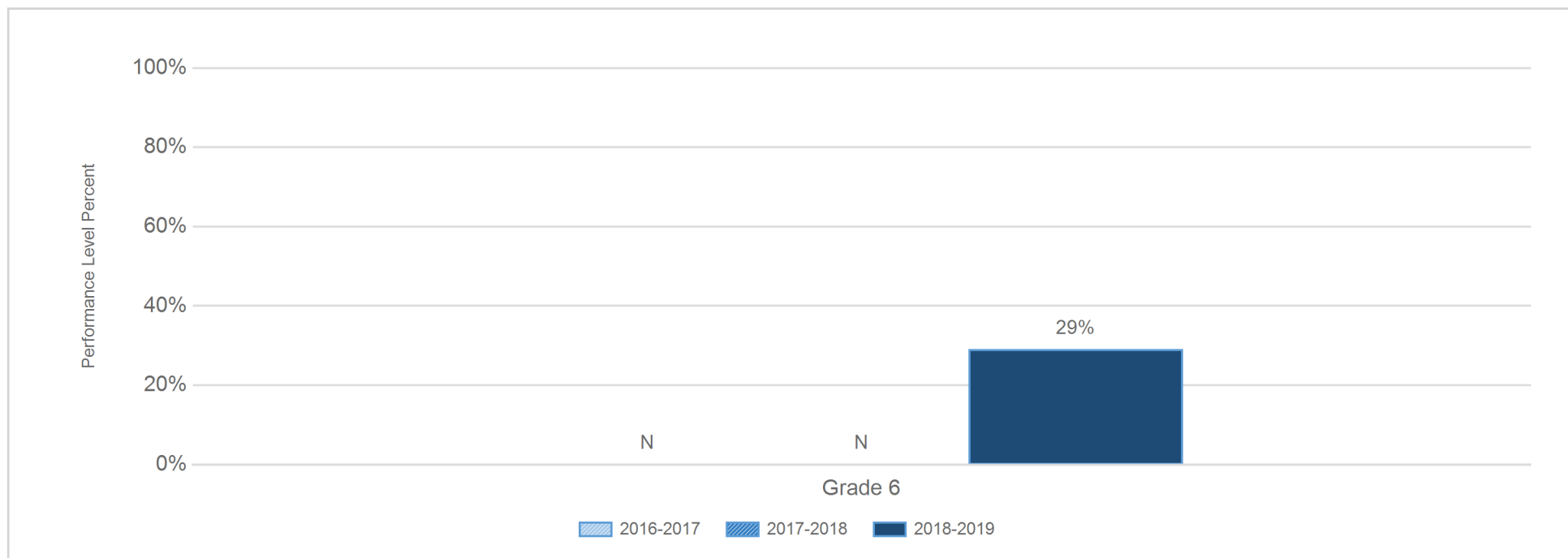

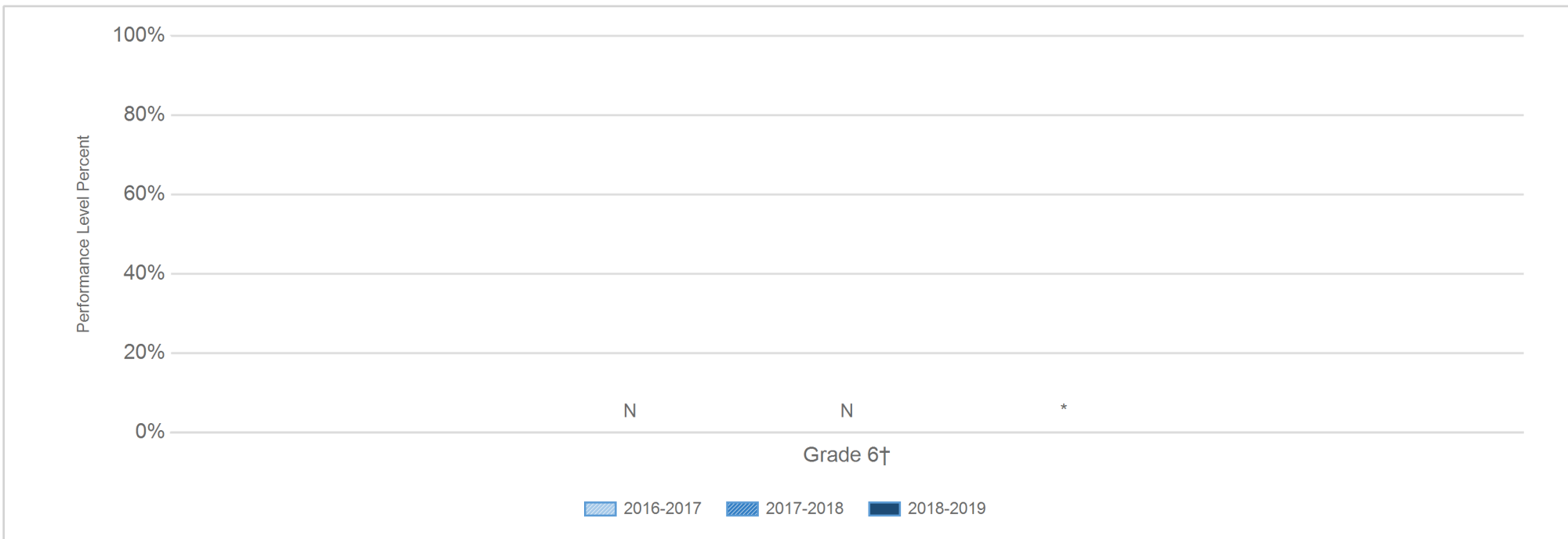

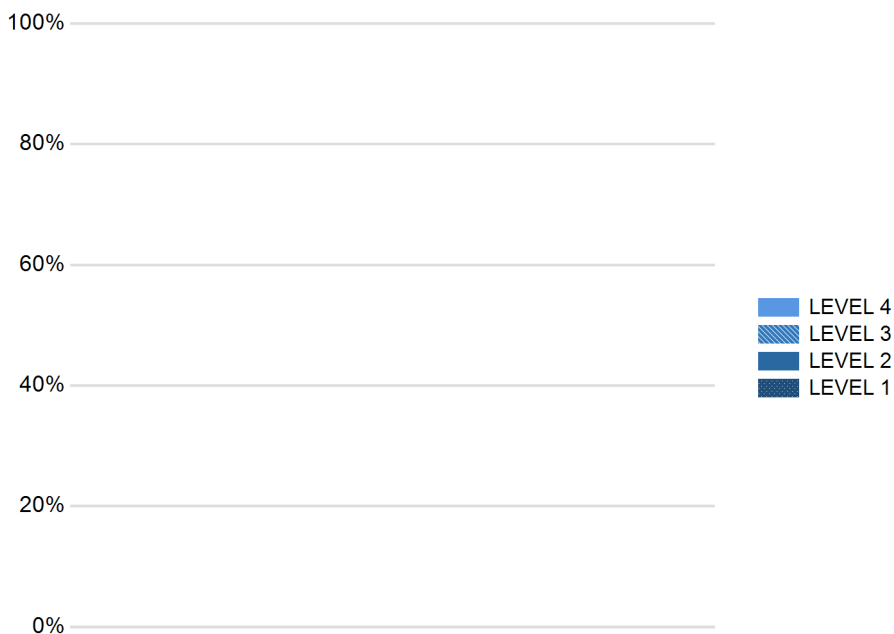

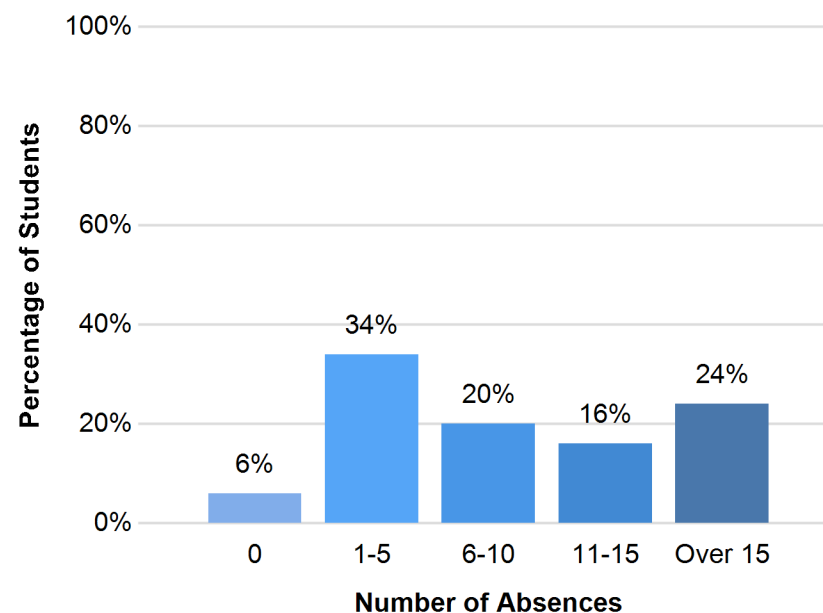

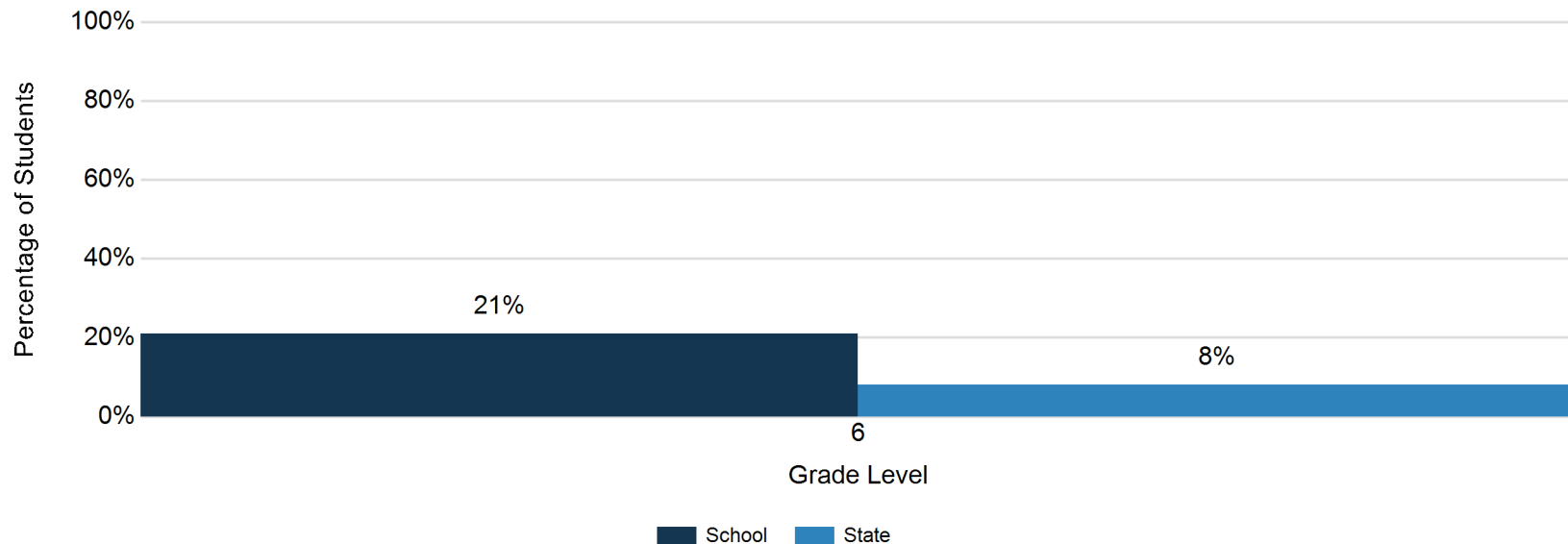
