# **Maintenance and Preservation of Library Collections**

Eligible Applicants: All New Jersey libraries and library-related agencies which

meet the definition of a library as stated in N.J.A.C. 6:68-1.2

are eligible to apply for this grant.

Required: Submission of a disaster plan with the application

Amount Available: \$200,000 Maximum Grant: \$15,000

**Technical Assistance Session: September 15, 1998** 

Deadline: November 5, 1998

The <u>purpose of the grant program</u> is to insure that library materials of significant historical, cultural or social value will remain in usable form and accessible to future researchers, historians and citizens. <u>Eligible projects include</u>: surveys and examinations of collections to determine preservation needs and options for treatment; and physical treatment, rehousing and reformatting of materials. Note: Formats that are not recognized as archivally stable and formats that depend on rapidly changing technology to be usable <u>are not</u> eligible.

# **AWARDS OF CONTRACT ANNOUNCED**

# Integrated Online Library Systems Implementation Grant for Libraries Serving Abbott Districts

The goal of this grant program is to insure equity in resource sharing and access to library materials for citizens of New Jersey residing in urban communities whose school districts have been designated as Abbott Districts (formerly referred to as "Special Needs" Districts). Funds will assist urban public libraries to become a member of a Library Computer Consortium providing online catalog, circulation and cataloging subsystems for their member libraries; or to share a Public Library's Integrated Online Library System. Grant funding is not intended to cover all one-time implementation costs but should act as seed money to attract local funding for the expansion of the system to fully meet the needs of the library and its community.

Hoboken Public LIbrary \$99,715. The library will join the BCCLS consortium and install 10 PCs supported by a T-1 line. Library and BCCLS staff will convert, barcode and link holdings for 75,000 titles using the BCCLS database. The library has weeded its collection and has budgeted money to cable the building and upgrade the electrical system.

Irvington Public Library \$100,000. The library will share the Newark Public Library's DYNIX system and install 13 PCs supported by a T-1 line. Twenty thousand existing machine-readable bibliographic records will be loaded and 30,000 titles will be converted by Ameritech. The library had a Net Day for cabling the building, the collection is already barcoded and money has been budgeted to upgrade the electrical system.

Long Branch Public Library \$98,925. The library will join the LMxAC consortium and install 9 PCs supported by a fractional T1 (128 kbps) line. Temporary staff will convert, barcode and link holdings for the entire collection of 100,000 titles using the consortium's database. The library is currently weeding the collection and has budgeted money to cable the building and upgrade the electrical system.

Paterson Free Public Library \$100,000. The Library will join the PALS Plus consortium and install 13 PCs supported by a 56 kbps line. Library staff will convert, barcode and link holdings for 80,000 titles using the consortium's database. The library had a Net Day for cabling the building and has upgraded the electrical system and weeded the collection.

# Technology Bond Fund Grant Program for Public Libraries 196 libraries awarded grants totaling \$1,159,936

Bond funds became available in mid-May. The State library will issue contracts in the order that the applications were received. The first half of the contracts will be mailed in July and the second half will be mailed in August.

Funds from the Higher Education Technology Infrastructure Fund were used to: 1) equip public libraries with state-of-the art computers and other equipment to support access to electronic information resources; 2) replace out-of-date, inadequate computer equipment; and 3) expand the number of computers available for patron direct access to the Internet. To be eligible to apply for this non-competitive grant program libraries had to meet all Per Capita State Aid

requirements and had to have at least one computer with a Pentium processor which is dedicated to patron direct access to the Internet or purchase and install one during the grant period. The maximum grant awarded to a library was \$6,000.

#### ANALYSIS OF THE GRANT APPLICATIONS

The Guidelines and application for the grant program were mailed to all eligible public libraries. Of this total, 196 libraries applied for the grant; and 35 eligible libraries did not submit an application.

As a result of this grant program, 17 libraries who do not presently provide a dedicated computer for public direct access to the Internet will be able to purchase one or more computers for public use. The majority of the libraries applying for the grant had between one and three computers dedicated for Internet access by the public. Eleven percent of the libraries applying for grant had four or more Internet public access computers.

The \$1,159,936 awarded to libraries will be used to purchase the following types of equipment: 365 PCs for Internet access; 50 PCs to replace dumb Integrated Library System terminals; 20 PCs for LAN, CD-ROM, Web, and ILS servers; 24 PCs to access CD-ROM materials; 181 printers; 31 CD-ROM towers, changers, jukeboxes; and 15 scanners.

# Technology Bond Fund Grant Program for County and Municipal Libraries with Branches 32 libraries awarded grants totaling \$359,759

Bond funds became available in mid-May. The State library will issue contracts for this grant program in August.

Funds from the Higher Education Technology Infrastructure Fund were used to: 1) equip county and municipal libraries and their eligible branches with state-of-the art computers and other equipment to support access to electronic information resources; 2) replace out-of-date, inadequate computer equipment; and 3) expand the number of computers available for patron direct access to the Internet. To be eligible to apply for this non-competitive grant program main libraries had to meet all Per Capita State Aid requirements and have at least one computer with a Pentium processor which is dedicated to patron direct access to the Internet or purchase and install one during the grant period. In addition, branch libraries had to have at least 1 FTE employee and be open for service a minimum of 35 hours per week (including one evening and some Saturday hours) in 1996 and continue to meet these requirements in 1998. The maximum grant awarded for a main library was \$6,000 and \$2,000 was awarded for each eligible branch library.

#### **ANALYSIS OF THE GRANT APPLICATIONS**

Of the 32 libraries awarded grants, 20 had branches that met the eligibility requirements. All main libraries already had at least one computer dedicated to patron direct access to the Internet. Twenty-seven main libraries reported that they had dedicated PCs for patron direct Internet access in their branch libraries (whether the branches were eligible for the grant or not). Seventeen of the main libraries had between one to five patron computers dedicated for public access to the Internet; and 14 main libraries had between 7 and 35 Internet public access computers.

The \$359,759 awarded to libraries will be used to purchase the following types of equipment: 160 PCs for Internet access; 12 PCs to replace dumb Integrated Library System terminals; 2 PCs for LAN and Web servers; 10 PCs to access CD-ROM materials; 74 printers; and 6 CD-ROM towers, changers, jukeboxes.



# New Jersey Library for the Blind and Handicapped 2300 Stuyvesant Avenue, Trenton, New Jersey



#### OM NORTH JERSEY

Take New Jersey Tumpike to Exit 7A (Great Adventure Exit). At the toll plaza, keep to your left over the bridge onto 195 West. Near Trenton, 195 divides; stay to the left (going straight ahead) for the Trenton/Camden connection. Remain left (straight ahead) for Route 129 and Trenton. Take 129 to the Cass Street light and tum left. When the street deadends at a light near the river, tum right for Route 29. Take 29 several miles to the light at Sullivan Way where you turn right and follow the road as it goes beneath the railroad bridge and bears to the left up hill. Go to the next light (Lower Ferry Road); turn right; go one block and turn right on Stuyvesant Avenue. Go approximately two blocks, watching for the Library sign and entry drive on your left. The Library is a low white building with red trim, set far back from the road.

#### ROM SOMERVILLE

Take 202 South to 31; take 31 South to 95. Take 95 South (toward Pennsylvania) to Exit 2 (West Trenton/Airport). At the top of the exit ramp, turn right. (This road will wind and will change names.) Go to the second light (Lower Ferry Road--Katzenbach School will be on your left) and turn left. Go one block and turn right on to Stuyvesant Avenue. Go approximately two blocks, watching for the Library sign and entry drive on your left.

## ROM SOUTH JERSEY

Take 295 North; as you begin to drive around Trenton, 295 becomes 95. Stay on 95 to Exit 2 (West Trenton/ Airport). Follow directions from Exit 2 under "FROM SOMERVILLE" above.

## FROM EAST AND SHORE AREAS

Take 195 West Follow the directions under "FROM NORTH JERSEY" above.

## FROM TRENTON TRAIN STATION

Take "609" bus which leaves from the front of the train station every 20 minutes. Have \$1.00 in change ready.

#### FROM PENNSYLVANIA

Take 95 North across the Delaware River to Exist 2 (West Trenton/Airport). At the top of the exit ramp, turn right. Follow the directions under "FROM SOMERVILLE" above.
