NEW TELEPHONE SYSTEM IN THE UNION VICINAGE SUPERIOR COURT

In order to improve and effectively respond to customer service needs, the Union Vicinage Superior Court is pleased to announce that it is converting to a new digital telephone system, effective Monday, July 21, 2008. The new system has enhanced selection menus and other upgraded options, such as telephone conferencing, to effect more reliable communications and continued telephone access to court services for all court customers. Throughout the conversion process, the court's most frequently dialed telephone numbers will have a recording that refers callers to the new telephone numbers. The new main access number will be (908) 659-4600.
