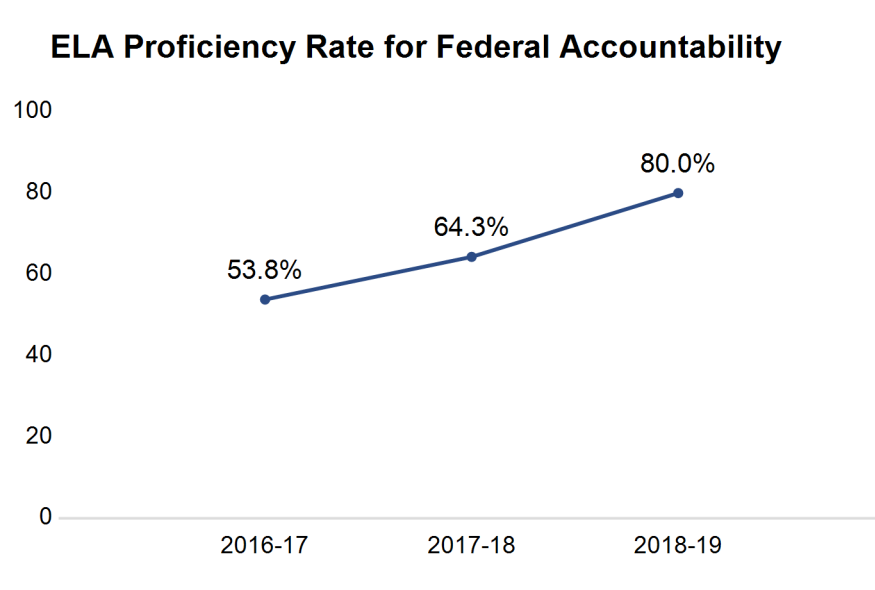

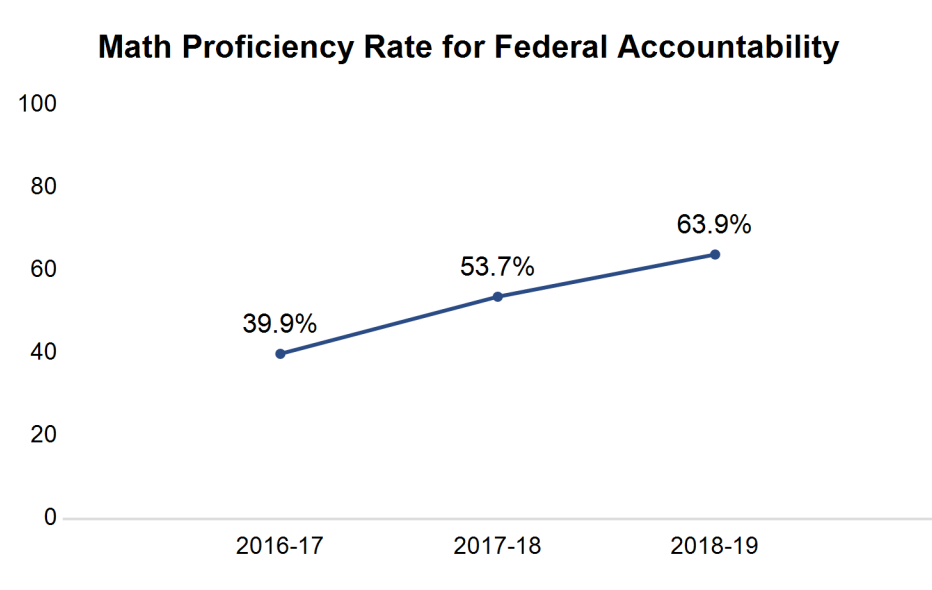
English Language Arts and Mathematics Performance Trends

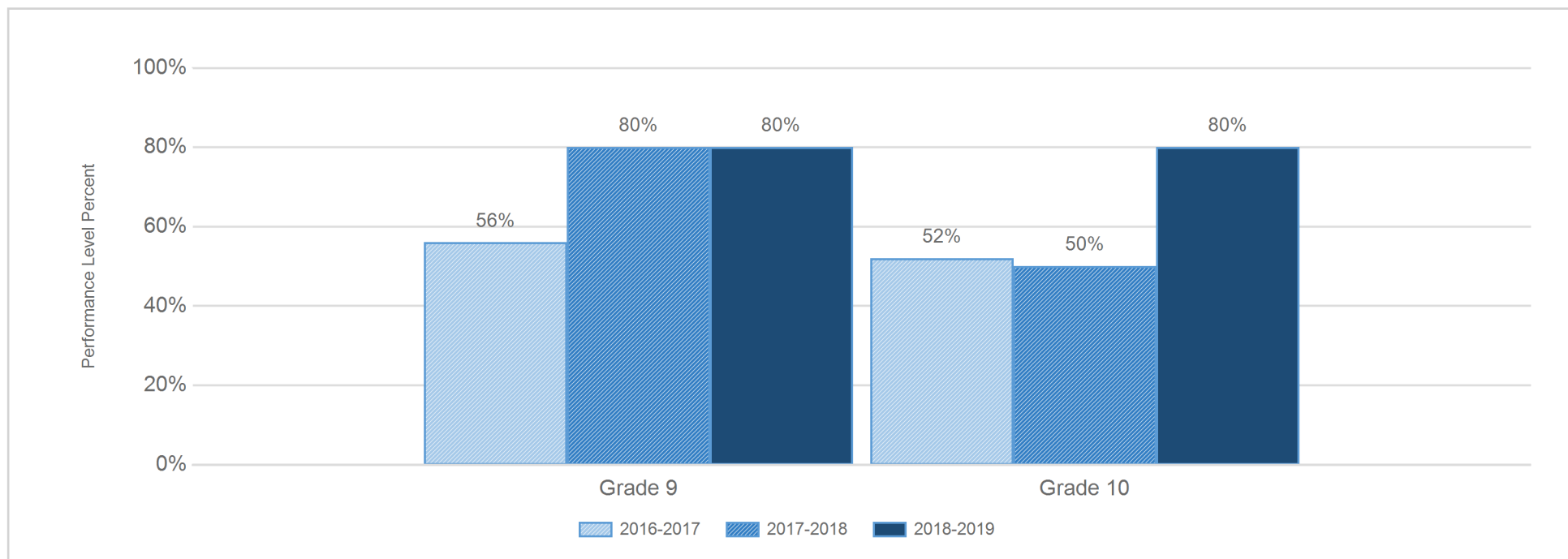

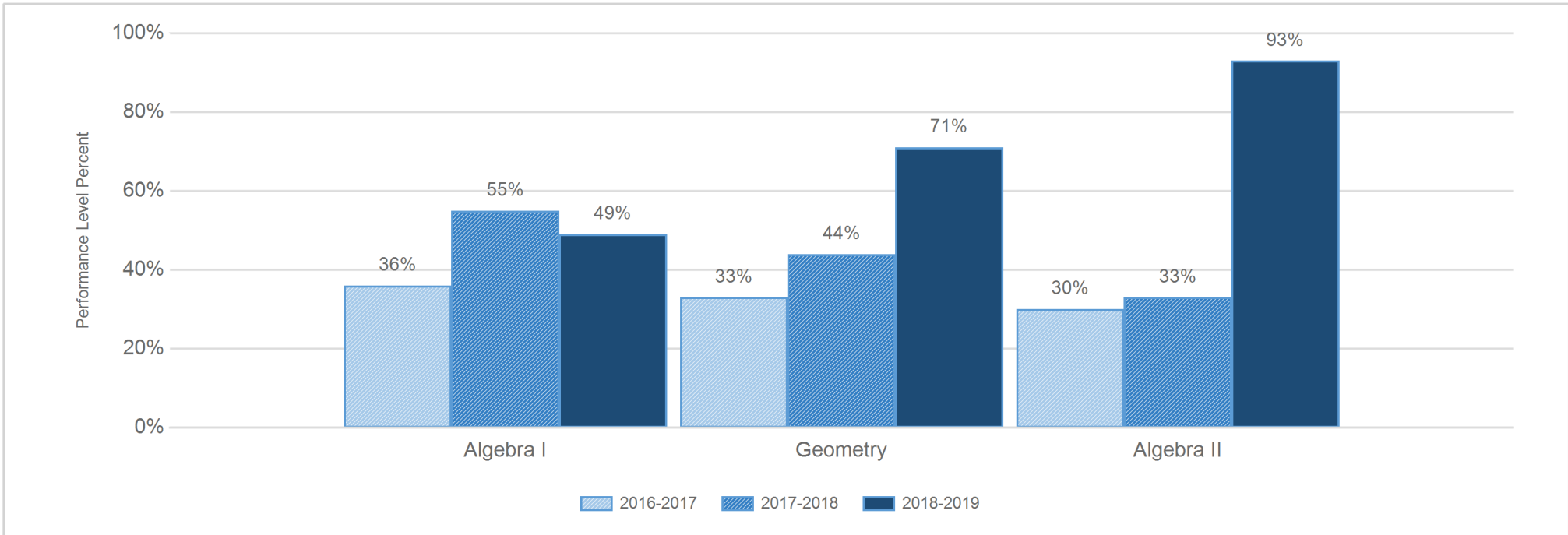

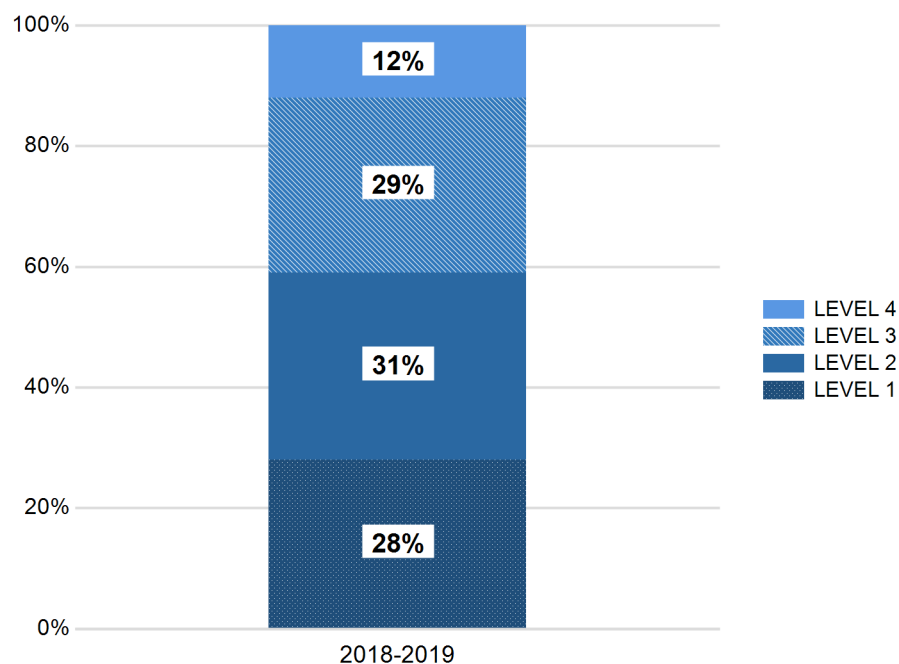

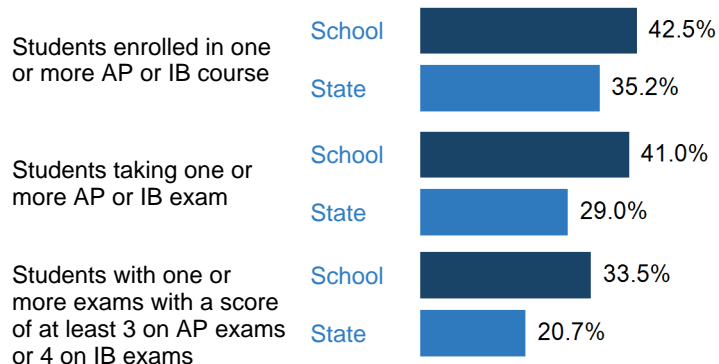

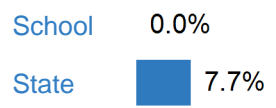

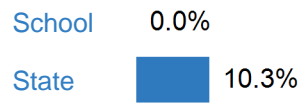
CTE Participants

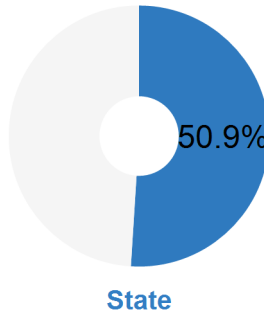

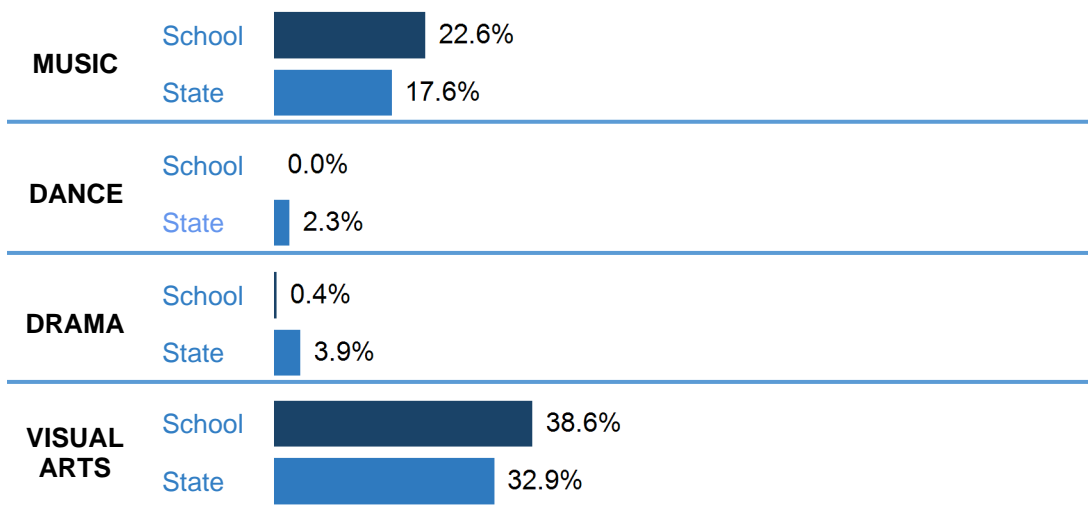

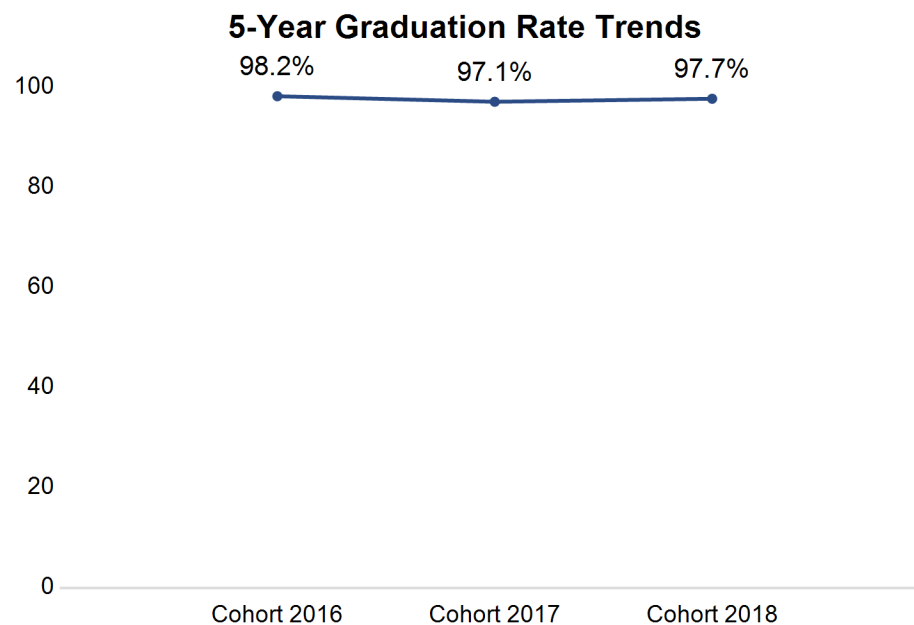

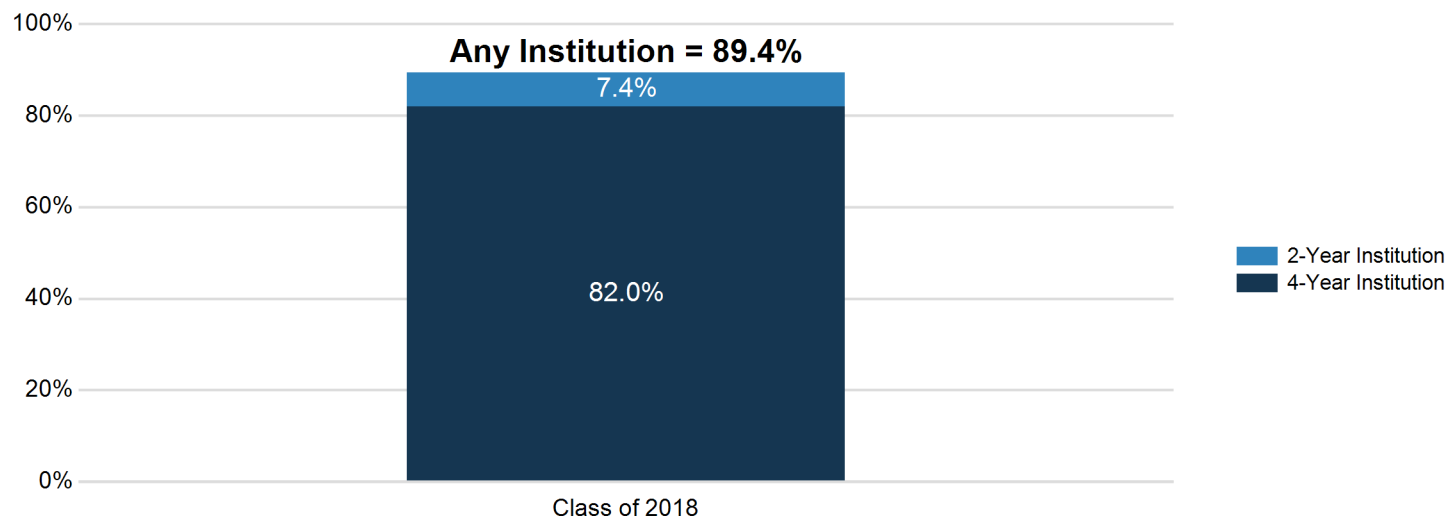

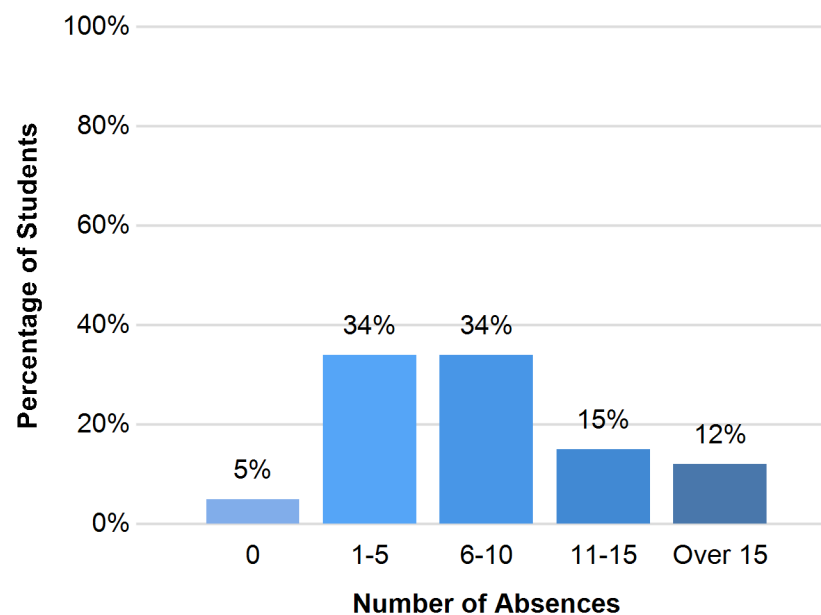

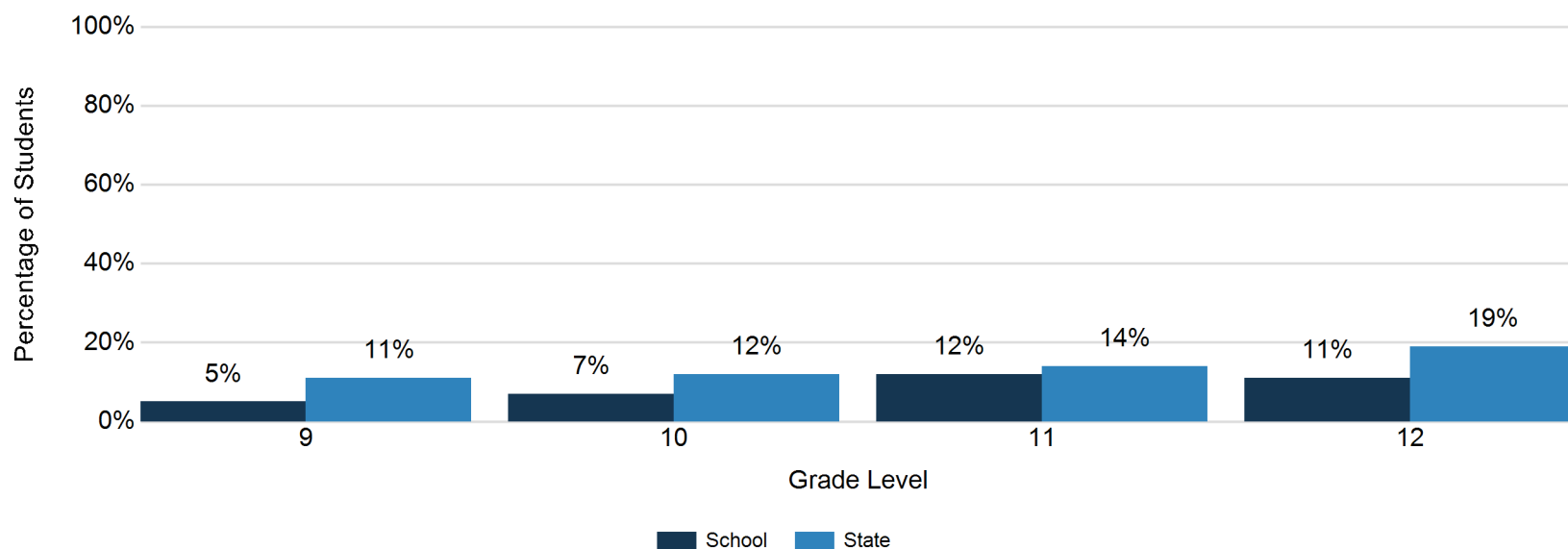

The co-teaching model is used for integrated classrooms. The HS offers a unique program designed to address students' academic and social-emotional needs. Resource replacement level classes are available for every grade level. The language and learning based disability program provides authentic life-skills learning opportunities and a successive transition program.



Student Health and Wellness:

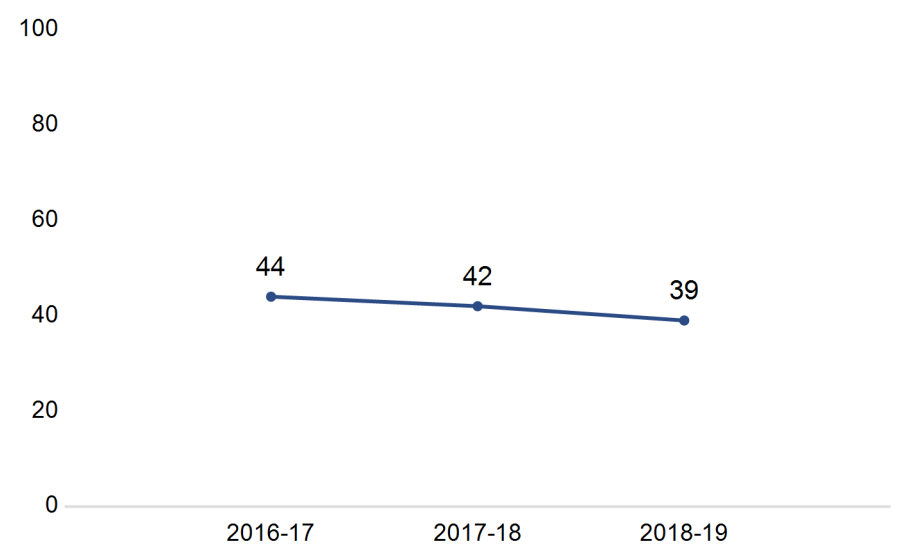

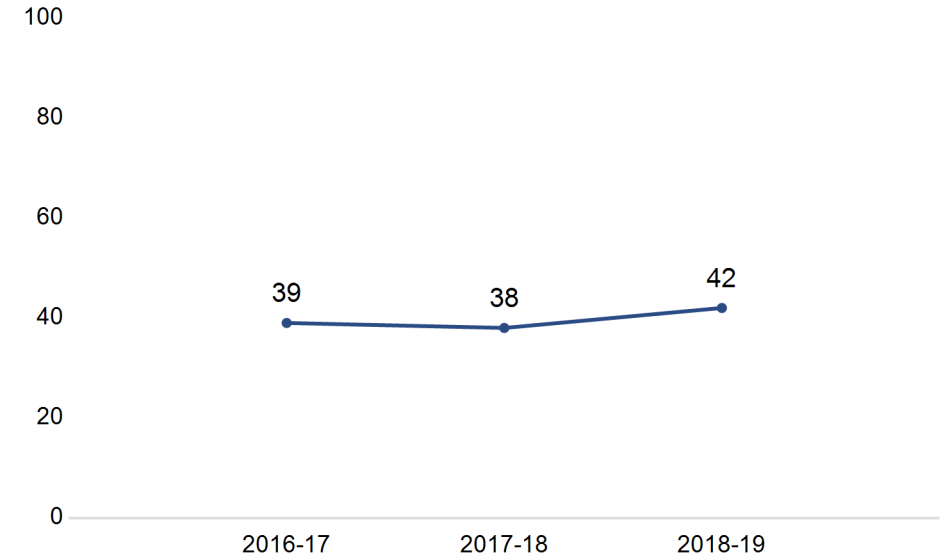

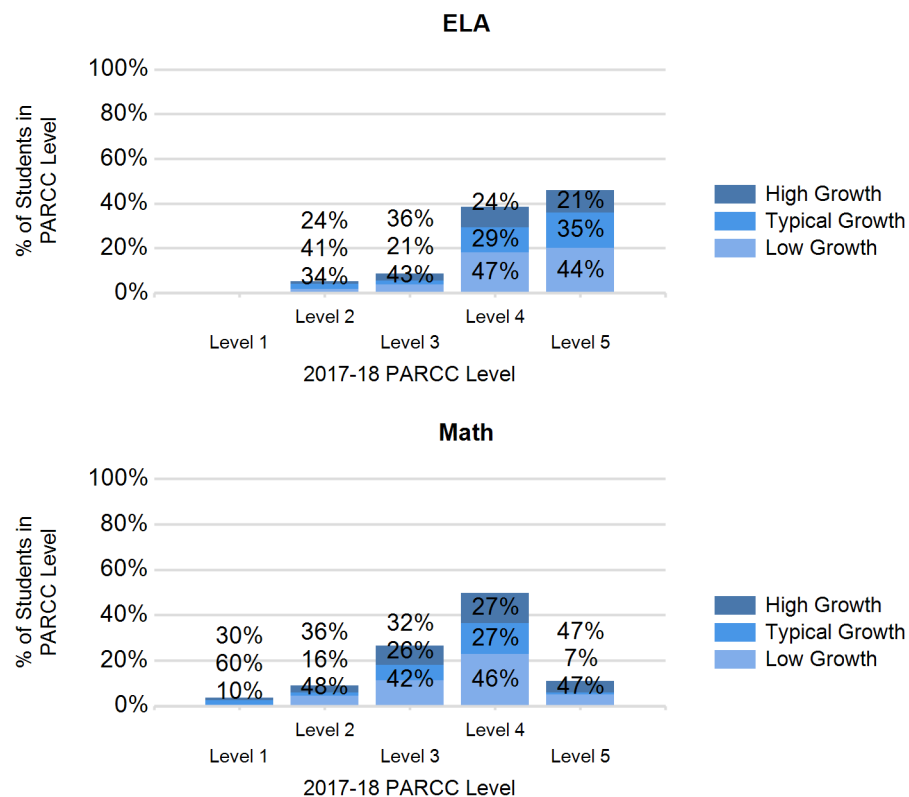

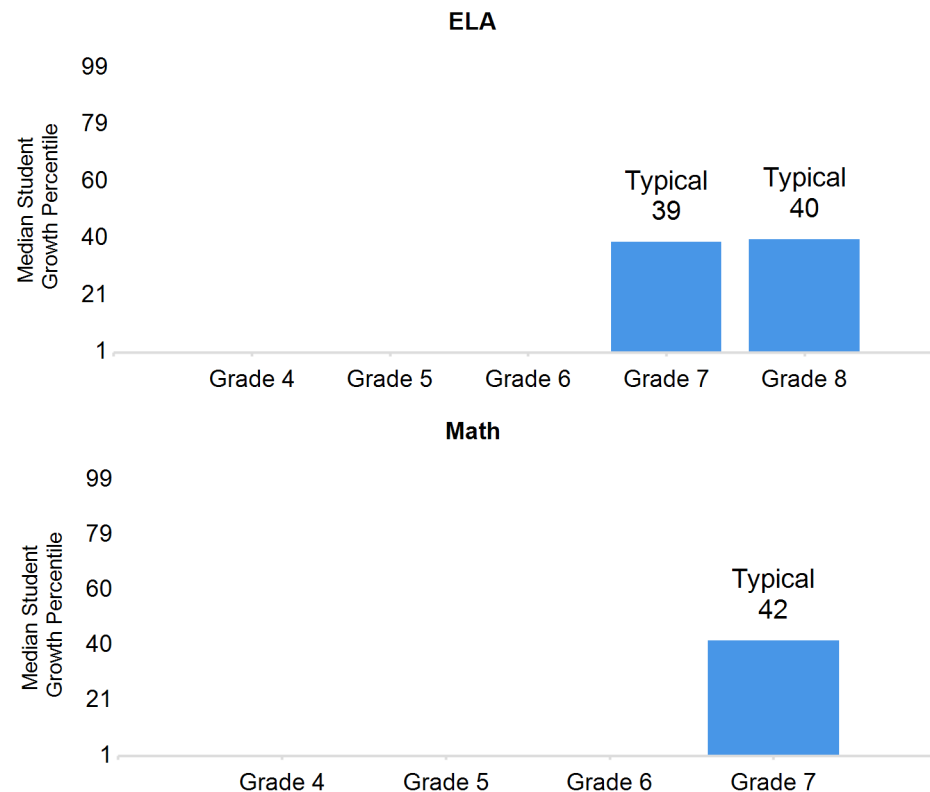
Student Growth by Performance Level

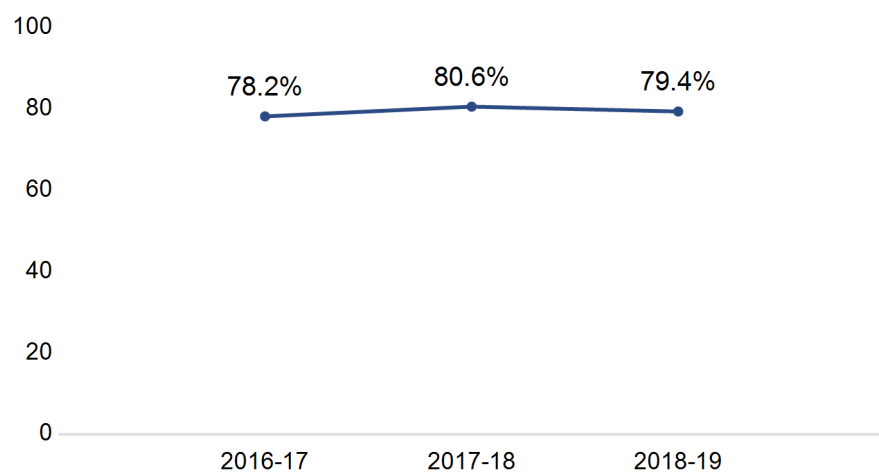

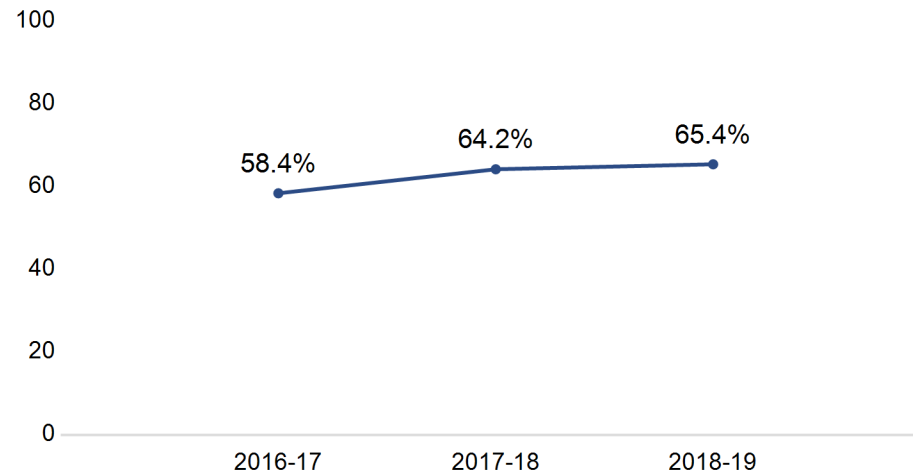

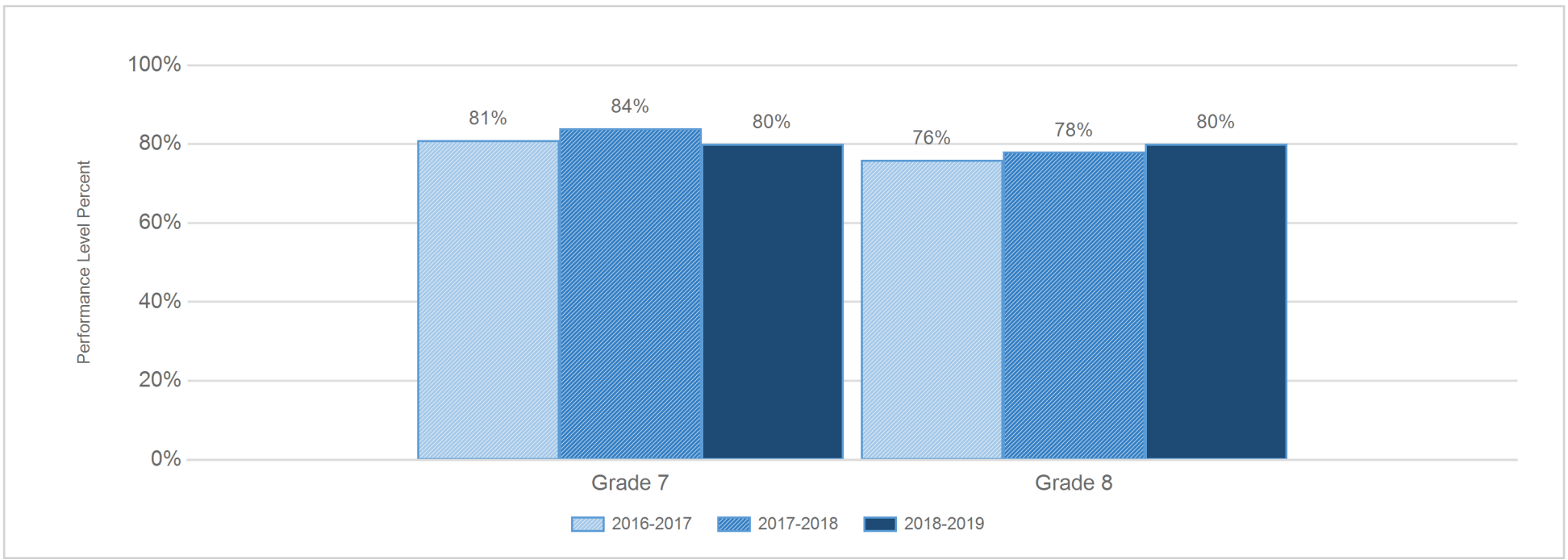

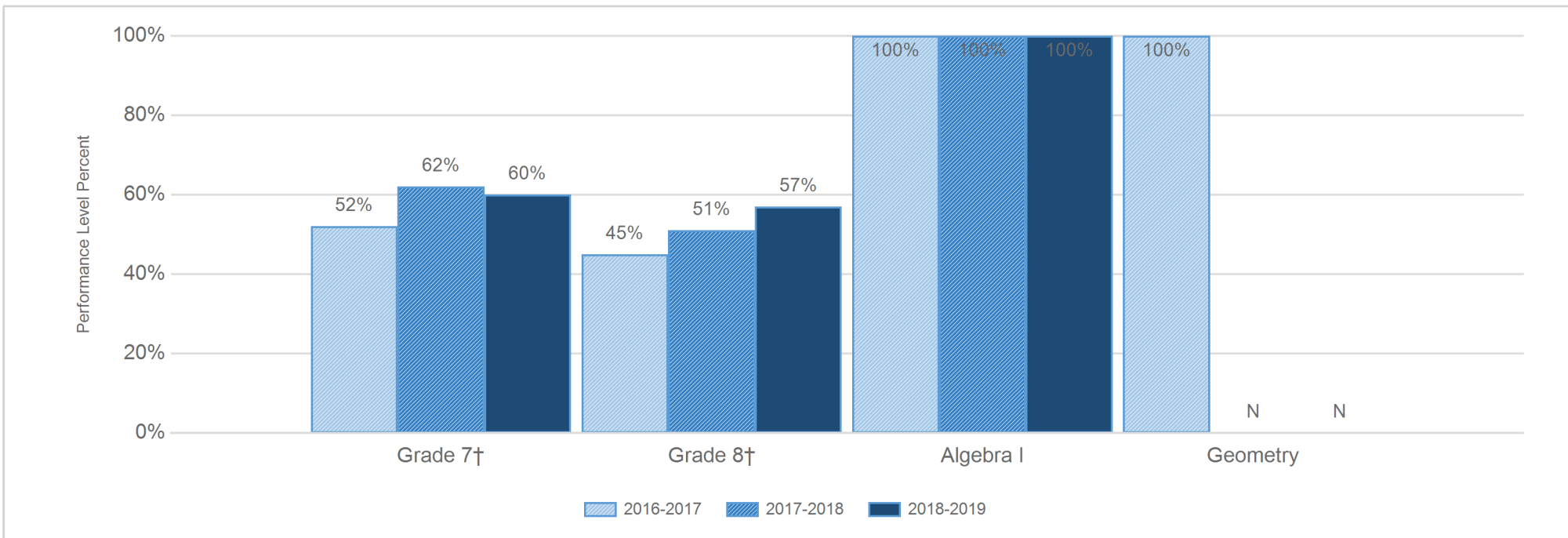

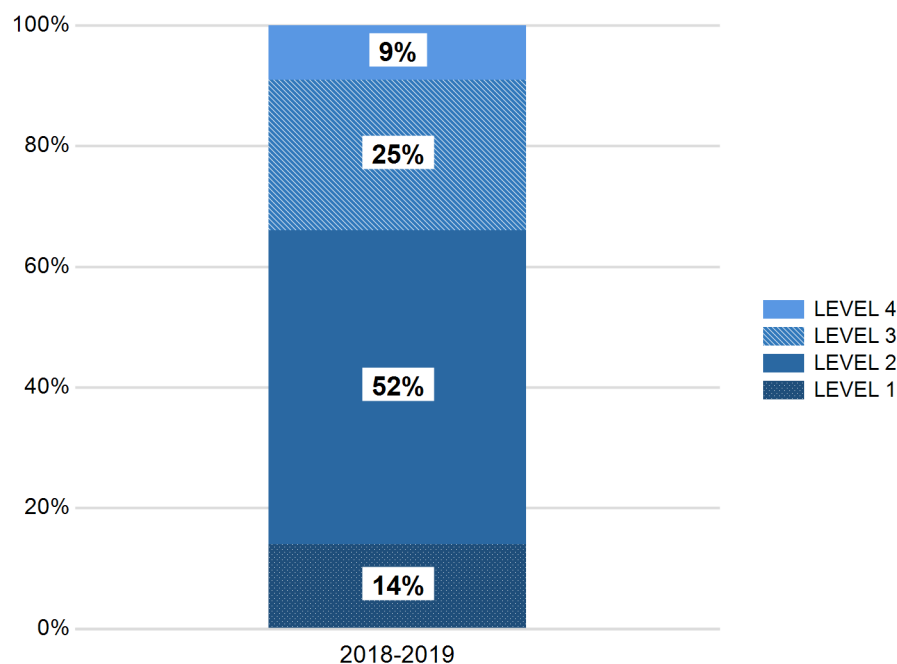

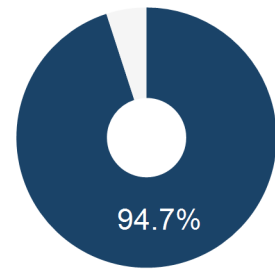

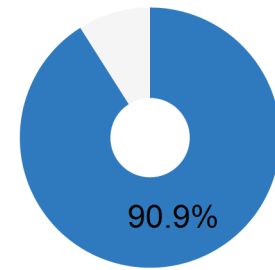

Students enrolled in one or more **visual and performing arts** classes

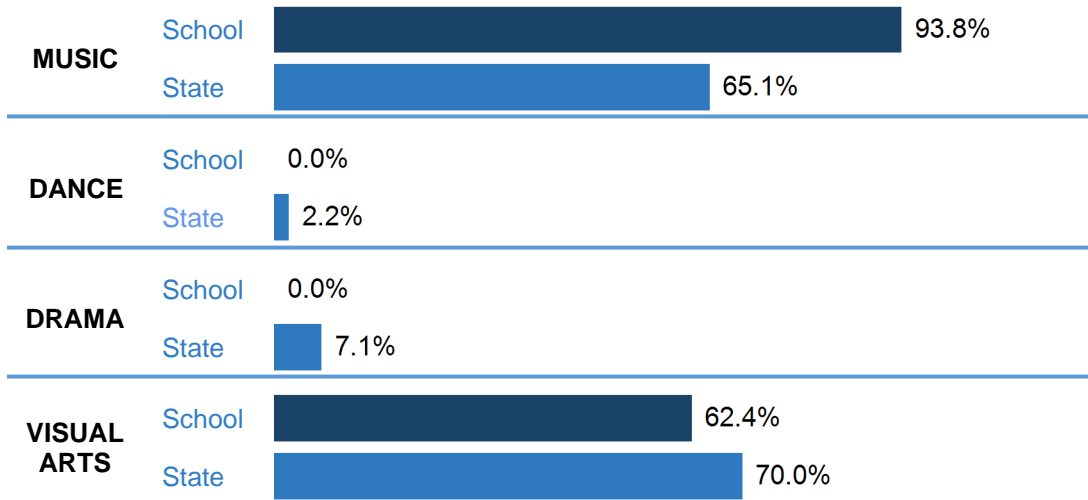

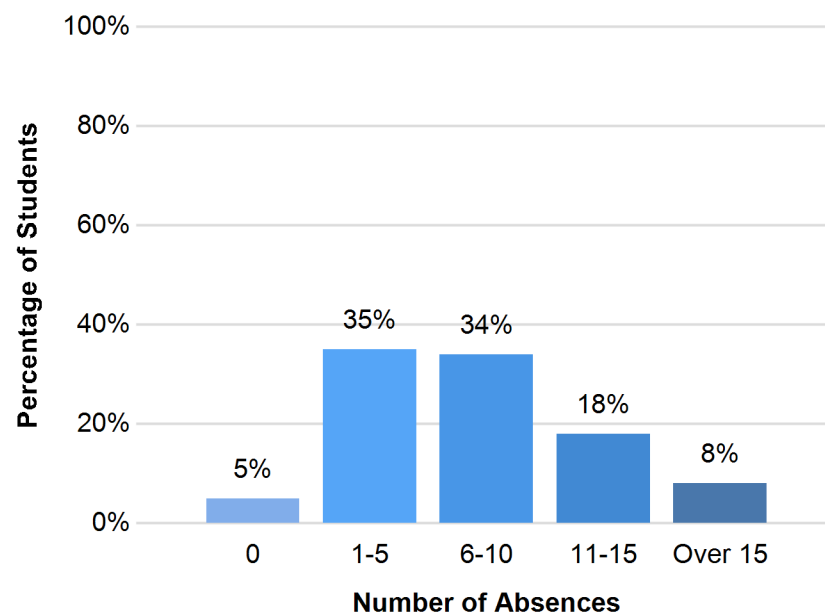

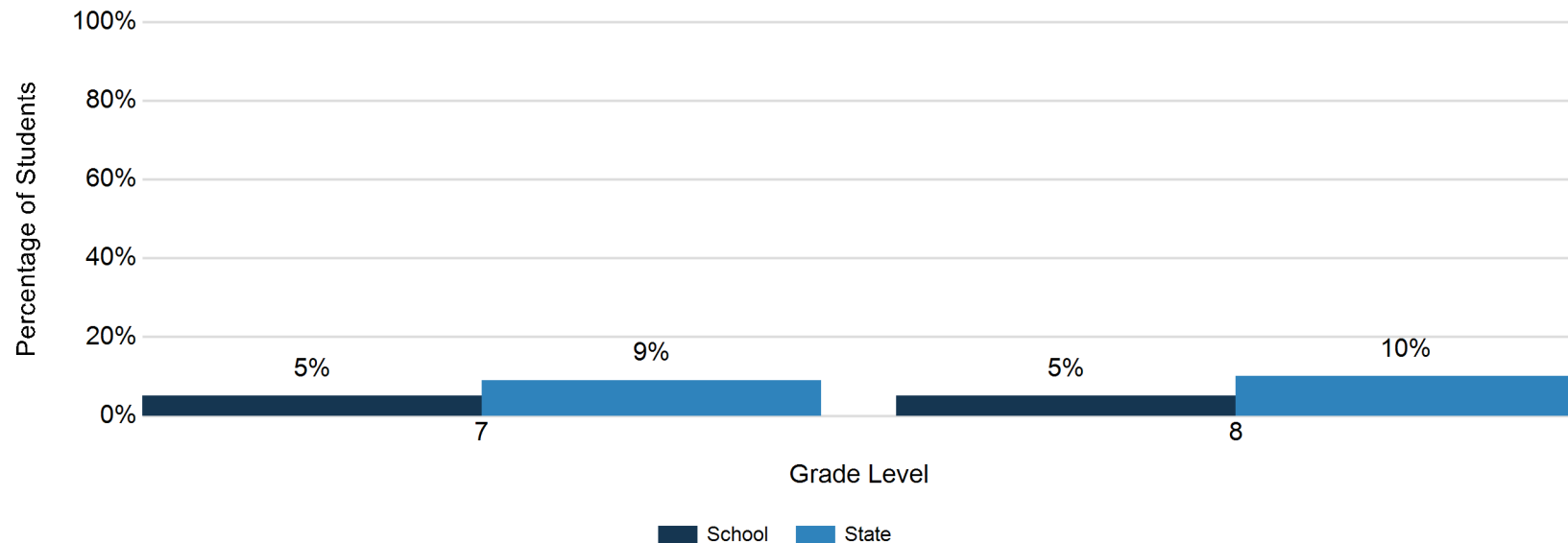
