Dear Mr. Porroni:

Attached is the New Jersey City University list of titles to be excluded from the residency requirement under the new residency law, N.J.S.A. 52-14-7 (the "New Jersey First Act").

These titles are to be excluded because, in accordance with N.J.S.A. 52-14-7, persons holding these faculty, research staff, and administrative positions at the University require special expertise or extraordinary qualifications in an academic, scientific, technical, or professional field or in administration so that, if not exempt from the residency requirement, would seriously impede the ability of the University to compete successfully with similar colleges, universities, or institutions in other states.
