**SUBCHAPTER 1. GENERAL PROVISIONS**

**10:133E-1.1 Purpose**

The purpose of this chapter is to list the services which the Division of Youth and Family Services shall provide to each eligible client and shall consider, when developing a case plan to contribute to achievement of the case goal.

**10:133E-1.2 Scope**

The provisions of this chapter apply to every applicant and client of the Division, and to each Division representative. The provisions of this chapter apply to each owner, director and employee of each service agency and each individual service provider with whom the Division has a contract.

**10:133E-1.3 Definitions**

The definitions in N.J.A.C. 10:133, Initial Response and Service Delivery General Provisions, are hereby incorporated into this chapter by reference.

**10:133E-1.4 Availability of services**

(a) An applicant or client may apply for the services listed in N.J.A.C. 10:133E-2 through a local office of the Division.

(b) The Division may provide the services listed in N.J.A.C. 133E-2 through direct service delivery by its own staff or by contract with another service provider.

(c) Some services listed in N.J.A.C. 10:133E-2.2 are not universally available. Some services are available only in certain geographic areas of the State. Some services are available to a limited number of persons at a given time. When this is the case, a waiting list may be established or an alternate service offered, if available and appropriate.

**SUBCHAPTER 2. SERVICES PROVIDED AND CONSIDERED**

**10:133E-2.1 Services the Division shall provide**

(a) The Division shall provide the following services to each client who meets the eligibility criteria in N.J.A.C. 10:133C-2, Eligibility for Services:

1. Assessment; and
2. Case management.

(b) For each child placed by the Division in an out-of-home placement, the Division shall:

1. Provide placement reviews, in accordance with N.J.A.C. 10:133H-3, and
2. Cooperate so that the Child Placement Review Board can provide placement reviews, pursuant to N.J.S.A. 30:4C-50 et seq.

**10:133E-2.2 Services as part of the case plan**

(a) In developing the case plan in accordance with N.J.A.C. 10:133D-2, the Division shall consider each of the following services:

1. Adoption subsidy;
2. Camp;
3. Case Assessment Resource Team;
4. Child care;
5. Clothing allowance;
6. Emergency maintenance service;
7. Family preservation services;
8. Homemaker service;

9. Information and referral;
10. Investigation;
11. Maintenance;
12. Out-of-home placement;
  - i. Adoptive placement;
  - ii. Alternative care home;
  - iii. Foster care;
  - iv. Group home;
  - v. Residential facility;
  - vi. Selected adoptive home;
- vii. Shelter care;
- viii. Supervised transitional living home;
- ix. Treatment home;
13. Post-adoption services;
14. Pre- and post-natal services;
15. Psychological/therapeutic services;
16. Respite care;
17. Self-sufficiency skills;
18. Title XIX Medicaid; and
19. Transportation.
