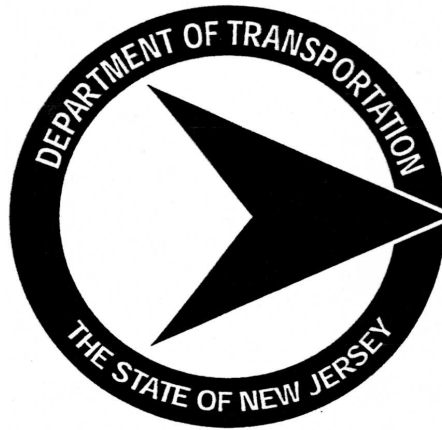

Dear New Jersey Citizens:

Public Law 1997, Chapter 4, (N.J.S.A. 27:1A-5.15) requires the New Jersey Department of Transportation (the Department or NJDOT) to annually prepare a report to the Governor and Legislature with an inventory of properties owned by the Department and held for transportation projects which are not under construction.

I am very pleased to present this report, which lists the properties owned by the Department, in accordance with this statute. As previously reported, the Department's inventory of properties not needed for construction was 1368.50 acres as of July 1, 2007. During the period between July 1, 2007 and December 31, 2008, approximately 11.38 acres were declared as excess and sold as surplus property. During this same period, through further research and refinement of its database, the Department has identified 218.91 additional acres that are owned by NJDOT.

As of December 31, 2008 the Department's inventory of excess land is 1,576.03 acres. Approximately 1,264.79 acres in the Department's inventory are retained and considered as being needed for present or future transportation needs. The remaining approximately 311.24 acres have either been declared excess and are available for sale or are being reviewed to make a formal determination of the land's status.

Property identified as surplus that is not sold in a two-year period from when it is declared excess and available for sale reverts back to the pool of properties considered retained by the Department. These properties can then be considered available for a potential future transportation use, but may again be evaluated for sale as surplus property if the Department receives an inquiry on a particular parcel. Reevaluation will ensure that changing needs or policies have not altered the decision to dispose of the property.

## **EXECUTIVE SUMMARY**

This report has been prepared in accordance with *Public Law 1997, c. 4 (N.J.S.A. 27:1A-5.15)*, which requires the New Jersey Department of Transportation (Department or NJDOT) to annually prepare a report to the Governor and Legislature on the inventory of property owned by NJDOT and held for transportation projects not under construction.

The Department has had a policy of selling lands not needed for transportation purposes and considered as excess and available to be sold as surplus property since 1956. Once a highway project has been completed, it is a goal of the Department to determine what parcels are excess and to initiate steps to dispose of them. Many parcels have been sold, but many more remain to be reviewed and determined if they can be disposed of as surplus property. Most of the parcels that make up the Department's inventory of land are small tracts that are often only of value to the adjoining property owner. While the Department does have some parcels of land that are large in size, many are landlocked; encumbered with restricted use, such as wetland or landscape; or are viewed as parcels that may be needed for future transportation needs.

The inventory of known NJDOT-owned excess property as of December 31, 2008 consists of 1,576.03 acres. As of July 31, 2007, the Department reported inventory of approximately 1,368.50 acres of land. Approximately 11.38 acres of this inventory was sold as surplus property through December 31, 2008. Through continuing research and refinement of its database, the Department has identified an additional 218.91 acres of land owned by NJDOT but not listed in the July 2007 inventory.

Potential new environmental requirements and changing needs of the Department cause the number of acres considered excess and available for purchase as surplus property to change from time to time. As a policy, all property identified as surplus that is not sold in a two-year period from when it was declared as excess and available for sale, reverts back to the pool of properties considered retained by the Department. These properties are then considered available for potential future use serving a transportation need but may be reevaluated on a case-by-case basis for sale as surplus property.

## **STATUTORY MANDATE**

*Public Law 1997, chapter 4, states as follows:*

**N.J.S.A. 27:1A-5.15. Inventory of certain State-owned properties, preparation**

*The Department of Transportation shall annually prepare, and submit to the Governor and the Legislature, an inventory of the properties owned by the State of New Jersey and held for transportation projects which are not under construction. The inventory shall include the location and size of the property, the date and cost of acquisition, the purpose for which the land was acquired and the reasons why the property has not been used for that purpose.*

Pursuant to the section of law cited above, the Department issues this report.

## **INTRODUCTION**

As of December 31, 2008, NJDOT's known inventory of properties consists of approximately 1,576.03 acres of land. Approximately 1,264.79 acres in the Department's inventory are retained and considered as being needed for present or future transportation needs. Of this total, approximately 311.24 acres have either been declared excess and are available for sale or are under review to determine the land's status.

This report identifies excess property in the Department's inventory – properties retained for current or future transportation needs, properties under review, and properties that have been cleared for sale between July 2007 and December 2008. Additionally, a summary of excess property sold by the Department from July 2007 through December 2008 is provided.

Since excess parcel review is a continuing process, inventory is expected to change frequently. Additional properties identified as owned by NJDOT will be added to the Department's inventory. In addition, completion of transportation projects may result in NJDOT property potentially becoming excess land.

NJDOT has its own parcel identification system to identify property that it owns. Tax block and lot information is also included, where available. Note that some municipalities do not use that type of designation for State properties adjoining highways.

### **PROPERTY MANAGEMENT POLICY**

The DOT adopted its current management plan for the acquisition, management and disposal of roadside property in 2001.

- To employ responsible environmental stewardship in managing the Department's property and seek opportunities to enhance the visual, environmental and scenic quality of New Jersey.
- To develop guidelines for acquisition of properties beyond the normal highway usage, which complement the State Development and Redevelopment Plan. The acquisition of properties needs to fit into the Department's overall capital investment strategy.
- To develop a viable excess land data management system, which will encompass a Geographic Information System (GIS) database. The GIS database will allow the Department to establish a comprehensive, computer-mapped inventory of all Department-owned property in order to better manage its existing property, facilitate reviews and enable broader planning capabilities.
- Investigate ways to transfer excess property to other entities that serve the public good, but are better able to preserve the land from development and maintain the property.

The technical and regulatory aspects of this policy continue to be developed and coordinated among the stakeholders having interest in these various initiatives.

All parcels are deemed to be needed by the Department until declared as excess and available for sale as surplus. Property identified as surplus that is not sold in a two-year period from when it was declared as excess and available for sale, reverts back to the pool of properties considered retained by the Department. These properties are then considered available for potential future use serving a transportation need such as wetland mitigation, roadway beautification, reforestation, park and ride locations, or other transportation need. As with all parcels retained by the Department, they may be reevaluated for sale as surplus property when the Department receives an inquiry on a particular parcel. Sale of such parcels would again be dependent on a determination of its potential need by the Department for transportation purposes.

### **EXCHANGES**

There are times when the Department will exchange land that it owns, considered excess surplus land, with an adjoining owner, municipality or other government agency for land that the Department has determined could be used for a transportation-related need. Exchanges of this kind, often involve a consideration of only \$1.00.

### **STATUS OF DISPOSAL OF DEDESIGNATED FREEWAYS**

State highway routes are set forth at N.J.S.A. 27:6-1. Five State highways had been designated as "freeways." In recognition of its holdings along particular routes, and where construction of a particular route would not be pursued, the Department sought passage of legislation dedesignating

four of these freeways. *P.L. 1997, c. 143* dedesignated Route 69, Section 1; Route 75, Section 3; Route 90, Sections 2 & 3; and Route 178, Section 1. Route 24 remains designated as a “freeway.”

Many parcels along the dedesignated routes have been sold. The following table summarizes the Department’s holdings for these routes:

### **EXPLANATION of TERMS and APPENDICES**

The following terms are used to describe the status of parcels owned by the Department:

- *Retain* means that the parcel is being retained for a specific purpose, such as wetland mitigation, or may be needed for a future transportation need, but that it can be reviewed on a case-by-case basis to determine its availability for sale or lease.
- *Under Review* means that the parcel is under review to determine if the property can be declared as excess and made available for sale as surplus property.
- *Available as Surplus Property* means the parcel has been declared as excess and deemed available for purchase as surplus property from the Department.

The appendices in this report provide recent land parcel sales through June 2007, the status of current NJDOT excess property and a summary by county of Department inventory acquired for transportation projects no longer under construction. They are described as follows:

**APPENDIX A** – Lists land parcels declared as excess by NJDOT and sold from July 1, 2007 through December 31, 2008 as surplus property; organized by county. This appendix does not include certain properties conveyed by the Department to the South Jersey Transportation Authority in 2005, as these properties were acquired with the sole intent to be conveyed to the Authority.

**APPENDIX B** – Lists right-of-way parcels owned by NJDOT to be retained for present or future transportation needs or that are under long-term lease; organized by county.

**APPENDIX C** – Lists excess right-of-way parcels owned by NJDOT declared as excess and available for sale as surplus property or currently under review to determine if the property can be declared excess; organized by county.

**APPENDIX D** – Summary of sold, retained, available and under review properties; organized by county.
