Annual Report on Access to Employer-Based Health Insurance

2007

Background

In August 2006, legislation was enacted (P.L. 2006, c.87) directing the Commissioner of the Department of Human Services (DHS) to prepare an annual report on Access to Employer-Based Health Insurance for NJ FamilyCare (NJFC) enrollees.

The purpose of the report is to identify those employers, with 50 or more NJFC/Medicaid enrollees, in the State whose employees and their dependents do not have access to employer-based health insurance coverage and receive, instead, insurance coverage through the publicly-funded NJ FamilyCare/Medicaid program.

Data Report Source

The Department of Labor and Workforce Development (LWD) utilized their database to match against a file containing NJFC/Medicaid enrollee social security numbers provided by DHS' Division of Medical Assistance and Health Services (DMAHS). The file utilized by the Department of Labor was not collected for the intent of producing this report.

It is important to note that there are limitations inherent in the information available for this report. The LWD file does not contain enrollee quarterly income or number of hours worked. As a result, the report cannot provide information on whether an employee is full-time or part-time or how long the employee has been employed with a particular employer. The report illustrates a "period of time" (from 04-01-07 to 06-30-07) and is a representation of what the employment picture looks like for certain NJFC/Medicaid eligibles in New Jersey.

Although the enabling legislation calls for the employer's address or work site, the data source utilized does not list individual employment sites. Instead, the data file provides an address directly related to each tax identification number which may be a corporate site or a payroll vendor. For this report, the tax identification number is listed for each employer.

NJ FamilyCare

NJ FamilyCare provides free or low cost comprehensive health insurance for uninsured children and certain low income parents. This program is both state and federally funded and eligibility is based on income and household size. Children can be eligible with household income up to 350% of the federal poverty level (FPL) (i.e., \$72,275 for a family of four). Parents' eligibility income threshold is much lower at 133% FPL (i.e., \$27,465 for a family of four). In most instances, to be eligible for NJFC, the enrollee must have been uninsured for three months.

While there are a few exceptions to this rule (family lost health insurance through no fault of their own, i.e., parent was laid off), higher income families (134% FPL and higher) cannot drop employer sponsored health care coverage to access NJFC.

Data Report Summary

The data shows that there are 328 employers in New Jersey with 50 or more NJFC/Medicaid enrollees. They employ a total of 45,680 employees (see Column A of Table 1) who are receiving health care coverage through NJFC/Medicaid. In addition, the data shows that 85,256 spouses and dependents (see Column B) of these employees are also receiving NJFC/Medicaid.

Of these 45,680 employees, 1,581 have private insurance (see Column F). "Traditional" Medicaid clients (funded under Title XIX of the federal Social Security Act of 1965) may have private insurance or third party liability (TPL). Medicaid then becomes the payer of last resort once the private coverage has reimbursed for allowable medical services.

Column D in the table shows the number of employees, 820, who are receiving services through the NJ Workability Program and are employed. NJ Workability offers full New Jersey Medicaid health coverage to people with disabilities who are working, and whose earnings would otherwise make them ineligible for Medicaid. Generally to be eligible for NJ Workability, a person must be between the ages of 16 and 64, working part time, full time or be self-employed, have a permanent disability and meet certain income and resource guidelines. As of August of this year, there were 2,550 enrollees on the NJ Workability program.

Also included in the data is information on government employers with 50 or more employees NJFC/Medicaid enrollees, for which there are twelve (see Table 2). These twelve government employers employed 1,834 NJFC/Medicaid enrollees with 3,976 spouses or dependents at a total cost of \$3,540,069.64. The cost to New Jersey for these enrollees is \$1,808,738.18.

Cost to the State

The total NJFC/Medicaid expenditures for the three month period from April 1, through June 30, 2007 were \$91,634,397.35. Of this \$91.6 million, \$83,739,132.89 was spent for Medicaid coverage while \$4,571,518.97 was spent for NJFC coverage.

In terms of state versus federal dollars spent for Medicaid expenditures, the cost to New Jersey was \$41,869,566.45 and for NJFC expenditures, the cost to New Jersey for this same time period was \$1,600,031.64.

The remainder of the funds, \$3,323,745.49, was state only funds. While not specifically reflected in the data provided, for the same time period noted, \$124,269 was paid in premium support payments by the state. The Premium Support Program (PSP) subsidizes employer-sponsored coverage by "buying in"

to private coverage available to the employee when it is most-effective. To be eligible to participate in the PSP, the employee must be NJFC eligible, dependent children must be under the age of 19 and uninsured. The employee must also have access to employer sponsored insurance.

Charity Care Information Submitted by the Department of Health and Senior Services

The statute requires the Department of Health and Senior Services (DHSS) to compile, to the extent data are available, information about employed recipients of charity care. Specifically, the law requests the following information: the employer's name and address; the number of recipients on charity care who are employed by the employer; and the cost to the State of providing charity care for employer's employees and their dependents. Please know that at this time data are not available due to the lack of a unique identifying number. The Department is in the process of implementing necessary policies and procedures to ensure the requested data may be collected for inclusion in future annual reports.
