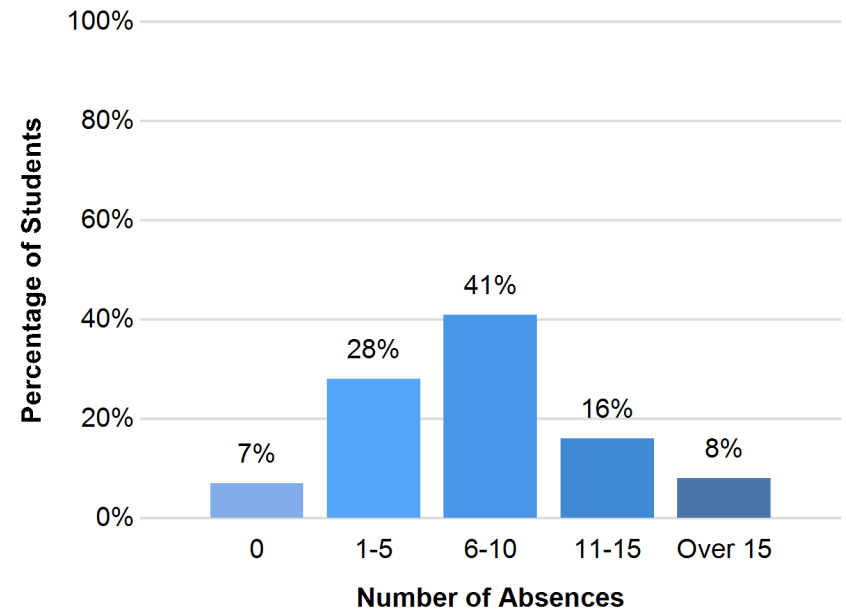

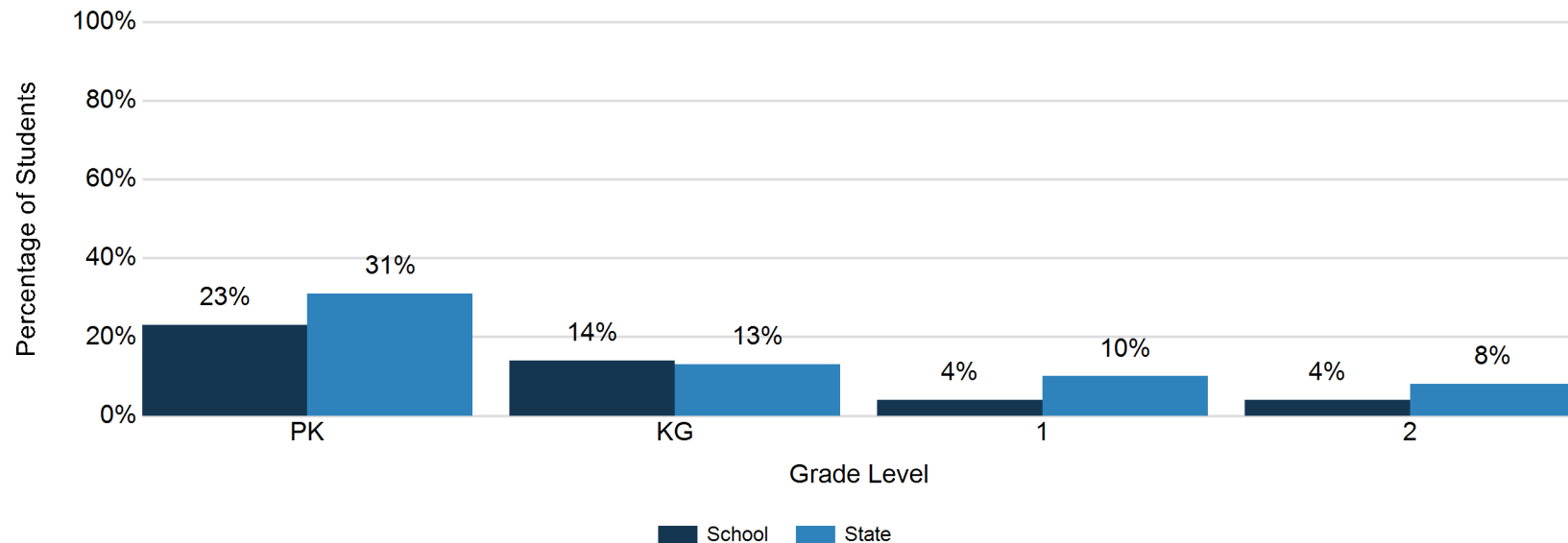

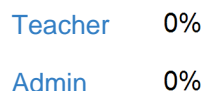

Courses, Curriculum, Instruction:

At North Cliff, students engage in Reading and Writing Workshop, Go Math, and Knowing Science programs. ELA (English Language Arts) and Math instructional approaches are both centered on a workshop structure, where teachers facilitate highly differentiated small group instruction. The science program is a hands-on inquiry based program where students explore, experiment, conjecture, analyze, and evaluate. The social studies program reinforces pillars of citizenship as well as literacy skills. The World Language program supports interpersonal, presentational, and interpretive modes of communication. Students also engaged in all related arts, with a concentrated effort on the creation of purposeful interdisciplinary connections.



Clubs and Activities:

The district offers many opportunities for students to participate in clubs and activities. Students K-2 participated in Jump Rope for Heart through the American Heart Association. In Grade 2, students can qualify for Project Primary, which is enrichment for students that meet the criteria.

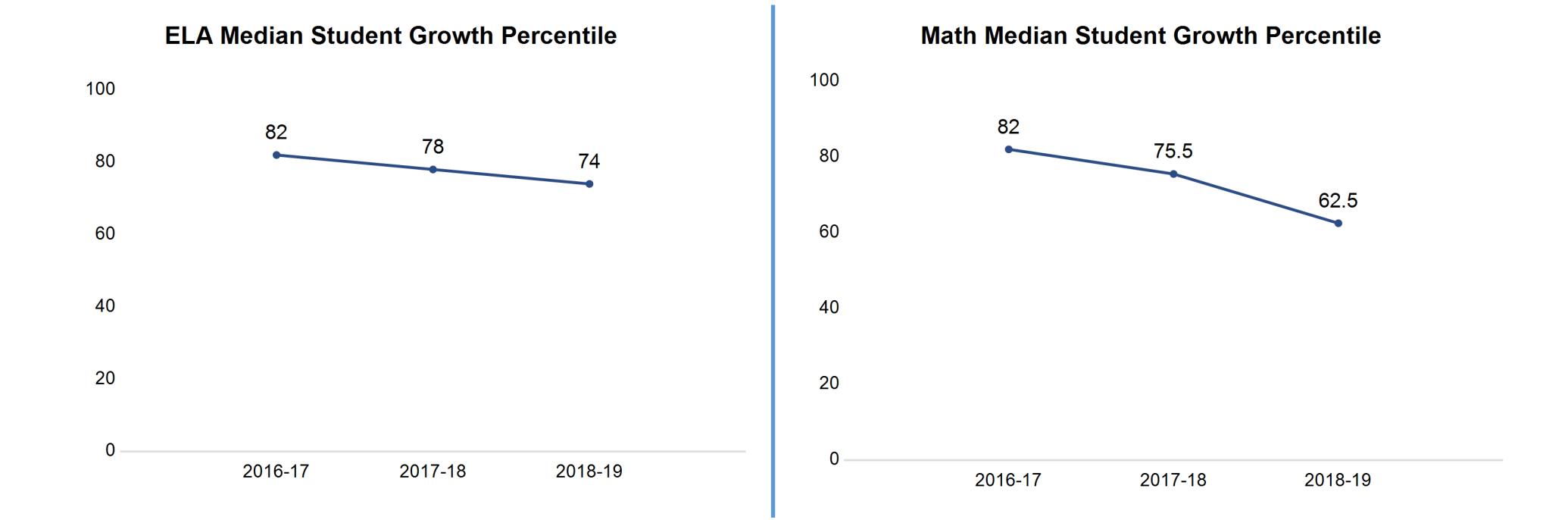

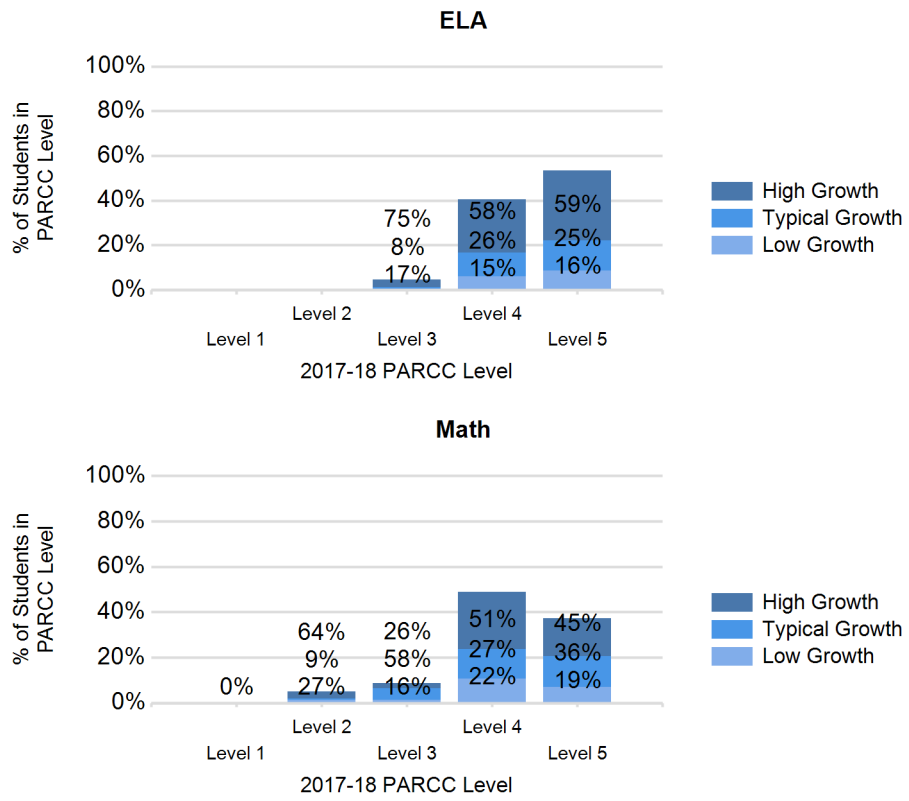

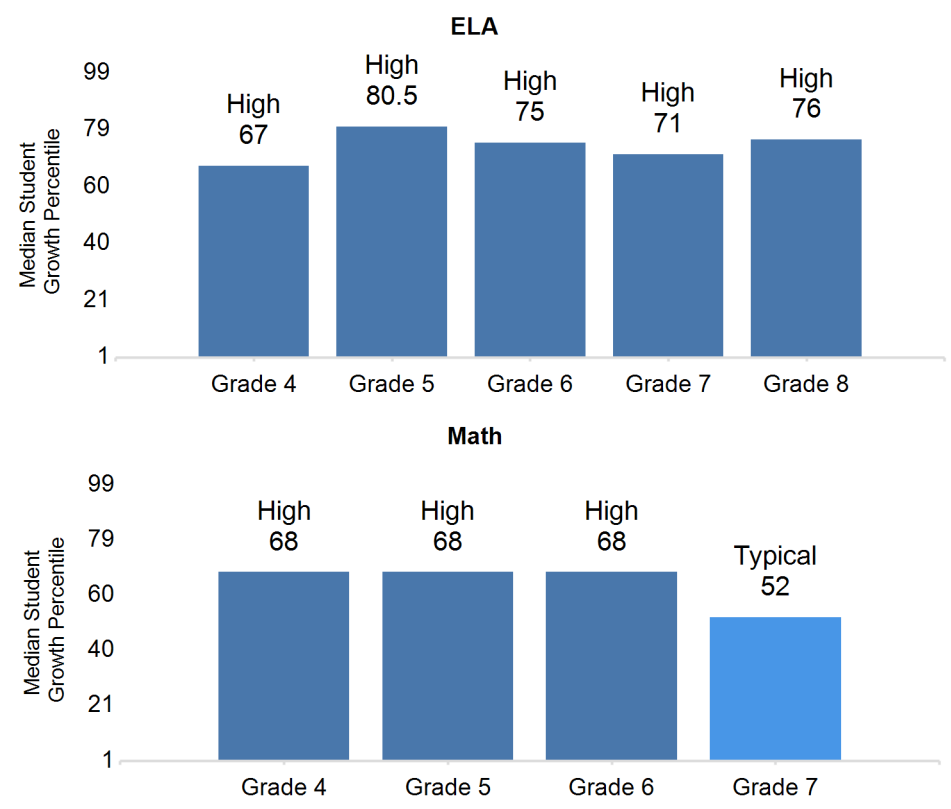
Student Growth by Performance Level

These graphs show the median Student Growth Percentile for students in each grade.



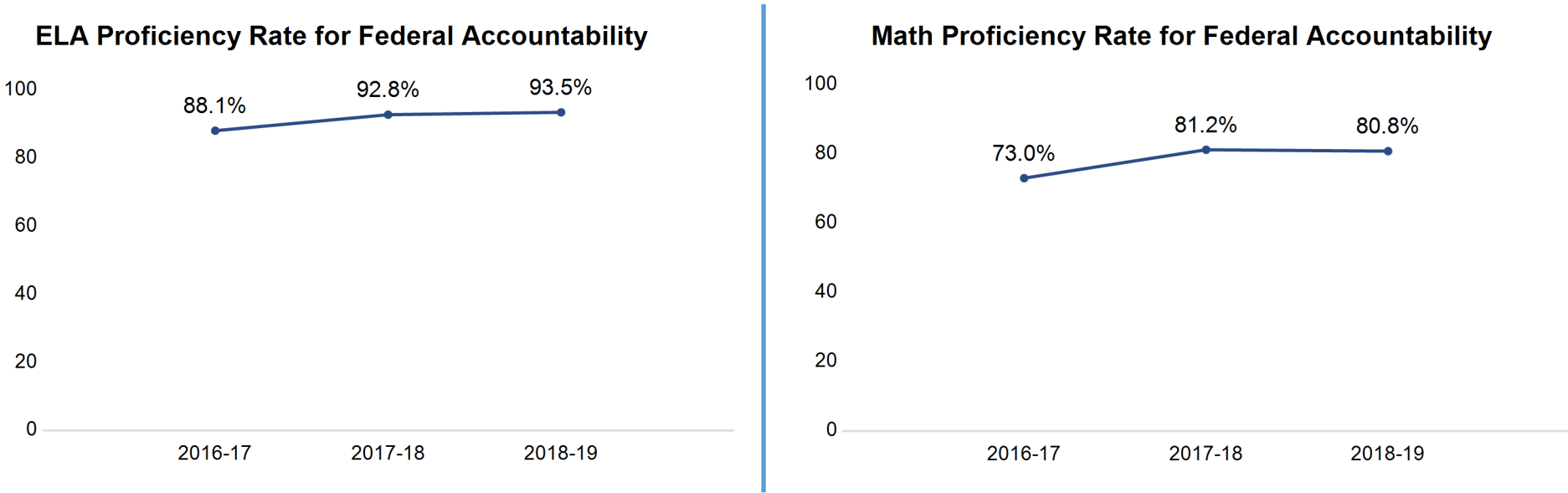

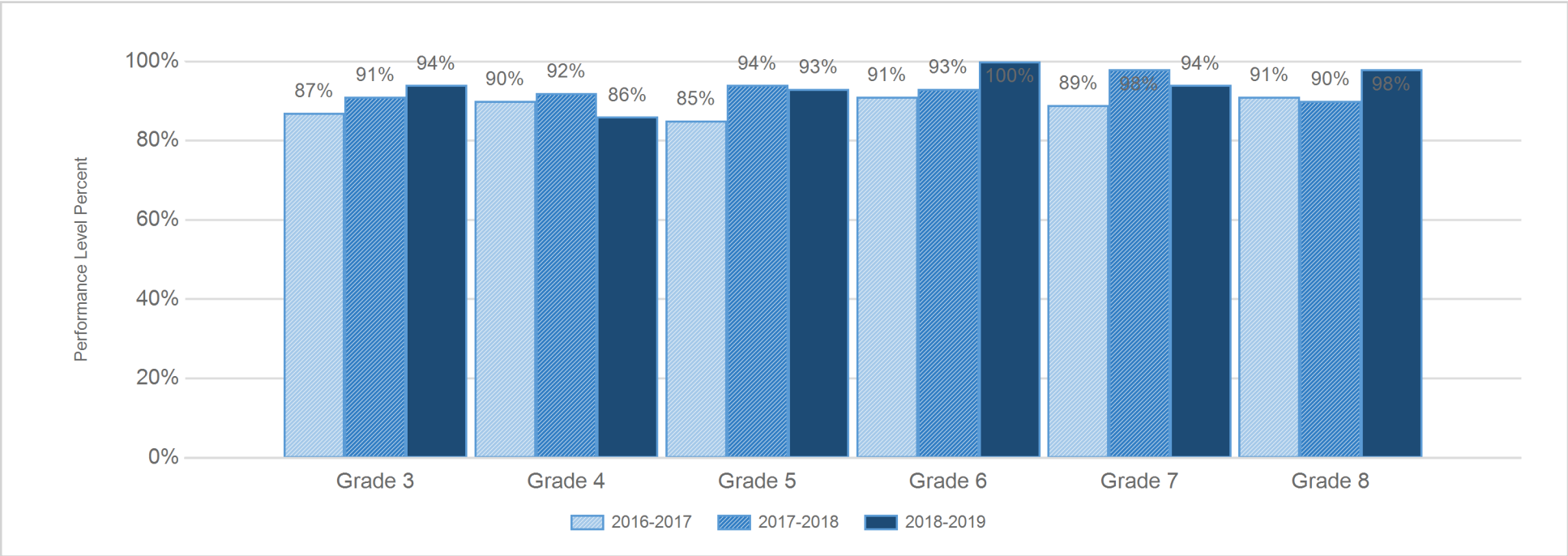

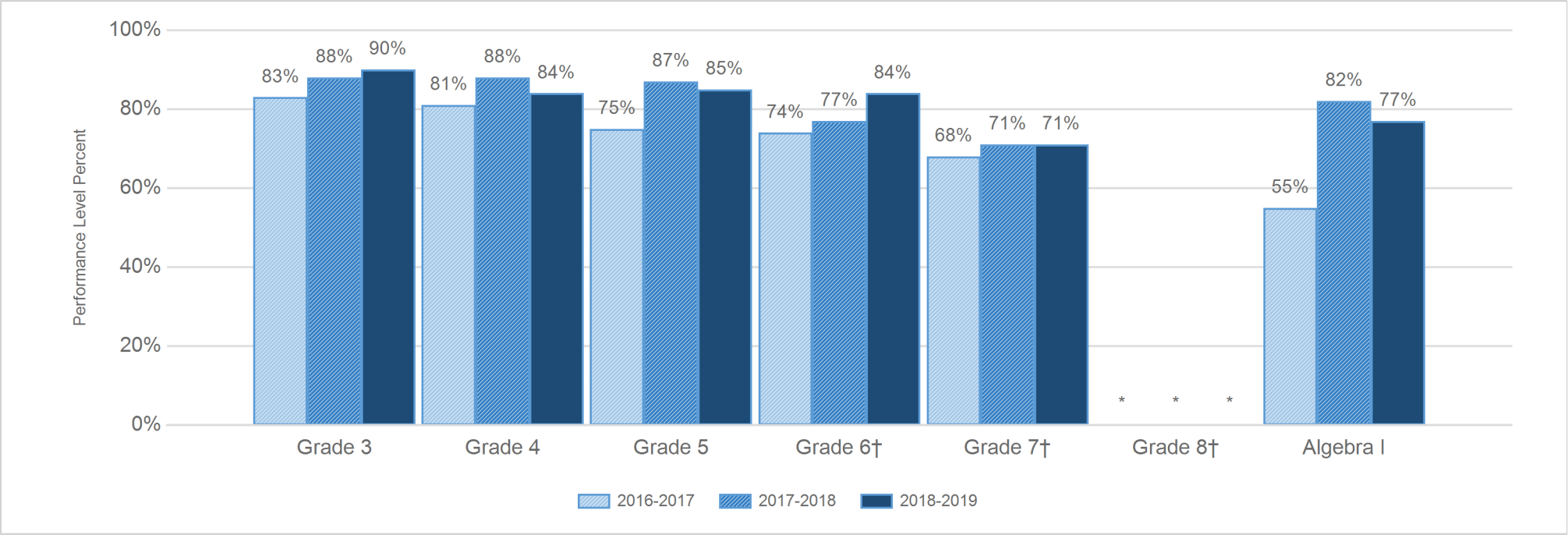

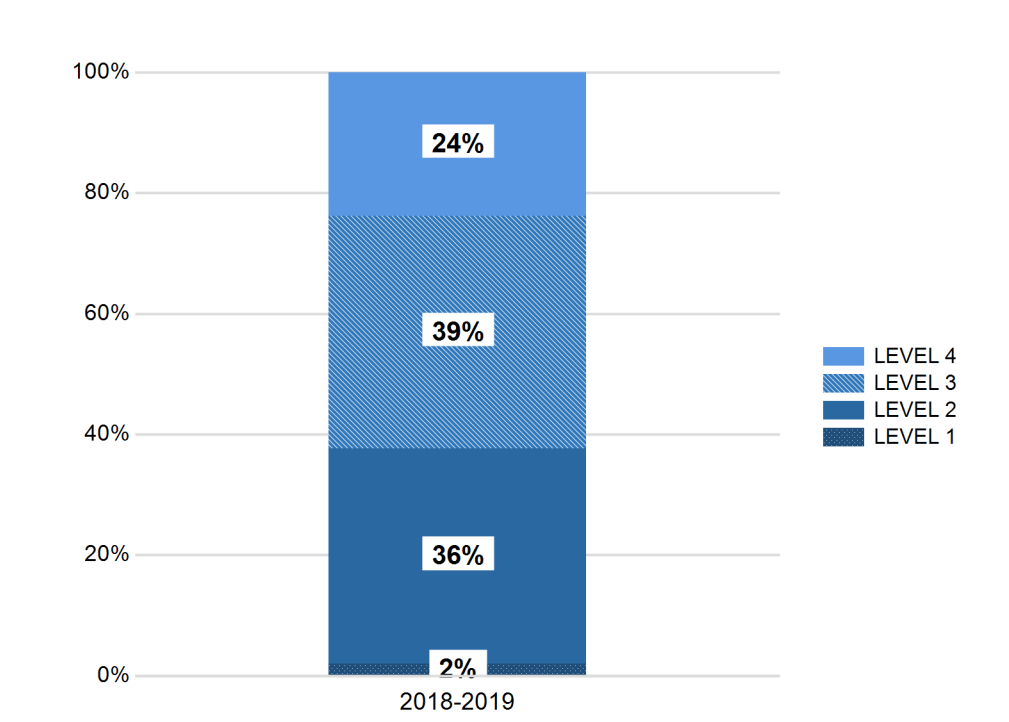

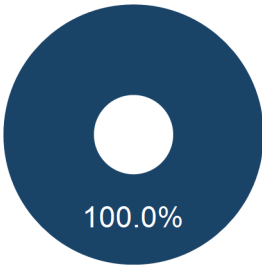

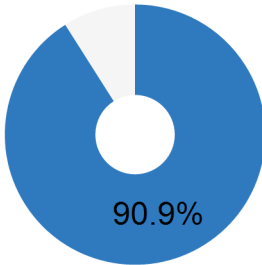

Students enrolled in one or more **visual and performing arts** classes

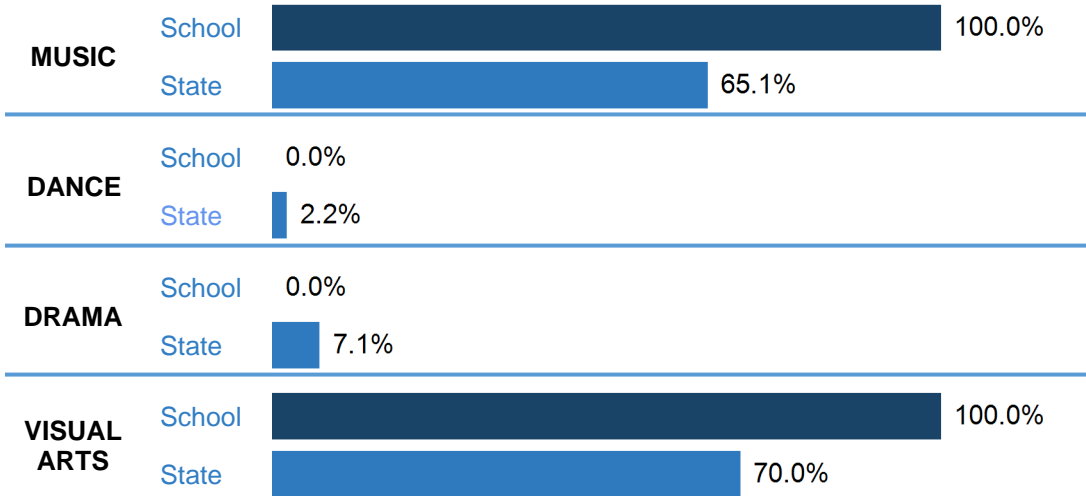

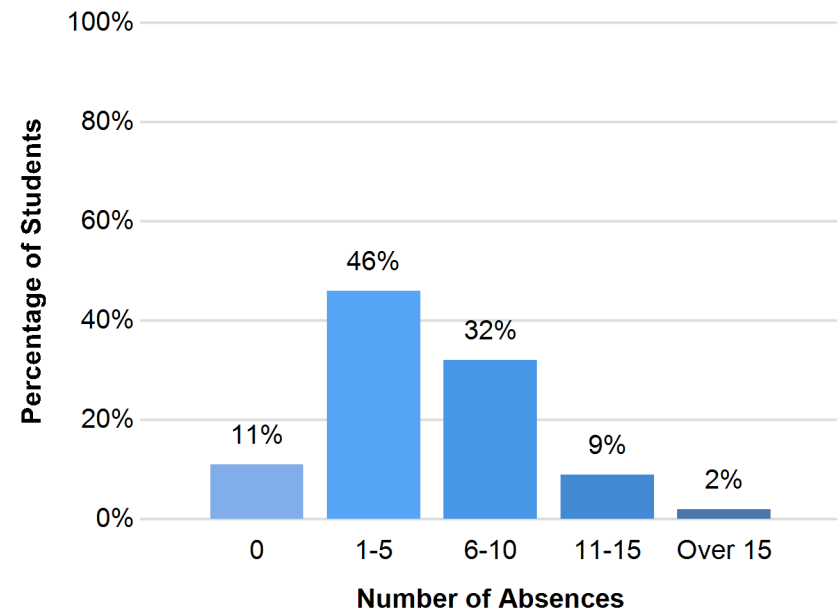

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





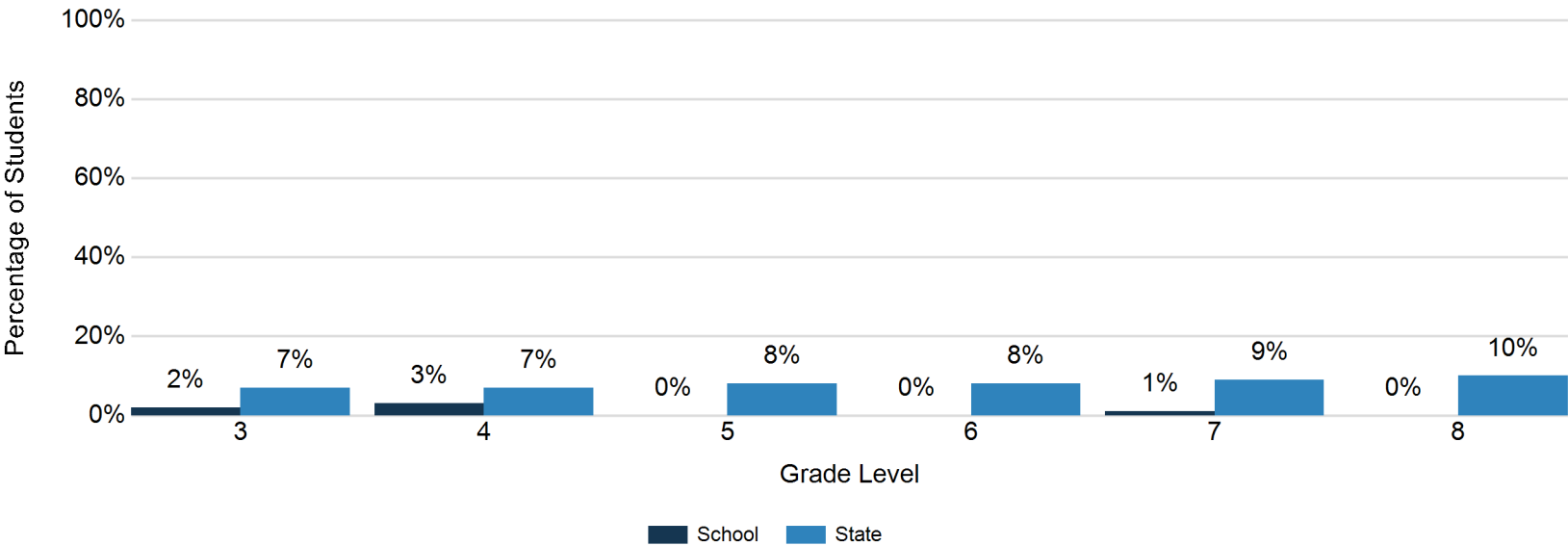

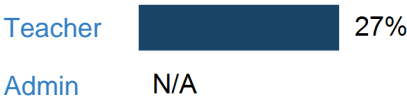

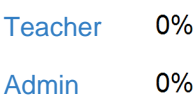

The middle school mathematics sequence culminates with Algebra I in eighth grade. The Social Studies program extends students' understanding of citizenship by promoting student led initiatives related to democracy and service learning. Approaches to science instruction are hands on and inquiry based, allowing students to engage in content just as “scientists” do. Students also have the opportunity to continue with their choice of World Language programs - French, Italian, or Spanish. Related Arts instruction culminates with the district’s theme-based “Related Arts Day”, which builds on classroom learning concepts from throughout the year.</p>
<div>  <div>Clubs and Activities:</div> </div>	<p>Upper School offers many opportunities for students to participate in clubs and activities. Students in grades 6-8 participate in “Educate to Innovate (E2i)”, a course that focuses on integrity, leadership, and innovation. Examples of this include student leadership activities, community service opportunities, and skill building through academic and artistic competitions. A large percentage of the school also participates in band, glee, and school musicals. Students are also given opportunities to participate in various competitions including the Spelling Bee (Grades 3-8), a Speech competition (Grade 8), and GATE (Gifted and Talented).
