



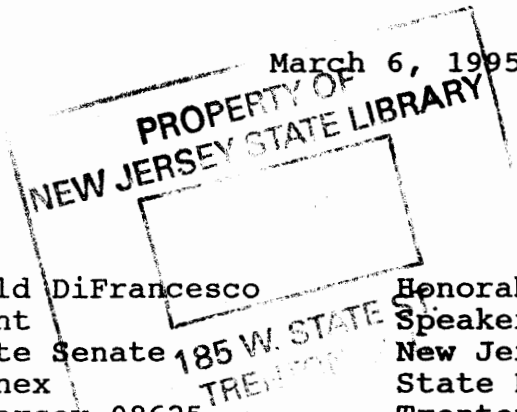

Consensual Intercept Reports 1993, Summary

The attached reports, based on intercept data submitted by law enforcement agencies statewide, provide information required by statute, N.J.S.A. 2A:156A-23(c) and (d), concerning the agencies utilizing intercepts, the nature of the investigation or activity, the offenses involved, and the results of the intercept activity. The reports include narrative highlights along with a detailed list of all intercepts authorized by county and investigating agency.

Non-Third Party Intercepts

- . Statewide, a total of 177 non-third party intercepts were reported: 46 were reported by the Attorney General's Office and 131 were reported by county and local law enforcement agencies within ten of the 21 counties.
- . Of the 158 intercepts installed and used (19 were never implemented and utilized), the majority (127 or 80%) were used in conjunction with criminal investigations. In addition, 28 intercepts were used for protection, two were utilized during internal affairs investigations, and one was used in conjunction with a motor vehicle violation investigation.
- . The majority (54%) of intercepts reported were for controlled dangerous substance violations.
- . Non-third party intercepts were used requested, installed and used in conjunction with 143 investigations. (More than one intercept may be employed during one investigation.) Of these investigations, 65 resulted in arrests, 26 were pending further investigation at the close of the report year, and 8 were referred to another agency for criminal prosecution, administrative action or municipal court action.
- . In all 143 subjects were arrested as a result of non-third party intercepts: 46 were indicted, 69 were pending grand jury at the end of the report year, and 25 were referred for action (15 were referred to another agency for criminal prosecution and 10 were referred to family court). One defendant was admitted into a pre-indictment diversionary program.
- . At the close of the report year, 22 of the 46 defendants indicted reached final disposition. All 22 defendants reaching final disposition were convicted through guilty pleas.

Third Party Intercepts

- . In all, 565 third party intercept applications were made statewide in 1993: 489 applications were processed through prosecutors' offices and 76 applications were processed through the Attorney General's Office. One application was withdrawn and the remaining 564 applications were approved.
- . Statewide, 329 intercepts were authorized, installed and utilized. In all, 85 intercepts were never implemented or used.
- . Application was made and approved to extend 80 intercepts. In all, 126 extensions were granted for these 80 intercepts.
- . The total number of days authorized including original days authorized and renewal days for all intercepts ranged from 1 to 180, with an average of 21 days authorized per intercept.
- . Considering only those 440 intercepts installed and used and for which days data was reported, the number of days used ranged from 1 to 98, while the average number of days used per intercept was 5.
- . Almost one-half (45%) of all intercepts authorized were for controlled dangerous substances; followed by theft (9%); murder, attempted murder and conspiracy to commit murder (8%); sexual assault (5%), assault (5%), arson/risking widespread injury (3%); forgery and fraud (3%) and official misconduct (3%).
- . Third party intercepts were authorized and used in conjunction with 358 investigations. More than one intercept may be employed during one investigation. (Excludes the 122 intercepts which were never implemented.)
- . Of those 358 investigations, 172 resulted in arrests, 74 were pending further investigation at the close of the report year, 5 were pending grand jury or court action, and 12 were referred for action (9 were referred to another agency for criminal prosecution and 3 were referred to another agency for administrative action). One intercept investigation resulted in the loss of a professional license.
- . At the close of the report year, 101 defendants were indicted, 139 were arrested and awaiting grand jury action, 54 were referred to another agency for criminal prosecution, 39 pleaded guilty to disorderly persons offenses, 5 were referred to family court for disposition, 2 were admitted into pre-indictment diversionary programs and 2 were adjudicated delinquent after being referred to family court. In all, 362 subjects were arrested as a result of third party intercepts during the report year.
- . Of those defendants with indictments reaching final disposition, 48 (91%) were convicted through plea, 4 were accepted into post-indictment diversionary programs, and 1 had indictment charges dismissed.

Consensual Intercepts 1993

Third Party N.J.S.A. 2A:156A-4(c)

Data reported by law enforcement agencies statewide were compiled to report on the operation of the third party consensual intercepts authorized under the Wiretapping and Electronic Surveillance Control Act, N.J.S.A. 2A:156A-4(c). This report provides narrative highlights concerning applications for consensual intercepts as well as intercepts authorized. As required by statute, the report contains data concerning:¹

- (1) The law enforcement agencies requesting authorization for the consensual intercept;
- (2) The character of the investigation or activity involved, for example, the offense investigated and the type of intercept authorized; and
- (3) The results of such activity.

In addition to the narrative highlights and detailed information provided for 1993 applications and consensual intercepts, supplemental follow-up data are provided for consensual intercepts reported in previous calendar years.

¹ The name of the investigating officer making the intercept is reported and maintained in the Attorney General's Office. For security purposes, these names are confidential and are available to the Governor and Legislature under appropriate circumstances.

APPLICATIONS

In 1993, 565 applications were made statewide for third party consensual intercepts in accordance with N.J.S.A. 2A:156A-4(c). Of the total applications seeking authorization, 76 were processed through the Attorney General's Office. These applications were submitted by the Division of State Police and the Division of Criminal Justice. The other 489 applications were authorized by 17 of the 21 county prosecutors' offices. Four county prosecutors' offices (Burlington, Cumberland, Hudson, and Salem counties) report no applications for third party consensual intercepts in 1993. Of the 565 applications for consensual intercepts, 564 were authorized. One application was withdrawn.

CONSENSUAL INTERCEPTS AUTHORIZED

In all, 564 consensual intercepts were authorized. Moreover, application was made and approval was granted to extend 80 of the original authorizations.

- . In 49 instances, one extension was granted.
- . In 20 instances, two extensions were granted.
- . In 8 instances, three extensions were granted.
- . In 2 instances, four extensions were granted.
- . In 1 instances, five extensions were granted.
- . In all, 126 extensions were granted.

- . Of the 80 original authorizations for which extensions were granted, 21 were processed by the Attorney General's Office and 59 were authorized by county prosecutors' offices.
- . Of the 564 intercepts for which authorization was granted, 440 were installed and used. In all, 122 intercepts were never implemented and information pertaining to installation was missing in two instances.
- . Days authorized for original authorizations ranged from 1 to 60, with an average of 16 days authorized per intercept. (Includes the 501 intercepts granted for which the number of days authorized was reported.)
- . For only those intercepts for which extensions were granted and for which all relevant days data were reported, the number of renewal days authorized ranged from 1 to 150. The average number of renewal days authorized was 35 days. (Includes the 61 intercepts for which extensions were granted and for which the number of renewal days was reported.)
- . While the total number of days including original days authorized and renewal days for all intercepts ranged from 1 to 180, the average number of days authorized per intercept was 21 days.
- . Considering only those intercepts installed and used and for which data was available, the number of days used ranged from 1 to 98, while the average number of days used per intercept was 5 days. (Excludes those 75 intercepts for which data for days authorized or days used was not reported.)

The type of surveillance conducted is categorized as wire, oral, or both wire and oral.

- . Of the 491 intercepts authorized and for which type of surveillance was reported, 184 (37%) involved oral intercepts, 177 (36%) involved wire intercepts, and 130 (26%) involved both oral and wire intercepts. (The type of surveillance conducted for 73 intercepts was not reported.)

Offense data collected and analyzed consider only the most serious substantive offense investigated. Of those 564 consensual intercepts granted, the largest proportion (45%) were authorized in conjunction with criminal investigations involving controlled dangerous substance offenses. A list of intercepts granted by category of most serious offense investigated follows.

²Includes 30 intercepts with missing offense data, six intercepts authorized for conspiracy with no substantive offense reported, two intercepts for harassment, malicious damage, robbery and serving alcohol to a minor, and one intercept for stalking.

INVESTIGATIONS UTILIZING CONSENSUAL INTERCEPTS

When conducting investigations, more than one intercept may be employed. Because of such instances, the use of intercepts is reported by considering the total number of investigations which employ consensual intercepts.

- . During 1993, the 564 intercepts authorized were in conjunction with 447 investigations.
- . The 440 intercepts actually installed and utilized were in conjunction with 358 investigations. (Excludes the 122 intercepts which were never implemented and the two intercepts for which installation and outcome data was not provided.)
- . Of those 358 investigations for which intercepts were installed and utilized, 172 resulted in arrests.
- . In addition, 74 investigations were pending further investigation at the close of the report year, 5 were pending grand jury or court action, and 12 were referred for action (9 were referred to another agency or jurisdiction for criminal prosecution and 3 were referred to another agency for administrative action). One intercept investigation resulted in the loss of a professional license.

INTERCEPT OUTCOME

Summary information regarding outcomes is provided below with detailed information on the following pages.³ The information provided concerns intercept and investigation outcomes, arrest and referral actions, defendant indictments resulting from each intercept application, the most serious offense charged, defendant dispositions, and administrative actions.

- . Of those 440 intercepts installed and used, five resulted in court-authorized electronic surveillance. These intercepts produced sufficient evidence to support court-ordered electronic surveillance applications.
- . At the close of the report year (December 31, 1993), a total of 362 arrests were made and 101 defendants were indicted statewide as a result of 1993 third party consensual intercepts.
- . Of those 101 defendants indicted, considering the most serious offense charged, 49 (49%) were indicted for controlled dangerous substances and 13 (13%) were indicted for theft offenses.
- . Eight defendants were indicted for murder offenses, seven were indicted for assault charges, and four were indicted for forgery/fraud and kidnapping offenses.
- . Three defendants were indicted for burglary, three for official misconduct and two for offenses involving arson/risking widespread injury, perjury, or sexual assault.

³In addition to defendant indictment and disposition data for 1993 consensual intercept applications, supplementary follow-up data are provided for intercepts reported in previous calendar years.

- . Moreover, one defendant was indicted for each of the following offenses: endangering the welfare of a child, impersonating a police officer, possession of explosives, and gambling.
- . In addition to those defendants indicted, 139 were arrested and awaiting grand jury action at the close of the report year, 54 were referred to another agency or jurisdiction for criminal prosecution, 39 pleaded guilty to disorderly persons offenses, 5 were referred to family court for disposition, 2 were admitted into pre-indictment diversionary programs and 2 were adjudicated delinquent after being referred to family court.
- . At the close of the report year, 53 of the 101 defendants indicted reached final disposition.
- . Of those defendants with indictments reaching final disposition, 48 (91%) were convicted through plea, 4 were accepted into a post-indictment diversionary program and one had charges dismissed.

Data reported by law enforcement agencies statewide were compiled to report on the operation of the non-third party consensual intercepts authorized under the Wiretapping and Electronic Surveillance Control Act, N.J.S.A. 2A:156A-4(b). As required by statute, this report provides data and narrative highlights concerning:¹

- (1) The law enforcement agencies utilizing non-third party consensual intercepts;
- (2) The character of the investigation or activity involved, for example, the offense investigated and the type of intercept authorized; and
- (3) The results of such activity.

In addition to the narrative highlights and detailed information provided for 1993 applications and consensual intercepts, supplemental follow-up data are provided for non-third party consensual intercepts reported in previous calendar years.

¹ The name of the investigating officer making the intercept is reported and maintained in the Attorney General's Office. For security purposes, these names are confidential and are available to the Governor and Legislature under appropriate circumstances.

In 1993, 177 non-third party consensual intercepts were reported in accordance with N.J.S.A. 2A:156A-4(b). Of the total non-third party intercepts, 46 were processed by the Attorney General's Office and 131 were processed by county and local law enforcement agencies.

- . Ten of the 21 counties (Bergen, Cape May, Essex, Hunterdon, Mercer, Monmouth, Morris, Ocean, Somerset and Warren counties) report non-third party intercepts processed by either county law enforcement agencies or local police departments. The remaining 11 counties report no law enforcement intercepts.
- . Of the 177 non-third party intercepts reported, 158 were installed and used. The remaining 19 were never implemented.

The type of surveillance conducted is categorized as wire, oral or both wire and oral.

- . Of those non-third party intercepts installed and utilized and for which the type of surveillance was reported (130), 93 involved oral intercepts, 29 involved wire intercepts and 8 involved both oral and wire intercepts.

The majority (127 or 80%) of the non-third party intercepts installed and utilized were reported to have been used in conjunction with criminal investigations. Twenty-eight intercepts were used for protection, two were utilized during internal affairs investigations, and one was utilized in conjunction with a motor vehicle violation investigation.

Offense data collected for non-third party intercepts and analyzed consider only the most serious substantive offense. Offenses investigated were reported for 144 of the 159 intercepts. A list of all intercepts by most serious offense, offense category or violation investigated follows.

INVESTIGATIONS UTILIZING CONSENSUAL INTERCEPTS

When conducting investigations, more than one intercept may be employed. Because of such instances, the use of intercepts is reported by considering the total number of investigations which employ intercepts.

- . Statewide, non-third party intercepts were requested, installed and used in conjunction with 143 investigations.
- . Considering only those investigations during which intercepts were installed and used, 65 (46%) resulted in arrests.
- . In addition, 26 (18%) were pending further investigation or grand jury action at the close of the report year and 8 were referred to another agency or jurisdiction for criminal prosecution, administrative action or municipal court action.

INTERCEPT OUTCOME

Summary information regarding outcomes is provided below with detailed information on the following pages.³ The information provided concerns intercept and investigation outcomes, arrest and referral actions, defendant indictments resulting from each intercept application, the most serious offense charged, and defendant dispositions.

- . At the close of the report year (December 31, 1993) a total of 46 defendants were indicted statewide as a result of 1993 non-third party consensual intercepts.

³ In addition to defendant indictment and disposition data for 1993 non-third party consensual intercepts, supplementary follow-up data are provided for intercepts reported in previous calendar years.

- . Of those 46 defendants indicted, considering the most serious offense of offenses category charged, 22 (48%) were indicted for controlled dangerous substance violations.
- . In addition, 12 (26%) defendants were indicted for official misconduct, 7 (15%) for assault, 2 (4%) for forgery/fraud, 2 (4%) for murder, and 1 for theft.
- . In all, 1993 non-third party consensual intercepts resulted in 143 arrests during the report year.
- . In addition to those 46 defendants who were indicted, 69 were pending grand jury action at the close of the report year, 25 defendants were referred to another agency or jurisdiction for action, and 1 defendant was accepted into a pretrial diversion program.
- . Of those 25 defendants referred for action, 15 were referred to another agency or jurisdiction for criminal prosecution prior to indictment and 10 were referred to family court.
- . At the close of the report year, 22 of the 46 defendants indicted reached final disposition.
- . All 22 defendants reaching final disposition were convicted through guilty pleas.
