Please file a wage complaint with the NJ Wage and Hour Division and Contract Compliance if any of the below statements apply:

- You are an employee working in New Jersey and you have a complaint about unpaid wages.
- You are an employee working in New Jersey in a construction-related public works project subject to the [NJ State Prevailing Wage Act \(https://www.nj.gov/labor/wageandhour/tools-resources/laws/prevailingwageact.shtml\)](https://www.nj.gov/labor/wageandhour/tools-resources/laws/prevailingwageact.shtml) and you have a complaint about unpaid wages or fringe benefits.
- You are an employee working in New Jersey providing [building services \(https://www.nj.gov/labor/wageandhour/tools-resources/laws/statebuildingcontractsact.shtml\)](https://www.nj.gov/labor/wageandhour/tools-resources/laws/statebuildingcontractsact.shtml) (e.g. janitor, security guard, window cleaner, etc.) for a property owned or leased by the State of New Jersey and you have a complaint about unpaid wages or fringe benefits.
- You are an employee with a complaint regarding the [Temporary Workers Bill of Rights. \(https://www.nj.gov/labor/worker-protections/myworkrights/temporaryworkers.shtml\)](https://www.nj.gov/labor/worker-protections/myworkrights/temporaryworkers.shtml)
- You have a complaint against a New Jersey company for violating a [NJ Labor Law \(https://www.nj.gov/labor/wageandhour/tools-resources/laws/\)](https://www.nj.gov/labor/wageandhour/tools-resources/laws/) that is under the jurisdiction of the NJ Wage and Hour Division and Contract Compliance.
