Nonfarm wage and salary employment in New Jersey increased by 8,200 from August to September to a seasonally adjusted total of 3,090,100.

The bulk of the increase was in government which rose over the month by 7,600 on a seasonally adjusted basis. This rise in government resulted, in large part, from a seasonal adjustment aberration in the local government segment. Because of decreased hiring this summer under CETA youth and other programs, terminations from local government payrolls in September were less than seasonally expected. Department analysts noted that local government employment in September was 800 below the level recorded in June, the month just prior to the hiring of summer youth, and almost 15,000 lower than in September 1980. A gain of 1,200 from August to September in the state government segment reflected the slightly earlier placement on payrolls of some employees of New Jersey institutions of higher education.

Private sector employment went up marginally from August to September to 2,570,400 as seasonally adjusted employment rose by 1,500 in private non-manufacturing industries and declined by 900 in manufacturing.

Within nonmanufacturing, jobholdings in trade were up by 2,700 to a seasonally adjusted level of 684,500, mainly due to increased hiring in department stores while employment in the service sector edged downward over the month. Layoffs in the casino industry contributed to the overall decline in services of 1,500.

Manufacturing employment dropped by 900 in September to a seasonally adjusted total of 775,700, mainly because of scattered layoffs and closings throughout the nondurable goods sector. The most substantial decreases were in foods and chemicals, both of which dropped by 800, and in apparel, which was down by 600. Recalls from a model-changeover layoff in the motor vehicle segment made transportation equipment the leader among manufacturing industries in over the month gains. September jobholding in the transportation equipment industry, however, remained 2,400 below the level of the 1981 high, recorded in July.

The weekly earnings of manufacturing production workers averaged \$326.82 in September, up by \$6.08 from August and \$25.97 from a year ago. The over the month rise was the largest since September 1980. Transportation equipment was responsible for most of this gain, with an over the month increase of \$78.39 primarily due to more overtime and higher wage rates. After seasonal adjustment, the average workweek registered 40.7 hours, down by 0.1 hours from August.

LABOR AREA COMMENTS (Nonseasonally adjusted data)

Total nonagricultural wage and salary employment decreased in September in eight of the state's ten major labor areas, while two registered increases.

The most substantial loss in jobholdings was recorded in the Atlantic City Labor Area, which dropped by 5,700 over the month. Following closely were the Long Branch-Asbury Park and Camden Labor Areas, dropping by 5,500 and 3,500, respectively. The Trenton Labor Area registered the largest increase in September, climbing by 1,900 jobs.

The Atlantic City decrease was concentrated in the nonmanufacturing division, declining by 5,600, primarily because of seasonal layoffs in services and trade and cutbacks in government because of terminations of the Summer Youth Employment Participants (SYEP). The Long Branch and Camden declines were also in nonmanufacturing. Terminations of the SYEP employees and greater-than-expected layoffs in trade and services accounted for the slump in employment. The Trenton increase, chiefly in nonmanufacturing, was due to scattered hirings in trade and services.

In the manufacturing division, activity was varied over the month, with six areas showing increases of from 100 to 5,700, three areas registering decreases of from 100 to 500, and only the New Brunswick-Perth Amboy-Sayreville Labor Area remaining the same. The Newark Labor Area recorded the largest increase, up by 5,700, mainly because of recalls after a model change-over in the transportation equipment industry.

Note: Hours and earnings data for labor areas are revised to new benchmarks. Data are not precisely comparable to previously issued data.

Detailed analysis on a labor area basis can be found in Employment and the Economy, a monthly newsletter available through the Division of Planning and Research. These reports are prepared for major areas by area analysts.



TECHNICAL NOTES

Nonfarm Wage and Salary Employment

Employment data refer to persons on establishment payrolls who received pay for any part of the pay period which includes the 12th of the month. The data exclude proprietors, the self-employed, unpaid family workers, farm workers, and domestic workers in households. Salaried officers of corporations are included. Government employment covers only civilian employees; federal military personnel are excluded.

Persons on an establishment payroll who are on paid sick leave (when pay is received directly from the firm), on paid holiday or paid vacation, or who work during any part of the pay period but are unemployed or on strike during the rest of the period, are counted as employed. Not counted as employed are persons who, during the pay period which includes the 12th, are laid off, on leave without pay or on strike for the entire period, or who are hired but do not work during the period.

Average Hours and Earnings

Hours and earnings data are derived from reports of payroll and man-hours for production and related workers in manufacturing. When the reported pay period exceeds one week, the payroll and man-hour figures are reduced to a weekly basis.

Average hourly earnings for manufacturing are on a "gross" basis, reflecting not only changes in basic hourly rates, but also such variable factors as premium pay for overtime and shift work, and changes in output of workers paid on an incentive plan. Excluded from average earnings are irregular bonuses, retroactive items, payments of various welfare benefits, and payroll taxes paid by employers.
