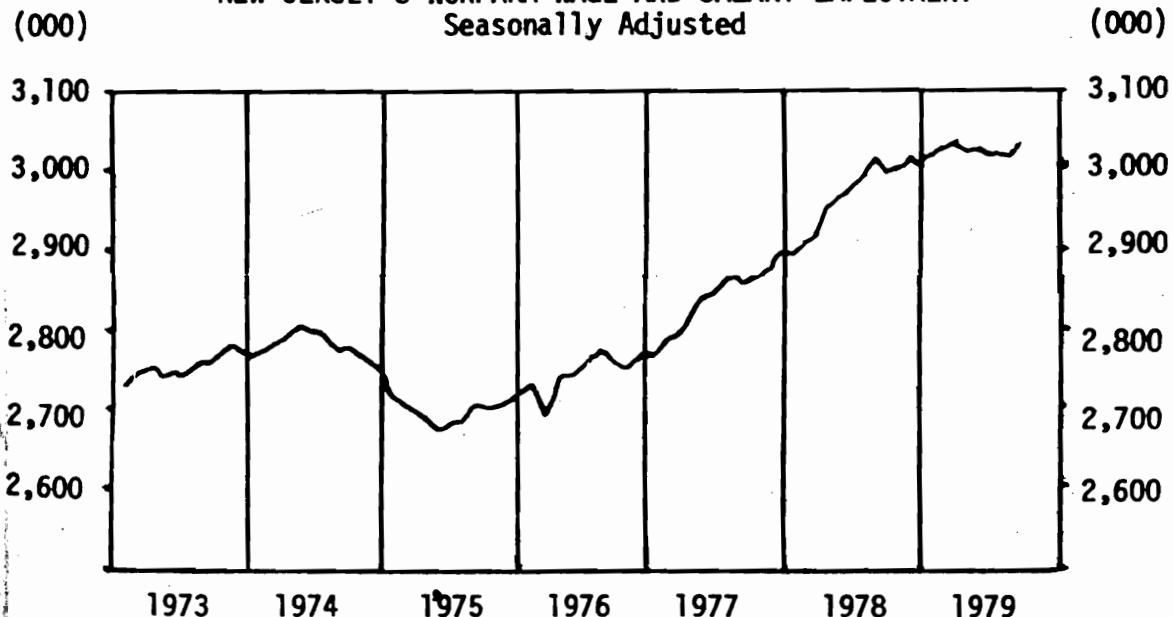

Total nonagricultural wage and salary employment rose by 8,400 to 3,026,500 in August on a seasonally adjusted basis, reaching the second highest level on record, (the record total occurred in March 1979). Nonmanufacturing employment increased by 11,200, while manufacturing employment decreased by 2,800.

On an unadjusted basis nonagricultural wage and salary employment in August totaled 3,071,200, an increase of 3,100 from the July level, as gains in the manufacturing sector more than offset losses in the nonmanufacturing sector. Among manufacturing industries, the nondurable goods employment gain of 9,100 was partially offset by a durable goods loss of 2,700.

Seasonal increases in the miscellaneous manufacturing industries accounted for the largest gain among the durable goods, increasing by 1,000. Electrical machinery and nonelectrical machinery suffered sharp declines of 2,700 and 900, respectively, as labor-management disputes were responsible for a combined loss of about 2,900 workers between these two industries.

Nondurable goods employment rebounded from seasonal declines in July. The leather industry registered the only employment loss in the sector, dropping by 100. The apparel industry dominated growth activity as it increased by 6,200, reflecting seasonal returns unpaid vacations in July.

Nonmanufacturing employment decreased by 3,300, although four out of seven industry groups increased from July. A loss of 3,900 employees in government and 1,100 in trade offset all gains in the nonmanufacturing sector.

The loss in government is attributable to the continued drop of school personnel on the local level, while seasonal declines in retail trade caused an overall drop in the trade industries. Among those industries to increase were services and construction with gains of 700 and 600, respectively.

After seasonal adjustment, a slight increase of 400 in nondurable goods employment was more than offset by a 3,200 decline in durable goods in the manufacturing sector. Transportation equipment had the largest gain among durable goods, expanding by 1,400 despite the loss of 700 workers in the motor vehicle industry due to the elimination of an assembly line. Offsetting all gains was a decline of 2,100 positions in electrical machinery, resulting from 2,000 striking workers. Additional decreases of 600 each were noted in the furniture, primary metals, fabricated metals, and miscellaneous manufacturing industries. Nondurable goods employment presented a mixed picture as gains more than offset declines. Gains in apparel, increasing by 1,300, and food, up by 700, were partially offset by decreases of 700 in rubber and 600 in textile products.

Nonmanufacturing employment expanded by 11,200, with the government sector providing more than one half of the growth. Government increased by 6,300, as local government expansion was responsible for the total increase. Services had the next largest gain, increasing by 3,100, and the largest employment decline was in construction, which dropped by 700.

Over the year, 30,300 employees (not seasonally adjusted) were added to nonfarm wage and salary payrolls; an increase of 1%. All of the increase was in the nonmanufacturing sector, as manufacturing employment dropped 2,800 from August 1978. Durable goods employment gained by 4,100, with the largest annual increase in the electrical machinery industry, which expanded by 1300 despite the effects of 2000 striking workers. Miscellaneous manufacturing employment, down by 700, had the largest annual decrease. Nondurable goods employment, had a decline of 6900 over-the-year, led by apparel and textile mill products, which decreased by 3600 and 2400, respectively, with printing and publishing, up by 1700, having the largest growth.

Nonmanufacturing employment rose by 33,100 from a year ago. Services reflect an increase of 23,300 or 70% of the annual nonfactory growth. Wholesale and retail trade, expanding by 10,700, had the next largest increase. The only decrease in employment among the nonmanufacturing industries was in government, which dropped by 7900 due to cutbacks at the local level.

LABOR AREA EMPLOYMENT COMMENTS

Before seasonal adjustment, nonfarm wage and salary employment declined from July-to-August in five of the State's ten major labor areas.

The Hackensack area, down by 2,300, had the largest decrease, due to cutbacks in the government and the trade sectors. The Atlantic City area, up by 1,600, had the largest increase, due to jobholding advances in the service sector.

In the manufacturing sector eight areas had increases. The Hackensack area, up by 900, had the largest increase, due to expansion in the "other nondurable goods" sector. The Vineland-Millville-Bridgeton area, up by 800, also had a sizeable increase, due to seasonal expansion in the food industry. The Newark area, which dropped by 1,600, had the largest decrease, primarily due to a drop of 2,400 in electrical machinery, which largely reflected a strike against one major firm.

In the nonmanufacturing sector all areas but Newark, Atlantic City, and Jersey City had decreases. The Hackensack and the Paterson-Clifton-Passaic areas, down by 3,200 and 1,300, respectively, had the largest drops. Both areas had sizable declines in the state and local government sector.

Over-the-year data showed that total nonfarm employment increased in all areas but Jersey City. The Newark area, up by 11,000, had the largest increase, primarily due to expansion in the service sector. The Atlantic City area rose by 10,200, reflecting job expansion in the construction and service sectors. The Perth Amboy-New Brunswick-Sayreville area also had a substantial increase of 6,400, because of advances in all nonmanufacturing groups but construction and government.

HOURS AND EARNINGS

The weekly earnings of manufacturing production workers averaged \$273.98 in August, a decrease of 25 cents from July and an increase of \$18.13 from a year ago. The average hourly earnings of \$6.65 were up 1 cent from July and up 47 cents from a year ago. During the August survey week, production workers averaged 41.2 hours, compared with 41.3 hours a month ago.

On an unadjusted basis, 12 out of 19 primary manufacturing industrial groups had increases in weekly earnings over the month. The largest increase was in primary metals, which rose by \$14.67. Transportation had the largest decline, dropping by \$44.19 because of a sharp decrease in overtime in all sectors.

The highest average weekly earnings in August were in the petroleum industry, which averaged \$416.73 for a 47.9-hour workweek. The highest hourly earnings were in the transportation industry which averaged \$8.87. The lowest average weekly earnings were in the leather products industry with \$148.15 for a 36.4 hour workweek.

TECHNICAL NOTES

Nonfarm Wage and Salary Employment

Employment data refer to persons on establishment payrolls who received pay for any part of the pay period which includes the 12th of the month. The data exclude proprietors, the self-employed, unpaid family workers, farm workers, and domestic workers in households. Salaried officers of corporations are included. Government employment covers only civilian employees; federal military personnel are excluded.

Persons on an establishment payroll who are on paid sick leave (when pay is received directly from the firm), on paid holiday or paid vacation, or who work during any part of the pay period but are unemployed or on strike during the rest of the period, are counted as employed. Not counted as employed are persons who, during the pay period which includes the 12th, are laid off, on leave without pay or on strike for the entire period, or who are hired but do not work during the period.

Average Hours and Earnings

Hours and earnings data are derived from reports of payroll and man-hours for production and related workers in manufacturing. When the reported pay period exceeds one week, the payroll and man-hour figures are reduced to a weekly basis.

Average hourly earnings for manufacturing are on a "gross" basis, reflecting not only changes in basic hourly rates, but also such variable factors as premium pay for overtime and shift work, and changes in output of workers paid on an incentive plan. Excluded from average earnings are irregular bonuses, retroactive items, payments of various welfare benefits, and payroll taxes paid by employers.
