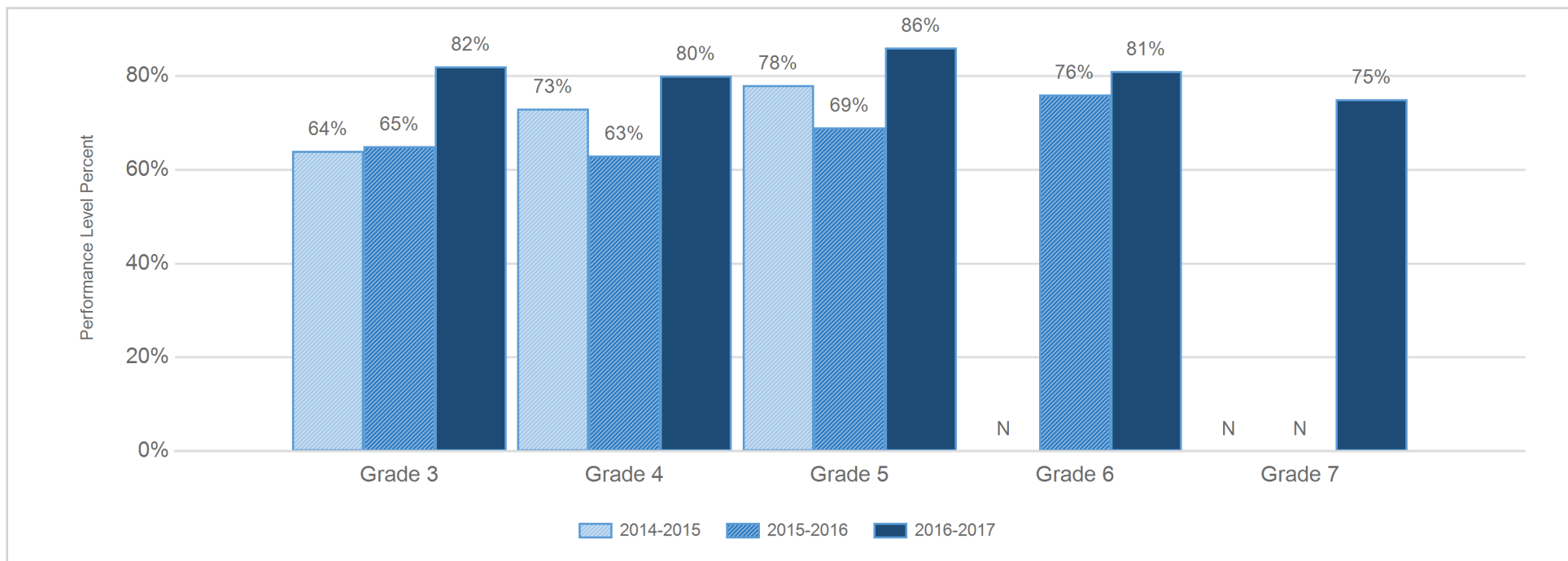

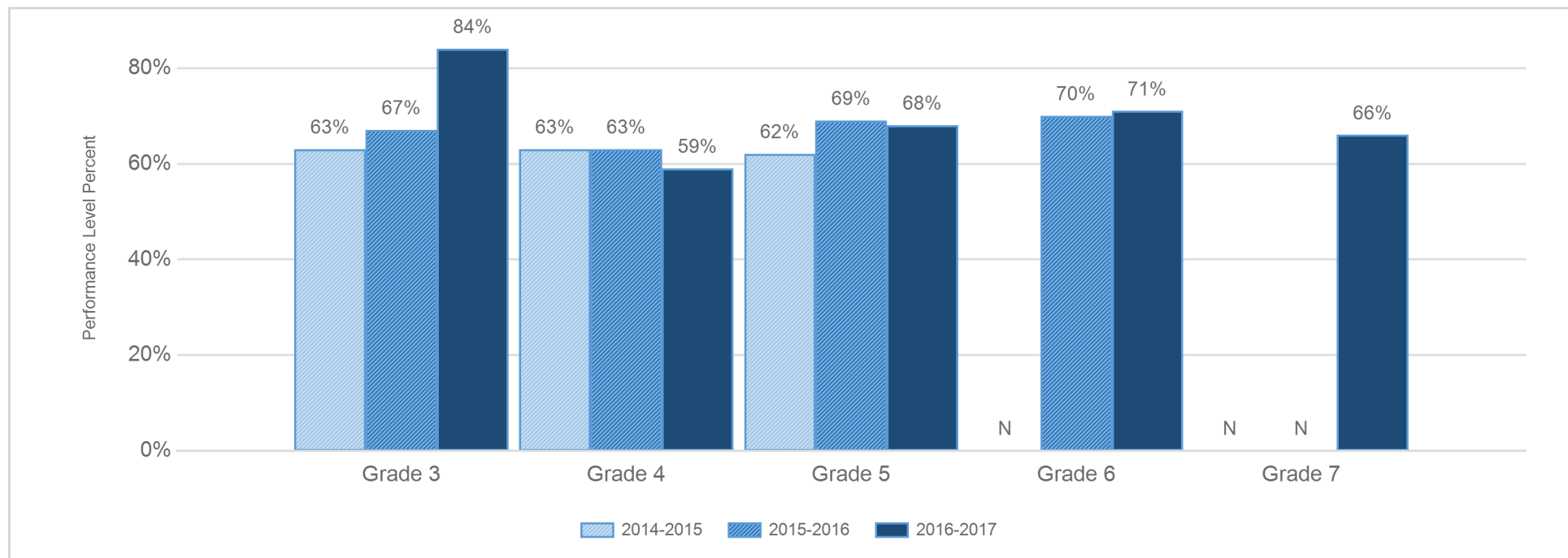

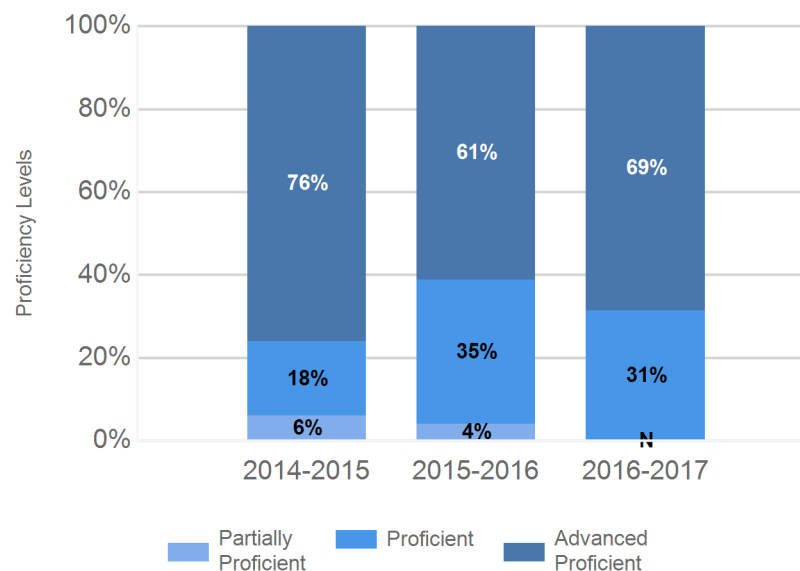

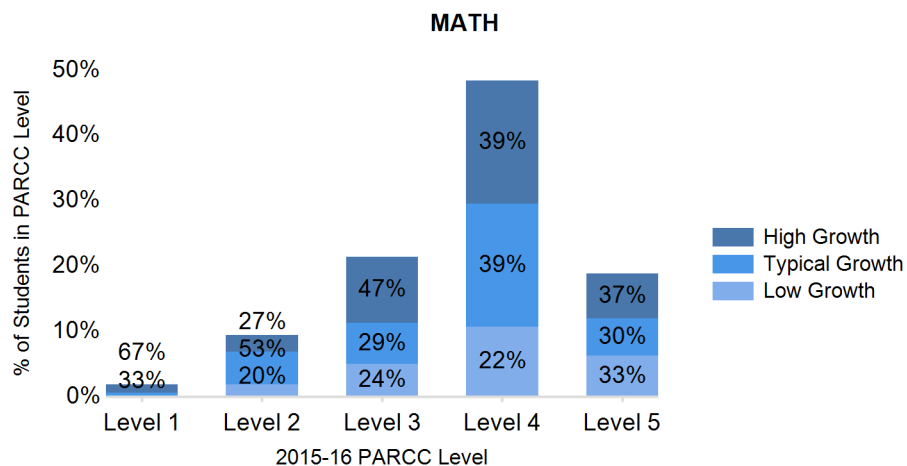

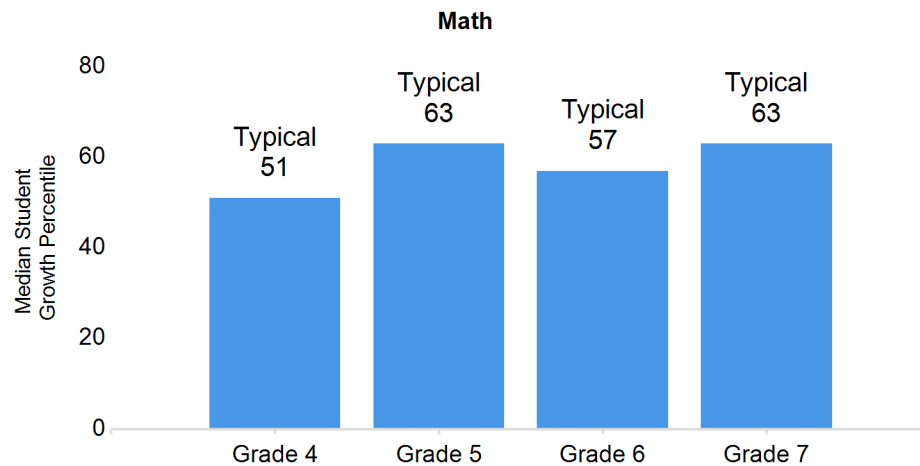
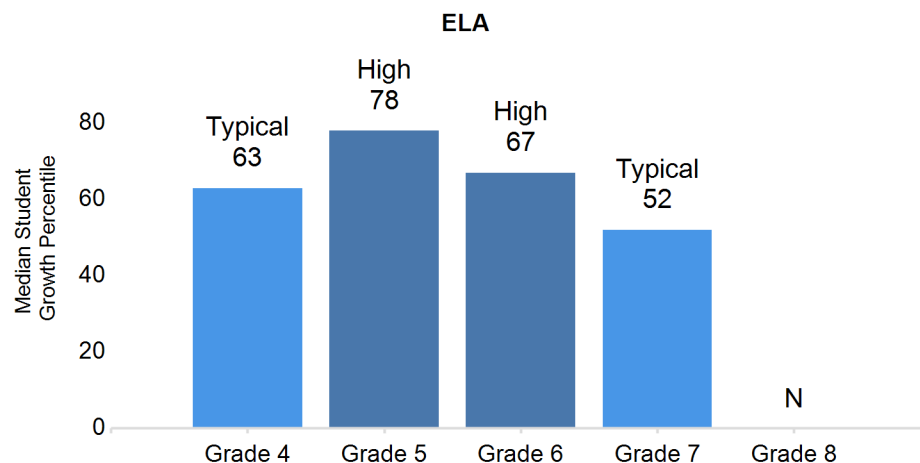
Student Growth by Performance Level

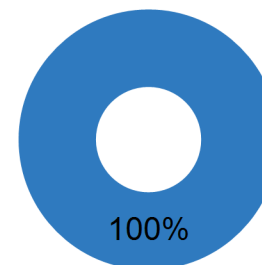

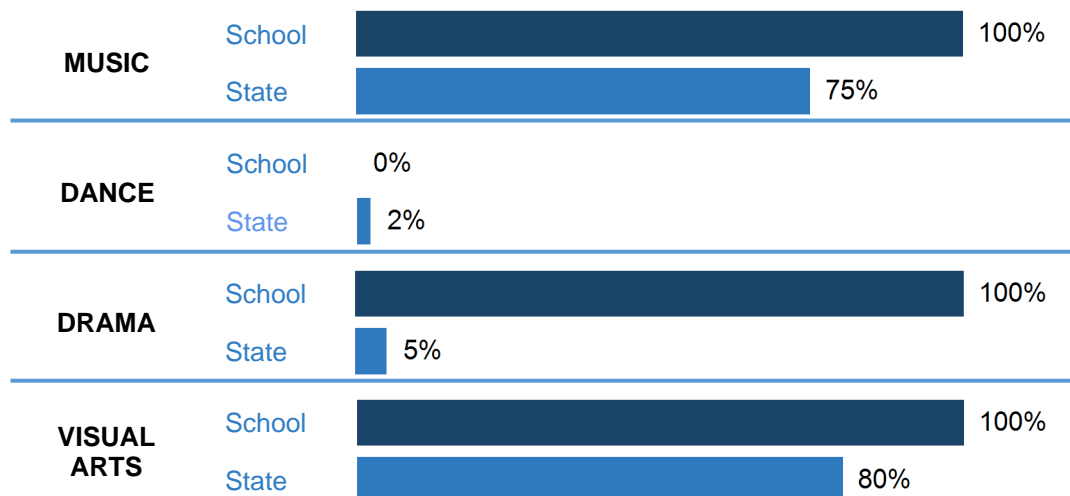

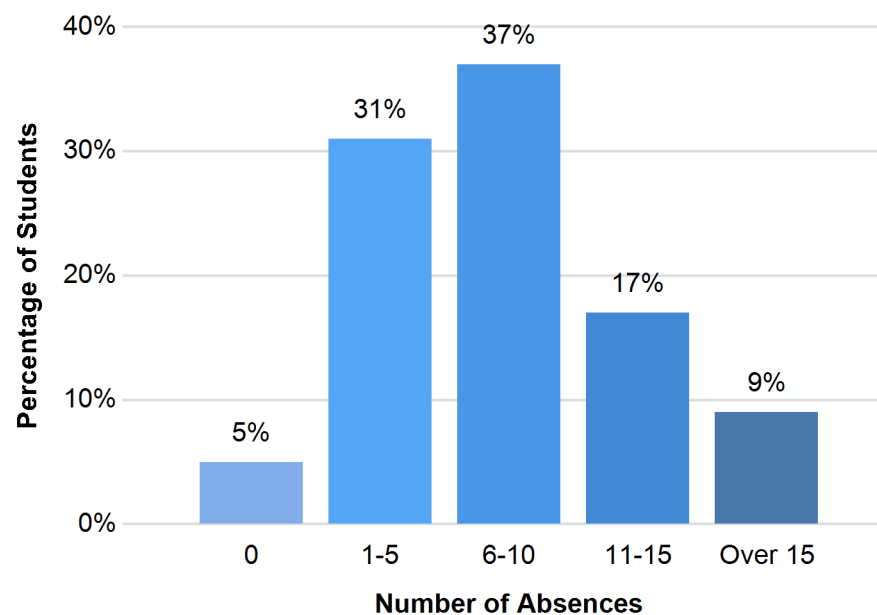

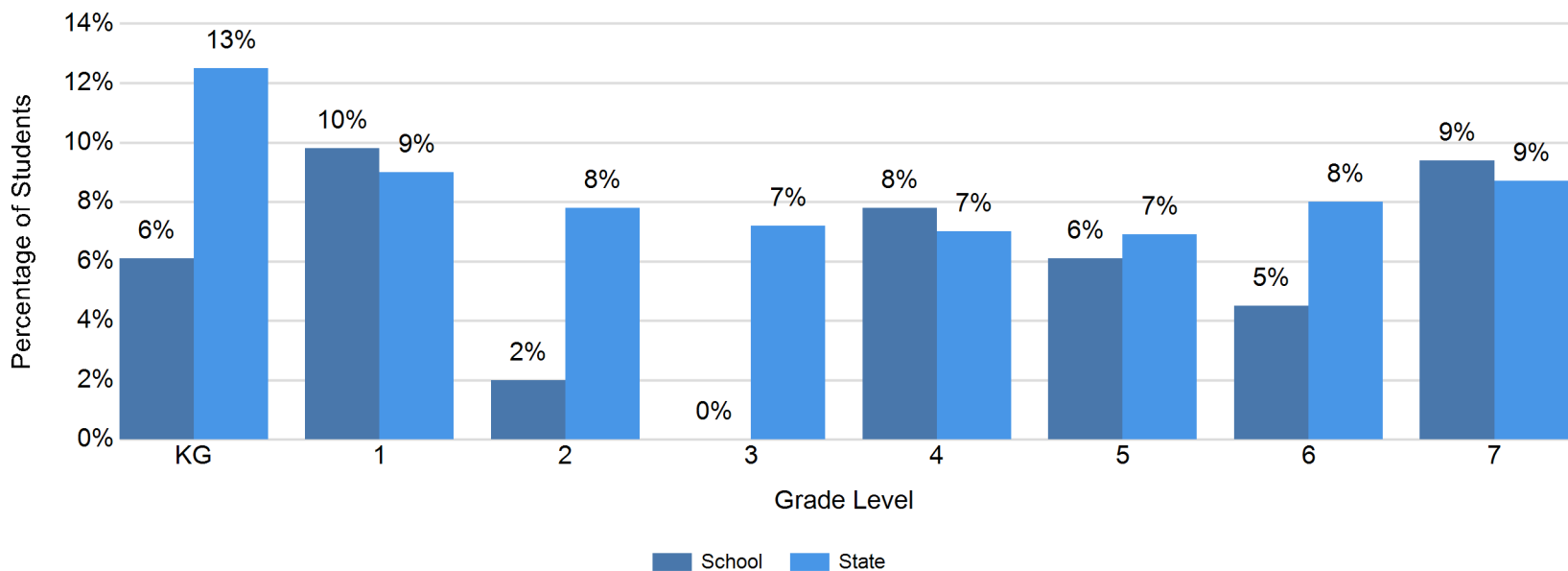

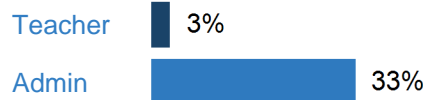
Bachelor's Degree
