PETER HARING, Ephraim Martin, James Linn, John Lambert, Ellis Cook and Charles Beardslee, esquires, severally produced certificates of their being duly elected members of this house, which were read and approved; and they thereupon took and subscribed the oaths required by law before Elisha Lawrence, esquire, one of the members returned for this house, and took their seats in Council.

Elisha Lawrence, esquire, produced a certificate of his being duly elected a member of this house, which was read and approved; and he thereupon took and subscribed the oaths required by law before James Linn, esquire, and took his seat in Council.

John Black, esquire, produced a certificate of his being duly elected a member of this house, which was read and approved; and he thereupon took and subscribed the affirmations required by law before Elisha Lawrence, esquire, and took his seat in Council.

The honourable Elisha Lawrence, esquire, was elected vice-president of the Council, pursuant to the constitution, and he thereupon took the oath of office and was seated in the chair.

Thomas Adams, was unanimously elected clerk of the Council, and took the oath of office accordingly.

John West was appointed door-keeper.

Ordered, That Mr. Haring do wait on the House of Assembly, and acquaint them, that a sufficient number of members of this house have met, elected the honourable Elifha Lawrence, esquire, vice-president, and proceeded to business.

The house adjourned until ten o'clock to-morrow morning.

Wednesday, October 28, 1795.

The house met—Present as before.

Mr. Haring reported that he had obeyed the order of the house of yesterday.

Mr. Anderson, from the House of Assembly, acquainted this house that a quorum of the House of Assembly had met, elected the honourable Ebenezer Elmer, esquire, their speaker, and proceeded to business.

The house adjourned until three o'clock P. M.

The house met.

Thomas Sinnickson, esquire, produced a certificate of his being duly elected a member of this house, which was read and approved, and he thereupon took and subscribed the oaths required by law before the vice-president, and took his seat in Council.

Mr. Sinnickson having given his reasons for non-attendance until this day,
Resolved, That they are satisfactory.

Mr. Armstrong, from the House of Assembly, acquainted this house, that they had appointed Messrs. Manning, Biddle and Wallace, or any two of them, a committee, to join a committee of Council, for the purpose of examining and burning the cancelled money now in the treasury, and requested that this house would appoint a committee to join the said committee for that purpose.

Ordered, That Messrs. Sinnickson and Cook, or either of them, be a committee to join the said committee for the foregoing purpose; and that Mr. Martin do wait on the House of Assembly and acquaint them therewith.

Mr. Martin reported that he had obeyed the order of the house.

The house adjourned until ten o'clock to-morrow morning.

Thursday, October 29, 1795.

The house met.

Joseph Cooper, esquire, produced a certificate of his being duly elected a member of this house, which was read and approved, and he thereupon took and subscribed the affirmations required by law before the vice-president, and took his seat in Council.

Mr. Cooper having given his reasons for non-attendance until this day,
Resolved, That they are satisfactory.

Mr. Biddle, from the House of Assembly, acquainted this house, that they had appointed Messrs. DeVroom, Walton, Hedden, French and Hand, or any three of them, a committee, to join a committee of Council, for the purpose of settling the accounts of the treasurer, and requested that this house would appoint a committee to join the said committee for the purpose aforesaid.

Ordered, That Messrs. Black and Lambert, or either of them, be a committee to join the said committee for the foregoing purpose ; and that Mr. Black do wait on the House of Assembly and acquaint them therewith.

The house adjourned until ten o'clock to-morrow morning.

Friday, October 30, 1795.

The house met—Present as before.

John Condit, esquire, produced a certificate of his being duly elected a member of this house, which was read and approved, and he thereupon took and subscribed the oaths required by law before the vice-president, and took his seat in Council.

Mr. Condit having given his reasons for non-attendance until this day,
Resolved, That they are satisfactory.

Mr. Blackledge, from the House of Assembly, acquainted this house, that they had appointed Messrs. Anderson, Wade and Frazer, a committee, to join a committee of Council for the purpose of inquiring into the state of the prerogative-office and of the secretary's office of this state, and report thereon, and requested, that this house would appoint a committee to join the said committee for the purpose aforesaid.

Ordered, That Mr. Condit be a committee to join the said committee for the foregoing purpose ; and that Mr. Linn do wait on the House of Assembly and acquaint them therewith.

Mr. Condit, from the committee for the purpose of inquiring into the state

of the prerogative-office, and of the secretary's office, of this state, reported as follows :

THAT from the best information the committee have been able to obtain without visiting the said offices, a part of which is from the chief clerk, who hath been employed in said offices for several years past, we find, that the same person who hath been appointed secretary, hath also holden the prerogative-office : That there remains unregistered in the prerogative-office about four years papers, consisting generally of wills, letters of administrations and guardianships, amounting to about fourteen hundred and forty : That the business in the secretary's office is also deranged and incomplete. Your committee do think it their duty to report, that they find about three hundred and sixty-five of the above wills, letters of Administration and guardianships, which belong to the year seventeen hundred and ninety-two, lodged in an unsafe situation, in Mr. Gersthom Craft's office in this town, which were, as we are informed, brought to this town by Samuel W. Stockton, esquire, while secretary, and a part of them registered in a book by his clerk, but not compared and certified ; which book also is now in Mr. Craft's office. From the above facts, your committee are of opinion, that as these papers are of great consequence to the inhabitants of the state, as many hundreds of titles for lands may be involved therein, measures ought immediately to be taken by the Legislature, to have the said papers that are in this town carefully transmitted to the secretary's office in the city of Burlington ; and that a law ought to be passed, compelling the secretaries and clerks of the prerogative-office in future to give ample security for the faithful performance of their duty in the said offices, and that some method ought to be devised by the Legislature for having all the unfinished business in the said offices completed as soon as possible.

Mr. Whilldin having given his reasons for non-attendance until this day,
Resolved, That they are satisfactory.

Mr. Sinnickson, from the committee appointed to join the committee appointed by the House of Assembly, to count and burn the cancelled loan-office money in the treasury, reported as follows :

THE committee of both houses do hereby certify, that James Mott, treasurer, has delivered to us the sum of sixteen thousand, nine hundred and seventeen pounds, twelve shillings, loan-office money, cancelled in the several counties by their respective boards of justices and freeholders, agreeably to the above statement, which we have examined, counted and burned.

Ordered, That Mr. Sinnickson do wait on the House of Assembly and acquaint them therewith.

Mr. Frazer, from the House of Assembly, brought to this house for concurrence, a resolution, that Gershom Craft, esquire, be employed as an engrossing clerk during the present session of the Legislature; that all bills ordered to be engrossed shall be delivered by the clerks of Council and of Assembly unto the said Gershom Craft to be carefully engrossed, and by him re-delivered in at the tables of the respective houses as soon as possible; and that the Legislature will provide for a compensation to the said Gershom Craft for his service. Also, a resolution, that the clerk of assembly be directed to furnish Matthias Day, printer, with fair and accurate copies of the laws as they pass during the present sitting of the Legislature, with marginal notes thereto, in order for publication as soon as may be after they are passed; which resolutions were respectively read, and ordered a second reading.

The house adjourned until three o'clock P. M.

The committee to whom was referred the warrant from the House of Assembly, granting a pension to John Russell, a soldier in Lieutenant Shadwick's company of militia, wounded in the service of the United States, reported,

THAT, in the opinion of your committee, there is no law now in force in this state which can justify the issuing any warrant to the said John Russell; and that if any provision is to be made in such case, it should be a general one, by a law for that purpose, embracing every case of the same nature, and under such limitations and restrictions as will effectually guard the state against imposition.

A petition from Isaac Neale, printer, in Burlington, praying that he may be appointed to print the minutes of Council and joint-meetings, was read, and ordered a second reading.

The house adjourned until three o'clock P. M.

The house met,

The house resumed the further consideration of the report of the committee on granting a pension to John Russell, and, after some time spent therein,

Mr. Manning, from the House of Assembly, brought to this house for concurrence, a bill, intitled, "An act to repeal part of an act, passed the twelfth day of June, seventeen hundred and ninety," which was read, and ordered a second reading.

Also, a bill, intitled, "An act for the relief of Benajah Parvin," which was read, and ordered a second reading.

The bill, intitled, "An act to raise the sum of fifteen thousand pounds for the year one thousand seven hundred and ninety-six," was read a third time;

On the question, Whether the said bill do pass? It was carried in the affirmative, *nem. con.*

Ordered, That the president do sign the said bill.

Ordered, That Mr. Haring do wait on the House of Assembly, and acquaint them that the said bill is passed by this house.

The house adjourned until three o'clock P. M.

The house met.

Mr. Haring reported, that he had obeyed the order of the house.

The bill, intitled, "An act for the relief of Benajah Parvin," was read a second time, with sundry vouchers accompanying the same, and debated;

On the question, Whether the said bill shall have a third reading? It was carried in the negative, *nem. con.*
