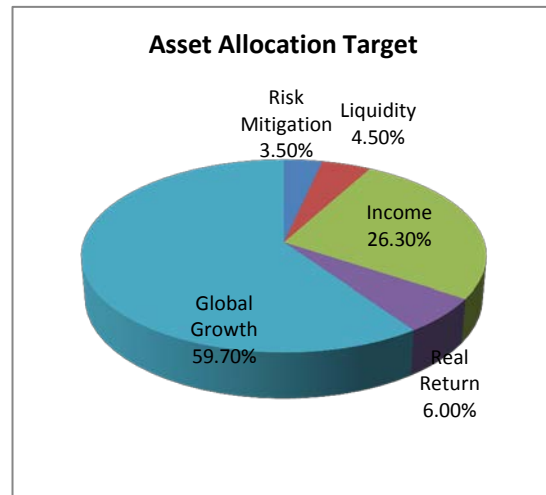
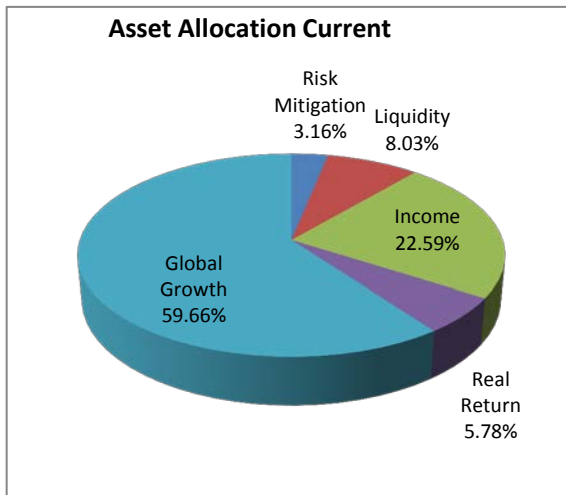

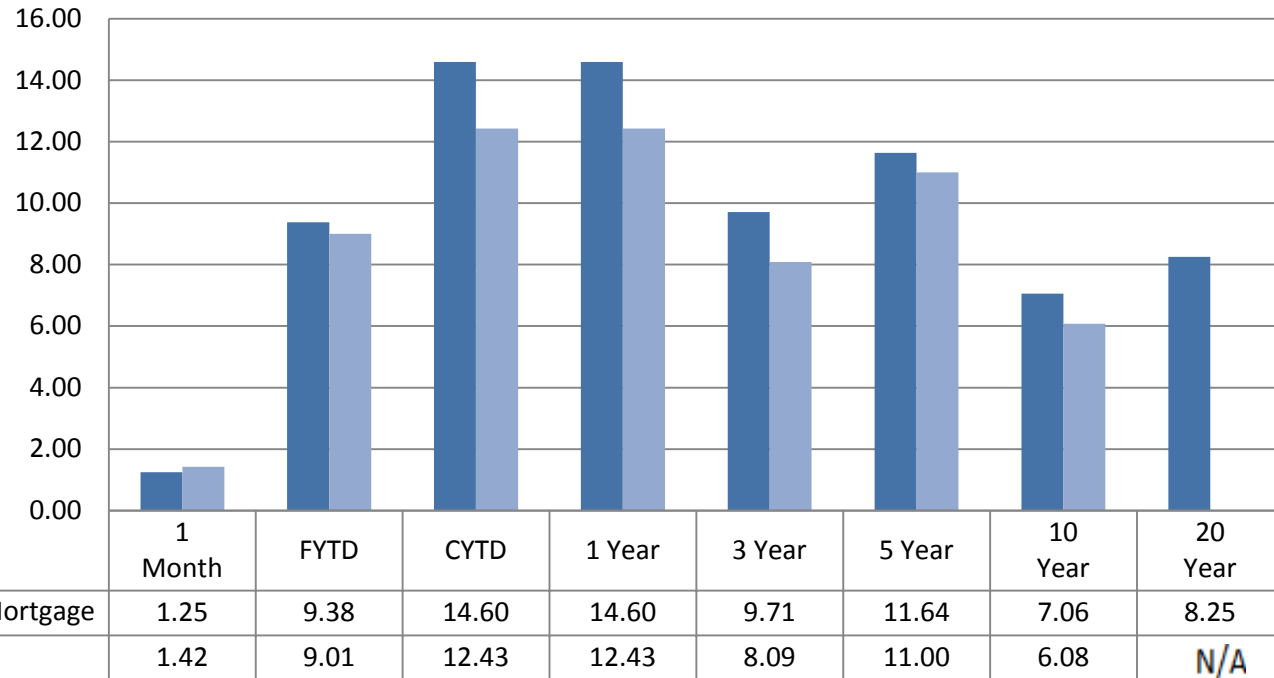

**Total Fund ex Police and Fire Mortgages as of 12/31/13**

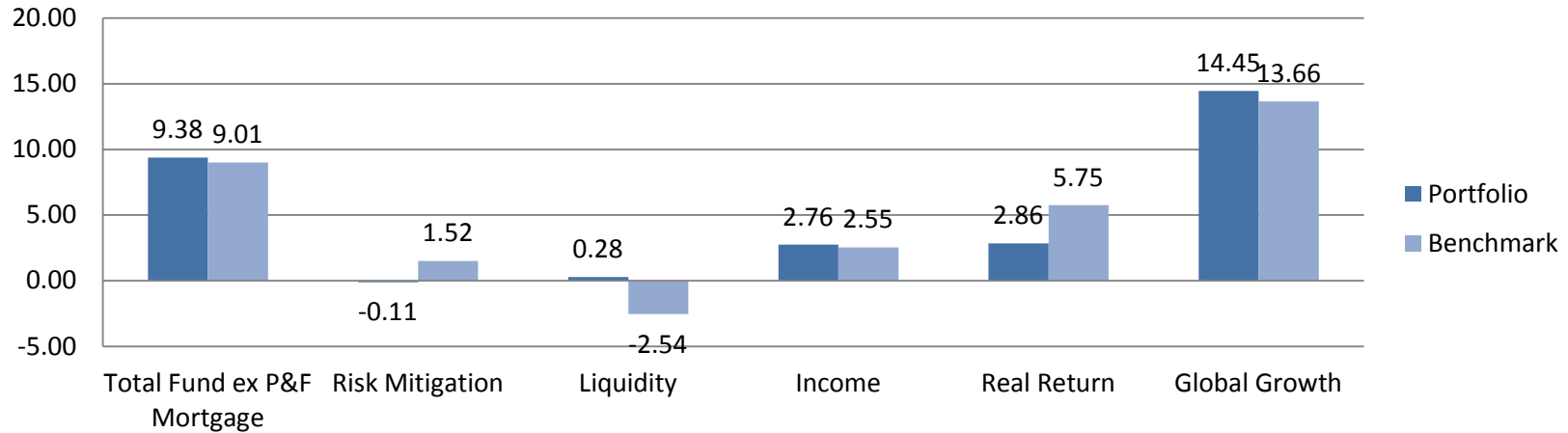

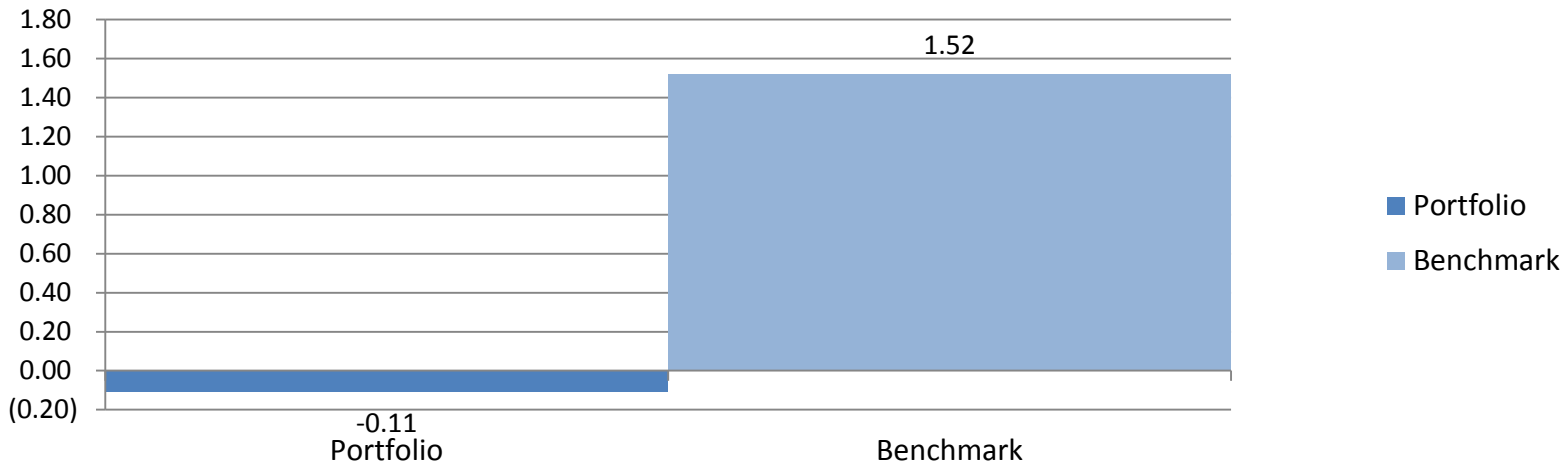

**FYTD Performance by Asset Class as of 12/31/13**



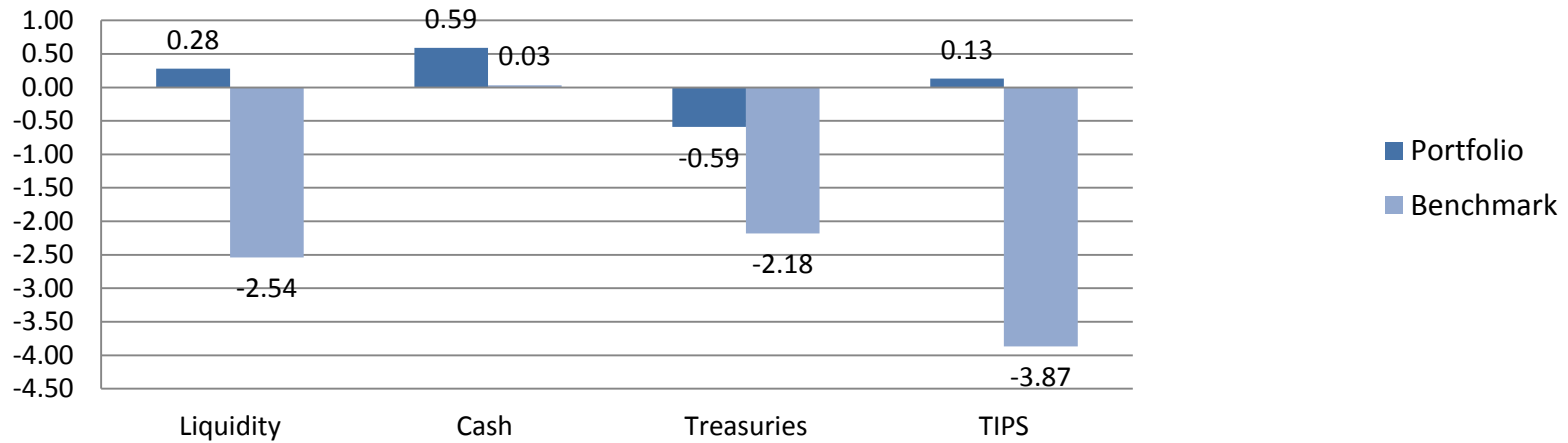
**FYTD Risk Mitigation Performance as of 12/31/13**



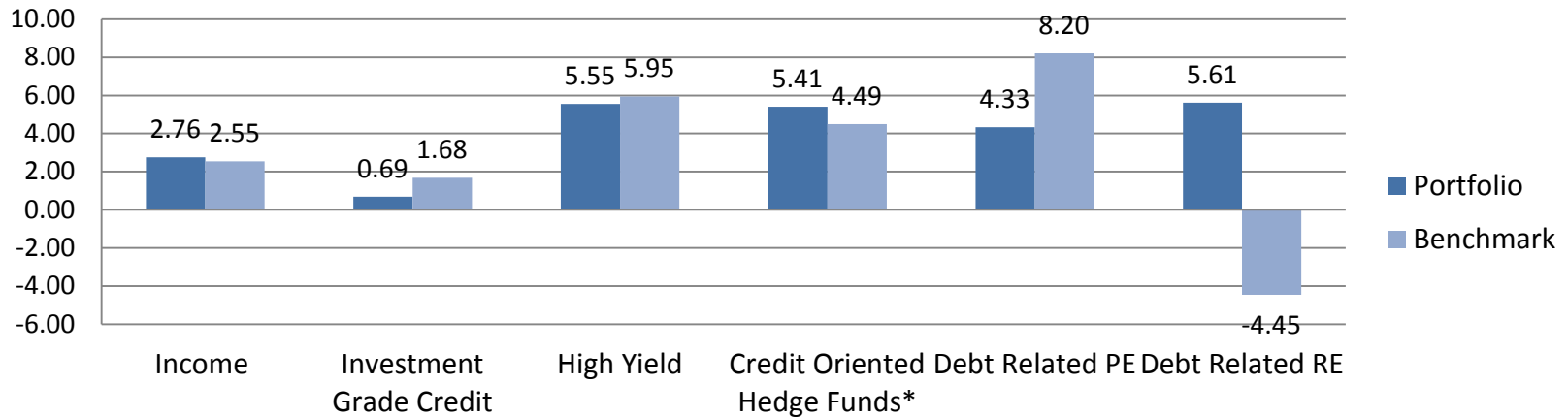

**FYTD Income Performance as of 12/31/13**



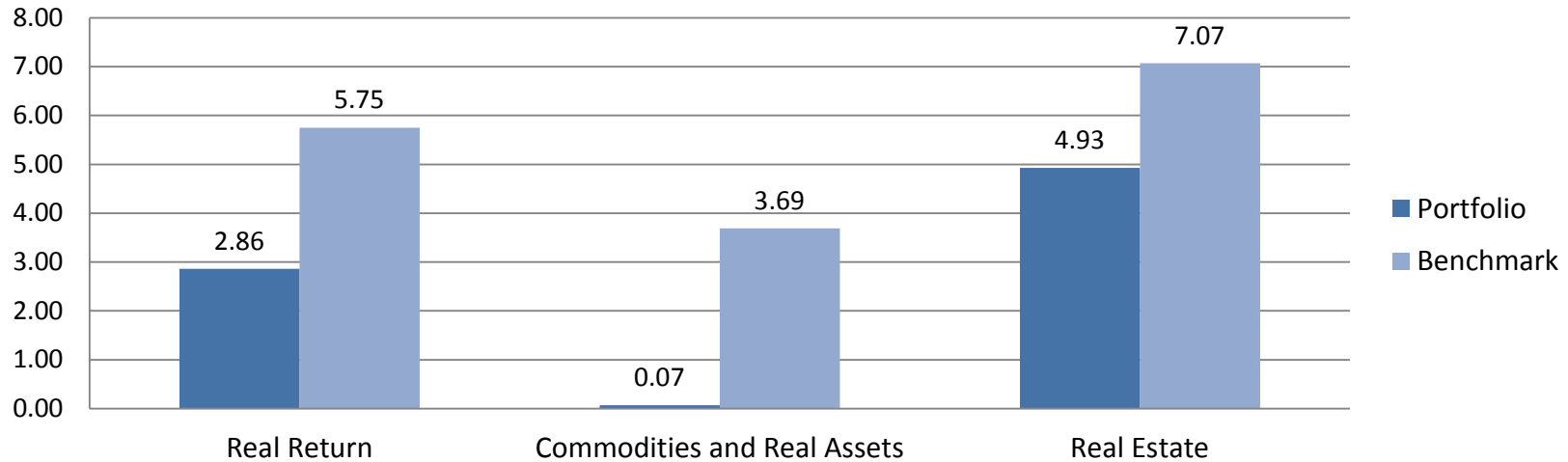

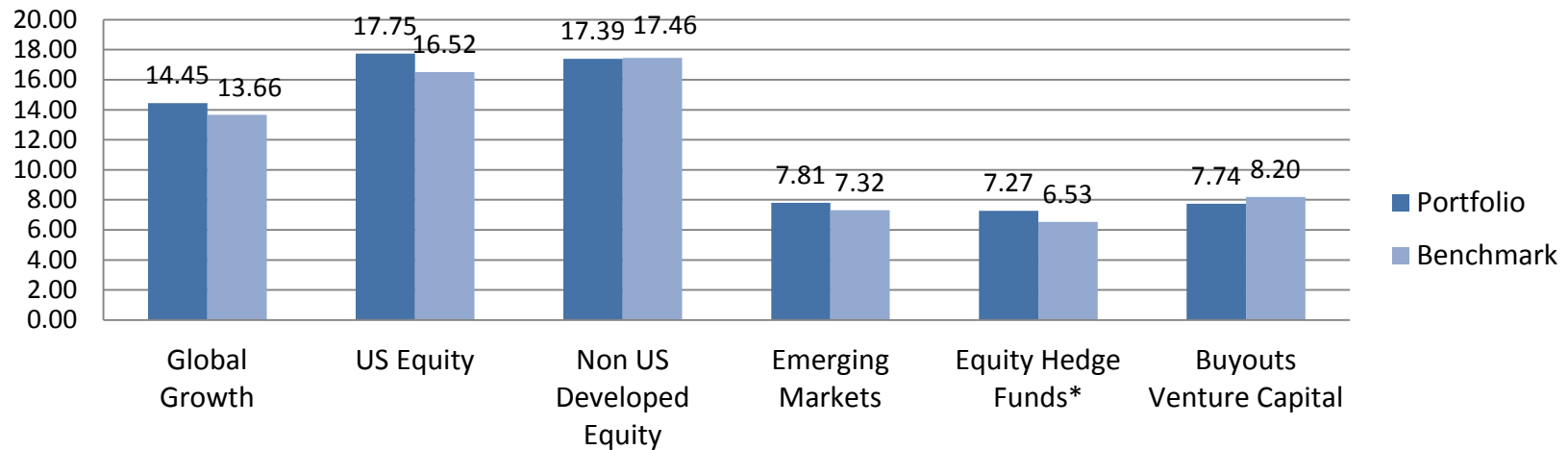
