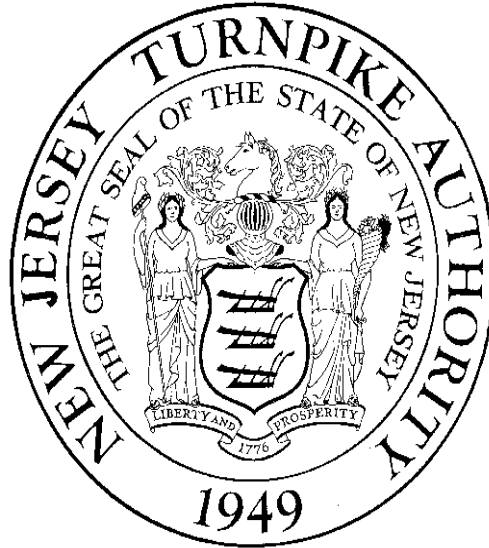

The work includes construction of sign structures, retaining walls, drainage improvements, utility relocations, and other miscellaneous work necessary and incidental to the completion of the project.
