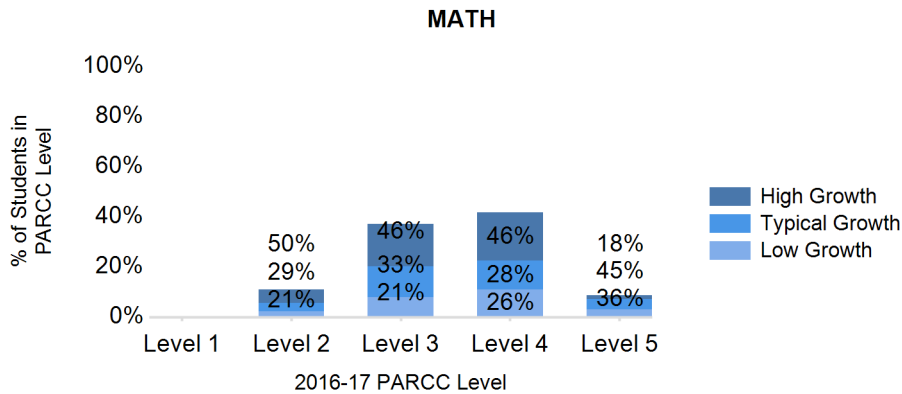
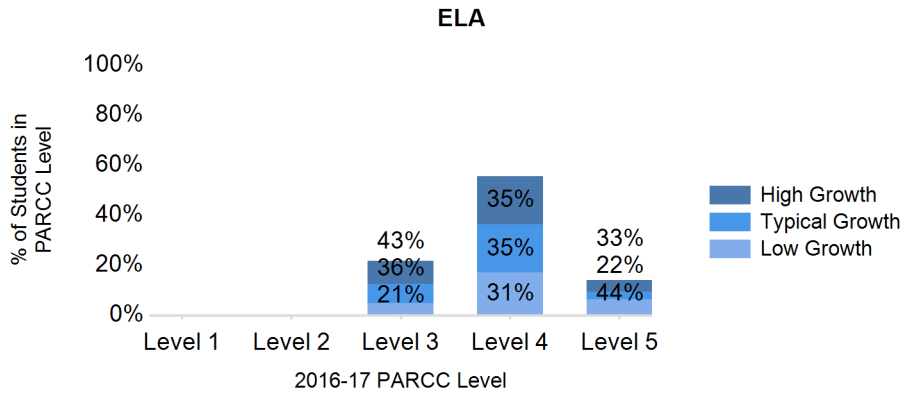

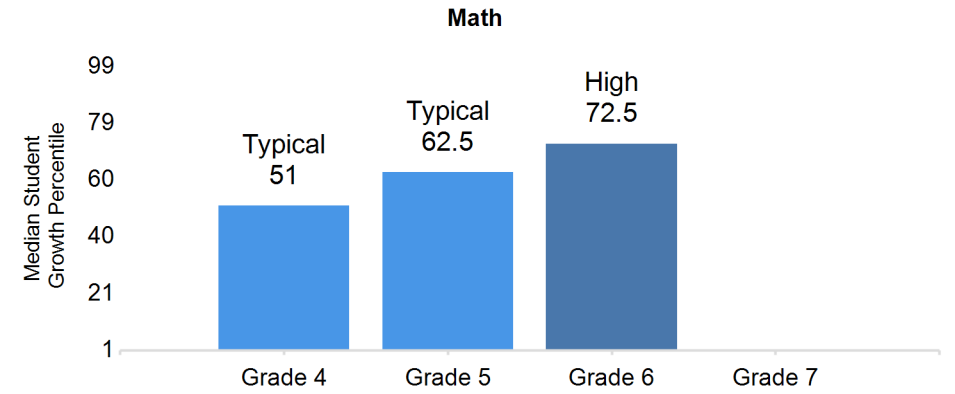
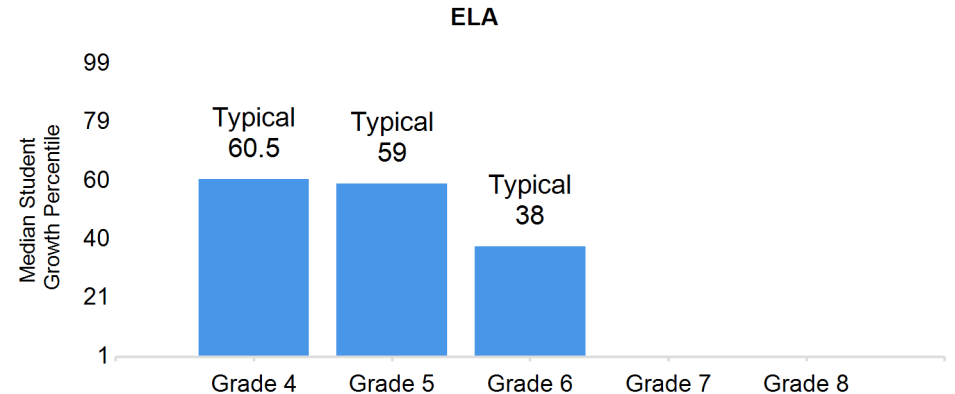
Student Growth by Performance Level

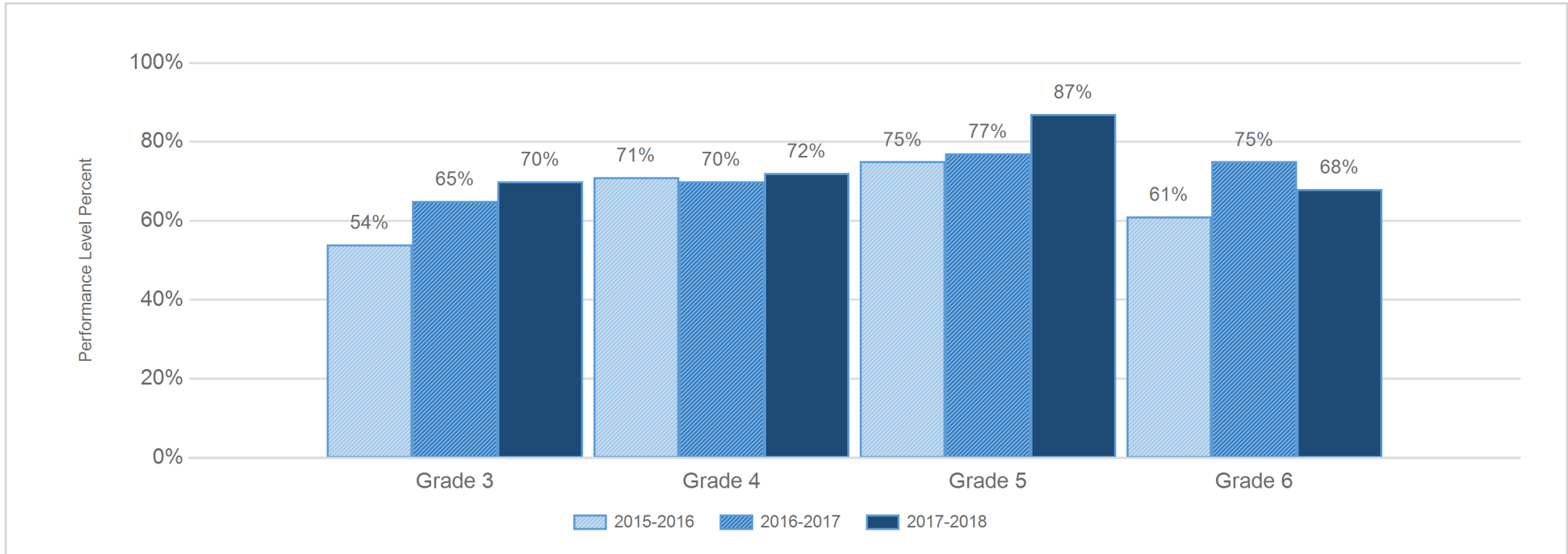

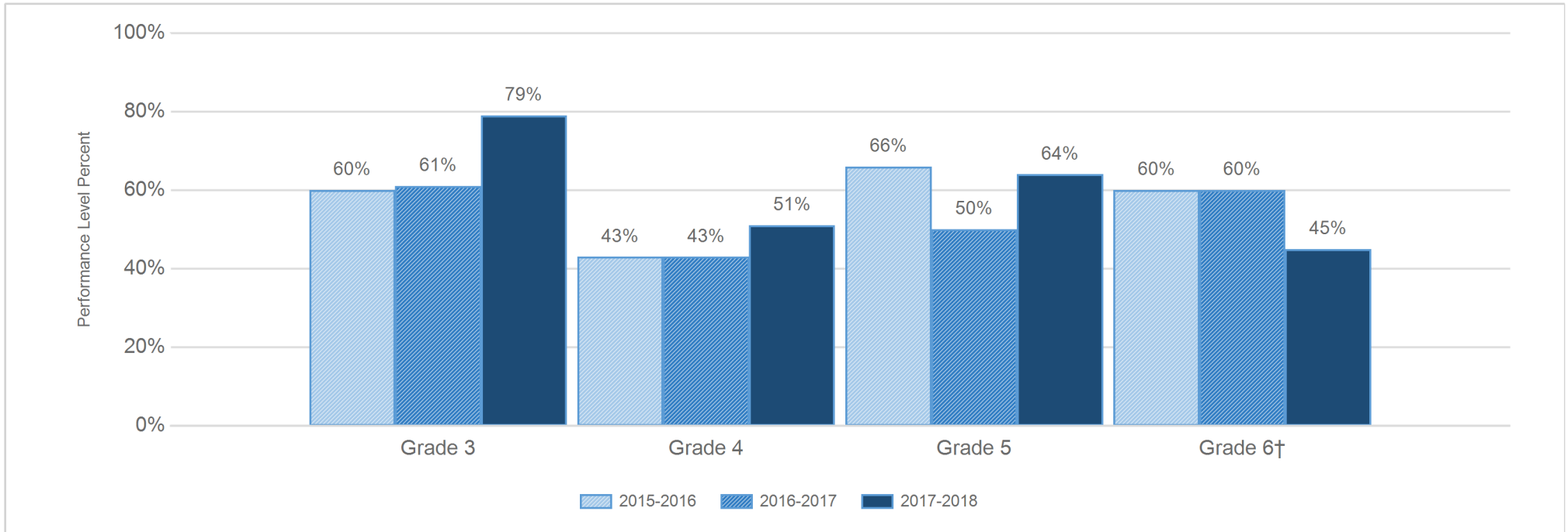

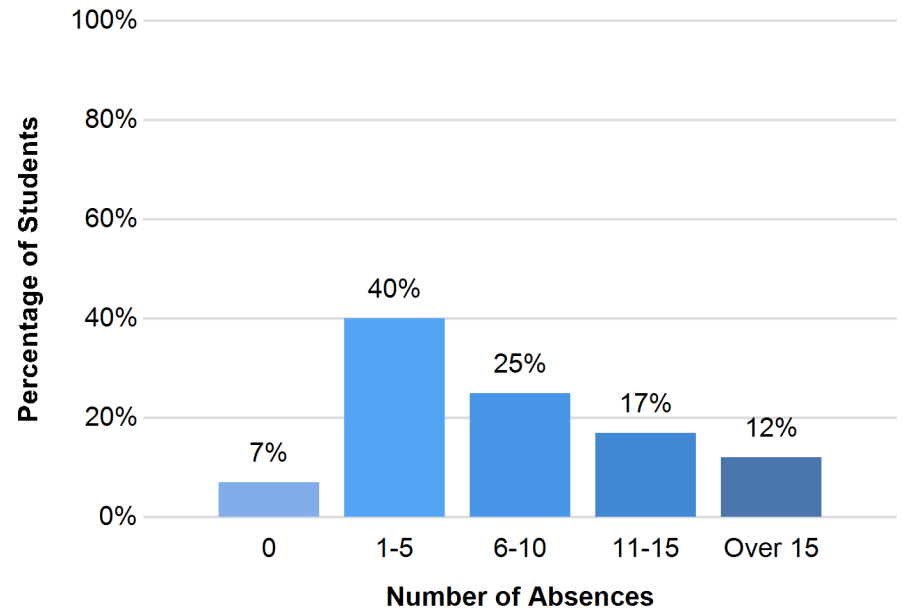

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





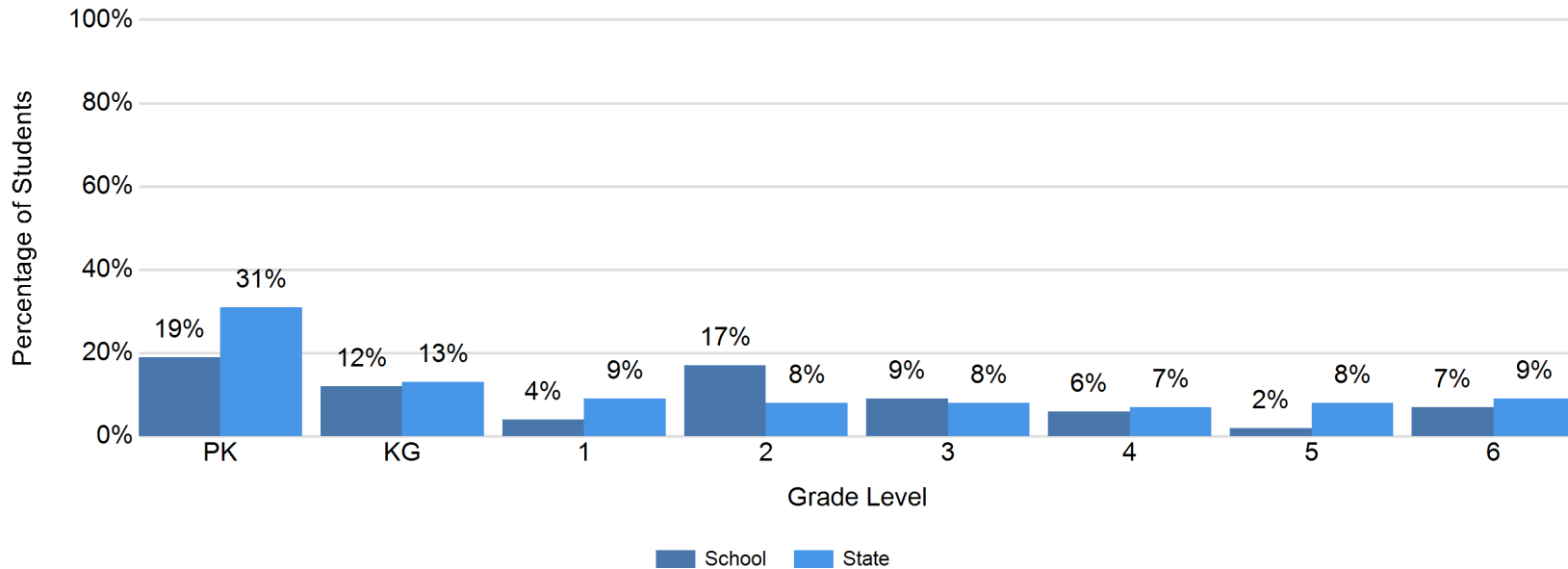

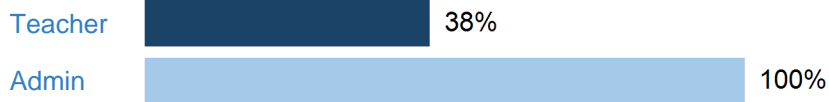

Technology and STEM:

Through fiscally responsible decision making, we are proud to offer students access to instructional technology in a variety of ways. All of our classrooms use interactive smartboards and projectors. Additionally, students have access to 300 chromebooks, more than 50 desktop computers, and at least two student computers in every classroom. Recently, the school began creating a makerspace where students will utilize two 3D printers and interactive electronic modules called littlebits to enhance STEM education. Finally, our technology program is expanding to include EZ Robots JD humanoids, 1 Rover robot, and virtual reality headsets. Students are actively engaged in assembling and programming the robots, exploring virtual field trips, and coding/designing virtual reality worlds as part of their educational experience.
