## REPORT.

TRENTON, N. J., November 1st, 1883. }

*To His Excellency George C. Ludlow, Governor of New Jersey :*

SIR—I have the honor to submit the following report for the year ending October 31st, 1883.

At the date of the last report the whole number of books in the library was 28,136.

Additions made since are as follows :

Whole number now in library..... 28,861

The library is again becoming very much crowded ; many books have to be piled away for want of shelf room. I would suggest that if the library be made a reference library only, there are many volumes in the miscellaneous collection which could be removed from the cases with little loss, and the shelves now occupied by such books would give all the room needed for the present for Government and State publications.
