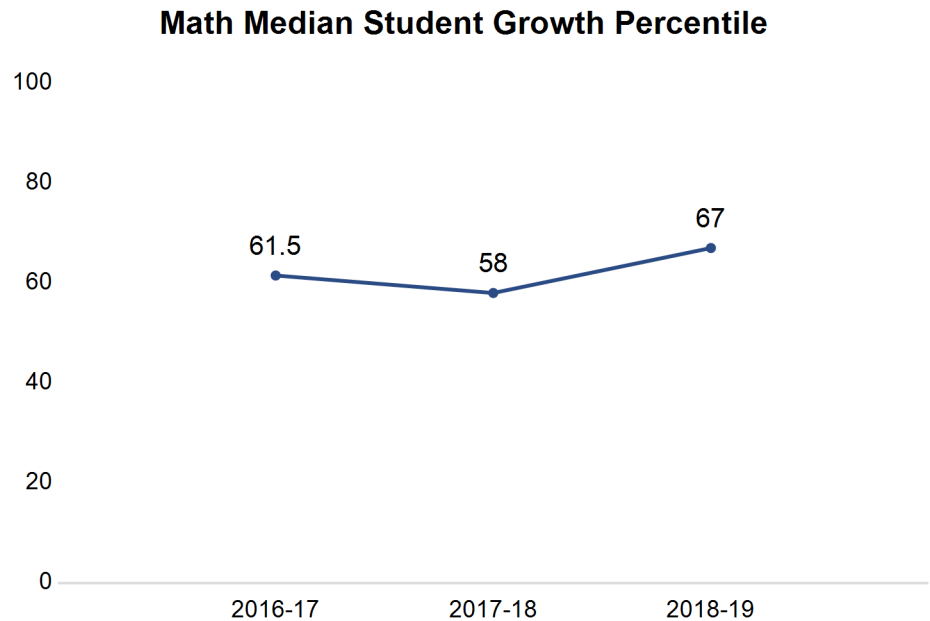
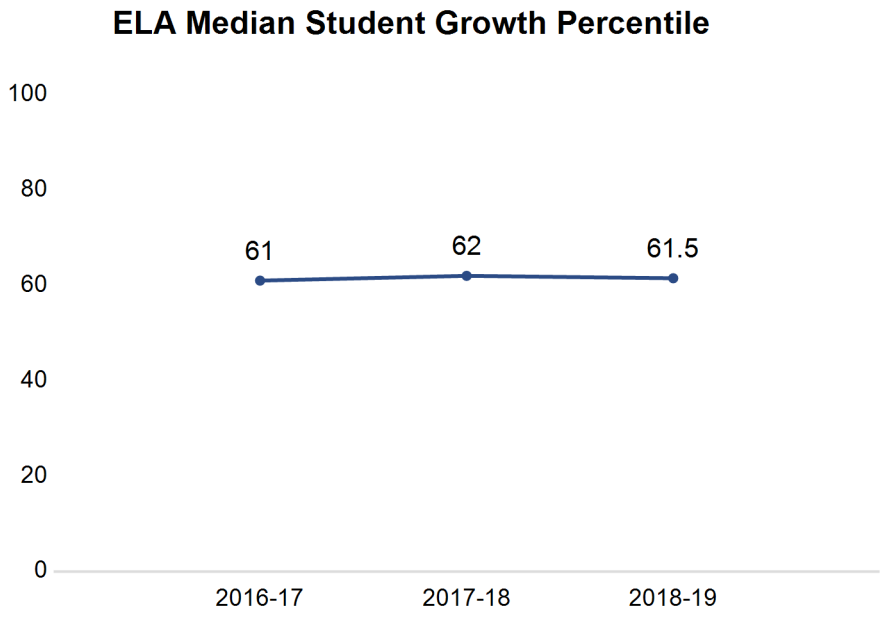

Student growth is a measure of how much students are learning each year. 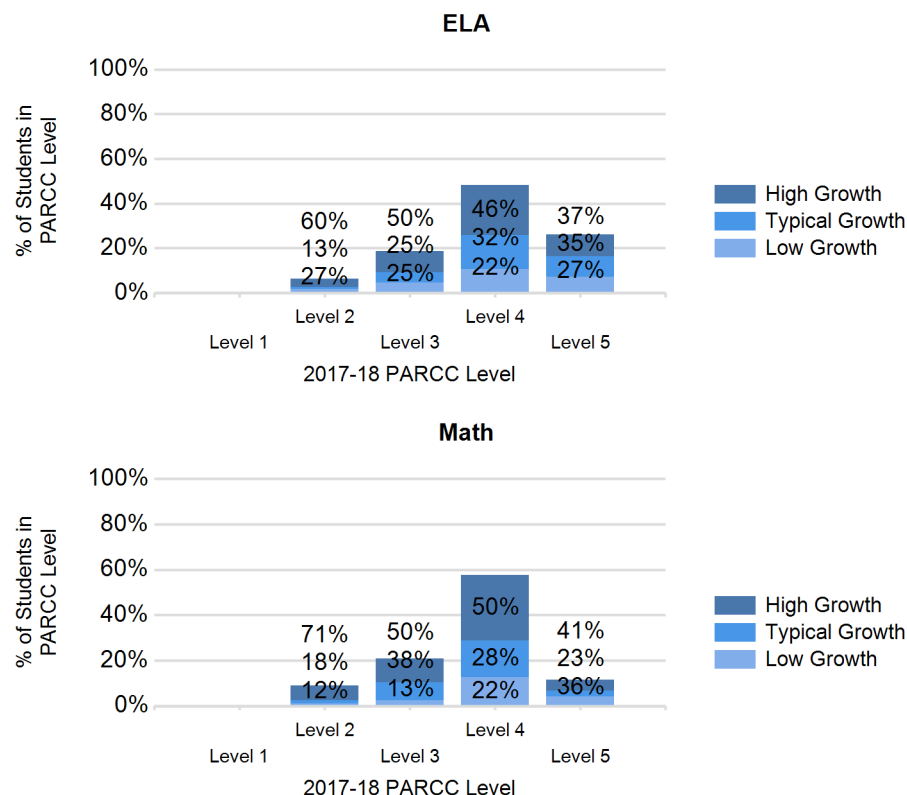

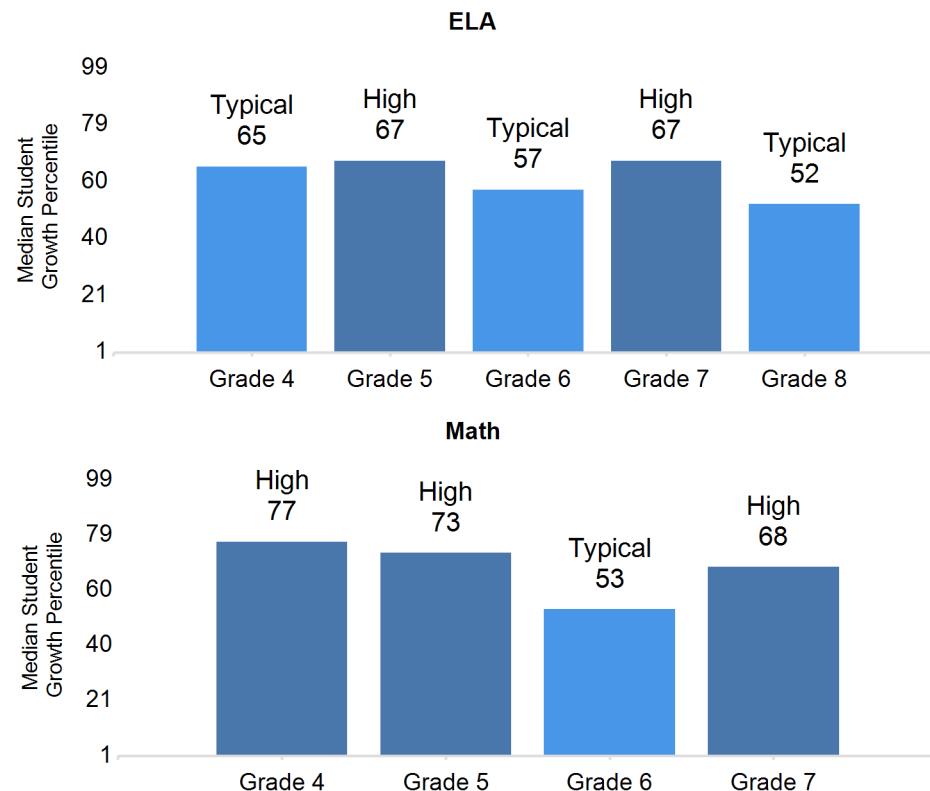
**Student Growth by Performance Level**

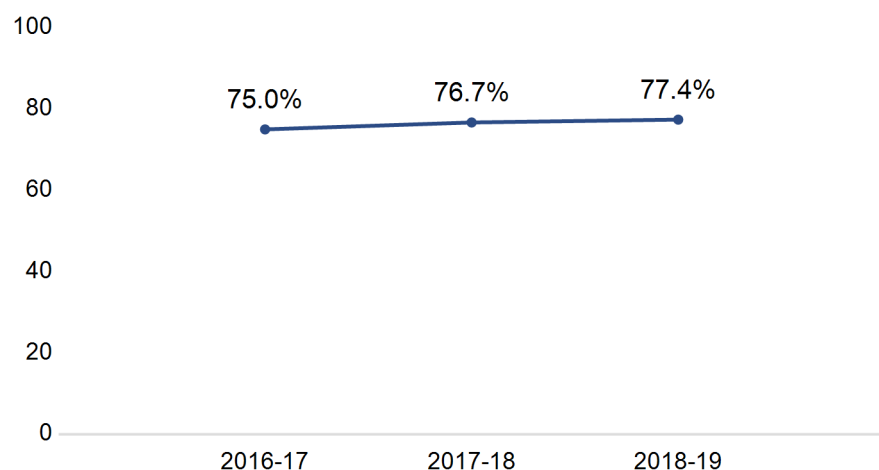

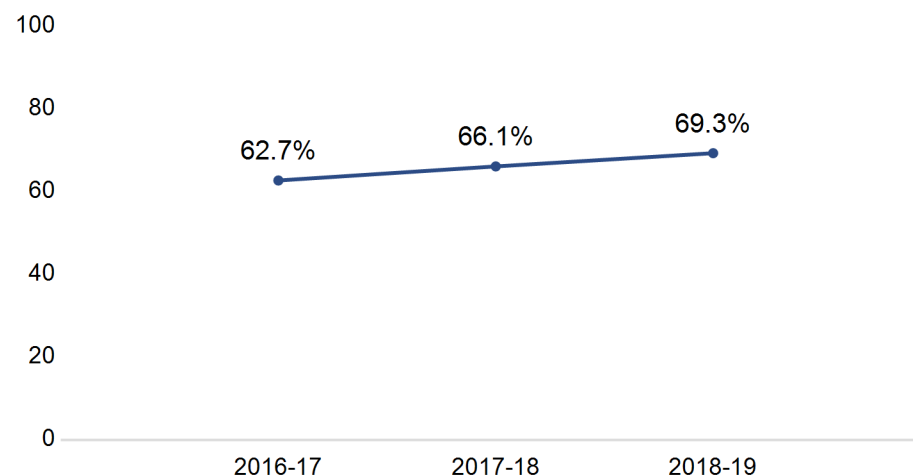
## English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the statewide assessment (NJSLA for 2018-19 and PARCC for 2016-17 and 2017-18) and the DLM alternate assessment. The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

## English Language Arts Assessment - Participation and Performance

This table shows performance on statewide assessments for English Language Arts both overall and by student group. It includes the results of students taking both the NJSLA and DLM assessments. NJSLA results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. A student is considered to have met or exceeded expectations if he/she scores at Level 4 or 5 on the NJSLA assessment or at Level 3 or 4 on the DLM assessment.

This table shows both the percentage of students that met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows progress towards meeting the state's long term goal of 80% proficiency by 2030. Annual targets are specific to each subgroup, school, and district and represent the expected proficiency needed to stay on track to meet the state's long term goal. Student groups where the annual target fields are grayed out are not required to meet annual targets under ESSA accountability. 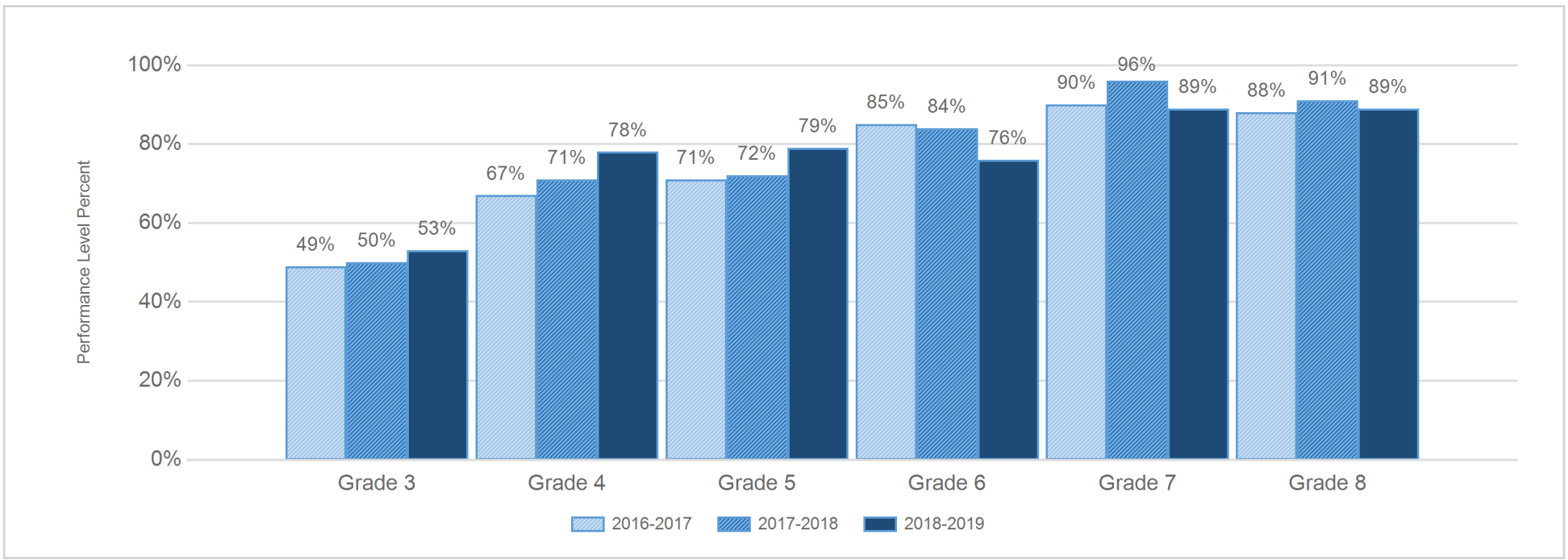

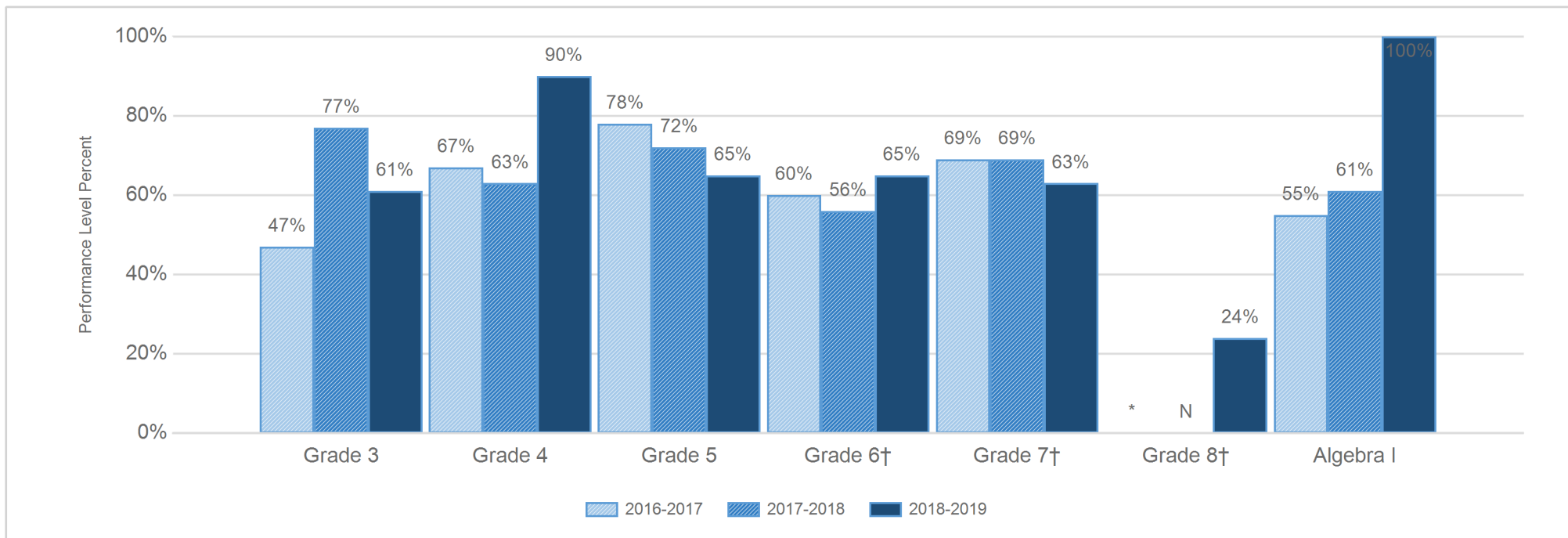

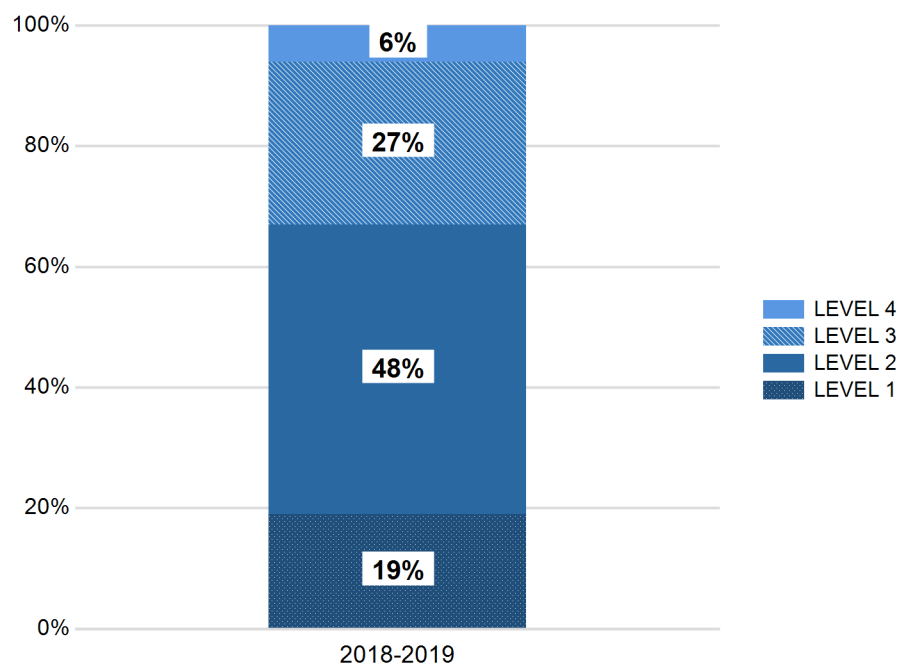

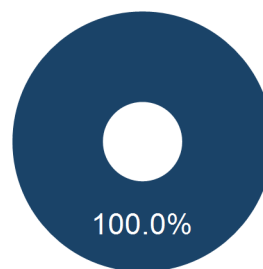

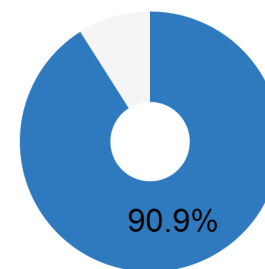

Students enrolled in one or more **visual and performing arts** classes

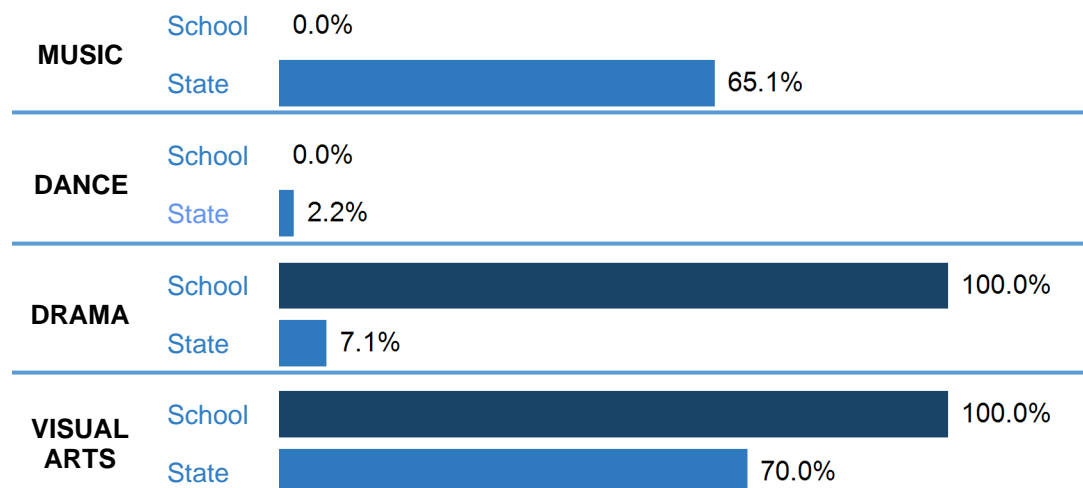

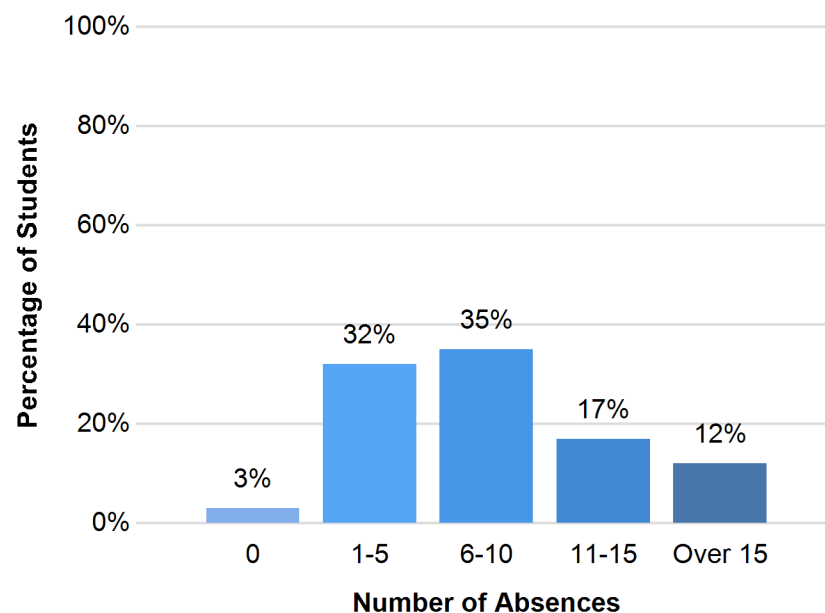

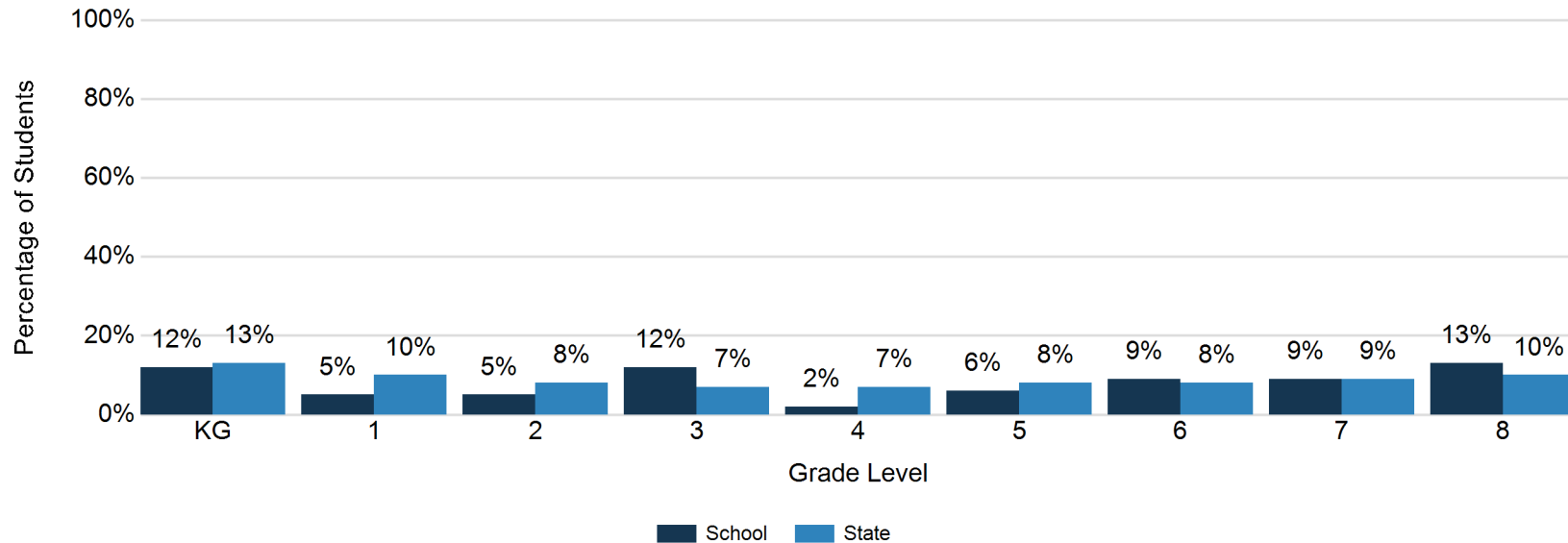

### Technology and STEM:

Virtual Reality: Students build their own virtual reality using the CoSpaces program. Students populate the world with different objects, structures, and characters, then use a block based coding language to add animations and other interactive features. Physical engineering: Students have a multitude of physical engineering projects, including sailcars, motorized sprinter cars, motorized ATVs, motorized doodle bots, and soda bottle PSI rockets. Students go through the engineering design process, with a focus on iteration, when building their projects. Lego Robotics: Students build a basic robot using Lego EV3 Mindstorm Platform and program it, then use various sized motors (outputs) and sensors (inputs). Coding: Students are introduced to basic coding functions, creating their own simple programs using the Scratch and Python coding languages, as well as simple Android apps using the MIT App Inventor.

GHS has an eight period day with each class lasting 42 minutes with a modified block schedule in Math and Language Arts. Schedules are set with the best interests of the students in mind. Green Hills School continuously leverages technology to improve student learning, enhance teaching practices and offer its students in grade K-8 a more personalized learning experience to meet their needs and their interests. A 1:1 chromebook initiative was implemented in grades 3-8, and classrooms in grades K-2 are equipped with chromebooks. In addition, Green Hills School offers programs in STEM education, Design Thinking, Robotics and Coding to all students in K-8. We are a NJDOE School of Choice and presently have 50 students attending from various towns throughout Sussex and Warren Counties. Green Hills School has compartmentalized in grades 3 and 4, with teachers delivering instruction as Math/Science and Language Arts/Social Studies content area specialists. Additionally, we developed and implemented a standards-based report card for grades K-4.
