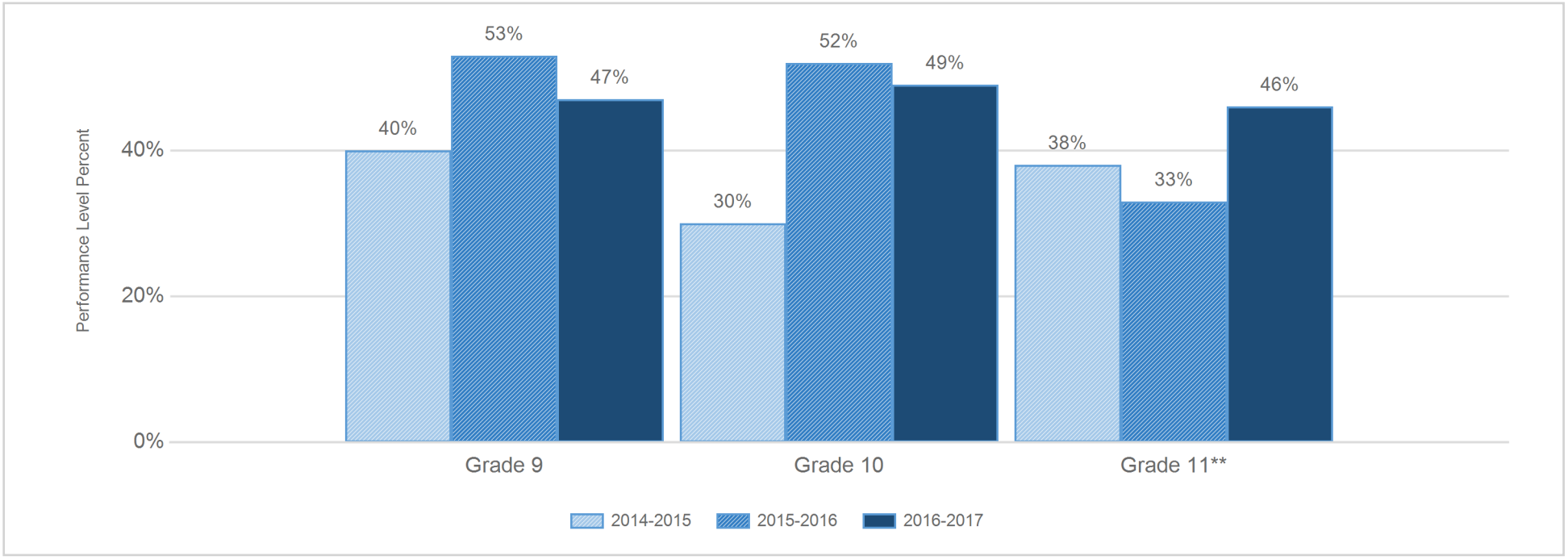

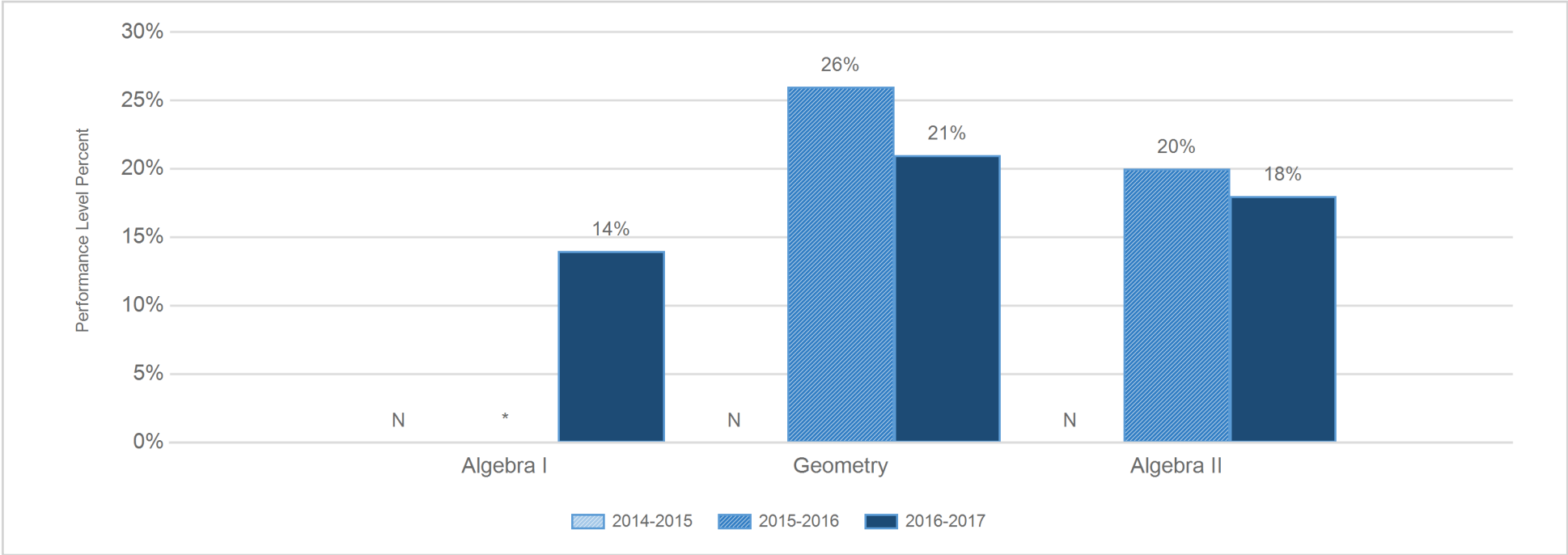

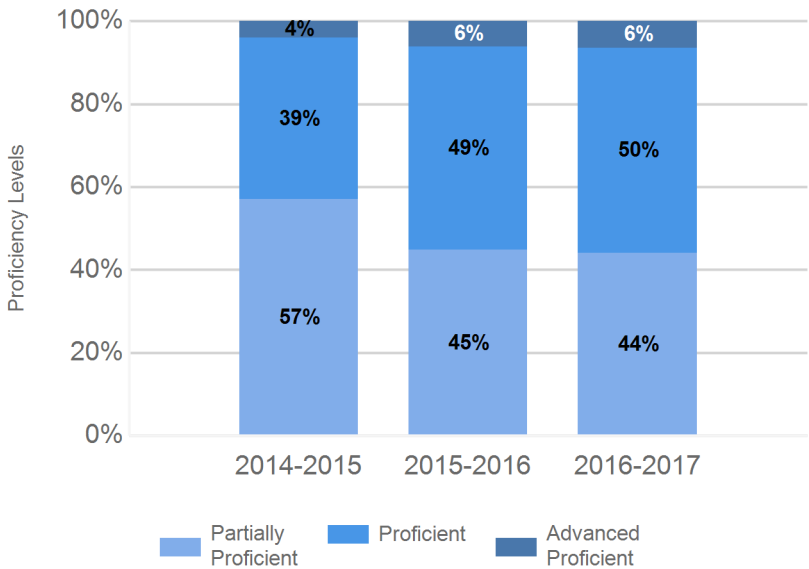

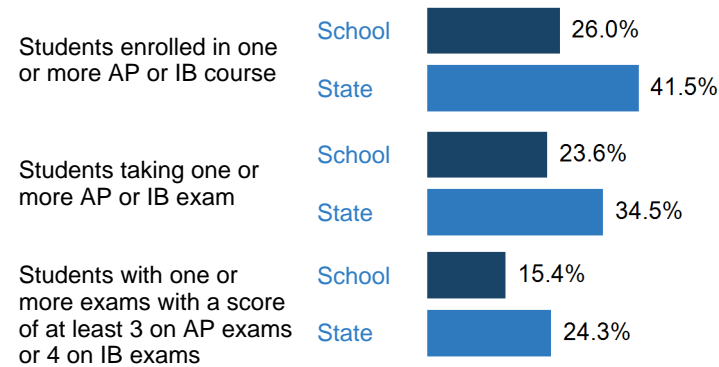

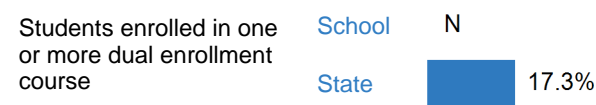

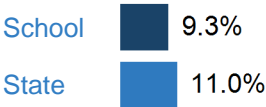

(completed only one course in an approved CTE program)



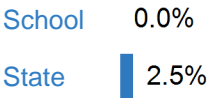

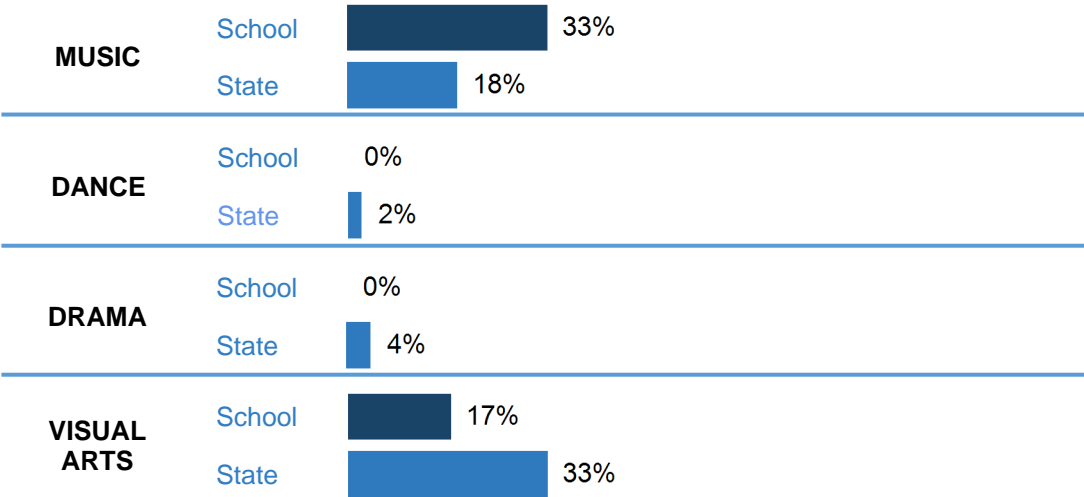

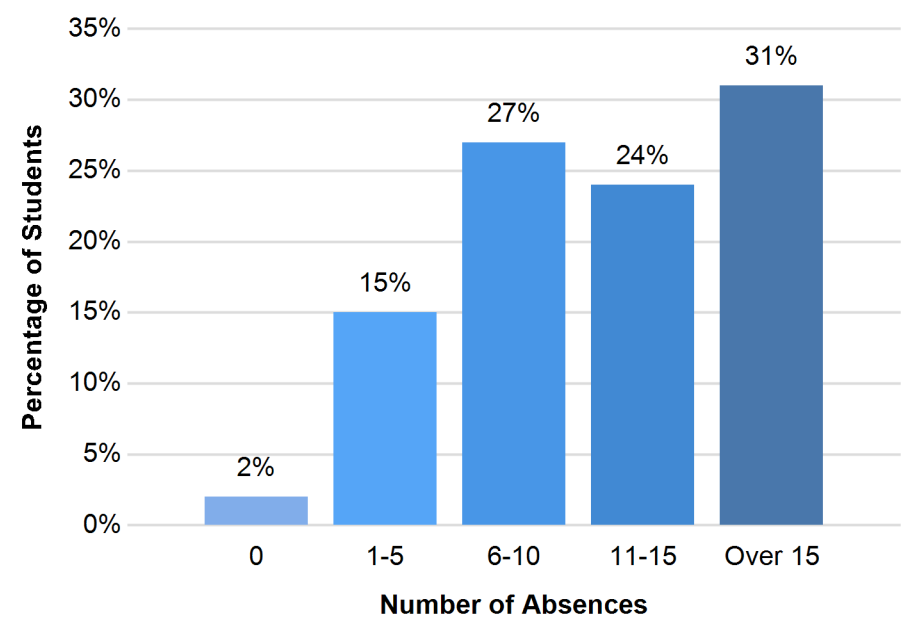

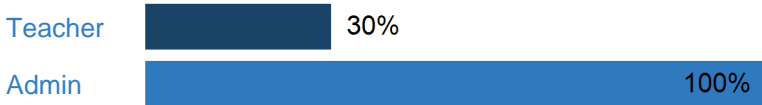

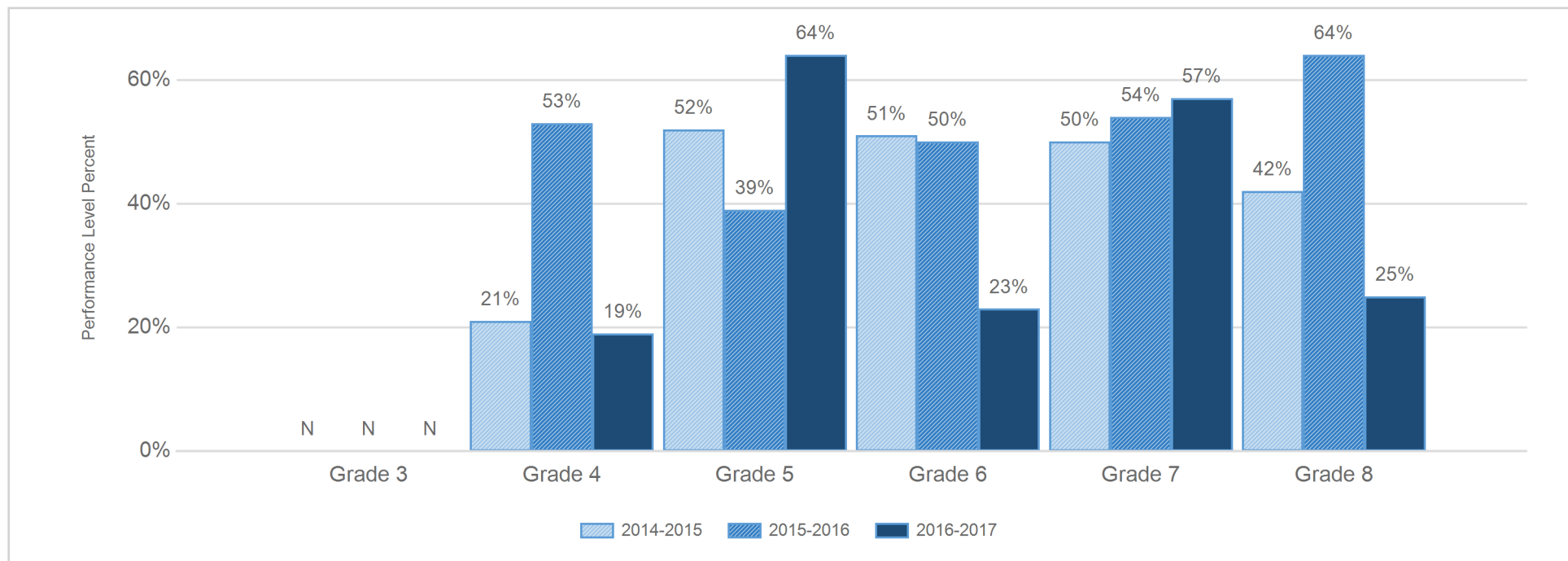

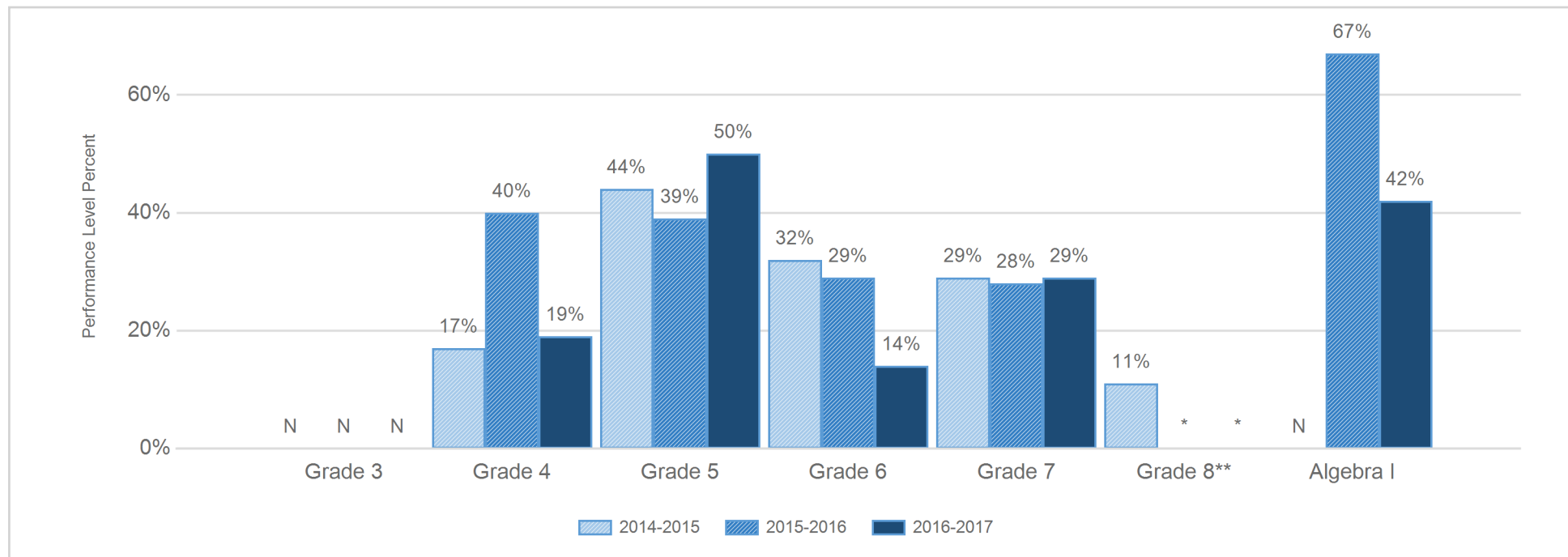

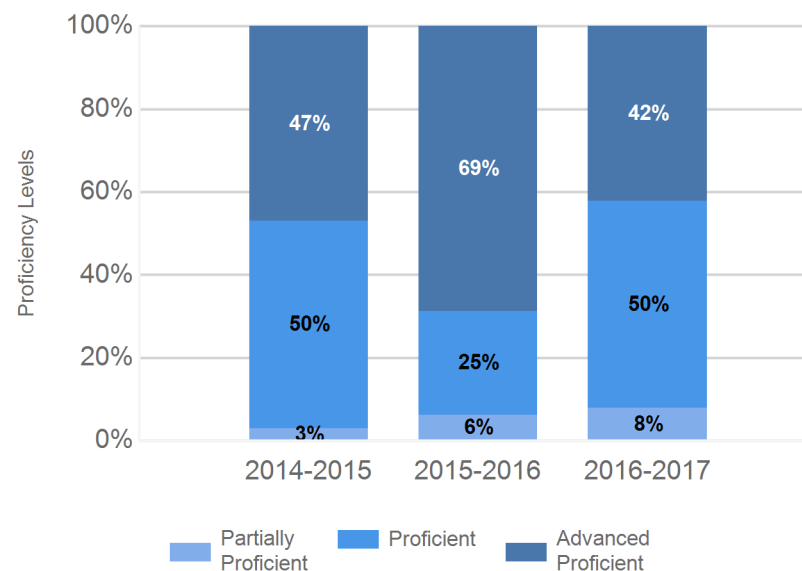

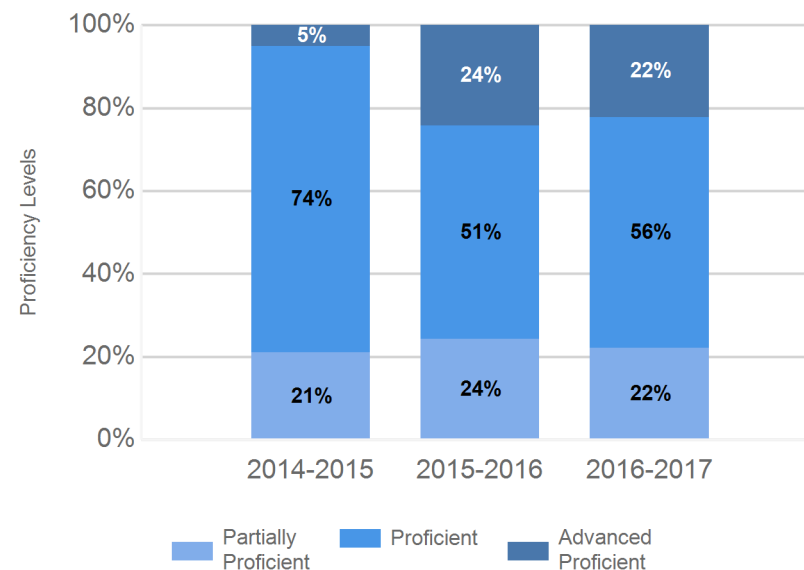

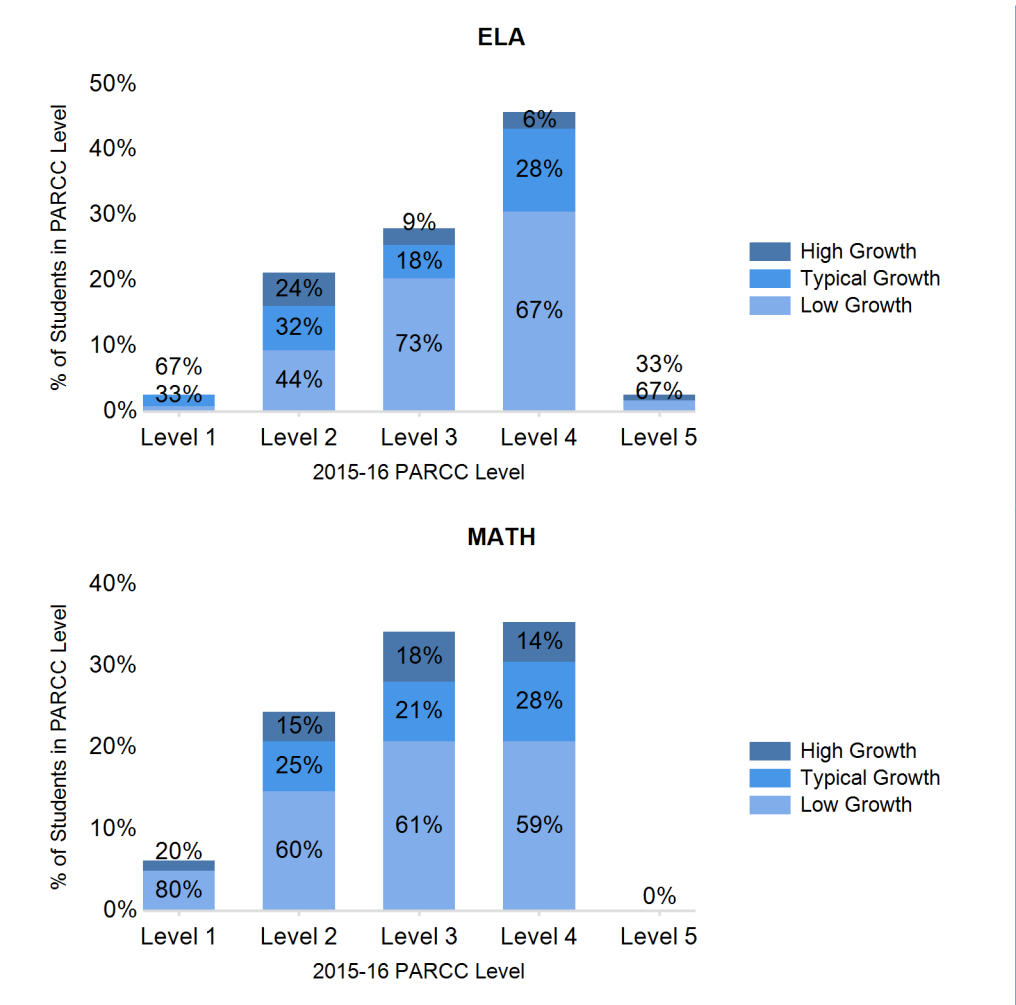

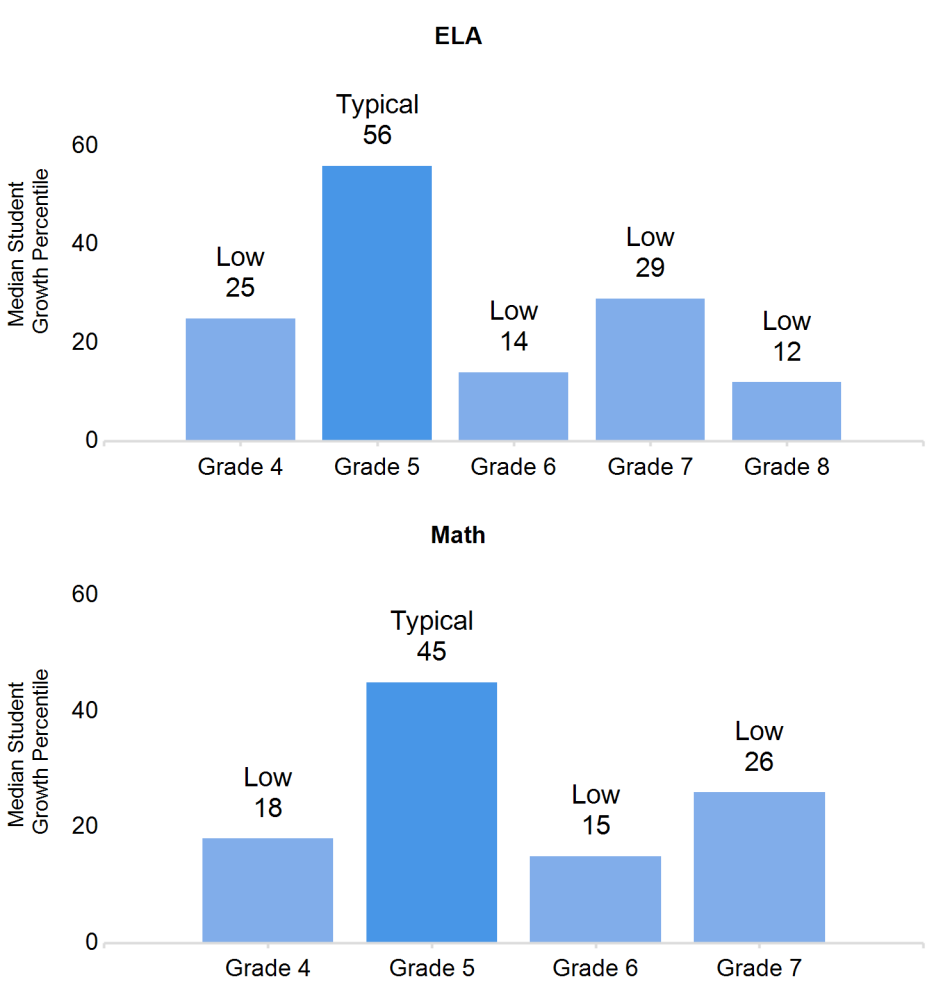

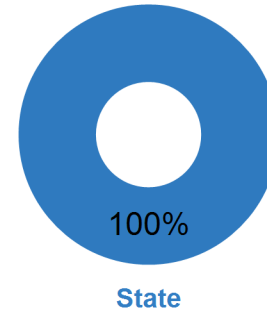

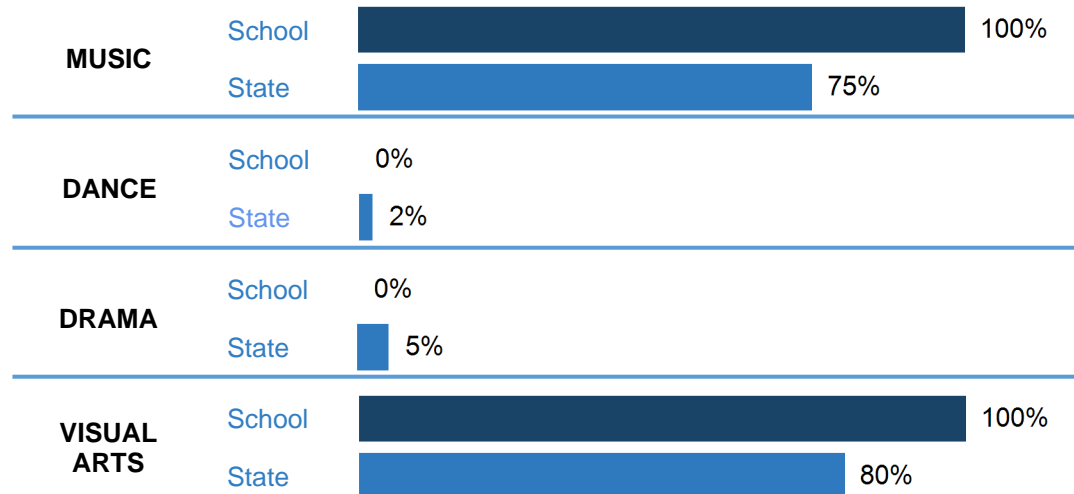

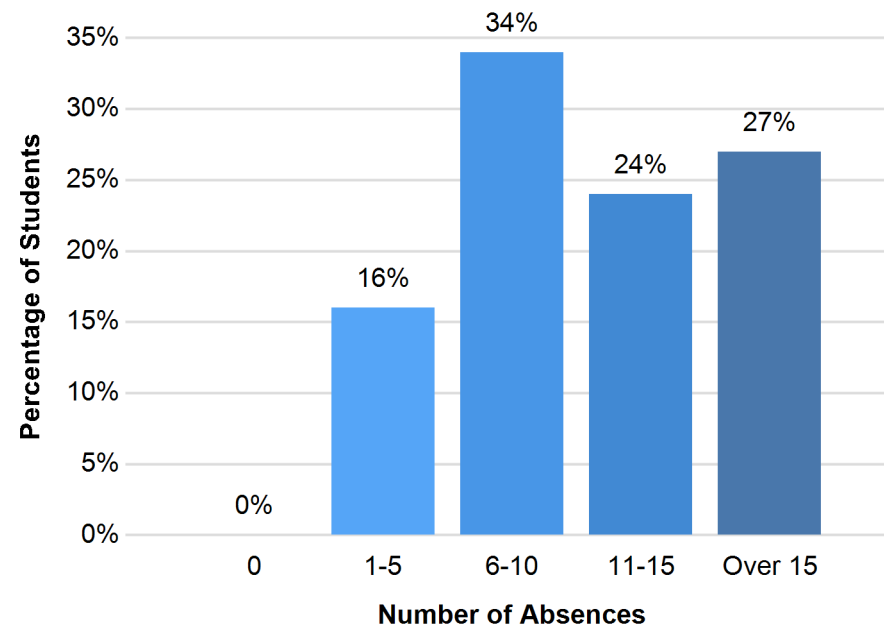

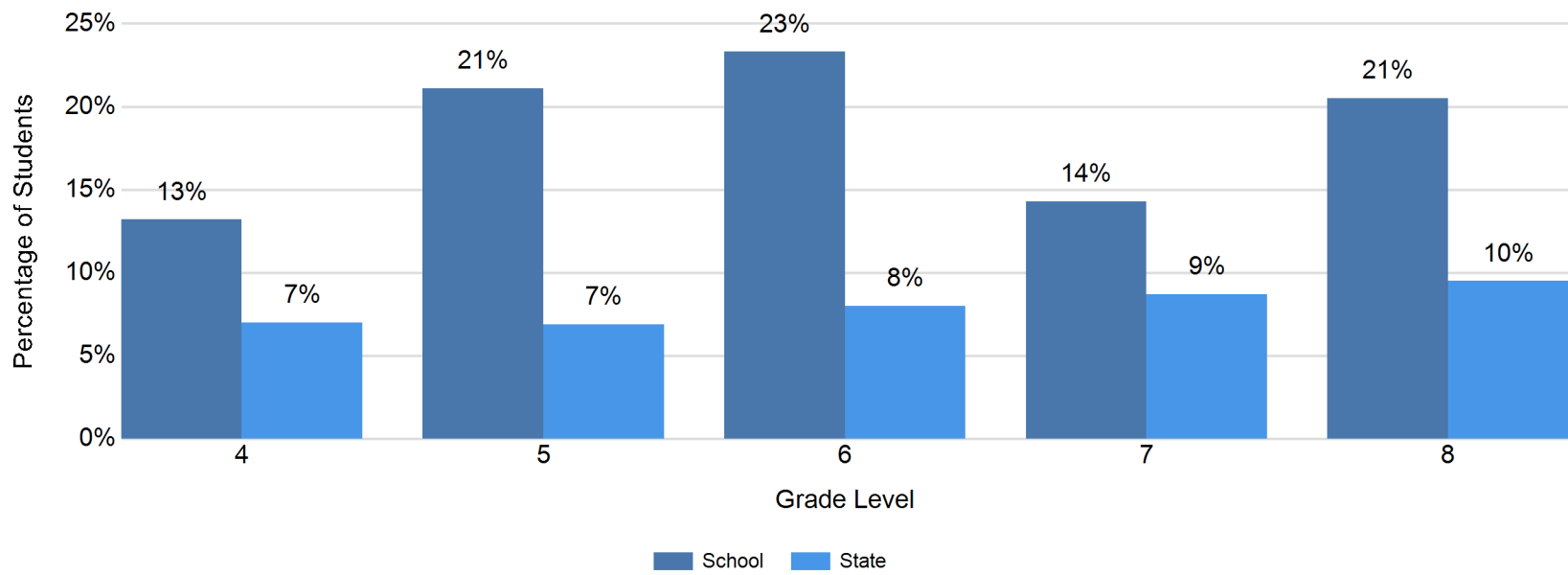

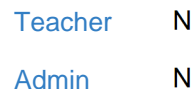

Overall, G-Suite has greatly increased communication and collaboration throughout the school community. G-Suite, Sketchup, Exhibitions, Earth, Hangouts, My Maps Google Cast for Education Youtube and Third Party Integration. Z-Space: 3-D computers-lessons can be created integrating questions on a Google Doc which students can answer and submit to a teacher. Frontier- digital platform for reading and writing for grades 3-6. Actively Learn- digital platform for reading and writing for grades 6-8. Fire and safety drills are conducted by all district schools on a regular basis to insure student and staff safety.

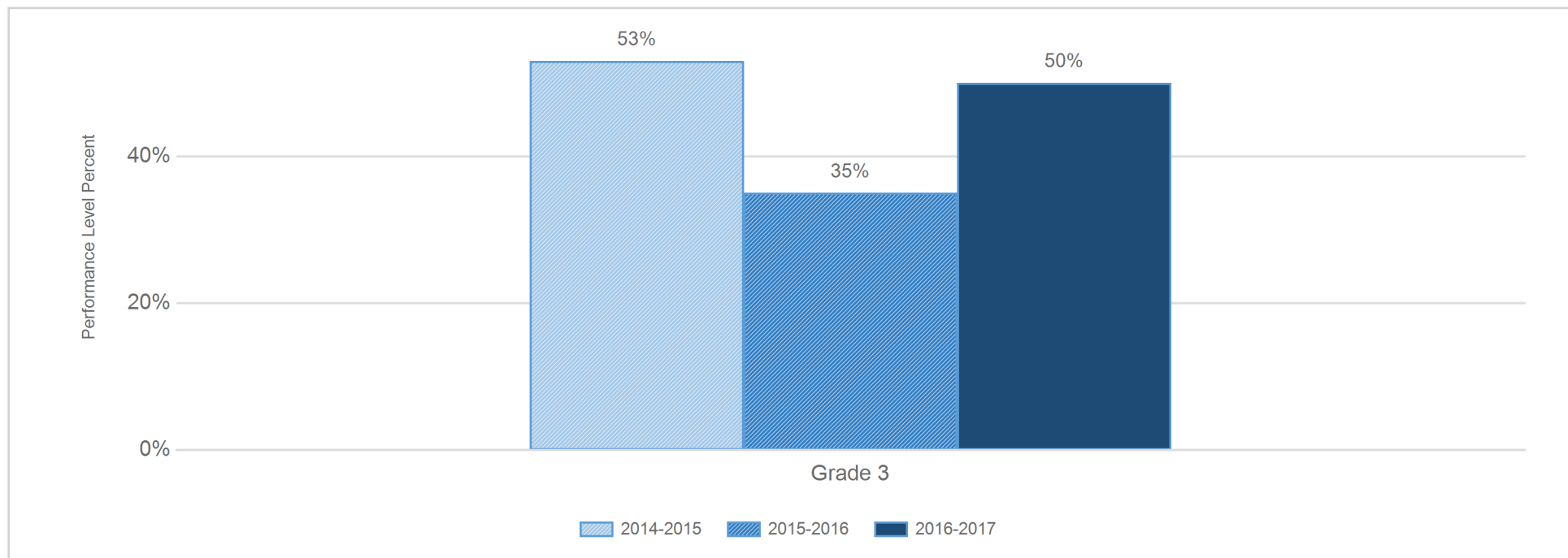

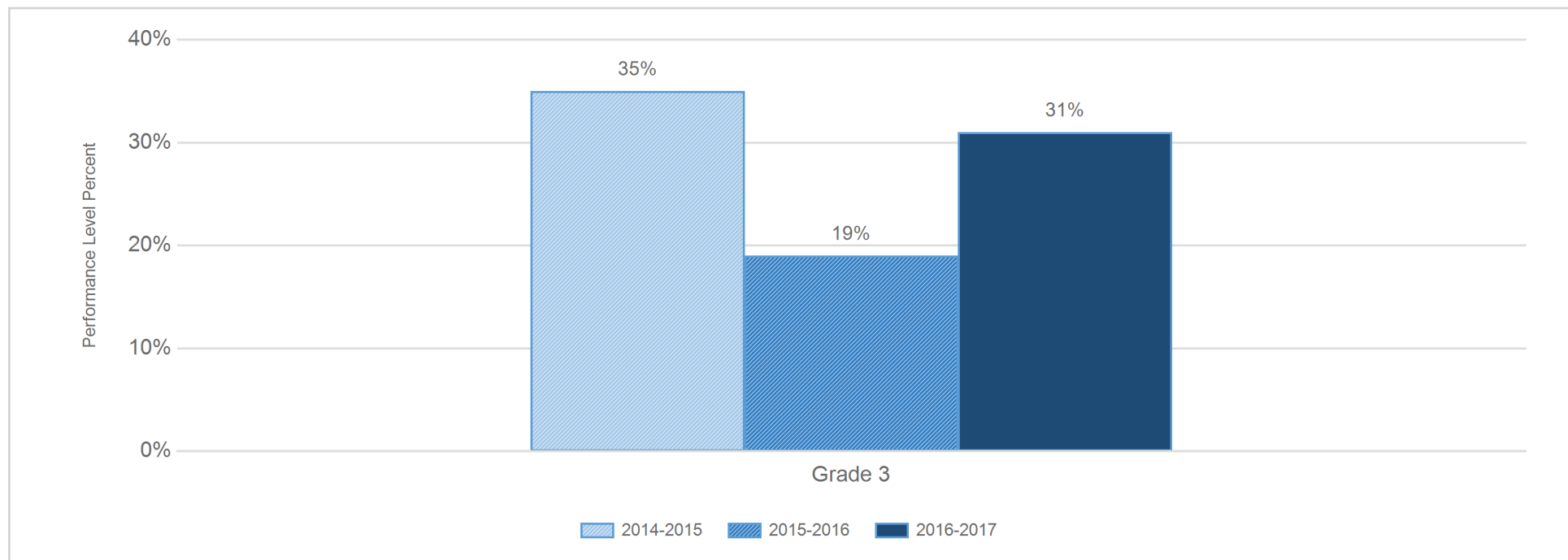

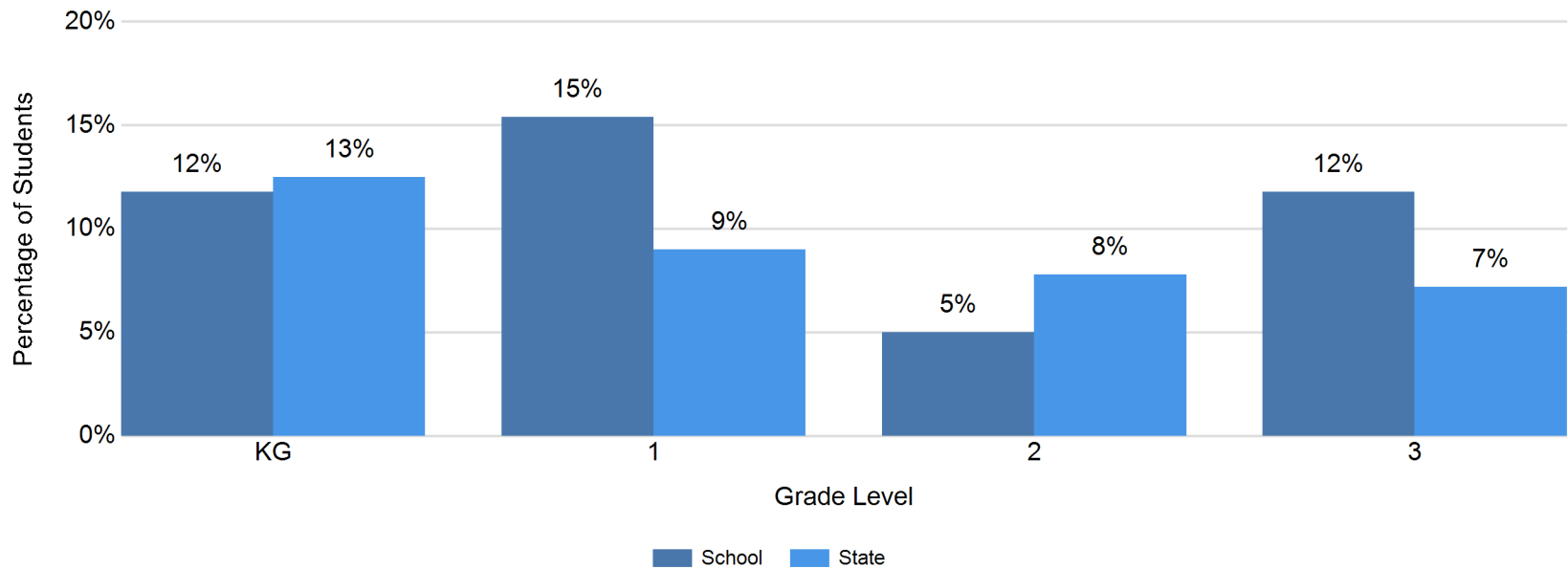
### Days Absent
