### **INTEGRITY OVERSIGHT MONITOR QUARTERLY REPORTS**

As required by the Governor's Executive Order No. 166 (EO 166) and the Office of the State Comptroller's Integrity Oversight Monitor Guidelines (IOM Guidelines), attached are the quarterly integrity oversight monitor reports for the period January 1, 2026 through March 31, 2026. Pursuant to the EO and the IOM Guidelines, reports are due to the Governor's Disaster Recovery Office (GDRO), the Legislature, the Attorney General and the State Comptroller within fifteen (15) business days of the due date of the report.

The IOM Guidelines require engaged monitors to provide reports describing the provision of services during the three (3) month period preceding the due date of the report, which shall include, but not be limited to, detailed findings concerning the integrity oversight monitor's scope of work and recommendations for corrective or remedial action relative to findings of malfeasance and inefficiency or any findings of fraud, waste, or abuse. The IOM Guidelines also provides that the quarterly reports must not include any information which may compromise a potential criminal investigation or prosecution or any proprietary information. Thus, consistent with the IOM Guidelines, the reports have been carefully reviewed for any such information and cleared for dissemination.
