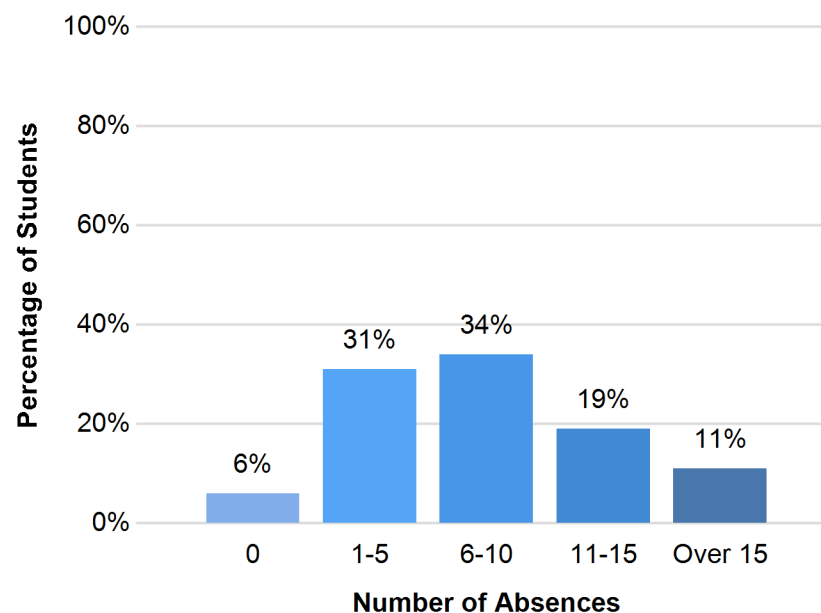

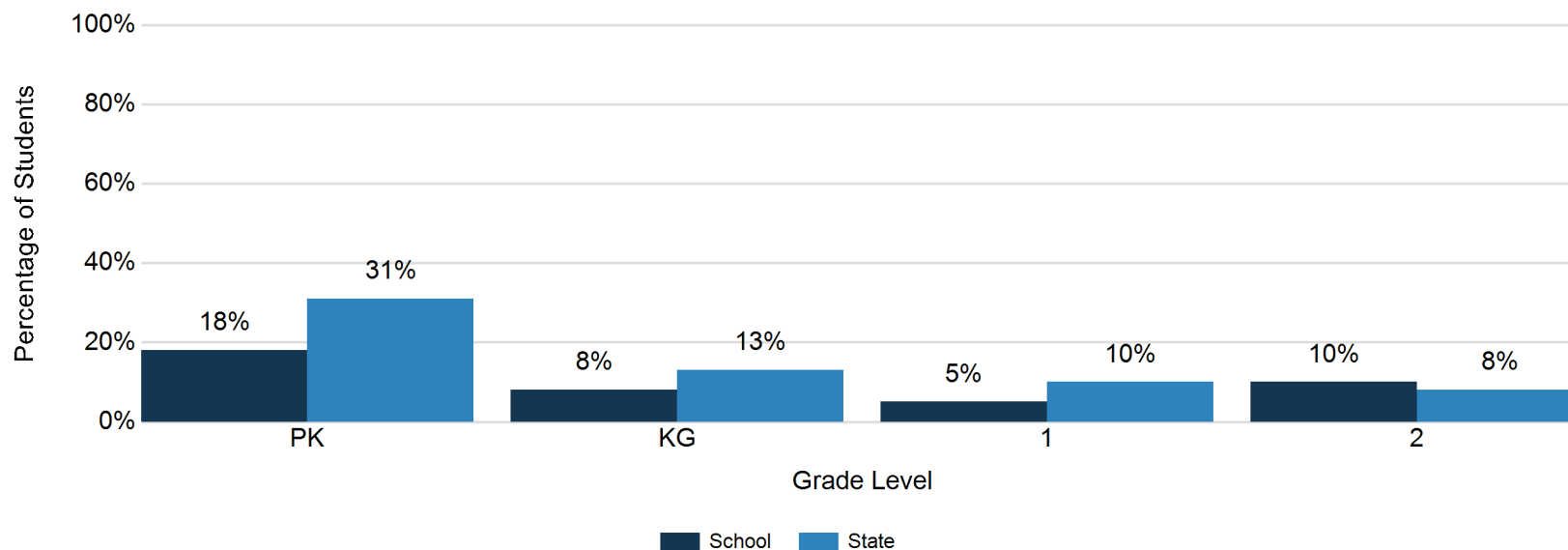

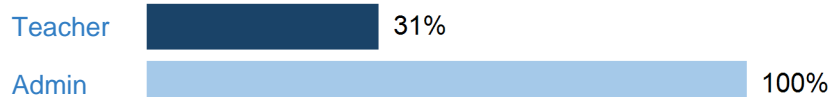

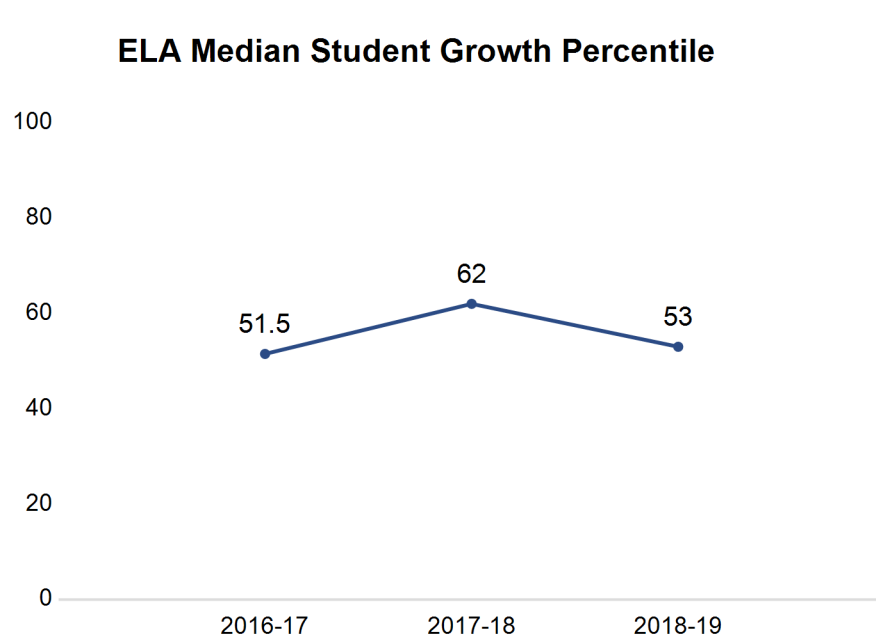

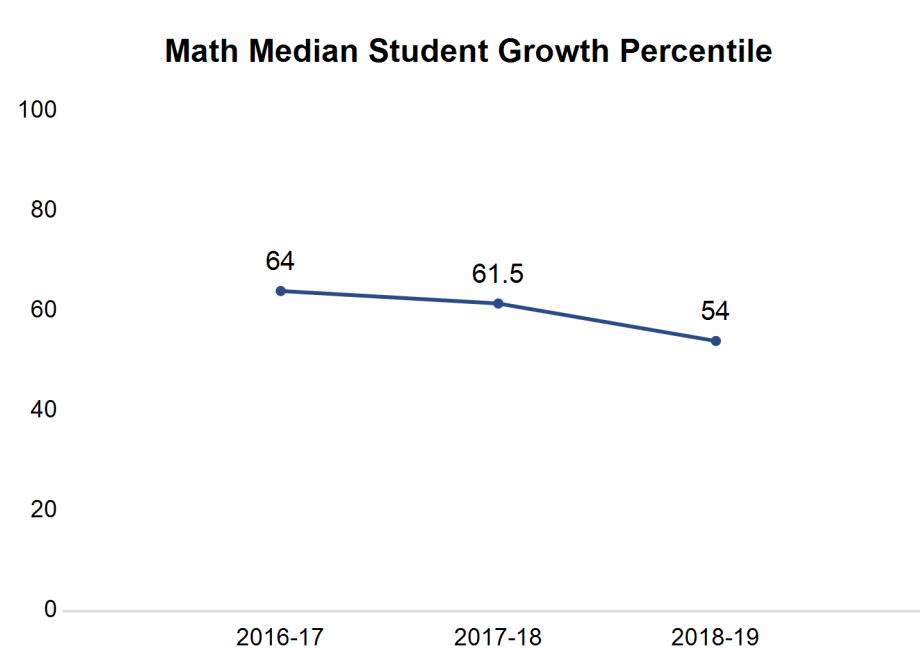

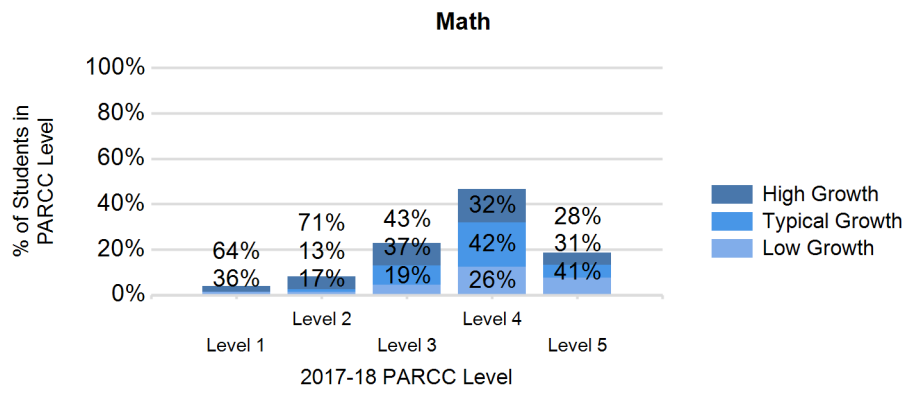
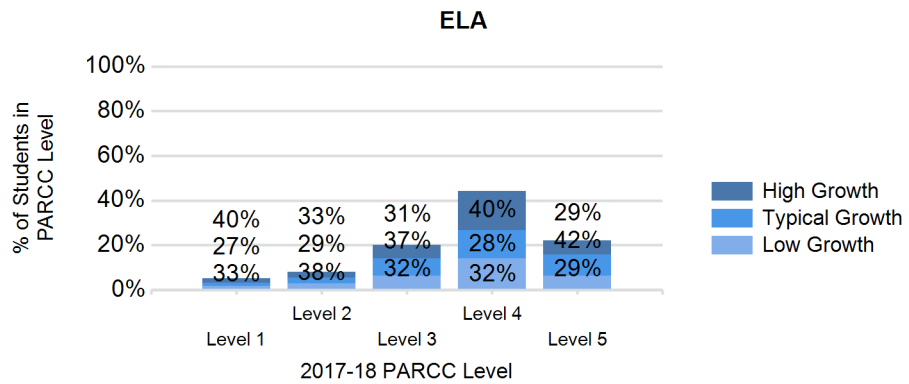

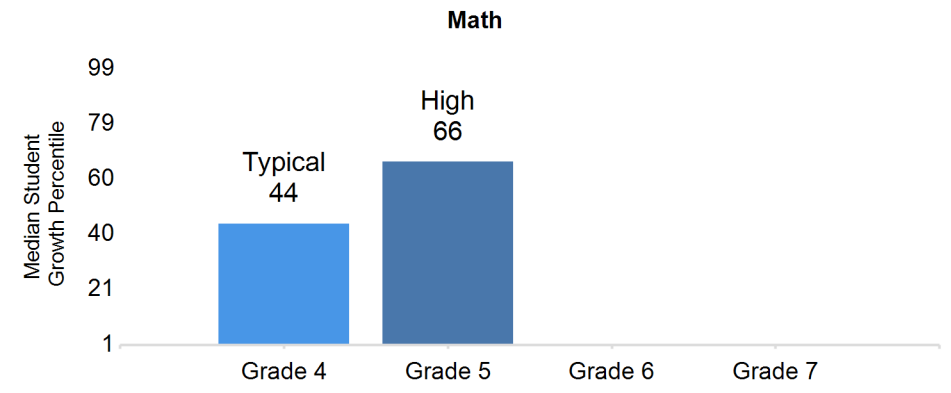
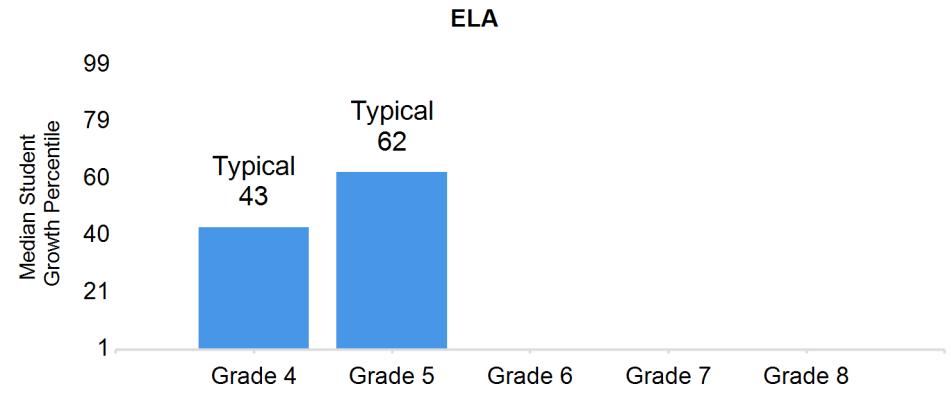
**Student Growth by Performance Level**

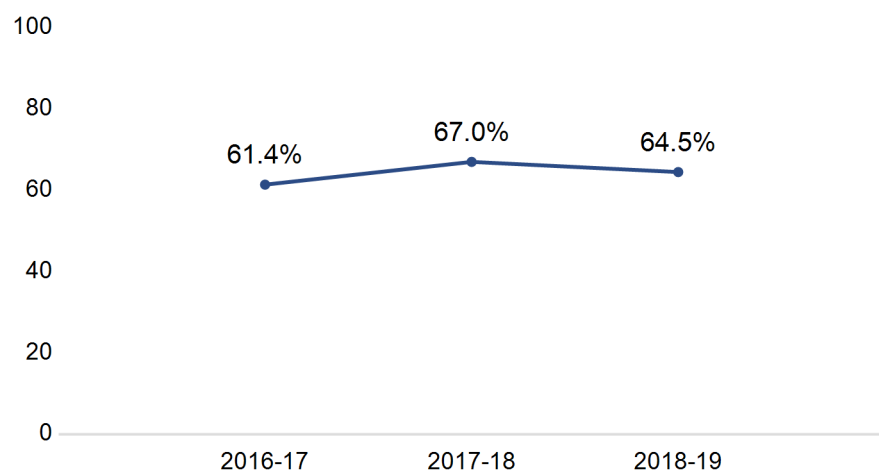

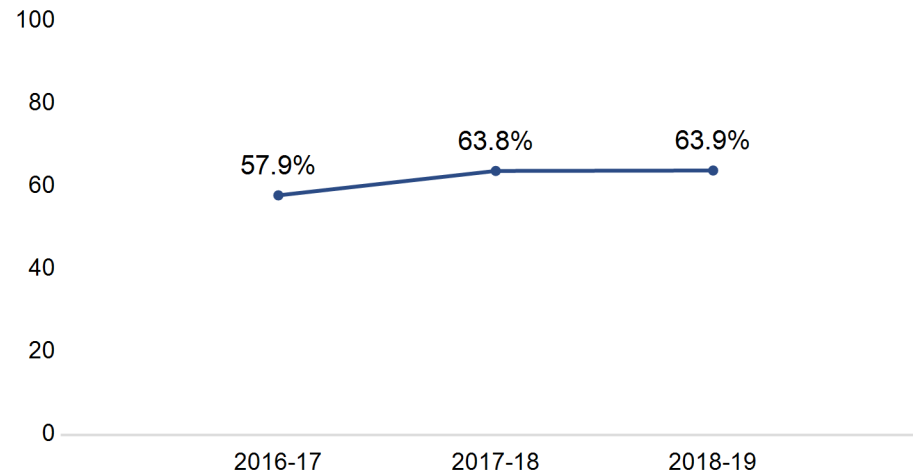

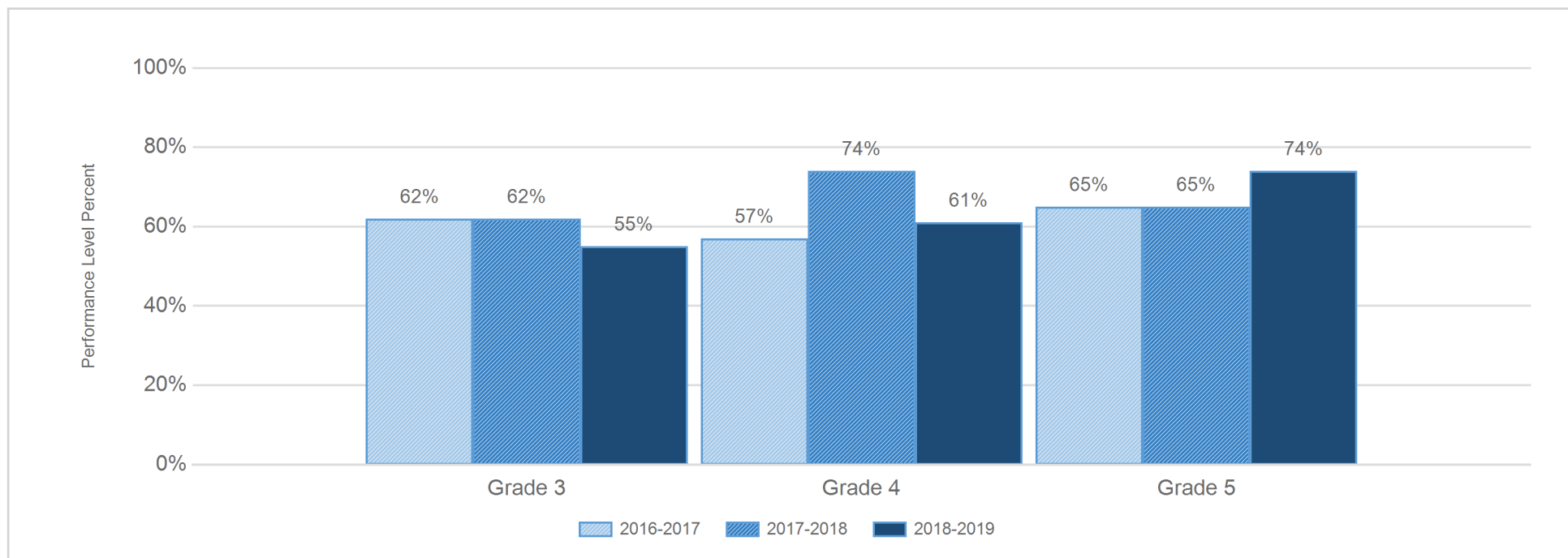

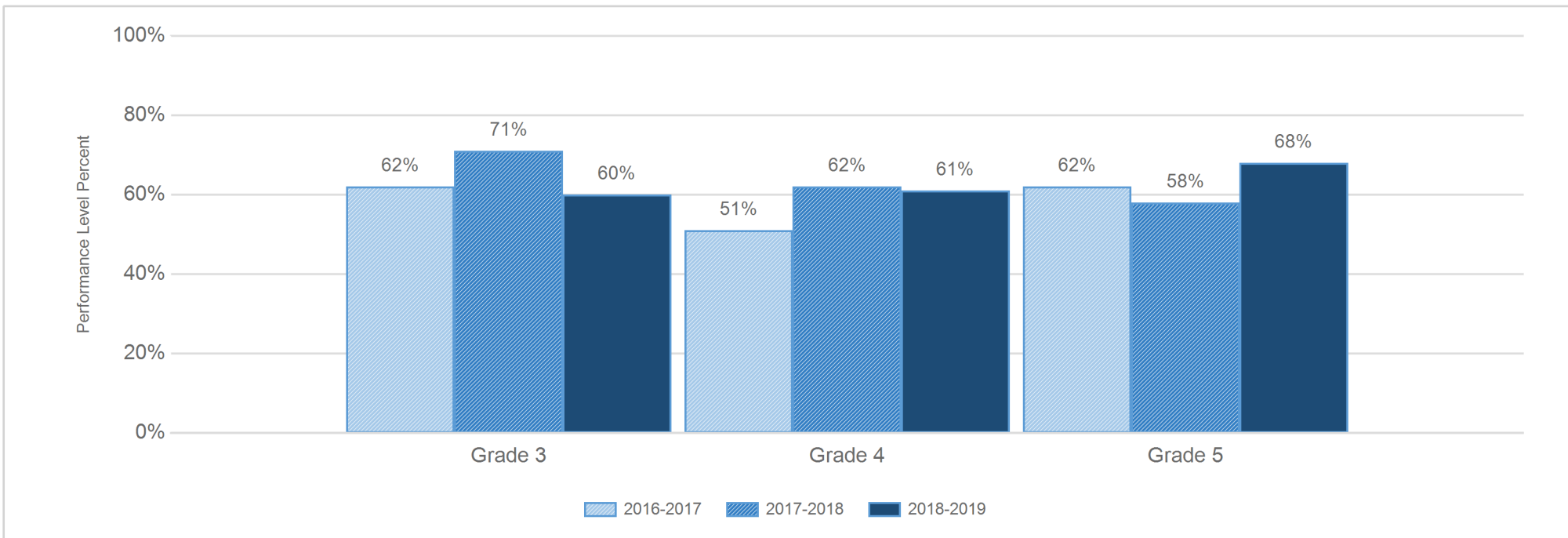

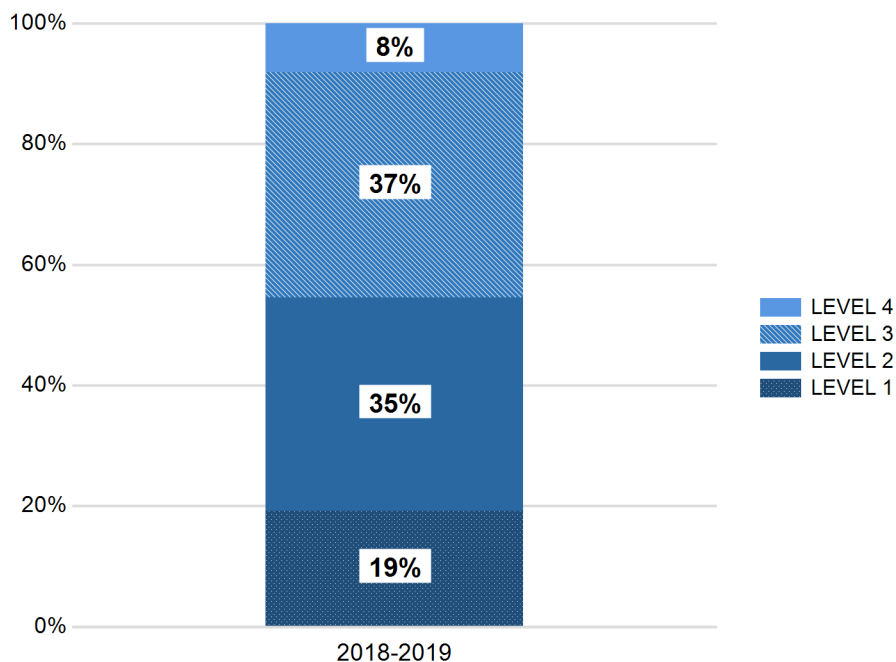

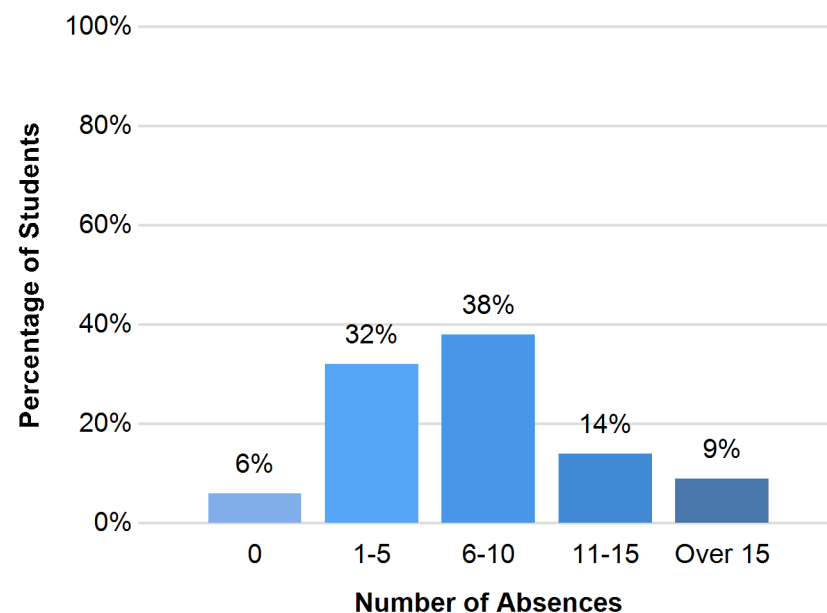

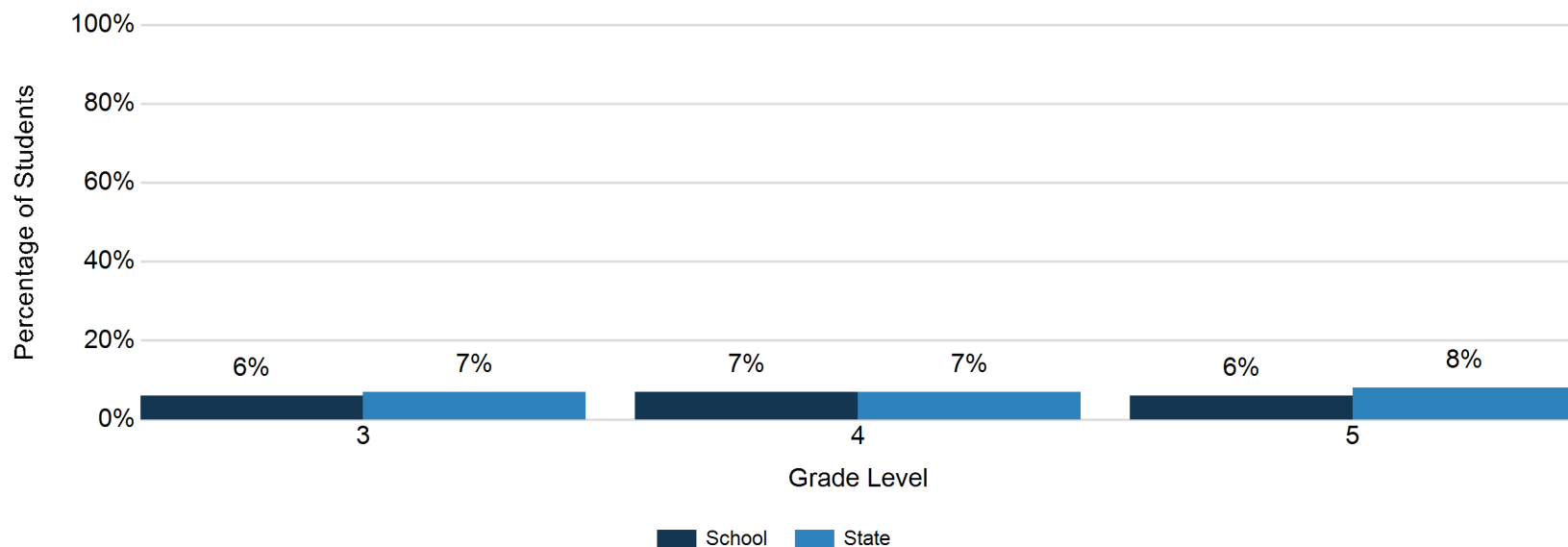

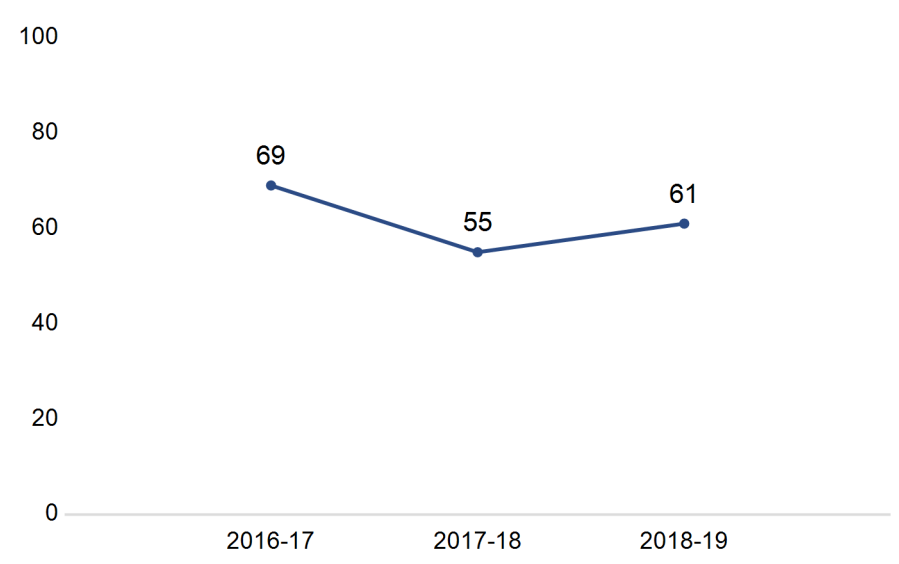

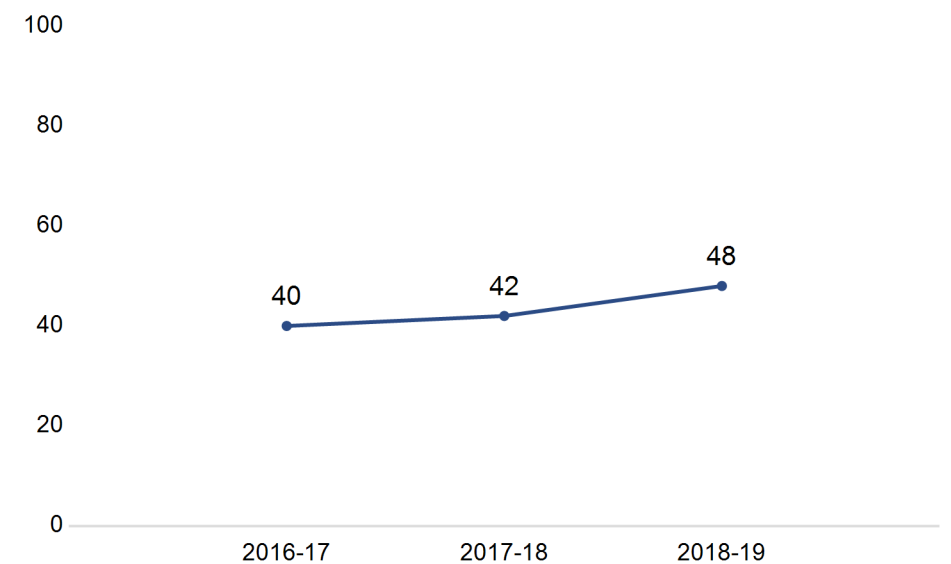

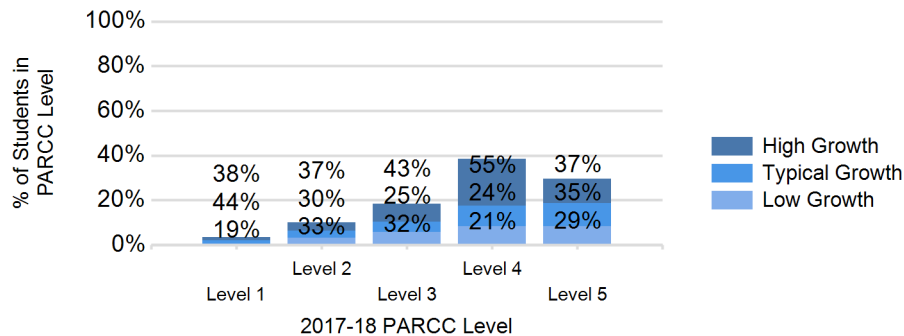

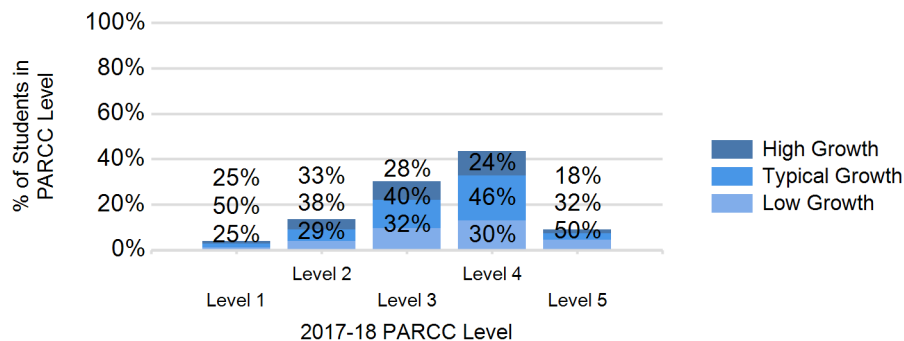
**Student Growth by Performance Level**

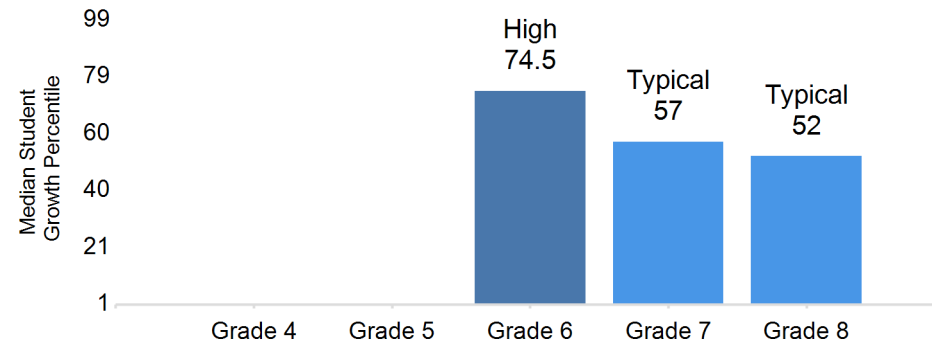

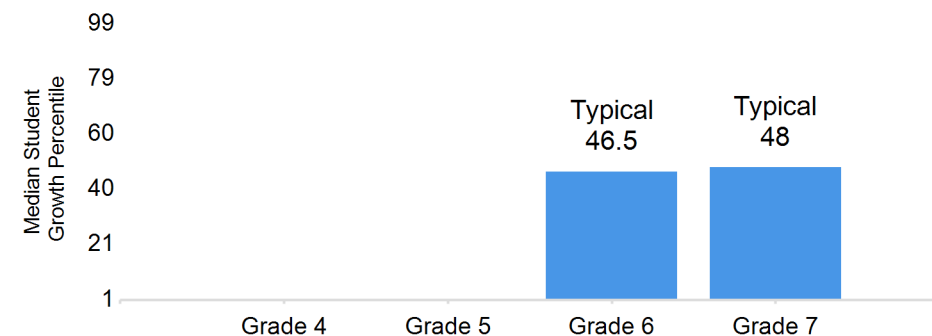
**Student Growth by Grade**

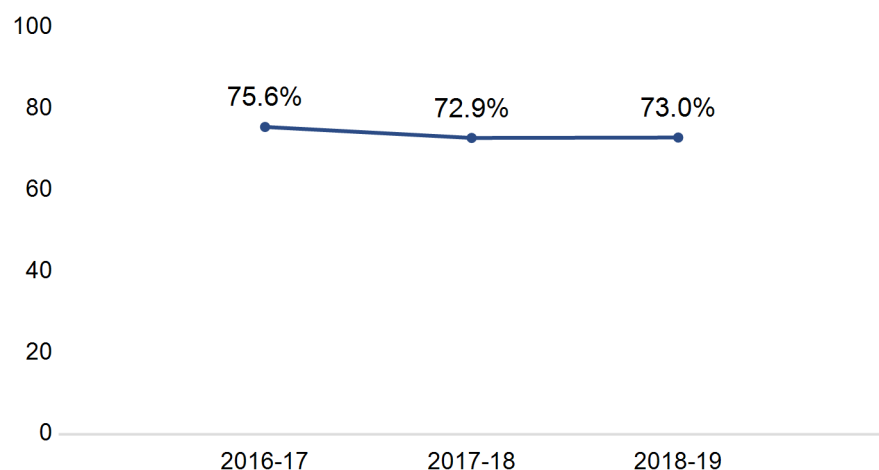

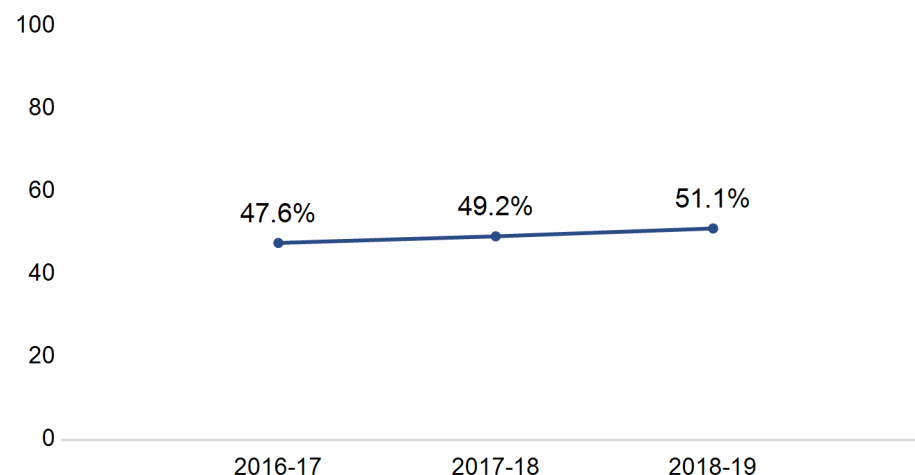

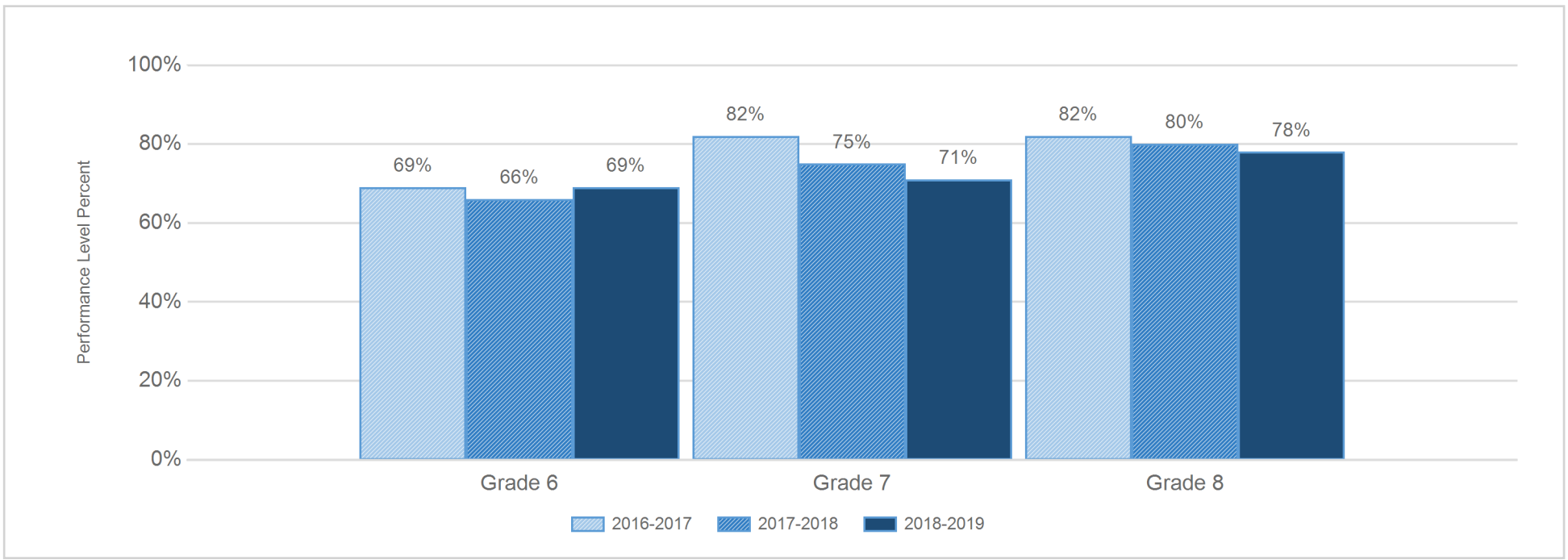

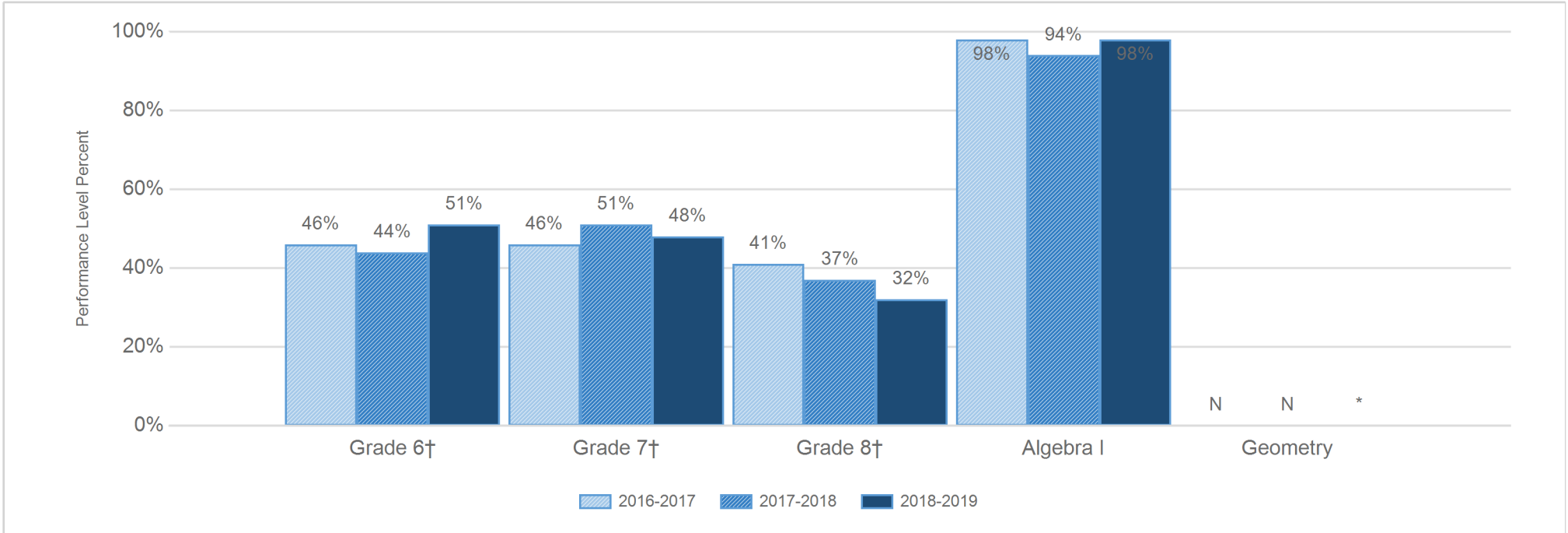

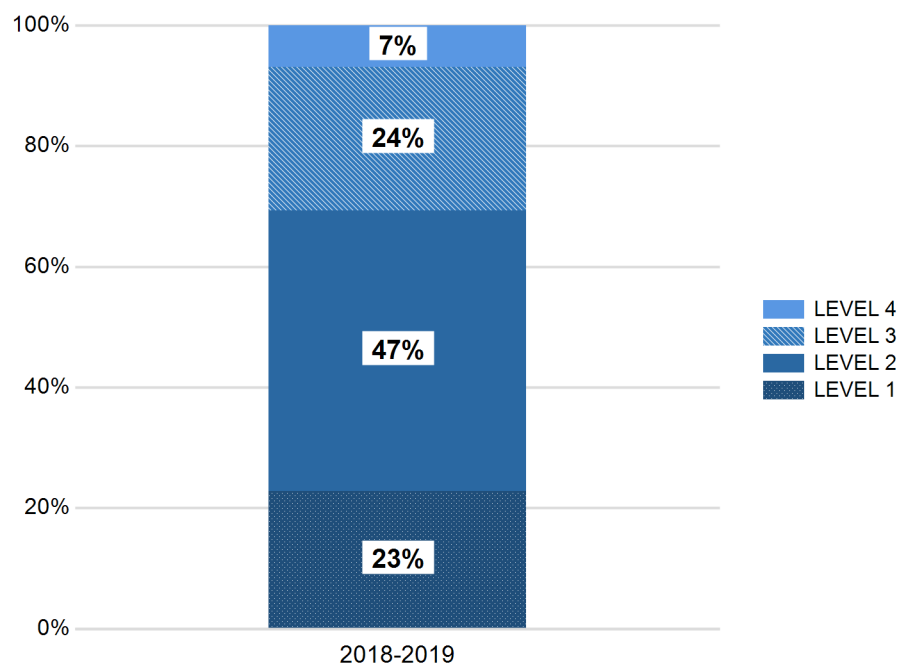

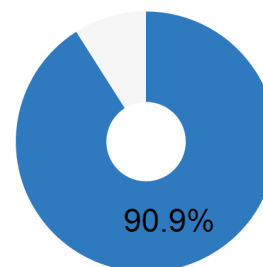

Students enrolled in one or more **visual and performing arts** classes

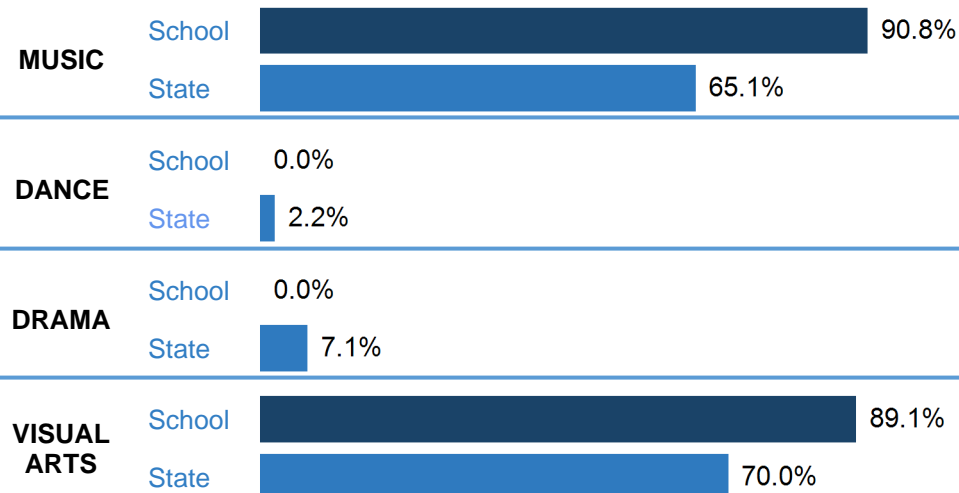

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The New Jersey Department of Education used input from New Jersey communities to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. 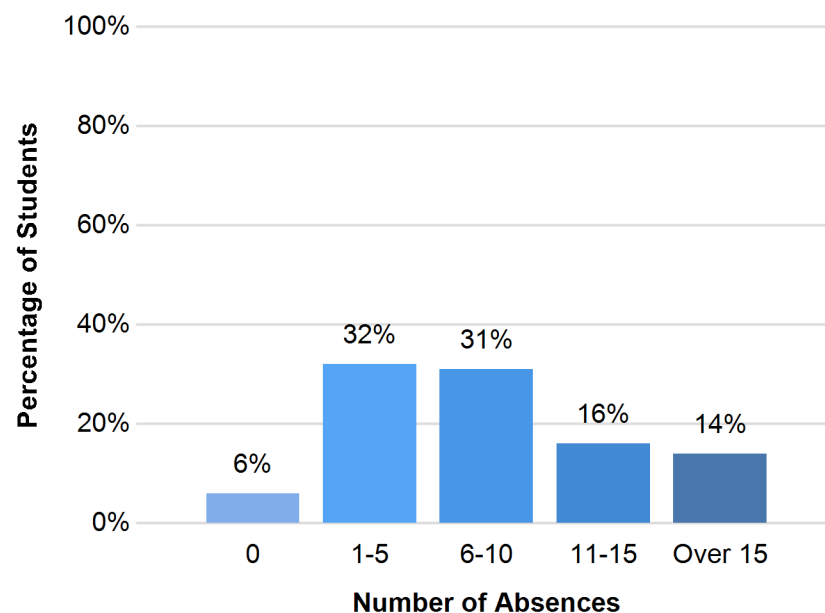

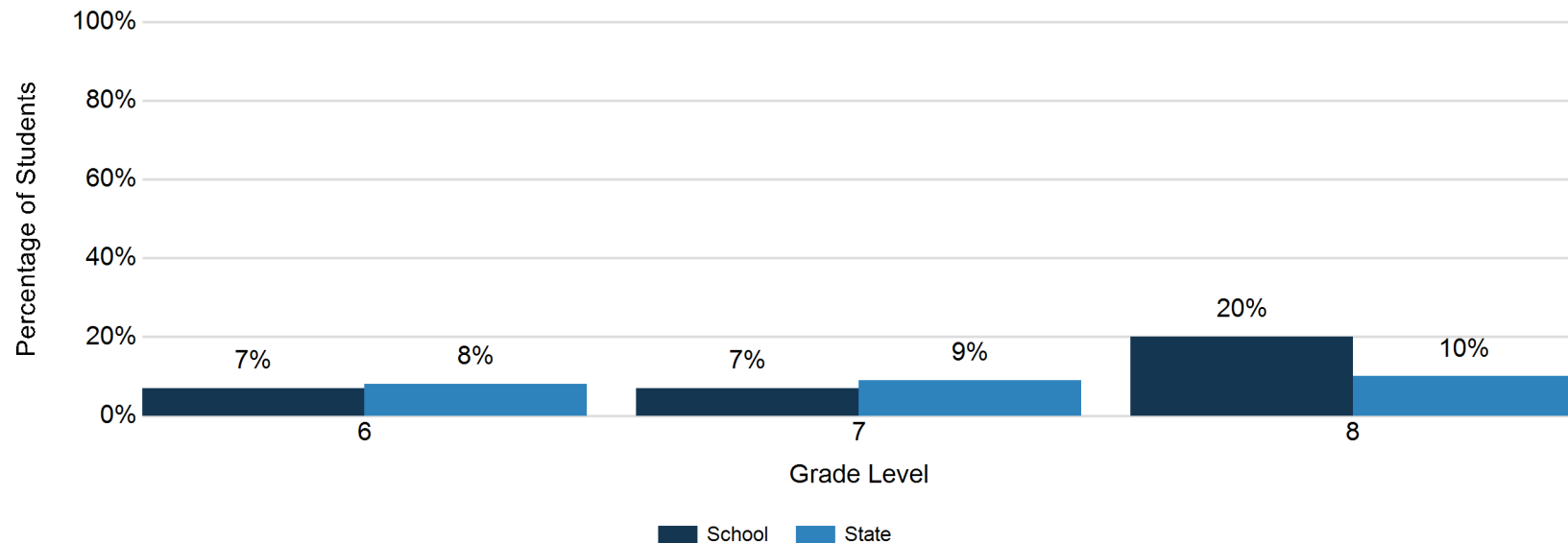

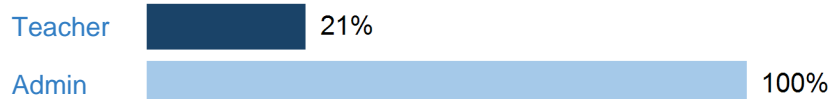
