## REPORT.

---

*To His Excellency Joel Parker, Governor of the State of New Jersey :*

SIR:—I have the honor to present this, my first report. On entering upon my duties on the first day of April last, I found the Library very much out of order, owing to the enlargement of the Library room, and as the room still remains unfinished, I have not been able to make any improvement, further than to remove the books of the law department from the floor to temporary shelves. Many of the books of the miscellaneous department are still piled on the floor of the alcoves, which is the best that can be done with them until the room is finished.

The crowded and disordered condition of the Library renders an early completion of the room desirable. I have received from the printer one thousand volumes of each of the following books :

Record of the Governor and Council of East New Jersey, 1682 to 1703.

Minutes of the Council of Safety of New Jersey, 1777.

Journal and Votes of the House of Representatives of New Jersey, 1703 ; printed and published under authority of Chapter DXLV, session of 1871, and have sent one copy of each to each of the State Libraries of the different States of the Union, also one copy to each of the public Libraries in New Jersey, and one copy to each of the College Libraries of New Jersey. I have also sent to the New Jersey Home for Disabled Soldiers, at Newark, New Jersey, two hundred and forty-eight (248) volumes of miscellaneous books (selected by the Commissioners of the Library), by authority of Joint Resolution number seven, session of 1872.
