DIRECTIONS: Somerset County Day; Thursday, August 19th, 1999  
Site-to-Site Directions

State House [Trenton] to AT&T; Open Space Site [Bernards Twp.]

- US Route 1 North;
- I-95 South;
- Route 206 North;
- Follow Rt. 206 thru Princeton, Montgomery, Hillsborough, and into Somerville;
- At the Somerville Traffic Circle, follow signs for I-287 North;
- I-287 North to I-78 East;
- Bottom of ramp bear RIGHT;
- Follow Route 525 South for 1 mile;
- Turn RIGHT onto Mountain Road; [large field on your right]
- Follow Mountain Road [very narrow & winding] for 1 mile;
- Park in a large clearing on right, across from the mailbox #266;
- Vans will be provided to transport all attendees to program site.

AT&T; Open Space Site [Bernards Twp.] to Hoechst Marion Roussel Corp. HQ [Bridgewater]

- Exit parking area on Mountain Avenue, turning LEFT and follow back to intersection with County Route 525;
- Go LEFT onto Route 525 North, and follow back to I-78;
- Take I-78 West;
- Take exit for I-287 North;
- After merging onto I-287 North, take 1st exit on right for Routes 202 & 206;
- At end of ramp, go RIGHT onto 202 & 206 South;
- Follow 202 & 206 South through Pluckemin;
- You will pass buildings for AT&T; and Pharmacia-Upjohn;
- Hoechst Marion Roussel will be next on your RIGHT;
- Use the 2nd entrance [marked "Commercial/Visitors"];
- Sign-in at Security Gate, and you will be directed where to park.

Hoechst Marion Roussel [Bridgewater] to Hillsborough Twp. Municipal Building [Neshanic]

- Exit HMR property, and turn RIGHT onto Routes 202 & 206 South;
- Follow 202 & 206 South past the Bridgewater Commons Mall, and back to the Somerville Traffic Circle;
- Follow signs for Route 206 South & Princeton;
- Follow 206 into Hillsborough;
- Pass Charlie Browns & Burger King on your left;
- At intersection with Amwell Road/County Route 514, go RIGHT;
- Follow Amwell to second traffic light;
- Turn RIGHT onto Beekman Lane;
- Follow Beekman Lane to stop sign, and Municipal Building will be on the left across the intersection;
- Use 1st driveway and park in lot on left;
- Once in the building, follow signs for Court Room.

Hillsborough Twp. Municipal Building [Neshanic] to Somerset Co. 4-H Fair [North Branch Park, Bridgewater]

- Exit Municipal Building parking lot, and go RIGHT onto Beekman;

- Make your immediate 1st LEFT onto Amwell Road;
- Road becomes South Branch Road/Route 625;
- Route 625 will make a number of turns, and road will change names from South Branch Road to River Road;
- Go RIGHT onto River Road [still Route 625];
- Follow River Road to intersection with Studdiford Drive/County Route 606 [NOT WELL MARKED];
- Go RIGHT onto Studdiford, and go over small bridge;
- Follow Studdiford to end;
- Go RIGHT onto County Route 567 North;
- Follow Route 567 to fork, and go RIGHT continuing to follow signs for Route 567;
- At `T' intersection, go RIGHT onto Old York Road [Route 567];
- Follow Old York Road to intersection with Milltown Road;
- Mark a hard LEFT into Milltown Road headed North;
- Follow Milltown Road across Route 202;
- North Branch Park will be on your LEFT.
