SUBJECT: January 1995 Social Security Cost-of-Living Adjustment (COLA)
Automated Update to the Long-Term Care System

Attached for your review is the January 1995 Social Security Income Increase List for patients in facilities in your county. For the January cost-of-living increase, an automatic 2.8% was computed for those Medicaid patients who had a PA-3L in the long-term care billing system prior to January 1995.

The Division's COLA UPDATE REPORT continues to be enhanced with a "COMMENT" column. A clarification of the comment is displayed on the first page of each facility's report. If a 1995 Social Security amount is entered on a PA-3L form that was in the long-term care billing system prior to January 1995, "95 EFF DTE NC" (PA-3L for 1995 In System - No COLA Increase Applied) will appear in the "COMMENT" portion of the COLA UPDATE REPORT. Since the COLA UPDATE REPORT will show the 1995 amount exactly as it was entered on the PA-3L form, it is important that the amount that was entered on the PA-3L accurately reflects the COLA increase.

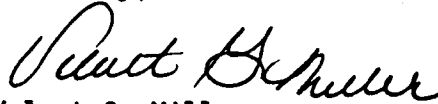
If on the COLA UPDATE REPORT, the recipient's available income (NET INC BEFORE column) is zero, the recipient's available income (NET INC AFTER column) will remain zero and one of two messages will appear in the "COMMENT" portion of the report:

- 1) SSA ZERO (COLA APPLIED - NET INCOME SET TO ZERO)
- 2) SSI ZERO (COLA NOT APPLIED - NET INCOME ZERO)

Since facilities are required to report all income changes, including those involving annual cost-of-living increases, a newsletter will be sent instructing them to carefully review the latest 1995 billing document and compare the patient payment amount listed against the amount in the "NET INC AFTER" column on the COLA UPDATE REPORT. The facilities will be instructed to report any corrections greater than or equal to \$1.00 to the county welfare agency or the Institutional Services Section area office, as appropriate, to ensure that a new PA-3L form is issued. No action is required for differences of less than \$1.00. The income of those Medicaid patients that may be affected by cost-of-living adjustments, but is not subject to the Social Security automatic increase, i.e., Railroad Retirement, is included in "NET INC AFTER" and should also be reviewed.

This information is to be communicated to appropriate staff. Your cooperation in this matter is necessary for the accurate and efficient operation of the long-term care billing system. Questions regarding this communication can be directed to the Bureau of Claims and Accounts at (609) 588-2885.
