**SUBCHAPTER 1. GENERAL PROVISIONS**

**10:133E-1.1 Purpose**

(a) The purposes of this chapter are to list the services that the Division of Child Protection and Permanency:

1. Shall provide to:
  - i. Each client as part of the case plan; and
  - ii. Each child placed by the Division in an out-of-home placement; and
2. Shall consider for each client, when developing a case plan to contribute to achievement of the case goal.

1. Every applicant and client of the Division;
2. Each Division representative; and
3. Each owner, director and employee of each service agency and each individual service provider with whom the Division has a contract.

**10:133E-1.4 Application for, provision of, and availability of services**

(a) An applicant or client may apply for the services listed in N.J.A.C. 10:133E-2 through a local office of the Division.

(b) The Division may provide the services listed in N.J.A.C. 10:133E-2 through direct service delivery by Division staff or through third-party social service contracts with other service providers. The Division also refers applicants and clients to service providers.

(c) Some services listed in N.J.A.C. 10:133E-2.3(b) are:

1. Not universally available;
2. Available only in certain geographic areas of the State; or
3. Available to a limited number of persons at a given time.

(d) When services are available as described in (c) above, a waiting list may be established or an alternate service offered, if available and appropriate.

**10:133E-2.1 Services required as part of the case plan**

The Division shall provide case management as part of the case plan to each client whose case is open or in accordance with N.J.A.C. 10:129-6.1 and 6.2.

**10:133E-2.2 Services required for children in out-of-home placement**

(a) For each child placed by the Division in an out-of-home placement, the Division shall:

1. Provide placement reviews, in accordance with N.J.A.C. 10:133H-3;
2. Cooperate so that the Child Placement Review Board can provide reviews, pursuant to N.J.S.A. 30:4C-50 et seq.;
3. Provide health care services as specified in N.J.A.C. 10:122C-7.1 and 10:122D-2.5; and
4. Provide educational support, other than those services provided by the Department of Education or by school districts, as specified in N.J.A.C. 10:122C-6.3 and 10:122D-2.6.

**10:133E-2.3 Services to consider for the case plan**

(a) In developing the case plan in accordance with N.J.A.C. 10:133D-1, the Division representative shall consider:

1. The individual strengths, needs, and resources of each Division client identified in an assessment;
2. The various services to meet the identified needs of each Division client;
3. Which services are provided to meet the identified needs of each Division client and the anticipated time frames;
4. Whether the services are provided to each Division client directly by Division staff or through contract by another service provider; and

5. The results of ongoing monitoring of services and adjustments identified by the monitoring.

(b) The Division representative shall consider each of the following services:

1. Adoption subsidy;
2. Camp;
3. Child care;
4. Clothing allowance;
5. Discharge planning and aftercare services;
6. Domestic violence services;
7. DYFS Legal Guardianship Subsidy Program;
8. Educational support;
9. Emergency maintenance service;
10. Family preservation services;
11. Health care services;
12. Homemaker service;
13. Maintenance;
14. Mentor services;
15. Out-of-home placement, which includes:
  - i. Adoptive placement;
  - ii. Foster care;
  - iii. Group home;
  - iv. Kinship care;
  - v. Residential facility;
  - vi. Selected adoptive home;
  - vii. Shelter care;
  - viii. Supervised transitional living home; and
  - ix. Treatment home;
16. Post-adoption services;
17. Pre- and post-natal services;
18. Psychological/therapeutic services;
19. Respite care;
20. Self-sufficiency skills;
21. Substance abuse services;
22. Title XIX Medicaid; and
23. Transportation.
