1. NOTICE

TO ALL MUNICIPAL ISSUING AUTHORITIES:

The enactment of the Revised Statutes on December 20, 1937 (P. L. 1937, c. 185) has necessitated certain changes in all application forms for licenses and in all license certificates issued pursuant thereto. It is highly desirable that all issuing authorities have a sufficient supply of application forms and license certificates prepared at the earliest possible moment so that they will be available when the time comes for the issuance of new licenses for the next fiscal year, beginning July 1, 1938.


Following are the prescribed forms of applications and license certificates:

- (1) New form of application for all municipal retail licenses, except club licenses.
- (2) New form of application for Club License.
- (3) New form of license certificate for Plenary Retail Consumption License.
- (4) New form of license certificate for Plenary Retail Distribution License.
- (5) New form of license certificate for Seasonal Retail Consumption License.
- (6) New form of license certificate for Limited Retail Distribution License.
- (7) New form of license certificate for Club License.

The form of application for all municipal retail licenses, except club licenses, set forth in Bulletin 72, Item 3, is superseded by the revised form hereinafter set forth in Item 2 of this Bulletin.

The form of application for club license, set forth in Bulletin 72, Item 4, is superseded by the revised form hereinafter set forth in Item 3 of this Bulletin.

Items 4, 5, 6, 7 and 8 of this Bulletin, supersede, effective for the period beginning July 1, 1938, the official forms for license certificates set forth in Bulletin 31, Items 11, 12, 13, 14 and 15.
