1. NOTICE

TO ALL MUNICIPAL ISSUING AUTHORITIES:

All licenses, except seasonal retail consumption licenses, will expire at midnight, June 30, 1935. Licensees must obtain their renewal licenses on or before that date in order to continue business without interruption. The law requires that a licensee who seeks to renew his license must comply with all the requirements pertaining to his original application. Accordingly, he must (1) file a new application accompanied by a full annual license fee for the period from July 1, 1935 to July 1, 1936 and satisfactory evidence that a new Federal tax stamp for such period has been obtained, and (2) publish a notice of intention once a week for two weeks successively. But this is only the mechanical part of the procedure. The thing that really matters is the investigation which must be made by the municipal issuing authorities and the hearing held if hearing be necessary. All this requires TIME. It is therefore highly desirable that applications be filed at once and notices of intention published at the earliest possible minute. Don't wait the last rush. A "Garrison finish" has its moments but won't be "placed" in this serious business of licensing. Undue delay means some licensee will have to close up shop.

Following are the revised rules and prescribed forms of applications:

(1) Revised rules governing advertising, including new form of notice of intention. These apply to all municipal retail licenses including club licenses.

(2) New form of application for all municipal retail licenses, except club licenses.

(3) New form of application for club license.

Note particularly that the revised rules governing advertising require that application must be filed at or before the first insertion of the notice of intention and that a hearing is to be set when any objection is filed without the necessity of any request therefor by the applicant.

There will be no substantial changes in the official forms of municipal retail licenses heretofore promulgated in Bulletin 31. The forms and changes are as follows:-

PLENARY RETAIL CONSUMPTION LICENSE: Use form in Bulletin 31, Item 11, except change expiration date to June 30th, 1936.

PLENARY RETAIL DISTRIBUTION LICENSE: Use form in Bulletin 31, Item 12, except change expiration date to June 30th, 1936.

SEASONAL RETAIL CONSUMPTION LICENSE: Use form in Bulletin 31, Item 13, except to omit the bracketed words, viz., "(May 15th to Sept. 15th; or Nov. 15th to April 15th, whichever period it is issued for)". The reason for this excision is because of a Bill now


pending in the Legislature, Senate 294, which may change those dates. Hence by eliminating the bracketed matter above quoted, the form is available for use whether the Bill is enacted into law or not.

LIMITED RETAIL DISTRIBUTION LICENSE: Use form in Bulletin 31, Item 14, except change expiration date to June 30th, 1936.

CLUB LICENSE: Use form in Bulletin 31, Item 15, except change expiration date to June 30th, 1936.

Licensees who intend to continue in business but fail to obtain their renewal licenses on or prior to June 30, 1935, will not be permitted to operate until all the legal requisites have been completed and licenses actually issued.

The law will be enforced. Licensees should be urged to act now and save embarrassment later.

2. REVISED RULES APPLICABLE TO ALL MUNICIPAL RETAIL LICENSES FOR ADVERTISING "NOTICE OF INTENTION" TO APPLY FOR A LICENSE

#1. Application for license must be filed with the issuing authority at or before the first insertion of advertisement.

#2. "Notice of Intention" shall be published in the following form:

#3. Name of "Issuing Authority" in the above form usually means the governing board or body of the municipality, whatever the name may be, for instance, the Mayor and Common Council, the Township Committee, etc., except where, pursuant to Section 5 of the Control Act, a Municipal Board of Alcoholic Beverage Control has been created, in which case such board is the Issuing Authority. In Cape May and Ocean Counties, the issuing authority is the Judge of the Court of Common Pleas; and the notice in those counties must state that objections be addressed to said Judge (not the municipal clerk) and must also state such other matters as may be required by said Judges respectively. If application is made pursuant to P.L.1934, C.44 by a member of any issuing authority or by a corporation, organization or association in which any member of an issuing authority is interested directly or indirectly, the State Commissioner of Alcoholic Beverage Control is the "Issuing Authority" and in that event the notice must state that objections be addressed to D. FREDERICK BURNETT, Commissioner, 744 Broad Street, Newark, N. J.

#4. "Type of License" in the above form means the name or kind of license applied for, which must be strictly according to the statutory language. For instance, Plenary Retail Consumption, etc.

#5. The notice of intention, fully filled out as above, shall be published once a week, for two (2) weeks successively, in a newspaper printed in the English language, published and circulated in the municipality in which the licensed premises are located. If, however, there shall be no such newspaper, then such notice shall be published in a newspaper printed in the English language, published and circulated in the county in which the licensed premises are located.

#6. Each municipal clerk shall immediately upon receipt of a written objection, duly signed by a bona fide objector, transmit forthwith to the issuing authority of the particular municipality said objection and everything pertaining thereto, whereupon it shall become the immediate duty of each issuing authority to afford a hearing to all parties and immediately notify the applicant and the objector of the date, hour and place thereof. In Cape May and Ocean Counties, the Judge of the Court of Common Pleas shall afford the hearing and notify the applicant and objector of the date, hour and place thereof.

#7. The date fixed for such hearing shall not be less than two (2) days after the second insertion shall have been published and should not be more than seven (7) days. For good cause, each issuing authority in the exercise of sound and fair discretion may, subject to appeal to the State Commissioner by the applicant, if he proves that he is aggrieved by the delay, fix a date for hearing later than said seven (7) days or may adjourn the hearing. This provision is made to include those cases where the issuing authorities are morally convinced but have not had time to gather the proof believed obtainable to demonstrate that the application should or might be denied.

#8. No hearing need be held if no such objections shall be lodged (but this in nowise relieves the issuing authority from the duty of making a thorough investigation on its own initiative), or if the issuing authority, on its own motion, after the requisite statutory investigation, shall have determined not to issue a license to such applicant.


