Chapter Historical Note

 - i. Southbound:
 - (1) From Dunns Mill Road to milepost 33.8.
 - ii. Northbound:
 - (1) From milepost 33.8 to milepost 35.1.
3. No left turn in Hillsborough Township, Somerset County.
 - i. Southbound into the entrance (2) of Nelson's Corner Shopping Center.
 - ii. From the Exits (2) of the Shopping Center to Route U.S. 206, southbound.
4. No left turn in Lawrence Township, Mercer County:
 - i. From Route U.S. 206 northbound onto Monroe Avenue and Hendrickson Road between the hours of 7:00 A.M. and 9:00 P.M., Sunday through Saturday.
5. No "U" turn movements in Princeton Borough, Mercer County:
 - i. For the entire length of Route U.S. 206 (approximate mileposts 53.31 to 54.47).
